Complete the "All Animal" registration form on the following page. Information and directions below.

**Registration required for 4-H, FFA, Youth Grange & Open Class Animal Exhibits by July 15, 2022.**

- Each Exhibitor needs their own registration form for all animals requiring a pen, stall, or cage. Only one exhibitor per form. This includes all livestock - beef, sheep, swine, goats and horses, alpacas, llamas, rabbits, poultry, cavies, and birds.
- An animal fee is required for EACH exhibit registered on the form.
- Registration is considered completed only when the exhibitor fee and all animal fees are paid. Please submit registration form and fees no later than July 15.
- The Fair will assign Exhibitor Number. Your Exhibitor Ticket and receipt will be mailed to you. Please be sure your mailing address is the correct address.
- Due to limited space, Douglas and Chelan County residents will be given first option for pen/stall/cage space. Exhibitors from other counties will be notified if space is not available.
- Most exhibits will share pen/stall/cage space due to limited exhibit areas. The Barn Superintendent will assign space a week before the Fair.

- Fill out name, address, county, and phone number.
- **FFA:** List Chapter name.
- **4-H:** List Club name, age as of October 1, 2021, and check the box that matches your age.
- **Youth Grange:** List Grange name, age as of January 1, 2022, and check the box that matches your age.
- If you have animals in FFA, 4-H and Youth Grange, use separate Registration Forms. When completing the form, use the following: • FFA Division –19 • 4-H Division- 20 • Youth Grange Division - 21
  - Open Class Division: Horse-15 Livestock-16 Poultry-17 Rabbits -18
- For **Class, Lot, and Breed** - Check the Fair Premium Book for information.
- **Description** - Describe your exhibit – if more space is needed, attach a separate sheet to your registration.
- **# of Pens/Stalls/Cages Needed** - Indicate number
- Write Exhibitor Ticket amount next to the appropriate category
- Write Animal Fees next to the appropriate category: **EACH** Large Animal fee is \$15; **EACH** Small Animal fee is \$5.
- Submit total amount for your Exhibitor Ticket and Animal Fees.
