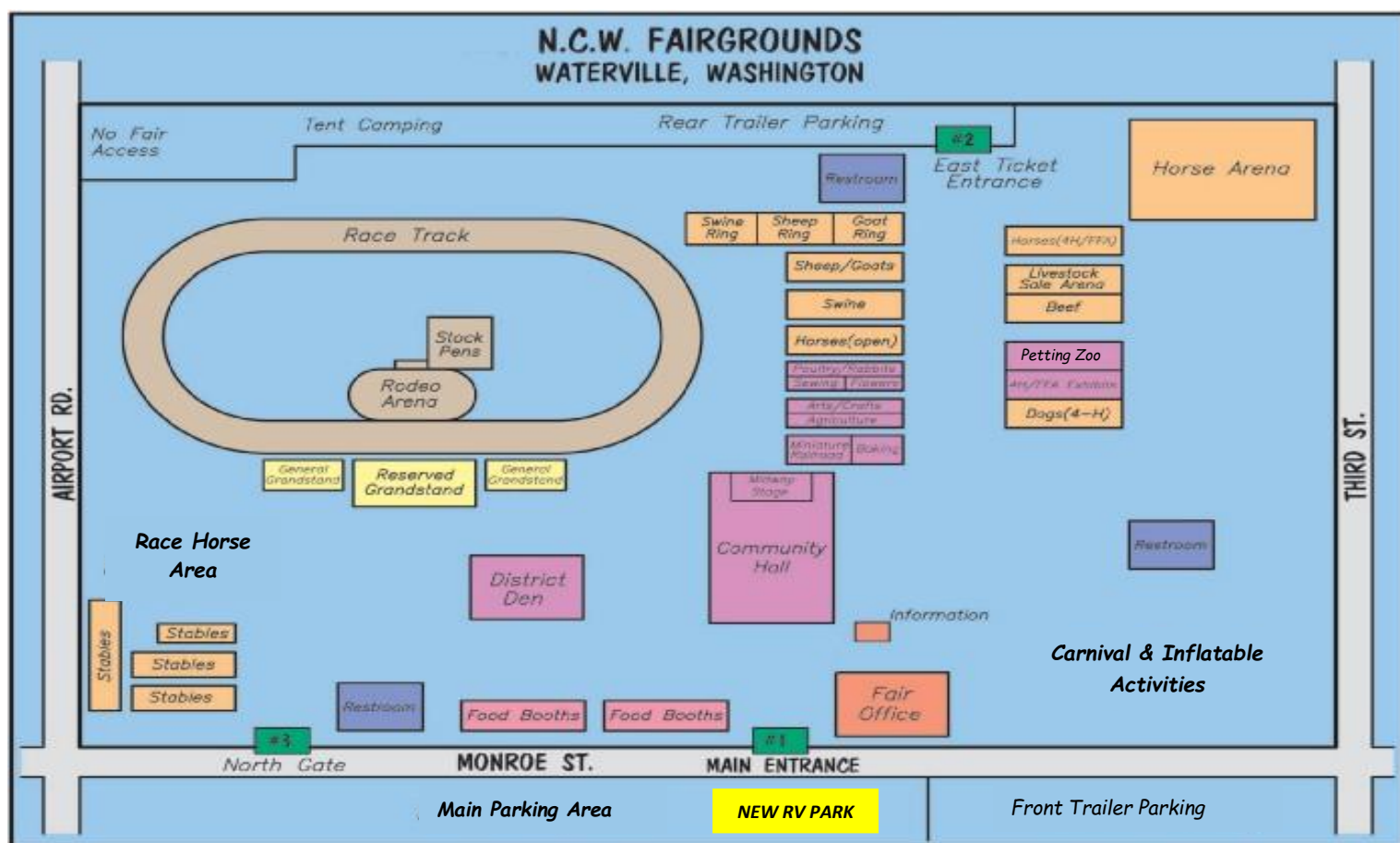

Information and directions for completing the "**All Animal**" registration form are on the following page. **Registration required** for 4-H, FFA & Open Class Animal Exhibits.

- Exhibitors need their own registration form for all animals requiring a pen, stall or cage. Only one exhibitor per form. This includes all livestock (beef, sheep, swine and goats), horses, alpacas, llamas, rabbits, poultry, caviar and birds.
- An animal fee is required for EACH exhibit registered on the form.
- Registration is considered complete only when the exhibitor fee and all animal fees are paid. Please submit registration form and fees no later than July 15.
- An Exhibitor Number will be assigned by the Fair. Your Exhibitor Ticket and receipt will be mailed to you so **please make sure your address is correct (per the US Postal Service)**.
- Due to limited space, Douglas County residents will be given first option for pen/stall/cage space. Exhibitors from other counties will be notified if space is not available.
- Most exhibits will be sharing pen/stall/cage space due to limited exhibit areas. The Barn Superintendent will assign space a week before the Fair.

All exhibits, including commercial exhibits, CANNOT be removed before 6:00 p.m. on Sunday, regardless of weather conditions. Exhibits removed prior to this time will forfeit all premium points. See General Rules.

2021 General Rules & Regulations

A. General Rules

1. The NCW Fair Manager and Executive Board are responsible for the general supervision of the entire fairgrounds, exhibit areas and RV Park. This includes, but is not limited to, when the gates, buildings and barns are opened, closed and locked, fairgrounds security and police protection.
2. Advertising restrictions: No person, unless contracted by the NCW Fair, will be permitted to distribute advertising materials on the fairgrounds, except from their place of business or exhibit space. The tacking or posting of any advertisement, bills, etc., other than within the space occupied by exhibits, is strictly prohibited. The distribution of handbills, fliers and heralds are not permitted. Anyone violating this rule is liable to a fine or expulsion from the fairgrounds. Begging, soliciting, singing or public speaking is prohibited.
3. No exhibit, tack boxes and equipment, including commercial exhibits or displays shall be removed or disassembled before 6:00 p.m. on the last day of the fair, regardless of weather conditions.
4. **LIABILITY FOR LOSS OR THEFT:** The owner or custodian of property of any kind brought to the fairgrounds, either for exhibit or other purposes, assumes, as a condition of his admission to the grounds, all risk of and responsibility for loss, damage or theft. The NCW Fair employs guards, traffic directors and other personnel to protect property on the grounds and ensure the safety of persons. The Fair Board and Fair Management and employees cannot and will not accept responsibility and liability for any damage or injury resulting from theft, fire, the elements, accidents or other conditions or causes, whether to exhibits, property of concessionaires, vehicles on the grounds and articles therein, or any other property of any nature whatsoever. Exhibitors, concessionaires and others having property on the grounds should make their own arrangements for guarding and protecting the same.
5. The Management reserves the right to remove from the grounds any exhibit, animal, concession, show, person, or persons deemed unsuitable to the nature of the Fair or objectionable to the general public. Removal will be immediate without return of money paid for space, stalls or admission.
6. **ACCESS TO CONCESSION** - Any official representative of the NCW Fair shall have access to the premises of any exhibitor or concessionaire at any and all times.
7. Pets are excluded from the Fair. A service animal accompanying a guest that is trained to provide a specific task for the benefit of the guest is allowed entry into the Fair. *All persons with a service animal must apply for and receive a permit from the Fair office before the animal will be allowed.* A service animal exhibiting disruptive, poor or unsanitary behavior must immediately be removed from the fairgrounds. See Section F for Dog Rules.
8. It shall be the sole right of the Fair Manager to direct and arrange the Race and Rodeo program. The number of Races and Rodeo events to be held during the time scheduled for the Grandstand Show will be determined on a daily basis, to fit the best interests of the show. In case of inclement weather, the Fair Board, Fair Manager and Race & Rodeo Committee will decide if the grandstand show and/or races are postponed or cancelled.



B. Exhibitor Information

Wednesday of the NCW Fair is "entry day." We encourage residents of the six counties in north central Washington to exhibit, but preference for livestock stalls goes to those living in Douglas and Chelan Counties first. Livestock exhibitors from other counties will be notified if stall space is not available. Entry deadlines listed below. Please check 4-H and FFA departments for special times and entry information.

1. Open Class Exhibits entered on Wednesday, 1-8:00 p.m.
2. Commercial Exhibits setup, Wednesday, 8 a.m. to 9 p.m.
3. All livestock exhibits accepted Wednesday, 3 - 8 p.m. Animal health requirements include a visual inspection by the Fair veterinarians and they will be only available during those hours. All livestock entries must come through the southeast gate. Poultry, rabbits, cavies and birds will be directed to a different gate for an animal health check. Livestock are not allowed out of livestock area. Once an animal is vet checked, the animal must not leave the livestock area before completion of Fair. NOTE: Rodeo arena is not considered part of livestock area.
4. Preregistration and purchase of exhibitor tickets will be required on all Open, FFA & 4-H animals, including horses, poultry, rabbits, cavies and birds. Registration deadline is to be postmarked no later than July 15, 2021. No late entries. Registration forms are in the 2021 Premium Book, at the NCW Fair Office and on the website, www.ncwfair.org. Tickets can be purchased via mail, phone or in person at the NCW Fair Office, 509-745-8480, Monday through Friday, 8:00 a.m. to 5:00 p.m.
5. Exhibitors and workers are expected to purchase Exhibitor or Season tickets and present them at the gates when entering. This is not considered an entry fee, but it is very necessary if the Fair Board is to award premium payments. When you purchase an Exhibitor Ticket, Season Pass or Daily Ticket, it admits you to the fairgrounds and exhibits. Tickets to the Big Bend Roundup Race and Rodeo event and the Friday night concert include admission to the fairgrounds on that day.
6. All exhibitors are required to register and receive their exhibitor number before presenting their exhibits to the department superintendent.
7. All fair participants must conduct themselves as responsible citizens. Any misconduct or unlawful acts by NCW Fair participants will not be tolerated. In the event of misconduct, the NCW Fair Board, along with the department superintendent involved, will rule on the suspension. Persons suspended from the Fair will forfeit all ribbons and premium monies and will immediately leave the fairgrounds. If that person is an exhibitor, their exhibit(s) will be removed. The NCW Fair Board will set the suspension period during its next regular meeting. An exhibitor who fails or refuses to exhibit an animal or article for any reason, forfeits all fees and premiums and cannot participate in the livestock sale.
8. Every animal or article must be entered for competition in the name of the owner or maker. Anyone trying to deceive the department superintendent in regard to ownership or anyone who purchases articles or borrows them for the purpose of exhibiting will forfeit all claims as exhibitors.
9. No animals can be removed without the approval of the superintendent, Fair Manager or Fair veterinarian.
10. It is the judge's option to award a Best of Show.
11. All exhibit entries will be judged using the Danish System. Blue, White and Red ribbons will be given to those exhibits meeting the criteria. A participation ribbon will be given to non-placed exhibits. 4-H Cloverbud exhibits will receive participation ribbons with blue ribbon premium points.

C. Livestock Exhibits

Rules found in this section are general and not intended to be complete or relieve the responsibility of the rules under individual departments or alter the fact that rules governing livestock are to be enforced by the respective division superintendent.

1. All livestock exhibitors are to comply with and adhere to the provisions required pertaining to Youth for the Quality Care of Animals.
2. The NCW Fair is not responsible for the death, sickness or damage of any animal from any cause in route to the fair, during the fair, in route to slaughter or in route home. Veterinarian services personally requested by an exhibitor are at the expense of the exhibitor.
3. If a 4-H, FFA or open class animal cannot make it through the entry and/or weigh in process on entry day of the Fair, the exhibitor will not be allowed to go home and bring a second animal to the Fair.
4. Bedding will be furnished for those animals properly entered by an exhibitor. At the discretion of the Fair, either straw or shavings will be provided for animal bedding.
5. Ownership deadlines for the NCW Fair are as follows:
Beef – February 15; Other animals – May 15.
6. Preregistration is required for all Open, FFA & 4-H animals, including poultry, rabbits, cavy and birds. Registration must be postmarked no later than July 15, 2021. The forms are available in the premium book or contact the NCW Fair Office at (509) 745-8480. All livestock exhibitor tickets must be purchased with animal registration by July 15.
7. Due to space limitations within barns, we may have to eliminate "out of area" (outside Douglas and Chelan Counties) registrations.
8. The NCW Fair provides livestock exhibitors with fresh stall bedding at no cost. An animal fee of \$15 will be charged per large animal (beef, swine, sheep, goats, horses) and a \$5 fee per small animal pen (rabbits, poultry, cavy, birds). This fee is paid with the animal preregistration.
9. The Fair veterinarian will be on the fairgrounds Wednesday, 3 p.m. - 8 p.m., to visually check all livestock. Livestock may not be brought into the grounds without this examination. The sole responsibility for admittance of an animal is that of the veterinarian. The veterinarian will be on the grounds at a specified time each day.
10. Quality Assurance Market Health Records and IAFE Ethics Forms are required before entrance into the Fair for all beef, sheep, goats, and swine. Beef will also require brand slips and Feed Affidavits. Documentation will include place of birth and location where livestock was raised for each animal marketed and third party verification. All documentation is required at the time of the vet check on August 25, 2021. For more information, contact your local 4-H leader or FFA chapter.
11. Absolutely NO dogs will be permitted on the fairgrounds or in RV parks, with the exception of service dogs, concessionaire or entertainer pets and 4-H member exhibits. Animals must be leashed at all times. See #7 under 2021 General Rules & Regulations.
12. All animals, equipment and exhibits must remain until 6:00 p.m. on Sunday.
13. Lambs must be shorn within 30 days prior to the fair. Blackface breeding sheep must be identified with a flock ID # assigned by the WSDA office before movement of such sheep from the premises of origin for the show, sale, purchase or other movement. Tattoos, electronic implants or tamperproof tags from an approved supplier must be used. Blackface sheep are defined as Suffolk or Hampshire breeds or crosses of other breeds with Suffolk or

Hampshire breeds. All sheep over 18 months of age (ewes, lambs, and wethers); all sexually intact sheep (rams and ewes, including ewe lambs under 18 months of age) going to a show, demonstration or exhibition must have official identification. Official ID for sheep is defined as: (1) USDA issued ear tags with assigned flock ID number and individual animal serial number, (2) Legible ear tattoos with USDA assigned flock ID # and individual animal series # (tattoo), (3) Ear tags and/or legible ear tattoo resulting from current active registration in the USDA Voluntary Scrapie Certification Program. All sheep other than wethers under 18 months will not be admitted to the fairgrounds without proper official ID.

14. Goats: All sexually intact goats (buck and doe) going to a show, demonstration or exhibition must have official ID. Official ID is identified for goats as 1) USDA issued ear tags with assigned flock number and individual animal serial number, 2) Legible ear, flank or tail fold tattoo with USDA flock ID # and individual animal serial (tattoo), legible breed registration tattoos (breed tattoos should be registered with the USDA Veterinary Services) when accompanied by their breed registration certificates or when the registration certificates or registration numbers are listed on a certificate of veterinary inspection, 3) Ear tags and/or legible ear tattoos from current active registration in the USDA Voluntary Flock Certification Program, 4) Electronic implant devices when animals are accompanied by an implant reader, and the implant number is listed on a breed registration certificate or certificate of veterinary inspection, and 5) All goats other than wethers will not be admitted to the fair without official ID.
15. All stalls and pens must be cleaned before 8:00 a.m. each day (except horses begin cleaning by 6 a.m. to be completed by 7:30 a.m.) and refuse disposed of as directed by the Superintendent. A suitable area will be furnished by the Fair for this purpose. ANY EXHIBITOR MISSING THIS EARLY CLEANUP WITHOUT PERMISSION OF THE DIVISION SUPERINTENDENT WILL BE REFUSED THE RIGHT TO CLEAN LATE AND WILL BE PENALIZED ALL OR PART OF ANY PREMIUMS TO BE AWARDED.
16. The NCW Fair Manager and superintendents reserve the right to cancel any class where there are less than four entries and combine classes should the best interests of the show require it.
17. NCW Fair 4-H and FFA Round Robin:
 - FFA and 4-H round robin events will run at the same time.
 - There will be four rotations of 12 minutes for a total of 48 minutes. Four minutes will be allotted for travel between rotations (there are four); 16 minutes for rotations. The total time for Round Robin should be about 64 minutes. Six individuals may take part in each of the six categories (Beef, swine, sheep, goat, horse) at a time.
 - FFA Grand Champion and Reserve Champion awarded.
 - 4-H Senior Grand Champion and Reserve Champion awarded.
 - 4-H Intermediate Grand Champion and Reserve Champion awarded.
 - Rotations will be beef to swine to sheep to goats to horse to beef.
 - Contestants will not reshow their own animals.
 - Animals will be marked to indicate the Grand Champion or Reserve Champion either in FFA or 4-H Seniors and Intermediates.
 - Judges will place the top five individuals in all fitting and showing classes.
18. **Load-Out Procedures**
Exhibitors may begin to remove stall decorations and tack on Sunday between 5:00 p.m. and 6:00 p.m. If this process is not completed prior to 6:00 p.m., you can resume after the packers have been loaded out. Load-out will start promptly on Sunday at 6:00 p.m. All packers (beef, hogs, sheep and goats) will be

permitted to load first. No other animals are to be removed from the barns until after the packers have been loaded.

No one is allowed in the barns during load-out of beef, hogs, sheep and goats. Guards will clear the barns of all persons by 6:00 p.m. and will remain at the gates to prevent entry.

During load-out, all beef and goats will exit the barn in the same manner they entered during load-in.

Interference with load-out can result in the loss of premium points. If interference occurs, depending upon the severity, exhibitors may lose the opportunity to participate as an exhibitor in the Fair in the future.

D. Health Requirements NCW Fair

1. The NCW Fair will have an official veterinarian in attendance Wednesday and at a specified time each day.
2. All breeding cattle should be blood tested for brucellosis and found negative within 30 days of entry to the fair. Proof of negative blood test of vaccination will be shown to veterinarian. Dairy cattle identified as official calf hood vaccinates under 20 months of age, and beef cattle identified as official calf hood vaccinates under 24 months of age, should not be tested. Steers should be exempt from brucellosis.
3. Individual health certificates are not required for entry.
4. Fair veterinarians will inspect all classes of livestock and poultry (including horses, pet animals, fur-bearing animals, pigeons, ducks, geese and turkeys), before they are exhibited, to determine that the livestock and poultry are free from infectious or contagious disease and ectoparasites. All poultry must test negative for Salmonella pullorum-typhoid (P-T). This rule applies to chickens, exotic fowl and game birds, but excludes waterfowl, doves and pigeons. Birds under the age of 16 weeks do not need to be tested for P-T. Exhibitors that meet one of the two options below do not need to have their birds P-T tested prior to exhibit:
 - The exhibitor is a participant in the National Poultry Improvement Plan (NPIP); or
 - Within the past twelve months, the show birds were purchased from NPIP participants, hatcheries, or feed stores. Exhibitors that do not meet the criteria above must test negative for P-T within 90 days of going to exhibit.
 - A veterinarian, vet tech or trained personnel can draw ½ cc of blood from each bird and send the samples to the WSU Avian Health and Food Safety Laboratory in Puyallup, WA or a WSDA field veterinarian needs to perform a P-T testing prior to the Fair.
5. Fair Veterinarians MUST and WILL REJECT ANY ANIMAL WITH INFECTIOUS OR CONTAGIOUS DISEASE OR ECTOPARASITES. EXHIBITORS should be aware that RINGWORM, WARTS, PINKEYE, STRANGLES, CONTAGIOUS, ECTHYMA, SCABIES, LICE, MITES, TICKS, AND FLEAS fall into these categories. No animal from a quarantined area or premise will be permitted to enter any fair.
6. ALL OUT-OF-STATE ENTRIES MUST COMPLY WITH THE State of Washington import regulations. A 2021 Health Certificate will be issued by an accredited veterinarian from the State of Origin for all out-of-state livestock and poultry entries.
7. No drug or medications shall be administered on the fairgrounds unless approved by the Fair veterinarian in writing. Anyone caught in this act shall have all exhibits removed from grounds and forfeiture of all premiums.
8. Any animal carcass that is packer rejected is returned to the exhibitor with forfeiture of all sales/monies dealing with that exhibit.

E. Horse Handling Rules

1. Anyone handling horses must wear boots.

2. All exhibitors must be suitably attired. Boots and helmets are required for all riding classes. Numbers must be clearly visible. Chaps are optional in riding classes.
3. No horses on the midway at any time.
4. Exercise times: Open Class 7-8 morning and evening EXCEPT 7:00-7:45 a.m. Saturday morning; 4-H and FFA 8:00-9:00 morning and evening EXCEPT 7:45-8:30 Saturday morning.
5. Horses must be under control at all times - NO LOOSE HORSES ALLOWED ON THE FAIRGROUNDS except in the round pen.
6. Horses (4-H, FFA) must be exercised daily; no longeing.
7. NO RUNNING HORSES. No loping horses outside of arena.
8. No horses allowed outside designated livestock area. RODEO ARENA IS NOT PART OF THE LIVESTOCK AREA.

F. Dog Rules

1. This is the policy regarding dogs on the NCW Fairgrounds and property during the annual NCW Fair and during other Fair sponsored events:
STRICT ENFORCEMENT; NO DOGS WILL BE ALLOWED ON THE FAIRGROUNDS.
2. "Fairgrounds" is defined as any area requiring paid admission, including the RV areas, Rodeo Arena or other posted areas.
3. Exceptions:
 - Dogs assisting visually or hearing impaired persons (See A. General Rules, #7 for additional information)
 - Dogs participating in Dog Show and/or Classes
 - Dogs traveling with vendors
 - Entertainers' dogs which are part of a performance contracted by the Fair.
 - Dogs belonging to race horse owners or riders. Dogs must be on leashes at all times
4. All persons with dogs, which meet one of the above exceptions, must apply for and receive a permit from the Fair office before the dog will be allowed on the Fairgrounds.
5. Restrictions:
 - Dogs for visually and hearing impaired must accompany person that the dog is assisting.
 - Dogs participating in Dog Show and/or Classes: Dogs to be allowed on Fairgrounds for Dog Show and/or Classes purposes only. Dog must be returned to benching area immediately after Show or Classes. Dogs will not be allowed in other areas of the Fairgrounds.
 - Vendors' dogs must remain on a leash within the rented vendor's area at all times except when being exercised.
 - Entertainers' dogs must be a part of Fair-contracted entertainment and must remain within Entertainment Area and be removed from Fairgrounds upon completion of contracted entertainment.
6. All dogs, including those in the Horse Race area, must remain on a leash at all times when outside of a cage or a vehicle.
7. Dogs will be exercised in a designated dog area only. All droppings must be picked up immediately and placed in the proper waste receptacle.
8. Dogs that are disruptive, unmanageable or are deemed unsafe to the public will be asked to be removed from the Fairgrounds and RV areas immediately and the dog permit will be revoked.
9. All persons(s) with dogs must produce permit upon request by any Fair Board member, Fair Manager or any person acting on behalf of the NCW Fair.
10. "Puppies" are considered dogs.
11. All stray dogs will be removed from the Fairgrounds and transported to Wenatchee Valley Humane Society.

12. We encourage all dog owners, for the health and comfort of their dogs, to leave their animals at home.
13. Permitted dogs are not allowed to run loose.

G. Recreational Vehicle and Camping Rules

The North Central Washington Fair areas for recreational vehicles and camping are intended to accommodate Fair participants and patrons during August of each year. The recreational vehicle area may be available for use during other times of the year. These areas are not intended for short-term or long-term residential use. By using the areas for recreational vehicle parking and camping, you agree to the following rules.

1. Daily use fees, based upon the length of your intended stay, *must be paid in advance*. If you do not pay the daily use fees in advance, your use of the area will be immediately revoked.
2. Quiet time is from 9 p.m. to 7 a.m. and, *during the Fair, quiet time is 10 p.m. to sunrise*. You must keep noise to a minimum during these hours. Noise during quiet hours will not be tolerated and will be grounds to immediately revoke your use of the area. **You may not use air conditioner units during the Fair in Front Lot Spaces A-Y or Back Lot Spaces 1-32. Air conditioning units may be used in Front Lot Spaces Z 1-14 during the Fair.**
3. Your assigned space must be kept clean and neat. Garbage and litter cannot be accumulated. All garbage and litter must be picked up promptly and placed in proper trash receptacles.
4. You may only use your assigned space. Parking in or using any other space is prohibited even if it appears the space is not being used. Excess vehicles must be parked in the Fair parking lot area. Recreational vehicle tip-outs may only be extended if the tip-out does not extend past the assigned space and leaves sufficient space for neighboring users to get in and out of recreational vehicles comfortably. Campers/RVs must fit into the space allotted, not to exceed 30' in front Lot A-Y and back Lots 1-32. RVs exceeding the space allotments will be asked to move to another lot if available.
5. **Children must be supervised at all times.** Children may not be left unsupervised in any recreational vehicle or at any campsite. There must be at least one authorized, supervising adult staying with children in your recreational vehicle or at your campsite during evening hours and overnight. Children may not play in or around other users' vehicles or campsites or play on Fairground property when the Fair is closed. You are responsible for any damages caused by your children.
6. You are responsible for your guests, their children and pets. Your use of the area may be immediately revoked if your guests, their children or their pets violate these rules.
7. The vehicle speed limit in and around the RV/campsite areas is 10 mph. The speed limit during Fair hours is 5 mph. Speeding is not tolerated. It will be grounds for immediate revoking your use of the areas.
8. **Dogs, other than a service animal or show animal, are not allowed in the area unless prior approval is obtained.** All dogs must be kept on a leash or inside your recreational vehicle at all times. Dogs may not be left tied up outside your recreational vehicle or at your campsite unsupervised. Dog droppings must be immediately picked up and disposed of in proper trash receptacles. Continuous barking, aggressive behavior or the failure to follow the above rules relating to dogs will be grounds to immediately revoke your use of the area. You will be held responsible for any damage caused by your dog.
9. You may not place freezers, refrigerators or other appliances outside your recreational vehicle or in your camping space.
10. **Use of open fires, fire pits and charcoal grills is prohibited.** Use of self-contained gas grills is allowed.

11. The Fair does not provide security at the recreational vehicle and camping areas. You **assume all risks of loss, damage to or destruction of your vehicle(s) and other property**, including loss of use resulting therefrom, whether by fire, explosion, theft, vandalism, the elements, collision or acts or omissions of the County or the Fair, their employees, agents and volunteers or resulting from any other cause. **You waive all claims of subrogation by your insurance companies. You agree to indemnify, defend and hold the County and the Fair, their appointed officials, employees, agents and volunteers, harmless from and against any and all claims, damages, losses and expenses for any bodily injury, sickness, disease or death, or any damage to or destruction of property, including the loss of use resulting therefrom, which are caused in whole or in part by your act or omission or caused by the use or condition of your vehicle(s).**
12. If your use of the recreational vehicle area or camping area is revoked, you must immediately remove all motor/recreational vehicles, tents and other property. **Motor vehicles, recreational vehicles, tents and other property not removed immediately will be towed/removed/impounded at your expense.**

H. NCW Fair 4-H & FFA Livestock Auction Sale

1. The Fair Board will have available at the NCW Fair, an auction whereby suitable market 4-H and FFA livestock can be sold. The sales are to be made subject to state and federal inspection at point of slaughter and the owner/operator shall be responsible for care and health of any animal until the animal is loaded for transportation to point of slaughter. Let it be further understood that the NCW Fair will provide a place for exhibit and arrange for an auction sale, but "The Fair" or its Officers at no time become the owners of the exhibits. All costs and care for any exhibit remain with the owner/operator. The Fair will not be responsible for any sale, collection or payment not made as part of the regular auction sale.
2. It is the responsibility of the livestock buyer to make arrangements for transportation and removal of their animals from the grounds after 6:00 p.m. Sunday. The Fair will not have anyone on the grounds after 6:00 p.m. to watch or feed livestock, therefore they must be removed. If you choose to leave custom animals on the fairgrounds after 6:00 p.m., those animals are the complete responsibility of the buyer. Buyers must notify the sales office about transportation arrangements for custom animals before noon on Sunday.
3. Animals sold as custom must be paid for by noon on Sunday of the Fair. If not paid for by noon, the animal will be considered a packer animal and be shipped as one. The buyer is responsible for the support price of the animal.
4. Bids for support price only. The buyer can indicate at the sales office that the bid will go for the support price only. Please keep in mind that market prices bid by commercial packers will be announced for each kind of animal.
5. AN EXHIBITOR IS ALLOWED TO SELL ONE MARKET ANIMAL THROUGH THE SALES RING (THIS INCLUDES GOATS). This does not limit the entries, but only this specified number will be sold through the sales ring. If the member is showing more than one animal in the market division of any class, the member must sell the animal that finished best in that Market Class through the Youth sale. THE FAIR WILL NOT BE RESPONSIBLE FOR THE SALE OF ANY SECOND ANIMALS. The member will take home any second animals or they may be sold private treaty at the Fair. For sale signs may be posted no sooner than Sunday morning. THE FAIR BOARD IS NOT RESPONSIBLE FOR ANY TRANSACTION OUTSIDE THE SALE RING BETWEEN THE BUYER AND EXHIBITOR.
6. Mandatory tagging of all livestock is required.

7. NO WHITE RIBBON ANIMALS WILL SELL THROUGH THE LIVESTOCK AUCTION.
8. No change of ownership or destination of market animal after 6:00 p.m. Saturday.
9. Three percent (3%) of the livestock sale and add-ons will be deducted each year to be used for livestock facility improvements and maintenance as deemed appropriate by the NCW Fair Manager.

I. Fur & Feather Auction Rules - (Cash/Check Sales)

1. The Annual Fur & Feather Auction will be Saturday at 9:30 a.m.
2. Only one animal per exhibitor may be sold at auction either in the Livestock or the Fur & Feather Auction.
3. All 4-H and FFA members carrying a rabbit, goat, or poultry project may choose to sell their animal by Thursday at noon. Register in the poultry/rabbit barn with the superintendent.
4. Only blue and red ribbon animals will be auctioned.
5. Exhibitor must fit and show the animal to be in the auction.
6. Exhibitor will be responsible for animal until purchaser claims it after 6:00 p.m. Sunday. Only cash or checks will be accepted by the department superintendent. No monies go through the NCW Livestock Sale.
7. There will be a minimum base bid of \$10.00 per animal.
8. Buyer has the option of taking animal or returning it to owner.

J. Premium Information

1. All premiums will be paid by check usually within 60 days from the end of the Fair. Checks that cannot be delivered because of an insufficient address will be held at the Fair Office. All checks not cashed will revert back to the General Fair Fund after January 1, 2021. Premium checks under \$5 will not be printed and considered a donation to the NCW Fair. Arrangements to receive and pick up a premium check under \$5 must be requested prior to November 1, 2021. Call (509) 745-8480.
2. The value of points for awards will be set by the Fair Board at the first Board meeting after a complete financial report is submitted to the Fair. If a natural disaster or circumstances beyond the control of the Fair Board occur that directly impacts the Fair proceeds, premiums will be paid by an equal division of the receipts to the exhibitors who have been awarded premiums, after paying the expenses of the fair.
3. Judges have been carefully selected by management and each is recognized for their capability of making expert decisions in their respective divisions. All exhibitors making entry in the Fair accept these judges and agree to abide by their decisions. The decisions of the judges will be final in all cases. Exhibitors are prohibited from interfering with a judge in any manner during the judging time. Refusal to stop interfering could result in forfeiture of any premiums.
4. All protests must be made in writing and accompanied by a deposit of \$20.00 in the Livestock, Horse Racing and Rodeo parts of the Fair, and \$10.00 in all other departments. This fee will be forfeited if protest is not sustained. Such protests must state plainly the cause of complaint or appeal and must be filed with the Manager within twelve hours AFTER THE CAUSE OF PROTEST. NO COMPLAINT OR APPEAL BASED UPON THE STATEMENT THAT THE JUDGE OR JUDGES ARE INCOMPETENT WILL BE CONSIDERED BY THE BOARD. THE JUDGE'S DECISION WILL BE FINAL.
5. **Keep your exhibitor tickets until after you receive your premium check.** You will need your card to prove your ID number in order to question any check amounts or mislabeled exhibit cards.

K. Barn Herdsmanship

1. All exhibitors including Open Class are expected to care for their animals, maintain their pens and equipment properly and to keep stalls and animals clean at all times. The exhibitor will be responsible for feeding and watering of their exhibit. If not done to the satisfaction of the appropriate superintendent, the exhibitor may be asked to remove exhibits from the NCW Fairgrounds and will forfeit any premiums.
2. Barn duty hours are from 8 a.m. to 8 p.m., Thursday through Saturday and 8 a.m. to 5 p.m., Sunday. The wash racks, scale area and show ring are considered a part of barn duty.

Rules, classes and lots are the same for all divisions listed below. Please put age on exhibit tags in Divisions 004, 005, 006.

001: Professional (orange tag)

Please bring business cards with entries.

002: Sr. Citizen: age 62+ (aqua tag)

003: Adult: age 18-61 (green tag)

004: Student: age 13-17 (purple tag)

005: Youth: age 7-12 (pink tag)

006: Child: age 6 and under (yellow tag)

Rules:

1. Paintings must be framed or canvas must have finished edges. Art not framed will be entered into craft division.
2. Sculptures should be firmly based.
3. All work must be entirely the work of the exhibitor.
4. There will be a Best of Show rosette plus 25 points awarded to one participant in each division as well as a Best of Show rosette plus 50 points awarded to one participant overall. There will be a Judges Choice rosette plus 20 points awarded to one participant overall.
5. Each day there will be an open vote by the public for People's Choice award. The winner will be announced each day of the fair at 3:00 p.m. A ribbon plus 10 points will be awarded to each recipient of the award. All exhibits in this department must be the work of the exhibitors and must have been completed within the last two years. No articles that have been judged before in the NCW Fair can be accepted for exhibit a second time.

Exhibitors may enter up to five (5) unique and different articles per lot in each class in NEEDLEWORK, SEWING, and QUILTING Divisions. Articles are considered UNIQUE as long as they vary by pattern or technique, and not just color.

Exhibits that significantly combine two needlework techniques may be entered in two lots with separate judging for each technique. For example, a pieced-quilt of hand-embroidered squares may be entered in both quilting and embroidery lots.

GARMENTS AND QUILTS MUST BE CLEAN AND LAUNDERED. The superintendent has the right to decline any exhibit that does not meet the above requirements or is not suitable for display.

Criteria for judging will be based on 1) Workmanship, craftsmanship and precision; 2) Creativity, design and originality; 3) Harmony and suitability of color and materials or fabric; and 4) Visual impact, cleanliness and presentation.

Special Awards:

1. Best of Show – Best of Show ribbons will be awarded in each division (Needlework, Sewing, and Quilting).
2. Best Youth exhibit in Fabric and Fiber Arts will receive a special award.
3. Best of Class, Superintendent's Choice and People's Choice ribbons will be awarded at the discretion of the judges and superintendent. Each winner will be awarded 25 extra bonus points.
4. Best of Show in the Upcycle Sewing class will receive a \$25 gift certificate from the Douglas County Historical Society (Thrifty Store).

HINTS FOR PREPARING VEGETABLE EXHIBITS:

Only vegetables of marketable quality will be considered so select exhibits carefully. Look for uniformity. Avoid those that are bruised or blemished.

Roots: Leave tops approximately one inch long on crops such as carrots, beets, parsnips, turnip and salsify. Wash carefully.

Beans: Tender and without strings; uniformity extremely important; no noticeable bulges due to enclosed beans.

Cabbage: When peeling, leave one set of leaves to be removed in preparing the cabbage for the table.

Carrots: Avoid injury by severe washing. Smoothness and a genuine carrot color usually accompany good quality carrots.

Corn: Cut straight with tips and butts full size and filled to end.

Cucumbers: Use a knife when picking. Leave 1/2" of stem on. **Eggplant:** 5" diameter at largest point.

Muskmelon: Netting deeply ridged uniformly over entire melon; greenish-yellow ground color.

Onions: Should be dry; remove only as many outer husks as necessary to make onions look clean and attractive. Roots may or may not be removed.

Parsnip: Avoid breaking tips; 2"-3" diameter at crown best.

Peppers: Uniform size and color

Potatoes: Average commercial size - dig and wash carefully.

Pumpkins & Squash: When ripe, shell is too hard to be pierced with thumbnail; harvest with knife, leave 1"-2" stem.

Tomatoes: Green stems may or may not be removed; use scissors; uniform size and color.

Turnips: Average size, do not remove tails.

Birds under the age of 16 weeks do not need to be tested for P-T. Exhibitors that meet one of the two options below do not need to have their birds P-T tested prior to exhibit.

- The exhibitor is a participant in the National Poultry Improvement Plan (NPIP); or
- Within the past twelve months, the show birds were purchased from NPIP participants, hatcheries or feed store. Exhibitors that do not meet the criteria above must test negative for P-T within 90 days of going to exhibit.
- A veterinarian, vet tech or trained personnel can draw ½ cc of blood from each bird and send the samples to the WSU Avian Health and Food Safety Laboratory in Puyallup, WA or a WSDA field veterinarian needs to perform a P-T testing prior to the Fair.
- No premium will be paid on more than one entry in any lot in each breed shown by the same exhibitor.
- Only standard varieties shall complete.
- All standard varieties of poultry, including Bantams, are eligible for competition for premiums.
- Fowls deemed unworthy will not be awarded a premium.
- Exhibitor is responsible for feeding and watering his or her exhibits.

Exhibit Only tickets have no charge, but allow exhibits to be entered on entry day and picked up on Sunday after 6:00 p.m. This ticket cannot be used for entry into the Fair. All animal exhibit entries must be received in the Fair office by July 15.
3. Each exhibitor shall be enrolled in vocational agriculture in his respective school (seniors graduating the spring prior to the fair are eligible to exhibit their supervised farm program and farm shop).
4. FFA participants must conduct themselves as responsible citizens. Any misconduct or unlawful acts on the part of the exhibitor, patrons or leader will be grounds for suspension of that person from participating in the NCW Fair. See 2021 General Rules & Regulations, B., #7.
5. All horticulture, agronomy and farm shop exhibits must be entered by 8 p.m. Wednesday.
6. Instructors shall be responsible for entering and for supervision of placement for their chapter's respective exhibits in any part of the FFA Division (If this is not possible, arrangements must be made with the superintendent prior to entry time).
7. All exhibit entries will be judged using the Danish System. Blue, White and Red ribbons will be given to those exhibits meeting the criteria. A participation ribbon will be given to non-placed exhibits.
8. Exhibits in horticulture, agronomy, vegetables and canned products must be homegrown or from the place where the family income is derived, or a part of the exhibitor's Supervised Program.
9. No individual health certificate prior to entry is required but fair veterinary personnel must write a blanket health certificate (see 2021 General Rules & Regulations) certifying that all animals in each class have been examined and found free from symptoms of contagious and infectious diseases.

10. All FFA exhibitors must adhere to the rules on Barn Herdsmanship.
11. All animals exhibited for breeding stock will be shown and judged by breeds. No competition between breeds or between sexes. Only breeding stock from Douglas and Chelan County are eligible.
12. Possession dates: February 15 for steers; May 15 for all other livestock and horses. All poultry and rabbits must be owned and cared for by exhibitor at least 30 days prior to fair time. Any given animal or animals may be shown in only one division. Example: a horse in FFA and same horse in open is not allowed.
13. All exhibits must have proper quantity to qualify.
14. Each exhibitor may enter only one entry in a lot number, except when lot number is qualified by the statement "any variety" in which case, any one exhibitor may enter as many exhibits in that lot as he or she has varieties, provided that the variety has not been entered under a different lot number; also, except in market livestock he may enter two.
15. Animals are shown in one lot unless shown as a pen.
16. Each entry must have the correct variety listed on the exhibit tag in order to qualify.
17. All berries to be shown in hillocks and wrapped in cellophane.
18. All questions or problems should be directed only to the FFA superintendent.
19. All grain and field samples shall be exhibited in one quart clear closed jars.
20. All sheaves shall not be less than 1.5" and not more than 2.5" inches in diameter.
21. All grass and legume seeds shall be exhibited in one pint clear closed jars.
22. All mounts must have been prepared by exhibitor and must be in book form.
23. Not more than one weed or one crop of a kind to be shown by any one chapter. This applies only to the plant mounts as singles, not books.
24. All livestock, poultry, rabbits, cavies and birds will be fed and cared for by the owner, unless other arrangements are made with the FFA Superintendent. Failure to do this will result in disqualification and removal from the grounds.
25. Weigh animals off the truck, less acceptable shrink of 2%.
26. All beef and dairy cattle scurs not to exceed 2 inches.
27. All beef and dairy cattle must have a neck rope or safety chain with proper safety snaps and will be on the animal at all times when in the barn areas.
28. Definition of ages for beef and dairy:
 - a. Senior Yearlings - calved between Sept. 1 & Dec. 31
 - b. Junior Yearlings - calved between Jan 1 & April 30
 - c. Summer Yearlings - calved between May 1 & Aug. 31

All animals less than the minimum or greater than the maximum, will not be sold through the 4-H and FFA Livestock Auction.
31. It is required that all lambs be shorn. Shearing to be done within 30 days prior to the fair.
32. Goats may have horns but must be tipped to the diameter of a dime. Horn tips must be covered as a safety precaution.
33. The NCW Fair will not be responsible for restitution of any exhibits

lost or an animal's death, sickness or damage from any cause in route to the Fair, during the Fair, in route to slaughter or in route to home. The interest of the Fair is for the animals sold through the livestock sale. The Fair is not responsible for sale of any exhibit not a recognized function of the NCW Fair. The NCW Fair will not be responsible for values or restitution, of condemned carcasses or parts of a carcass. Condemnation of a carcass will be that from inspectors, veterinarians or written information from the slaughtering plant. See 2021 General Rules & Regulations at the front of the premium book.

34. Fitting and Showing is mandatory in at least one class of market livestock in order to receive premiums and to be eligible for the sale.
35. Be sure that exhibitors have Market Health Records and brand slips to turn in at time of arrival and weigh-in. Without those records, the exhibitor will not be able to participate in the livestock sale.
36. Be sure that each exhibitor weighs their animal in beef, sheep, goats, and swine market lots and that it is identified as FFA on the weight card. Give chapter name for the address, not the mailing address.
37. Be sure to read the GRADY AUVIL MEMORIAL HORTICULTURE EXHIBIT AWARD in Fruit Exhibits. All entries are subject to approval by the FFA Superintendent before being placed in the exhibit area.
38. No drug or medications shall be administered on the fairgrounds unless approved by the fair veterinarian in writing. Anyone caught in this act shall have all exhibits removed from grounds and forfeiture of all premiums.
39. Any animal carcass that is packer rejected is returned to the exhibitor with forfeiture of all sale monies dealing with that exhibit.
40. AN EXHIBITOR IS ALLOWED TO SELL ONE MARKET ANIMAL THROUGH THE SALES RING. This does not limit the entries, but only this specified number will be sold through the sales ring. THE FAIR BOARD IS NOT RESPONSIBLE FOR ANY TRANSACTION OUTSIDE THE SALE RING BETWEEN THE BUYER AND EXHIBITOR. NO WHITE RIBBON ANIMALS WILL SELL THROUGH THE LIVESTOCK SALE.
41. The dress for all FFA showing contests is dark jeans, collared shirt, FFA jacket, appropriate shoes, no hats.
42. ALL LIVESTOCK MUST BE PREREGISTERED AND EXHIBITOR TICKETS PURCHASED BY July 15, 2021. No late entries accepted unless room is available. Preregistration forms are in the NCW Fair book or available by calling the Fair office at 509.745.8480.

- 2. All exhibitors must be suitably attired. Boots and helmets are

required for all riding classes. Numbers must be clearly visible.

Chaps are optional in riding classes.

3. No horses on midway at any time.
4. Open horse exit: out North door; 4-H horse exit: out East door.
5. Exercise times: Open- 7-8 morning and evening EXCEPT to 7:45 Saturday morning; 4-H and FFA - 6-7 morning and evening EXCEPT 7:45-8:30 Saturday morning.
6. Horses must be ridden, longed or controlled on lead line. NO LOOSE HORSES ON FAIRGROUNDS.
7. All horses are to be exercised daily; no longeing.
8. NO RUNNING HORSES. No loping horses outside the arenas.
9. No horse allowed outside designated livestock area.
10. RODEO ARENA not considered part of livestock arena.

General Health Requirements, #4. All exhibitors will be required to attest in writing that they are not in violation of this WAC. This signed document will be forwarded to the state veterinarian within one week of the conclusion of the event.

All poultry must test negative for Salmonella pullorum-typhoid (P-T). This rule applies to chickens, exotic fowl, and game birds; but excludes waterfowl, doves, and pigeons. Birds under the age of 16 weeks do not need to be tested for P-T. Exhibitors that meet one of the two options below do not need to have their birds P-T tested prior to exhibit:

- The exhibitor is a participant in the National Poultry Improvement Plan (NPIP); or
- Within the past twelve months, the show birds were bought from NPIP participants, hatcheries or feed stores. Exhibitors that do not meet the criteria above must test negative for P-T within 90 days of going to exhibit.
- A veterinarian, vet tech or trained personnel can draw ½ cc of blood from each bird and send the samples to the WSU Avian Health and Food Safety Laboratory in Puyallup, WA or a WSDA field veterinarian needs to perform a P-T testing prior to the Fair.

RULES/GUIDELINES for 4-H EXHIBITS

All 4-H exhibits must have been grown or made by the 4-H member during the current 4-H year. All exhibit entries will be judged using the Danish System. Blue, White and Red ribbons will be given to those exhibits meeting the criteria. A participation ribbon will be given to non-placed exhibits. Cloverbud exhibits will receive participation ribbons with blue ribbon premium points.

1. Read the general fair rules and regulations regarding entry times, judging, payment of premium points and removal of exhibits.
2. Any 4-H member currently enrolled in the 4-H program may exhibit in the NCW Fair. Members can only exhibit in the project areas in which they are enrolled.
3. 4-H age levels (determined by age as of October 1 of the previous year): Cloverbud: ages 5-7; Junior: ages 8-10; Intermediate: ages 11-13; Senior: ages 14-18.
4. Exhibit tags are available at the NCW Fair Office in Waterville and the Chelan-Douglas 4-H Office in Wenatchee.
5. Each exhibitor will fill out exhibit tags (top and bottom) completely. One tag per each entry or activity.
6. It is the responsibility of each member to check specific requirements under each Class and Lot.
7. Best of Show rosettes will only be awarded when there are five (5) or more entries in a Class, except where otherwise noted and when judges deem appropriate.

GENERAL RULES FOR LIVESTOCK

4-H members who are exhibiting Market Animals (beef, sheep, swine and goat) must turn in a Producer Affidavit & Health Record for their animal at weigh-in.

1. All entries in registered class must show either certificate of registration in breed association to which it belongs or show satisfactory proof to judge that animal is purebred and application for registration has been made.
2. Any 4-H club member currently enrolled in a livestock project during the current year is eligible. Cloverbud 4-H members may not be enrolled in or show large dairy goats, meat goats, beef, sheep, horse or swine projects. Cloverbud members may show miniature goats, poultry, rabbits, covies and dogs.
3. Animals that are shown in 4-H classes cannot be entered in open classes. (Exception, Lads & Ladies Lead)
4. An animal may be shown in only one lot unless shown as a pen.
5. Any animal entered in market classes that has been exhibited at any previous show must be exhibited by the original owner.
6. Grand and Reserve Champion rosettes may be given in all breeds. No champion selected unless judge deems appropriate.
7. Fitting & Showing is mandatory in at least one class of Market Livestock in order to receive premiums and participate in the market sale.
8. All fitting and grooming, washing and handling of the animals is to be done by the Exhibitor, except for junior members who may be assisted by an older 4-H member. All livestock, poultry and rabbits will be fed and cared for by the owner, unless other arrangements are made with the 4-H superintendent. Parents may only handle project animals when the safety of the child may be compromised. Out-of-control or unsafe animals should not be exhibited at Fair.
9. No drugs or medications shall be administered on the fairgrounds unless approved by the fair veterinarian in writing.

10. Any animal carcass that is rejected by the packer will be returned to the exhibitor with forfeiture of sale monies.
11. An exhibitor is allowed to sell one market animal through the sales ring. This does not limit the entries, but only this specified number will be sold through the sales ring. All market animals must sell through the Youth Sale unless it is a second animal. The Fair Board is not responsible for any transaction outside the sale ring between the buyer and exhibitor. This choice must be made before sale time. No white ribbon animal will sell through the livestock sale.
12. All market animals will be weighed off trucks.
13. Animal weights: **Market Goats** – 80 pounds minimum to 120 pounds maximum; **Sheep** - 100 pounds minimum to 150 pounds maximum; **Swine** - minimum 235 pounds to maximum 290 pounds; **Steers** - 1000 pounds minimum to 1550 maximum.
14. The Fair Board provides an auction at the North Central Washington Fair where suitable market 4-H and FFA livestock can be sold. The sales are subject to state and federal inspection at point of slaughter and the owner-cause whatsoever up to the time the animal is loaded at the fairgrounds for transportation to point of slaughter. The Fair Board recommends that each exhibitor insure his animal(s) so that any loss will be covered.
15. No changes of ownership or destination of market animals after 6:00 p.m. on Saturday of the Fair.
16. Required that all lambs be shorn within 30 days prior to the Fair.
17. No horns on market steers and scurs not to exceed two (2) inches.
18. All beef and dairy cattle shall have extra neck rope or chain with proper safety snaps.
19. 4-H cattle cannot be shown or sold through the auction unless halter broken and can be handled by exhibitor.
20. Goats entered in market and showmanship classes may have horns but must be tipped to the diameter of a dime. Horn tips must be covered as a safety precaution. Scurs cannot exceed 1" without being covered. No horned dairy goats allowed.
21. Possession dates: February 15 for steers; May 15 for all other animals except fair lots that allow younger animals to be entered.

GENERAL RULES FOR HORSE ACTIVITIES

All registration forms are due July 15, 2021.

1. Horse and exhibitor must attend two 4-H horse events or one 4-H show and 4-H horse camp in order to participate in horse events at NCW Fair.
2. All fitting and grooming, washing, saddling and handling of the horse is to be done by the Exhibitor, except for Junior members, who may be assisted by an older 4-H member. Leaders or parents may only handle project animals when the safety of the child may be compromised. Out-of-control or unsafe animals should not be exhibited at Fair.
3. When entering contests wear clothing appropriate to that contest. Boots are required. Western cut jeans and long sleeve shirts are required in Western classes. Chaps and spurs are optional in Pleasure classes. Helmets are required in all riding classes.
4. Equipment to be clean, properly adjusted to both horse and rider and used correctly. Curb chains must lay flat against the jaw of the horse. Tie downs and hackamores are not allowed. Nosebands are not allowed in all Western classes. All equipment must conform to the 4-H Horse Contest Guide, PNW 574.
5. Barn clean up begins at 6:00 a.m. and must be completed prior to 8:00 a.m. Failure to clean your horse's stall will result in loss of premium points. SEE K. BARN HERDSMANSHIP under 2021 Rules & Regulations.
6. Lead chains may be used under the chin if laid flat.
7. No chaps in Bareback or Equitation classes. Spurs are optional.
8. Exercise time - horses must be saddled and boots and helmets are required.
9. No double riding, no ponying and no switching of horses during exercise time or any other time.
10. When on barn duty, members must wear boots.

GENERAL RULES FOR HORSE WESTERN GAMING ACTIVITIES

1. All gaming members must do showmanship with their gaming horses.
2. Exhibitors may be asked to submit to a close inspection before any event. The close inspection provides the show management an opportunity to examine the tack and equipment being used by the 4-H member. Exhibitors failing the close inspection will not be allowed to make their scheduled run in that event.
3. Riders may hold onto the saddle horn. Two hands may be used on the reins, and hands may be changed. 4-H members must wear their exhibitor number on their back or both sides of their horse at all times while mounted.
4. Standard 4-H western clothing must be worn. Belts are optional.
5. A breast collar is required for all horses.
6. Required equipment includes western saddle with a saddle horn, throat latch on the bridle, and roping or single piece reins.
7. Option equipment includes: running martingales with rein stops, tie-downs attached to a breast collar, nosebands, draw reins, splint boots, bell boots, or bandages, mechanical hackamores, gag bits, whips under 36 inches, bats, or quirts.
8. Equipment NOT allowed: Mecate reins, tied split reins or buckled reins.
9. Riders are considered mounted when their knee is over the center line of the horse's back. Riders must remain mounted until the judge's final acknowledgement.
10. Re-rides are run after the last rider in that event. Penalties do not carry over from the original ride. Acceptable reasons for re-rides include timing device failures, course obstruction as determined by the judge or the course is measured incorrectly. Unacceptable reasons for re-rides include horse or rider damage to arena equipment, failure to tack or participant's equipment or horse or rider accident or injury.
11. Riders MUST acknowledge the judge before starting and after completing the course.
12. Coaching is defined by show management and at the judge's discretion is not allowed. It is inappropriate for ring help, announcer, timers, etc., to coach, encourage or comment to or about exhibitors on the course.
13. There will be a 5-second penalty for each stake, pole, barrel or small container knocked down. Intentionally righting a pole or barrel is allowed with no penalty.
14. Disqualifications include:
 - Failure to enter the arena mounted
 - Entering the arena with the assistance of anyone other than another mounted 4-H member
 - Failure to cross the start line within 60 seconds from the time the gate opens
 - Upsetting the start-finish markers
 - Crossing the start-finish line outside of the start-finish line markers
 - Crossing the start-finish line (breaking the barrier) with any part of the horse or rider (outside the customary start and finish)
 - Run-outs, refusals (a balk is not considered a refusal if the horse finally finishes the course correctly)
 - Leaving the course
 - Failure to follow the pattern for the event
 - Passing any obstacle completely on the wrong side
 - Circling any obstacle while on course (except flag races and other container events)
 - Failure to keep all four feet of the horse from crossing a lane line at the same time
 - Failure to keep all four feet of the horse inside the run-out box
 - A horse being unruly or out of control
 - Spurring or striking the horse in front of the cinch
 - Striking the horse with arena equipment
 - Using rubber bands or anything else to anchor the rider to the horse or saddle
 - Failure to acknowledge judge before and/or after run.

15. Show management or the judge may disqualify a rider for unsportsmanlike conduct, profanity, unnecessary roughness, abusing the horse or disorderly conduct of any kind. The judge may also disqualify an unmanageable horse for reasons of safety or the exhibitor's inability to handle or control the horse.
16. Please refer to Pacific Northwest Horse Contest Guide for more information.

HORSE HANDLING RULES

1. NO HORSES ON MIDWAY AT ANY TIME.
2. OPEN HORSE Barn EXIT: Out North door. 4-H & FFA HORSE Barn EXIT: Out East door.
3. EXERCISE TIMES – OPEN CLASS: 7:00-8:00 mornings and evenings, EXCEPT only until 7:45 Saturday morning. 4-H & FFA: 8:00-9:00 mornings and 6:00-7:00 evenings EXCEPT 7:45-8:30 on Saturday morning.
4. Horses must be ridden, longed or controlled on lead line. NO LOOSE HORSES ALLOWED ON FAIRGROUNDS.
5. All horses are to be exercised daily.
6. NO RUNNING of horses in the arenas.
7. No loping of horses allowed outside of arena.
8. No horse in 4-H Division is allowed in the rodeo arena.

GENERAL RULES FOR FAIR ACTIVITIES

The following rules apply to 4-H members and leaders when participating in 4-H activities. Not following these rules may result in disqualification, forfeiture of all awards and potential removal from the 4-H program. Washington State University Extension provides all 4-H events.

1. Volunteers must adhere to the Washington State University 4-H Youth Program policies.
2. All volunteers, participants, and parents must adhere to the Washington 4-H Ethics Code - A Valuable Partnership (C1000).
3. No alcoholic beverages
4. No drugs
5. No smoking or chewing tobacco
6. No abuse of animals
7. No coaching of youth while they are in the ring or showing their animals
8. Adults may not groom or school an animal while on the grounds. Designated adults may help members with their project.
9. The ring is off limits to everyone except working show personnel.
10. Approach the judge for information only, not to dispute a placing and only after judging is completed.
11. Show personnel may dismiss a visibly ill animal from participation.
12. All exhibitors must participate in Herdsmanship.
13. Leaders will ask a member of their club to leave the show grounds with his or her animal if behavior is unacceptable.
14. Only dogs entered in novice and higher classes may be off leash at any time and only in the show or practice ring.
15. Prong, spike collars, head collars, electric collars, and muzzles are not allowed in the show.
16. Dogs may be shown with minor, noncontagious ailments. However, this is a show management decision and a veterinarian's certificate may be required.
17. Exhibitors must wear sturdy, appropriate footwear.
18. Anti-social or uncontrollable dogs will be sent home.
19. Exhibitors must dress appropriately; shorts and bare tops are inappropriate. Improperly-dressed exhibitors will be asked to change or leave.
20. Running or rowdy behavior is not allowed.

- The exhibitor is a participant in the National Poultry Improvement Plan (NPIP); or
- Within the past twelve months, the show birds were bought from NPIP participants, hatcheries, or feed stores. Exhibitors that do not meet the criteria above must test negative for P-T within 90 days of going to exhibit.
- A veterinarian, vet tech or trained personnel can draw ½ cc of blood from each bird and send the samples to the WSU Avian Health and Food Safety Laboratory in Puyallup, WA or a WSDA field veterinarian needs to perform a P-T testing prior to the Fair.

2. Entries must be firmly mounted on matte board, not poster board. Minimum mat margin is 1" on all sides and maximum mat margin is 2½" on all sides. Use dry mount tissue, photo glue, photo stickers or other suitable substance to attach. Framed entries and non-mounted entries will not be accepted.
3. All entries must be printed on photographic paper. Entries printed on paper, cardstock, etc., will not be accepted.
4. Entries must be either enlargements of black/white or color negatives or colored slides or digital captures that have not been manipulated in any way: 5"x7", 5"x14", 8"x10" or 8"x12". (Photos must be one of these sizes).
5. Color enhancements and changes may not be made to the original photo unless it is entered in the digitally enhanced lot.
6. Attach a completed exhibitor label for each picture. Labels may be obtained from the Chelan-Douglas 4-H office.
7. A Grand and Reserve Champion will be awarded in each group (Junior, Intermediate and Senior) if appropriate.

16. Theme Board: A series of 3 to 6 photos depicting a specific theme. All photos are mounted on one board with a title, captions or poem. Photos may be black/ white or color, each photo is 3 ½"x5" or larger, up to 8"x12" or 5"x14".
17. Album/Portfolio: minimum of 25 pictures all taken by the exhibitor, arranged in an artistic or themed way.
18. Photojournalism: All photos must be of newsworthy nature. They must be captioned. Include information on who, what, where, when and why in each caption. Photos may be black/white or color. Entries will be scored on journalistic value, quality of photo and captions.
 - One enlarged photo, mounted and captioned. (5"x7", 8"x10", 8"x12", 4"x12", or 5"x14")
 - Story board: 2 to 4 pictures depicting a single newsworthy story, any size but the total exhibit must not exceed 11"x14", mounted and captioned.
 - Album: minimum of 10 newsworthy photos with captions.
19. Digital Imaging: Images can be sandwiched, cut & paste, retouched, cloned, filters or any other special effects can be used. Original image and modified image should be mounted on exhibit mat. An index card should explain what was done to arrive at the final image. Finished pictures must be 5"x7" and no larger than 8"x10".
 - Regular film and camera, black/white or color.
 - Digitally imaged by scanning then enhanced or manipulated and printed by exhibitor.
 - Digital capture, black/white or color. Photo taken with digital camera then enhanced or manipulated and printed by exhibitor.
20. Digitally Restored Photos: Scanned photo taken by regular—not digital - camera. Original photo may have been taken by a person other than the exhibitor. The exhibitor will scan the photo and repair the photo using modern techniques. The original photo may have been damaged in some manner. Judging will be on how well the exhibitor repaired the original photo. Finished pictures must be 5"x7" and no larger than 8"x10". An untouched copy of the original photo must accompany the entry along with an index card explaining how the photo was restored and special techniques used.

Video must have been filmed and edited by exhibitor. Videos should be submitted on a CD or flash drive. Videos should be a minimum of two minutes and a maximum of five minutes.

CANNING

- All canned products must be preserved according to USDA and Washington State University recommendations.
- Only products canned and dried according to USDA and WSU recommendations will be judged at the Fair.
- Jam, jelly and pickle products need not be WSU Extension recipes, but processing recommendations must be followed.
- Contact WSU Extension for current canning books and recommendations.
- Any canned food entered without a canning label or with incorrect information that could suggest a safety problem will not be judged.
- Canned products to be exhibited in standard canning jars.
- Rings should be removed.
- All jam and jelly products must be exhibited in standard canning jars, processed and sealed with a lid. No paraffin is permitted.
- All jars must be labeled giving type of food, processing method and elevation, processing time and date. Labels are available from WSU Extension prior to the Fair. Place labels on top of jar.

DRYING

- All dried foods should be exhibited in airtight plastic bags. The quantity should be representative of the dried food. CLASS 65 — EDUCATIONAL DISPLAYS/POSTERS

Educational displays will be displayed in the 4-H Building.

- Still life educational displays may show any topic of an educational nature. The size may range from a poster format to a table display. The display will be judged on educational value (50%), design (30%), and originality, creativity and neatness (20%). Ask for C0679 for judging details.
- Possible entries could include various flours with bread exhibits; products prepared from animal byproducts: shearing, carding and/or weaving of wool; clothing care labels with samples showing proper an improper care.
