- 1. Youth Board Jake Joeckel reported. They made a couple of additions to the schedule. Sunday Short Round will have the theme of "Cancer Awareness" so contestants will be asked to wear pink. The Friday night performance will have the "Hope Counts" theme for contestants to wear blue.
- 2. Lawsuit Annie Walter reported to the Board. She has been in contact with the attorney. He will respond formally in a written letter to the complaining party. There is nothing in writing and it is parties that have a difference of opinion on the way an agreement between NLBRA and a vendor was interpreted.
- 3. Negotiations with Lazy E Sam Stoddard Addressed the Board to handle the negotiations. All Board members were asked to list up to 3 things that they would like to see changed for the committee to take to the negotiations. He also asked that people give up to 3 things that they really liked about the current contract with the Lazy E.
- 4. Finals Discussion Plans are in place. There will be no ATV's or any other motorized vehicles to be on the Lazy E grounds. Only the people working as in Board Members are approved to have them.
