



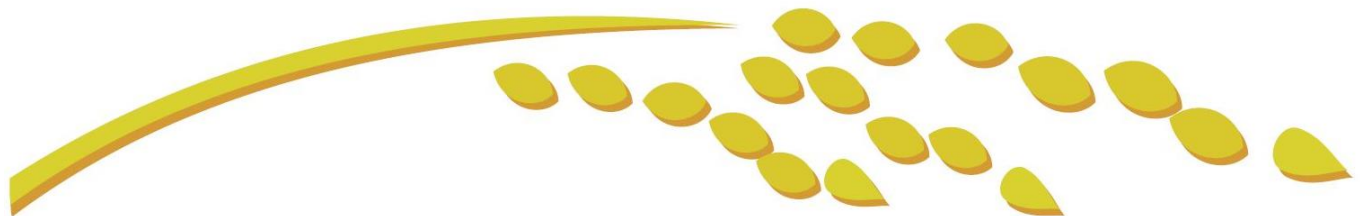

Late entries will be charged a fee of \$25.00 per head through July 12<sup>th</sup>. Late entries need to be made with the Competitive Exhibits Office. After July 12<sup>th</sup> late entries will not be accepted.

## ALL GOAT GENERAL RULES:

1. All project animals must be owned by June 1<sup>st</sup>. Please refer to FFA Rules if borrowing an animal.
2. Fitting, feeding and stall duty/cleaning tasks done by exhibitors only. (Parents may supervise but not participate unless in case of an immediate safety concern)
2. Scrapies- dairy and meat goats must have official USDA Scrapie ID in the form of USDA tag, tattoo or microchip following USDA guidelines. Market wethers or wethers under 18 months do not need a scrapies tag. USDA: 866-873-2824.
3. **FFA members must show in fitting and showing to receive premiums.** Exhibitor chooses one animal for fitting and showing in this division (i.e., pygmy, meat, and dairy are separate divisions).
4. Animals must be cleaned, clipped, and show ready prior to haul in.
5. Each FFA member may enter 7 animals in the goat class (stall space permitting). If showing in both 4H and FFA the exhibitor may show no more than 8 animals between the two organizations. No more than two animals may be shown in each class.
6. Each animal shows in only one type class (exception: group classes). Animals cannot be shown in both FFA and 4-H.
7. **Age of animal determined by age as of show day, Tuesday of fair.**
8. Rosettes for Grand and Reserve awarded if deserving. Grand Champion Overall Showman qualifies to compete in the FFA Round Robin on Saturday.
9. **To qualify to compete in FFA Round Robin there must be at least 5 different exhibitors competing in the Division's Fitting and Showing. Dairy goats, meat goat, and pygmy goats are different divisions.**
10. All animals, tack, feed, etc. must be stored within the number of assigned pens (and/or allotted areas). You may be asked to share tack space with other clubs.
11. All goats must be removed from the fairgrounds by 10 a.m. Sunday after the Fair.
12. No does allowed past 3 months pregnant.
13. No bucks allowed in barn. Exception: nursing offspring under 4-8 weeks of age; these must be included in entries (no premium) and will count toward exhibitor's total number of goats.
14. **Water must be always available to all goats in pen.** Hay should be fed in a feeder multiple times per day. Goats found without water could have exhibitor forfeit all premiums, this includes goats being left Saturday night for Sunday pickup.
15. **The following are prohibited:** muzzles, drenching/tubing; diuretics; inhumane or unethical treatment; paints/dyes; adhesives for attaching hair/hair substitutes/other objects for purpose of deception.

**16. DAIRY GOAT DOES:**

- a. Senior Does (MUST BE IN MILK and at least 24 months old as of show day)
- b. Junior Doe (less than 24 months as of Monday of fair, never in milk. Goats less than 24 months in milk show with Sr. Does)
- c. MUST be clipped according to breed characteristics PRIOR to check in.
- d. Milking station available in front of goat barn. Exhibitors must clean area and check in with super for more details.
- e. No horns allowed on dairy does.

**17. MEAT GOAT DOES:**

- a. Senior Doe – Doe 24 months+ as of show day. Does who have kidded or exhibited signs of pregnancy. (Doe under 24 months only if it has kidded.)
- b. Junior Doe – Doe that is 24 months or younger, doe has not kidded.
- c. Horned Meat Does allowed only under following conditions:
  - Horns allowed for ABGA-registered does (American Boer Goat Association) w/ registration papers provided at check in
  - Horns must be wrapped.
  - Exhibitor must be able to handle their horned goat safely.
  - Dairy, pygmy, and other non-ABGA papered breeds may not have horns.

**18. MARKET GOATS:**

- a. Must be fit with a “terminal clip” (uniformly body clipped to 3/8 inch or less above hocks and knees) prior to check in.
- b. Weight: Minimum 80 lbs., no maximum
- c. Market goats must be an unbred doeling or wether under one year of age  
New for 2026: Market goats are to show no evidence of permanent yearling teeth (effective 2026). Refer to Lynden Jr. Livestock Sale Rules for more details: [www.lyndenjrlivestock.org](http://www.lyndenjrlivestock.org)
- d. Market goats are to remain in their pen on Saturday night and MUST be left with water and hay or premiums will be pulled.
- e. Refer to rule 17 for horn information.

##### ID Prior to arrival MUST meet USDA requirements for Scrapie ID Program

##### The goal of the Veterinary Inspection is to minimize the potential for contagious and infectious diseases (including parasites). Examples of Infectious Disease and Parasites include:

- ORF
- Infectious Foot Rot
- Ring Worm
- Warts
- High Fever
- Respiratory Disease

##### No Visible External Parasite Burden (or related clinical signs):

- Lice
- Evidence of Diarrhea
- Dry, Hoarse Cough
- Mange
- Pale Mucous Membranes

##### Adequate Body Condition – Minimum BCS of 2.5/5

- 1: Emaciated
- 2: Thin
- 3: Good Condition
- 4: Overweight
- 5: Obese
- Feed and water should be available at the Fair at all times

##### Castrated Properly

- Do your best to have castration done ahead of time so the site has time to heal properly

##### Dehorned properly and completely healed
