



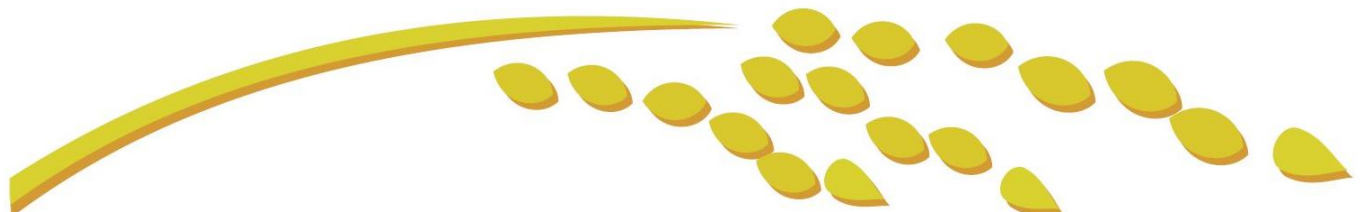

Late entries will be charged a fee of \$25.00 per head through July 12. After July 12 late entries may not be accepted.

Rules:

1. FFA members must enter fitting and showing and choose other CLASSES.
2. Fair vet must and will reject any animal with an infectious disease or ectoparasites, ringworm, warts, pink eye, strangles, contagious ecthyma, scabies, lice, mites, ticks, fleas, and all respiratory diseases.
3. Helmets must be worn in gaming events, no matter of age. This is not an option, it is mandatory!
4. Western attire or FFA official dress is acceptable.
5. No cross entries of animals between FFA and 4H.
6. Cross entry with Open Class is allowed.
7. Equine Health Declaration must be filled out and presented at Vet Check.
8. A red ribbon must be tied on the tail of horses known to kick.
9. FFA Horses not showing in Open Class will haul in and out the same day. FFA Horse exhibitors will receive a special parking pass for the day.
10. To qualify to compete in FFA Round Robin there must be at least 5 different exhibitors competing in the Division's Fitting and Showing.

FOR VETERINARIAN USE ONLY – CHECKLIST TO BE MET FOR THE NORTHWEST WASHINGTON FAIR

The goal of the Veterinary Inspection is to minimize the potential for contagious and infectious diseases (including parasites). Examples of Infectious Disease and Parasites include:

- Strangles
- Respiratory Disease
- Ring Worm
- Warts
- High Fever

No Visible External Parasite Burden (or related clinical signs):

- Mange
- Lice
- Gastro-Intestinal (i.e. Evidence of Diarrhea)

Adequate Body Condition – Minimum BCS of 4/9 – Henneke Scale

- 1-2: Severe Emaciation
- 3-4: Thin
- 5-6: Healthy
- 7-8: Overweight
- 9: Sever Obesity

- Feed and water should be available at the Fair at all times

Lameness/Prescription Drug Use

- Horses on any prescription meds, especially *Bute*, *Banamine*, *Equioxx* or *Surpass* SHOULD bring a letter of explanation from their Veterinarian.
- No horses with significant lameness, arthritis or chronic laminitis will be admitted.
