## Rules

- All exhibitors and animals are subject to the TNF& Livestock Rules, along with the Health Rules.
- All rabbits must be pre-entered. Registration must be received via email or phone by Thurs., Aug. 31st to the Dept. Head, listed above. At time of registration Exhibitors/Family must declare the number of sale cages, no cages will be added past the deadline. Maximum of 8 cages per family, maximum 2 rabbits per cage.
- 3 <u>Registration fees will be due at check-in.</u> There are no refunds on scratched entries. Only Ear changes will be allowed prior to judging and NO additional entries will be accepted.
- 4 <u>Breeds will be sanctioned with their National Clubs by breeder donation only.</u> Rabbits not recognized with ARBA will be judged together in a Bunny class.
- 5 This is a carrying cage show so your rabbits are free to leave after the show. Carrying cages must be leak-proof.
- 6 Rabbits left for sale can be purchased anytime during the week but will not be released until the last Sunday of the fair. Buyer must be 21. ALL rabbits must be picked up the last Sunday of the fair, Sept. 17<sup>th</sup>, between the hours of 4 7 p.m., CST.
- Only exhibitors entered in the show can leave rabbits for sale. For every one rabbit shown, one rabbit may be left for sale with a maximum of 16 per family. Please see the Dept. Head before cooping any rabbits.
- 8 See Dept. of Agriculture Health Rules in front of book pertaining to rabbits. As an exhibitor please be sure your rabbits have water at all times while on the property. All reasonable care will be taken to provide a safe show, however, each exhibitor is ultimately responsible for all personal property including rabbits. The Nashville Fair will not be responsible for any loss that may occur, but will give every entry our best attention.
