2022 The Nashville Fair Livestock Rules

- 1. When entries exceed stall or pen facilities, animals will be accepted according to the date the entries are accepted online. Submit your entries early. Stalls and pens are furnished for show stock only.
- 2. An exhibitor is the person entering livestock in the fair. <u>Open Show</u>: the exhibitor <u>does not</u> have to be the owner of the animal listed on the registration paper. <u>Junior Show</u>: the exhibitor does have to be the owner of the animal listed on the registration paper.
- 3. The animal name, registration number, official required id number, and birth date must be on the entry forms at time of entry.
- 4. All exhibits must have an attendant with the animals until the entry books are completed. The attendant must have in his/her possession all necessary health certificates and the proper breed association registration papers.
- 5. Bedding is provided by the fair. Beef Cattle will be provided mulch and all other livestock will be provided shavings. No straw will be allowed.
- 6. An animal may be shown in only one breed show.
- 7. See the individual departments for the arrival, check-in, show and release times. Tardiness beyond the official breed arrival and release schedule will not be tolerated. Failure to heed this rule will result in forfeiture of <u>ALL</u> premiums. The only legitimate excuse for early release is sickness or death and must have the Livestock Superintendent approval.
- 8. Any exhibitor washing animals in undesignated areas, dumping milk in undesignated areas, and blocking passageway gates in the barns will forfeit <u>ALL</u> premiums.
- 9. The Nashville Fair or its agents, directors, employees or volunteers will not be responsible for any article of any nature or animal exhibited for any loss, damage, or accident that may occur. Each exhibitor shall be responsible for any injury that may occur to any person whomsoever, by any animal exhibited or arises from the negligence of the person in charge of such animal.
- 10. All trailers and trucks will be parked in the designated parking area.
- 11. ** A LOCK IS RECOMMENDED FOR ALL TRAILERS**
- 12. All service dogs MUST be on a leash.
- 13. If it is determined before, during or after a show that an exhibitor has violated a General or Health rule, show management has the right to subject the exhibitor to the following disciplinary provisions:
 - a. Forfeiture or return of awards, prizes, premiums or proceeds
 - b. A written letter of reprimand to the owner, exhibitor, fitter and/or disqualifications that may include any or all shows and Divisions at The Nashville Fair and may be for any number of years
- 14. There will not be an Official Photographer, Official Veterinarian or Feed Store supplied by the fair.
