### Special Rules

1. Articles entered should belong to a former age and be in good condition - no chips, cracks, missing parts, or glued pieces will be accepted.
2. Reproductions will not be accepted
3. Any article which has been entered prior to 2023 and won a ribbon will not be accepted.

4. All items must fit in cases provided by the New Mexico State Fair.
5. Only one entry per class per person.
6. Multiple items may be entered if they are a set. Small items must be attached to a display (board, cork, materials, etc.)
7. Entries will be judged on rarity, age and condition.
8. No clothing items will be accepted as we cannot display them properly.
9. You may write a short history of your article but do not include your name. Card should be legible and easy to read in the display case.
10. Precautions are taken for the safety of all entries, but in no case, will the New Mexico State Fair, the state of New Mexico, employees, contractors or volunteers be held liable for the loss or damages to any entry while in the Fair's possession. Participants are encouraged to carry their own insurance.
11. Participant recognizes that marketing of the Fair and its grounds requires use of photography and video. Participant hereby expressly grants to the Fair the irrevocable, assignable right and license to take, use and publish participant images and work without the need for any other approval. Images and work will not be used for profit.
12. Participants are responsible for picking up their own work or provide written authorization for pick-up by another individual.
13. **NEW:** Work must be picked up Tuesday, September 17, 2024 from 9:00am – 4:00pm. Any work remaining on the Fairgrounds after this date will be considered abandoned and shall become the property of the NM State Fair to be disposed of at its discretion.
