Special Rules

1. One entry per section per class only.
2. Entry must be constructed by the exhibitor.
3. Entry must be accompanied by a description.
4. Entry must allow for other entries to be displayed side by side.
5. Competition or non-ribbon exhibits must fit within limited space available display cases. Non-ribbon exhibits will be displayed only if space permits.
6. Entry must have a **sturdy base** other than the one included with Legos. Fair **will not** provide material for bases. **Secure** Legos to a base to prevent Legos from coming apart or falling off when moved.
7. Entries **no larger than** 12" wide x 18" long x 16" high. Entries **will not** be accepted if larger than specified size, **NO EXCEPTIONS.**
8. Entry must not have been entered in previous NM State Fair competitions.
9. Entries will not be reviewed by theme with the exception of the Bionicle Competition.
10. Entries will be judged on Creativity, Ingenuity and Imagination.
11. Bionicle's must have a stand and base to support them.
12. Entry must be stable, if it appears unstable, entrant will be asked to pick up model and may be unable to participate.
13. Precautions are taken for the safety of all entries, but in no case, will the New Mexico State Fair, the state of New Mexico, employees, contractors or volunteers be held liable for the loss or damages to any entry while in the Fair's possession. Participants are encouraged to carry their own insurance.

14. Participant recognizes that marketing of the Fair and its grounds requires use of photography and video. Participant hereby expressly grants to the Fair the irrevocable, assignable right and license to take, use and publish participant images and work without the need for any other approval. Images and work will not be used for profit.
15. Participants are responsible for picking up their own work or provide written authorization for pick-up by another individual.
16. **NEW:** Work must be picked up Tuesday, September 17, 2024 from 9:00am – 4:00pm. Any work remaining on the Fairgrounds after this date will be considered abandoned and shall become the property of the NM State Fair to be disposed of at its discretion.
17. **NEW: Two hours In Person Lego Competition.** Competitors will be provided pre-sorted Legos. At close of competition Awards will be presented. All Legos are property of NM State Fair and are not to be removed. Theme is your choice.
