I. <u>INTRODUCTION</u>

A. <u>Purpose of this Request for Proposals</u>

The State of New Mexico, New Mexico State Fair Commission, ("Fair"), is inviting responsible offerors to submit competitive sealed proposals to provide rodeo stock and production services. As further described below, after taking into consideration the evaluation factors set forth in the Request for Proposals, at the end of the evaluation process the responsible offeror whose proposal is found to be the most advantageous to the Fair will be selected for contract award. At that point, it is anticipated the Fair will enter into an agreement with the selected offeror who shall perform in the capacity of rodeo stock contractor for the term of the contract.

B. Summary of Scope of Work and Term

The scope of work shall consist of providing rodeo stock and all necessary personnel and equipment to produce and operate a PRCA sanctioned rodeo and WPRA barrel racing event during the annual New Mexico State Fair. A detailed scope of work, which is subject to regulatory oversight, may be found in Appendix "B", titled "Contract Terms and Conditions". Please note that the New Mexico State Fair has six bucking chutes and one roping chute that will be used.

This Agreement shall not become effective until signed by the general manager of the Fair. This Agreement shall terminate, without notice, on June 30, 2023. The Fair reserves the option of renewing the contract for a maximum of three additional one-year periods, or any combination of years and/or months not to exceed a total of four years, at the same terms and conditions contained herein, subject to written concurrence by the Contractor and the Fair.

Other employees of the Fair do not have the authority to respond on behalf of the Fair. However, nothing stated by the Procurement Manager orally or in writing shall operate to amend this RFP unless such statements are reduced to a written amendment in accordance with GSD Rule 1.4.1 NMAC. NO ORAL OR WRITTEN QUESTIONS CONCERNING THIS RFP SHALL BE DIRECTLY ADDRESSED BY OFFERORS OR POTENTIAL OFFERORS TO ANY OTHER MEMBER OF THE FAIR UNTIL CONTRACT HAS BEEN AWARDED AND THE PROTEST PERIOD HAS EXPIRED. AN OFFEROR'S FAILURE TO COMPLY WITH THIS RESTRICTION MAY RESULT IN DISQUALIFICATION OF THE OFFEROR.

D. <u>Definition of Terminology</u>

"<u>Annual Event</u>" means the Annual State Fair Event traditionally held during the month of September at Expo New Mexico in Albuquerque, New Mexico. The beginning date and the number of days allocated for the Annual Event is subject to change at the discretion of the Fair/Expo.

"<u>Contractor</u>" means successful offeror awarded the contract.

"<u>Expo New Mexico</u>" or "<u>Expo</u>" is the facility that houses the properties owned by the State of New Mexico, New Mexico State Fair Commission.

"<u>New Mexico State Fair Commission</u>" or "<u>Fair</u>" is the agency under whose jurisdiction this Request of Proposals is released.

"<u>Offeror</u>" is any person or legal entity that chooses to submit a proposal in response to this Request for Proposals.

"PRCA" means the Professional Rodeo Cowboy's Association.

"<u>Request for Proposal</u>" or "<u>RFP</u>" means all documents, attached or incorporated by reference, used for soliciting proposals.

"<u>Responsible Offeror</u>" means an offeror who submits a responsive proposal and who has furnished, when required, information and data to prove that his financial resources, production or service facilities, personnel, service reputation and experience are adequate to make satisfactory delivery of the services or items of tangible personal property described in the proposal.

"<u>Responsive Proposal</u>" means an offer or proposal that conforms in all material respects to the requirements set forth in the request for proposals. Material aspects of a request for proposals include, but are not limited to, quality, quantity, or delivery requirements.

"<u>Rodeo</u>" means the PRCA rodeo held at Expo New Mexico during the Annual Event.

"<u>WPRA</u>" means the Women's Professional Rodeo Association.

The terms "must," "shall," "will," and "require" identify a mandatory item or factor. Failure to comply with a mandatory item or factor will result in the rejection of the offeror's proposal.

The terms "can," "may," "should," "preferably," or "prefers" identify a desirable or discretionary item or factor.

E. <u>Background Information</u>

The New Mexico State Fair Commission is an agency of the State of New Mexico. Its mission is to preserve and enhance the agricultural, multi-cultural heritage, and historic legacy of New Mexico.

The 2019 Annual Event had an attendance of approximately 472,000. The 2022 eleven-day Annual Event will be held September 8th through September 18th.

During the Annual Event, the Fair features livestock, agricultural, and art exhibits, concessions, villages emphasizing cultural heritage, a carnival and live horseracing. A variety of free entertainment is available on the streets and stages. The Fair is also host to a series of PRCA sanctioned rodeo performances in Tingley Coliseum with entertainment provided by a variety of major stars.

Expo New Mexico, which is situated on a 236 acre site in the heart of Albuquerque, is open yearround and is the site of many other events: equestrian, livestock, dog, cat, car, ice, arts and crafts shows, home and builders' shows, concerts, circuses, live and simulcast horse racing, a casino featuring slot machines, rodeos and many others.

Our Fair remains a historic and cultural beacon for the generations to come, and we continue to nurture and grow a year-round business model for our agency that ensures its self-sustainability far into the future. II. <u>CONDITIONS GOVERNING THE PROCUREMENT</u>

This section of the RFP contains the schedule for the procurement, describes the major procurement events and the conditions governing the procurement.

A. <u>Sequence of Events</u>

The Procurement Manager will make every effort to adhere to the following schedule. However, departure therefrom shall not invalidate a procurement where Fair management determines the departure not material.

B. <u>Explanation of Events</u>

The following paragraphs describe the activities listed in the sequence of events shown in Section II, Paragraph A.

1. Issue of RFP

This RFP is being issued by the Fair.

Additional copies of the RFP can be obtained from the Procurement Manager.

2. <u>Pre-Proposal Conference</u>

A pre-proposal conference will not be held for this procurement.

3. <u>Distribution List Response Due</u>

Potential offerors should hand deliver or return by facsimile or by registered or certified mail the "Acknowledgement of Receipt Form" that accompanies this document (see Appendix "A") to have their organization placed on the procurement distribution list. The form should be signed by an authorized representative of the organization, dated and returned by the date stated on the form.

The procurement distribution list will be used for the distribution of written responses to questions and any RFP amendments.

Failure to return this form shall constitute a presumption of receipt and rejection of the RFP, and in such case, the potential offeror's organization name shall not appear on the distribution list.

4. Deadline to Submit Additional Written Questions.

Potential Offerors may submit additional written questions as to the intent or clarity of this RFP until 2:00 p.m. local time on Monday, May 16, 2022. All written questions must be addressed to the Procurement Manager (See Section I, Paragraph C.)

5. <u>Response to Written Questions/RFP Amendments</u>

Written responses to written questions and any RFP amendments will be distributed to all potential offerors whose organization name appears on the procurement distribution list. An "Acknowledgement of Receipt Form" will accompany the distribution package. The form should be signed by the offeror's representative, dated, and hand-delivered, or returned by facsimile or by registered or certified mail by the date indicated thereon. Failure to return this form shall constitute a presumption of receipt and withdrawal from the procurement process. Therefore, the offeror's organization name shall be deleted from the procurement distribution list.

Additional written requests for clarification of distributed answers and/or amendments should be received by the Procurement Manager no later than five (5) days after the answers and/or amendments were issued.

6. <u>Submission of Proposal</u>

ALL OFFEROR PROPOSALS MUST BE RECEIVED FOR REVIEW AND EVALUATION BY THE PROCUREMENT MANAGER OR DESIGNEE NO LATER THAN 2:00 PM MOUNTAIN STANDARD TIME ON TUESDAY, JUNE 7, 2022. Proposals received after this deadline will not be accepted. The date and time will be recorded on each proposal at the Expo New Mexico receptionist desk by the receptionist on duty in the administration building upon their arrival. Proposals must be addressed to the Procurement Manager and delivered to the receptionist on duty at the address listed in Section I, Paragraph C. Proposals must be sealed and labeled on the outside of the package to clearly indicate that they are in response to the "Rodeo Stock Contractor" RFP #22- 004. Proposals submitted by facsimile will not be accepted.

NO EXCEPTIONS TO THIS DEADLINE WILL BE ALLOWED. For the purpose of determining the timeliness of a proposal, cell phone time in the reception area of the administration building of the New Mexico State Fairgrounds will be used to sign in any and all competitive proposals and will be deemed to be the "Official Time".

A public log will be kept of the names of all offeror organizations which submitted proposals. Pursuant to NMSA 1978 § 13-1-116, the contents of any proposal shall not be disclosed to competing offerors prior to contract award.

7. Evaluation of Proposals

The evaluation of proposals will be performed by an Evaluation Committee selected by the management of Expo New Mexico. This process will take place following the due date specified in Paragraph II.6. During this time, the Procurement Manager may, at her option, initiate discussions with offerors who submit responsive or potentially responsive proposals for the purpose of clarifying aspects of the proposals, but proposals may be accepted and evaluated without such discussion. Discussions SHALL NOT be initiated by the offerors.

8. <u>Selection of Finalists</u>

The Evaluation Committee will select and the Procurement Manager will notify the finalist offerors. Only finalists will be invited to participate in the subsequent steps of the procurement. The schedule for the oral presentations, if any, will be determined at this time.

9. Best and Final Offers from Finalists

Finalist offerors may be asked to submit revisions to their proposals for the purpose of obtaining best and final offers. Best and final offers may be clarified and amended in writing at the finalist offeror's oral presentation.

10. Oral Presentation by Finalists

Finalist offerors may be required to present their proposals to the Evaluation Committee. The Procurement Manager will schedule the time for each offeror presentation.

11. & 12. Contract Award

After review of the Evaluation Committee Report, a contract will be sent for execution to the offeror deemed by the evaluation committee as most advantageous to the Fair. The Offeror will return the signed contract to the Fair, and the signed contract will then be submitted to Fair management for consideration and possible award. Please be advised that no contract with the Fair is legal and binding until approved by and executed by the general manager.

The contract will be awarded to the responsible offeror or offerors whose proposal is most advantageous, taking into consideration the evaluation factors set forth in the RFP. The most advantageous proposal may or may not have received the most points.

In the event that mutually agreeable terms cannot be reached within the time specified, the Fair reserves the right to finalize a contract with the next most advantageous offeror without undertaking a new procurement process.

13. Protest Deadline

Any protest by an offeror must be timely and in conformance with NMSA 1978 §13-1-172 and applicable procurement regulations and must be filed no later than 15 calendar days after knowledge of the facts or occurrences giving rise to the protest. Any person or business that has been sent written notice of any fact or occurrence is presumed to have knowledge of the fact or occurrence. Protests must be written and must include the name and address of the protestor and the request for proposals title. The protest must provide any other information requested by the Procurement Manager. It must also contain a statement of grounds for protest including appropriate supporting exhibits, and it must specify the ruling requested from the Procurement Manager. The protest must be delivered to the Procurement Manager.

C. <u>General Requirements</u>

This procurement will be conducted in accordance with the State Purchasing Agent's procurement regulations, GSD Rule 1.4.1 NMAC. (Available on the internet at www.state.nm.us/spd)

1. Acceptance of Conditions Governing the Procurement

Offerors must indicate their acceptance of the Conditions Governing the Procurement section in the letter of transmittal. Submission of a proposal constitutes acceptance of the Evaluation Factors contained in Section V of this RFP.

2. Incurring Cost

Any cost incurred by the offeror in the preparation, transmittal or presentation of any proposal or material submitted in response to this Request for Proposals will be borne solely by the offeror. In addition, the New Mexico State Fair Commission will not be responsible for any costs or expenses incurred by the offeror in making its oral presentation.

3. <u>Prime Contractor Responsibility</u>

Any contract that may result from this RFP shall specify that the prime contractor is solely responsible for fulfillment of the contract with the Fair. The Fair will make contract payments to only the prime contractor.

4. <u>Subcontractors</u>

Use of subcontractors must be clearly explained in the proposal, and major subcontractors must be identified by name. The prime Contractor shall be wholly responsible for the entire performance whether or not subcontractors are used.

5. <u>Amended Proposals</u>

An offeror may submit an amended proposal before the deadline for receipt of proposals. Such amended proposals must be complete replacements for a previously submitted proposal and must be clearly identified as such in the transmittal letter. The Fair's personnel will not merge, collate, or assemble proposal materials.

6. Offerors' Rights to Withdraw Proposal

Offerors will be allowed to withdraw their proposals at any time prior to the deadline for receipt of proposals. The offeror must submit a written withdrawal request signed by the offeror's duly authorized representative addressed to the Procurement Manager. The approval or denial of withdrawal requests received after the deadline for receipt of proposals is governed by the applicable procurement regulations.

7. <u>Proposal Offer Firm</u>

Responses to this RFP, including proposal prices, will be considered firm for ninety (90) days after the due date for receipt of proposals or sixty (60) days after receipt of a best and final offer, if one is submitted.

8. Disclosure of Proposal Contents

The proposals will be kept confidential until a contract is awarded. At that time, all proposals and documents pertaining to the proposals will be open to the public, except for the material that is proprietary or confidential. The Procurement Manager will not disclose or make public any pages of a proposal on which the offeror has stamped or imprinted "proprietary" or "confidential" subject to the following requirements.

Proprietary or confidential data shall be readily separable from the proposal in order to facilitate eventual public inspection of the non-confidential portion of the proposal. Confidential data is normally restricted to confidential financial information concerning the offeror's organization and data that qualifies as a trade secret in accordance with the Uniform Trade Secrets Act, 57-3A-1 to 57-3A-7 NMSA 1978. The price of products offered or the cost of services proposed shall not be designated as proprietary or confidential information.

If a request is received for disclosure of data for which an offeror has made a written Request for Confidentiality, the procurement officer shall examine the offeror's Request for Confidentiality and make a written determination that specifies which portions of the proposal should be disclosed. Unless the offeror takes legal action to prevent the disclosure, the proposal will be so disclosed. The proposal shall be open to public inspection subject to any continuing prohibition on the disclosure of confidential data.

9. <u>No Obligation</u>

This procurement in no manner obligates the State of New Mexico or the Fair to the eventual rental, lease, purchase, etc., of any product, equipment or services offered until a valid written contract is approved by Fair management and other appropriate authorities.

10. Termination

The New Mexico State Fair Commission reserves the right to cancel this Request for Proposals at any time for any reason, and to reject any or all proposals, in whole or in part, submitted in response to this Request for Proposals.

11. <u>Sufficient Appropriation</u>

Any contract awarded as a result of this RFP process may be terminated if sufficient appropriations or authorizations do not exist. Such termination will be effected by sending written notice to the Contractor. The Fair's decision as to whether sufficient appropriations and authorizations are available shall be accepted by the Contractor as final.

12. Legal Review

The Fair requires that all offerors agree to be bound by the General Requirements contained in this RFP. Offerors are encouraged to seek legal counsel for a review of this document. Any offeror concerns must be promptly brought to the attention of the Procurement Manager.

13. <u>Governing Law</u>

This procurement and any agreement with offerors that may result shall be governed by the laws of the State of New Mexico. Venue shall lie in Bernalillo County, State of New Mexico.

14. Basis for Proposal

Only information supplied by the New Mexico State Fair in writing through the Procurement Manager or in this Request for Proposals should be relied upon in preparation of offeror proposals.

15. Contract Terms and Conditions

The contract between the Fair and a contractor will follow the format specified by the Fair and contain the terms and conditions set forth in Appendix "B", "Contract Terms and Conditions". However, the Fair reserves the right to negotiate with a successful offeror provisions in addition to those contained in this RFP. The contents of this RFP, as revised and/or supplemented, and the successful offeror's proposal will be incorporated into the contract.

Should an offeror object to any of the Fair's terms and conditions, as contained in this Section or in Appendix "B", that offeror must propose specific alternative language that would be acceptable to the Fair. General references to the offeror's terms and conditions or attempts at complete substitutions are not acceptable to the Fair and will result in disqualification of the offeror's proposal.

Offerors must provide a brief discussion of the purpose and impact, if any, of each proposed change followed by the specific proposed alternate wording.

16. Offeror's Terms and Conditions

Offerors must submit with the proposal a complete set of any additional terms and conditions that they expect to have included in a contract negotiated with the Fair.

17. Contract Deviations

Any additional terms and conditions, which may be the subject of negotiation, will be discussed only between the Fair and the selected offeror and shall not be deemed an opportunity to amend the offeror's proposal.

18. Offeror Qualifications

The Evaluation Committee may make such investigations as necessary to determine the ability of the Offeror to adhere to the requirements specified within this RFP. The Procurement Manager will reject the proposal of any Offeror who is not a responsible offeror or fails to submit a responsive offer as defined in Sections NMSA 1978 §§ 13-1-83 and 13-1-85.

19. <u>Right to Waive Minor Irregularities</u>

The Evaluation Committee reserves the right to waive minor irregularities.

20. <u>Change in Contractor Representatives</u>

The Fair reserves the right to require a change in contractor representatives if the assigned representatives are not, in the opinion of the Fair, meeting its needs adequately.

21. Notice

The Procurement Code, NMSA 1978 §§ 13-1-28 through 13-1-199, imposes civil and criminal misdemeanor penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for illegal bribes, gratuities and kickbacks.

22. Ownership of Proposals

All documents submitted in response to this Request for Proposals become the property of the State of New Mexico, New Mexico State Fair Commission.

23. Electronic Mail Address Required

A large part of the communication regarding this procurement will be conducted by electronic mail (e-mail). Offeror must have a valid e-mail address to receive this correspondence. (See also Section II.B.5, Response to Written Questions / RFP Amendments).

24. Use of Electronic Versions of this RFP

This RFP is being made available by electronic means. If accepted by such means, the Offeror acknowledges and accepts full responsibility to ensure that no changes are made to the RFP. In the event of conflict between a version of the RFP in the Offeror's possession and the version maintained by the Fair, the Version maintained by the Fair shall govern.

25. <u>New Mexico Preferences</u>

To ensure adequate consideration and application of NMSA 1978, § 13-1-21 (as amended), Offerors must include a copy of their preference certificate with their proposal. Certificates for preferences must be obtained through the New Mexico Department of Taxation & Revenue <u>http://www.tax.newmexico.gov/Businesses/in-state-veteran-preference-certification.aspx</u>.

A. New Mexico Business Preference

B. New Mexico Resident Veterans Business Preference

In addition to a copy of the certification, the Offeror should sign and complete the Resident Veterans Preference Certificate form, as provided in this RFP.

An agency shall not award a business both a resident business preference and a resident veteran business preference.

The New Mexico Preferences shall not apply when the expenditures for this RFP includes federal funds.

II. <u>RESPONSE FORMAT AND ORGANIZATION</u>

A. <u>Number of Responses</u>

Offerors shall submit only one proposal.

B. <u>Number of Copies</u>

Offerors shall deliver six (6) signed, identical sealed copies of their proposal to the location specified in Section I, Paragraph C on or before the closing date and time for receipt of proposals.

C. <u>Proposal Format</u>

All proposals must be typewritten or computer generated on standard 8 1/2 by 11 inch paper (larger paper is permissible for charts, spreadsheets, etc.) and placed within a binder. Pages must be numbered sequentially. Proposal must be readily separable from the binder in order to facilitate copying by the Fair, should extra copies be necessary. Ring binders, presentation folders, and report folders are acceptable; comb binders, strip binders and other binders of a similar nature are NOT acceptable.

1. <u>Proposal organization</u>

The proposal must be organized and indexed in the following format and must contain, as a minimum, all listed items in the sequence indicated.

- a) Letter of Transmittal (Appendix "D")
- b) Table of Contents
- c) Response to Mandatory Specifications
- d) Response to Other Specifications
- e) Completed Cost Response Form (Appendix "C")
- f) Offeror's Additional Terms and Conditions
- g) Other Supporting Material

Within each section of their proposal, offerors should address the items in the order in which they appear in this RFP. All forms provided in the RFP must be thoroughly completed and included in the appropriate section of the proposal. <u>All discussion of proposed costs, rates or expenses must occur only in the section with the cost response form.</u>

Any proposal that does not adhere to these requirements may be deemed non-responsive and rejected on that basis.

Offerors may attach other materials that they feel may improve the quality of their responses. However, these materials should be included as items in a separate appendix.

2. <u>Letter of Transmittal</u>

The proposal must be accompanied by a letter of transmittal. The letter of transmittal must:

a) Identify the name and address of the submitting organization;

- b) Identify the name, title, telephone and fax numbers, and e-mail address of the person authorized by the offeror to contractually obligate the organization;
- c) Identify the name, title, telephone and fax numbers, and e-mail address of person authorized to negotiate the contract on behalf of the organization;
- d) Identify the names, titles, telephone and fax numbers, and e-mail address of persons to be contacted for clarification.
- e) <u>Explicitly</u> indicate acceptance of the Conditions Governing the Procurement stated in Section II, Paragraph C.1, the Procurement Code Regulations GSD Rule 1.4.1 NMAC.
- f) Be signed by the person authorized to contractually obligate the organization.
- g) Acknowledge receipt of any and all amendments to this RFP.

Offeror should use the form found in Appendix "D" in response to this specification.

IV. SPECIFICATIONS

A. <u>Mandatory Specifications</u>

No points will be awarded for meeting the Mandatory Specifications, but failure to meet them will result in rejection of the Offeror's proposal.

1. Contract Terms and Conditions

Offeror should use the form found in Appendix "E" in response to this specification.

Offerors must respond to the requirements found in Appendix "B", "Contract Terms and Conditions". Specifically state whether or not offeror is prepared to meet each of the requirements set forth in paragraphs 1 through 43, on an item-by-item basis in the order in which they appear. It is not necessary to re-type each paragraph. An offeror may state that he/she is prepared to meet each of the requirements by referencing the specific paragraph numbers to which the offeror is agreeing. If the offeror is not prepared to meet certain requirements, state the paragraph number(s) to which you are referring at this point and state your objections with specificity.

2. PRCA Membership

- a. Offeror must provide proof, in the form of a copy of the Offeror's current PRCA membership card, that he/she is a full stock contractor sanctioned by the PRCA. All subcontractors, if any, must be PRCA approved.
- b. State the number of continuous years the Offeror has been a PRCA member and Sanctioned Stock Contractor.

3. <u>Years of Experience</u>

Offeror must provide evidence that he/she has a minimum of seven (7) years experience with rodeo operations and productions of the size described in this RFP.

4. Judgments

- a. Describe in detail whether or not Offeror has any pending claims, suits or judgments against it for any reason during the past seven (7) years beginning with January 1, 2015 through December 31, 2021.
- b. If yes, please provide the date of the incident giving rise to the claim, suit or judgment; the circumstances as alleged against the Offeror; the Offeror's response to the allegations; and the disposition of the claim, suit, or judgment.
- c. Describe in detail whether or not injuries to patrons have occurred arising out of Offeror's rodeo operations.
- d. Also indicate whether or not Offeror has ever filed bankruptcy or reorganization under the Bankruptcy Code.

5. <u>Campaign Contribution Disclosure Form</u>

Offeror must complete and sign the Appendix G, Campaign Contribution Form. This form must be submitted with your proposal whether an applicable contribution has been made or not.

B. <u>Other Specifications</u>

1. <u>Experience</u>

The proposal should contain the following information on the offeror as well as on any subcontractors or consultants to be used, if any:

- a. Experience and reliability of the offeror's organization is considered in the evaluation process. Therefore, the offeror is advised to submit any information that documents successful and reliable PRCA experience in past performances, especially those performances related to the requirements of this RFP.
- b. Provide a list of the clients the offeror has gained and/or lost in the past five years.
- c. List the rodeo engagements and number of performances the offeror has produced as the primary contractor in the past year.

2. <u>Quality and Quantity of Stock</u>

The Fair believes that a successful rodeo requires stock that provides each contestant as fair and equal an opportunity as possible to win a specific event. The Offeror must provide information on how stock will be supplied in all events, including the short-go, to create, as best as possible, fair and equal pens for each contestant. This information should include how the Offeror has done this for other rodeos and what subcontractors, if any, will be utilized. Offeror shall also describe the type of stock that will be used in any short round or final round should such round be designated by the Fair.

3. <u>Additional Services/Equipment</u>

Should the Offeror desire, it may propose any extra services or equipment that has not been requested in this RFP. The Offeror can earn up to fifty (50) award points should any of these services or equipment be desirable to the Fair. State the cost to the Fair, if any, for such services or equipment. The cost of additional services and/or equipment will not be included in the cost proposal evaluation.

4. <u>Production/Entertainment</u>

The Fair desires the Offeror to provide details as to how Offeror proposes to produce a rodeo that provides entertainment beyond the traditional rodeo in order to stimulate interest in non-traditional rodeo fans. The Offeror should describe what entertainment ideas and plans Offeror has implemented in other rodeo productions.

- 5. <u>Cost to the Fair</u>
 - a. The offeror shall provide a price for all the services/equipment required by the contract terms and conditions found in Appendix "B". The cost must be stated as a per performance cost to the Fair.
 - b. If the Offeror chooses to submit a multi-year proposal, then it must submit prices for each year it contemplates up to a maximum of four (4) years.
 - c. The offeror must complete the "Cost Proposal Form" found in Appendix "C" <u>without deviation</u> from the required format. Do not re-type the form or alter the form in any manner.

V. <u>EVALUATION</u>

The following is a summary of evaluation factors with a point value assigned to each. These weighted factors will be used in the evaluation of individual offeror proposals. Only finalist offerors will receive points for oral presentations (if any)

B. <u>Evaluation Criteria</u>

Points will be awarded on the basis of the following weighted evaluation criteria:

1. EXPERIENCE: Experience with similar projects, expertise and past performance of the Offeror. "Similar" shall mean projects that include like magnitude and hours. This will be evaluated by Offeror's description of prior experience and quality of references. The references supplied by the Offeror may be contacted by the Fair to determine, for example, the working relationship, quality of work, and the ability of the Offeror to produce in a timely and professional manner.

2. QUALITY AND QUANTITY OF STOCK: Points will be awarded based on such things as quality and quantity of stock available taking into account the Fair's desire to provide a fair and equal as possible opportunity to win.

3. ADDITIONAL SERVICES AND/OR EQUIPMENT: Points will be awarded based on the relevancy, desirability, and relative cost, if any, of additional services and/or equipment proposed. The cost of additional services and/or equipment will not be included in the cost proposal evaluation.

4. **PRODUCTION/ENTERTAINMENT:** Points will be awarded based on the Offeror's ability to enhance the entertainment value of the rodeo and factors described in paragraph IV.B.4 on page 17.

5. COST TO THE FAIR: Costs for multi-year proposals will be determined by averaging the maximum cost proposed for each year.

The evaluation of each offeror's cost proposal will be conducted using the following formula:

Lowest Responsive Offeror Cost This Offeror's Cost X 250 = Award Points

In submitting a proposal for Evaluation Criteria number 5, the Offeror must complete the "Cost Proposal Form" found in Appendix "C" <u>without deviation</u> from the required format. Do not re-type the form or alter the form in any manner. <u>Do not re-state these values in any other location in your proposal.</u>

6. ORAL PRESENTATION, IF ANY: Points will be awarded to finalist Offerors for the oral presentation based upon the quality of the presentation, the knowledge and experience of the key staff, response to questions, and demonstrated understanding of the project.

7. NEW MEXICO PREFERENCES: Percentages will be determined based upon the point based system outlined in NMSA 1978, § 13-1-21 (as amended).

A. New Mexico Business Preference

If the Offeror has provided their Preference Certificate, the Preference Points for a New Mexico Business is 5%.

B. New Mexico Resident Veterans Business Preference

If the Offeror has provided their Preference Certificate **and** the Resident Veterans Certification Form, the Preference Points are awarded as followings:

- 10% for less than \$1M (prior year revenue)
- 8% for more than \$1M but less than \$5M (prior year revenue)
- 7% for more than \$5M (prior year revenue
- C. <u>Evaluation Process</u>
- 1. All offeror proposals will be reviewed for compliance with the mandatory requirements stated within the RFP. Proposals deemed non-responsive will be eliminated from further consideration.
- 2. The Procurement Manager may contact the offeror for clarification of the response as specified in Section II, Paragraph B.7.

- 3. The Evaluation Committee may use other sources of information to perform the evaluation as specified in Section II, Paragraph C.18.
- 4. Responsive proposals will be evaluated on the factors in Section V which have been assigned a point value. The responsible offerors with the highest scores will be selected as finalist offerors based upon the proposals submitted. Finalist offerors who are asked to submit revised proposals for the purpose of obtaining best and final offers will have their points recalculated accordingly. Points awarded from the oral presentations, if any, will be added to the previously assigned points to attain final scores. The responsible offeror whose proposal is most advantageous to the Fair, taking into consideration the evaluation factors in Section V, will be recommended for contract award to the New Mexico State Fair management as specified in Section II, Paragraph B.11. Please note, however, that a serious deficiency in the response to any one factor may be grounds for rejection regardless of overall score.

APPENDIX "B" CONTRACT TERMS AND CONDITIONS STATE OF NEW MEXICO NEW MEXICO STATE FAIR COMMISSION PROFESSIONAL SERVICES AGREEMENT

THIS AGREEMENT is made and entered into by and between the **State of New Mexico**, **New Mexico** State Fair, hereinafter referred to as the "Fair" and ______, hereinafter referred to as the "Contractor".

1. <u>Definitions</u>.

"<u>Annual Event</u>" means the Annual State Fair Event traditionally held during the month of September at Expo New Mexico in Albuquerque, New Mexico. The beginning date and the number of days allocated for the Annual Event is subject to change at the discretion of the Fair.

"<u>Expo New Mexico</u>" or "<u>Expo</u>" is the facility that houses the properties owned by the State of New Mexico, New Mexico State Fair Commission.

"PRCA" means the Professional Rodeo Cowboy's Association.

"Rodeo" means the PRCA rodeo held at Expo New Mexico during the Annual Event

"<u>WPRA</u>" means the Women's Professional Rodeo Association.

The terms "must," "shall," "will," and "require" identify a mandatory item or factor. Failure to comply with a mandatory item or factor will result in the rejection of the Offeror's proposal.

The terms "can," "may," "should," "preferably," or "prefers" identify a desirable or discretionary item or factor.

2. <u>Scope of Work</u>.

The Contractor shall:

- A. Provide all necessary rodeo stock for the following events during the Rodeo:
 - 1. Saddle bronc riding
 - 2. Steer wrestling
 - 3. Calf roping
 - 4. Bull Riding
 - 5. Team roping
 - 6. Bareback bronc riding
 - 7. Slack Rodeo
 - 8. Mutton busting
 - 9. Free Style Bull Fighting

All stock shall be of a quality consistent with a top 20 PRCA rodeo event and acceptable to the Fair and the PRCA. The rough stock should be of the caliber of animal that has scored at least a "18" in at least 6 rodeos in the past year. The minimum number of stock supplied shall be in accordance with all of rule part R8 of the PRCA rule book. The Fair will be provided a list of all bucking stock to be used and the owner of said stock as soon as they arrive on the grounds and are determined to be healthy. The Fair reserves the right to reject stock. Said stock will be replaced to the satisfaction of the Fair. The list will state the number of times the stock has been bucked during the year prior to the start of the Fair rodeo and the last time the stock will have been bucked prior to its scheduled performance at the Fair rodeo. Steer and cattle shall be good quality and as fresh and consistent as possible.

B. Provide a bull for each rodeo performance suitable to allow the rodeo clowns the opportunity to demonstrate their bullfighting and bull handling skills.

C. Provide a sufficient number of sheep and protective gear for all mutton busting contestants and prizes for all participants and the grand prize for the winner of each event.

D. Provide, at offeror's expense, the following properly qualified personnel in numbers necessary for the operation of a major PRCA rodeo and subject to the Fair's approval:

- 1. Rodeo secretary
- 2. Rodeo judges
- 3. Rodeo timers
- 4. Pickup personnel
- 5. Stock and chute workers

E. Provide all necessary pickup horses, equipment, feed, medical care, and supplies for the care of rodeo stock.

F. Provide all equipment used for livestock during performances, for example, flank straps, halters, bull flanks, horn wraps, neck ropes and gate ropes, etc.

G. Provide a minimum of one (1) individual to be at Expo New Mexico not later than three (3) days prior to the beginning of the Rodeo/Xtreme Bulls performance in order to advise and coordinate the installation and set-up of the rodeo chutes and other necessary equipment.

H. Ensure that adequate staff is on-site as required and designated by Fair. A key staff member must be accessible by cellular phone at all times during the performance of this Agreement.

I. Provide a production manager to be available and provide all production services and maintain all facilities during the Rodeo and Xtreme Bulls Performance. Production services are to include producing the Rodeo/Xtreme Bulls, managing contestant entries, receiving contestant entry fees, and set-up of the order of events, set-up of stock for performances, handling all prize money and payoffs thereof, and any other production services related to the Rodeo.

J. Assist the Fair in hiring of all clowns, barrel men and announcer as well as any specialty acts to be provided.

K. Obtain PRCA approval for the Rodeo.

L. Be in compliance with part 9 of the PRCA rule book regarding all animal rights issues. Must be familiar and up to date on any new Rules/Bylaws.

M. Arrange for appropriate credentials for Rodeo staff and participants with the Fair's credentials department.

N. Assume responsibility for communications between the Fair and the Rodeo participants regarding rules of the Fair.

O. Contractor shall warrant that it will not hold any rodeos in the state of New Mexico within a minimum of sixty (60) days prior to the first scheduled date of the Rodeo.

P. Comply with all PRCA rules and regulations with regard to all activities of the Contractor having to do with the production of the Rodeo.

3. <u>Rodeo Schedule and Location</u>.

A. The dates for the 2022 Annual Event are September 8 through September 18.

B. The Fair will hold a minimum of four (4) performances of the PRCA sanctioned rodeo during the month of September each year during the term of this Agreement.

C. The Rodeo will be held in Tingley Coliseum located on the fairgrounds. The stock will be housed in a penned area immediately to the north of the coliseum.

D. The Tingley Coliseum arena will not be available to the Contractor during certain times, which include, but are not limited to, entertainer load-in, queen candidate competition, and sound checks. The Contractor will be required to determine such times by communicating with the Fair's rodeo coordinator.

4. Work Environment.

The Fair will provide office space, RV parking, and a stock holding area mutually agreeable to the Contractor and the Fair.

5. <u>Video Rights</u>.

Fair reserves and retains video rights to all segments of rodeo performances, including those segments which may include representatives of Contractor. Contractor hereby consents and grants to Fair: (a) the right to film, tape, record, photograph and/or otherwise capture or reproduce any or all of the featured segment appearances involving Contractor; (b) the right to make use of and permit others to make use of any pictures, photographs and other likenesses of Contractor for any purpose in connection with advertising, publicizing, commercializing and

exploiting the Fair; and (c) the right to broadcast and to permit others to broadcast reproductions which might include the video likeness of Contractor by means of video tape or any other transmitting medium, for any purpose in connection with advertising, publicizing, commercializing and exploiting the Fair.

6. <u>Alcohol and Drugs</u>.

It is the policy of the Fair to prohibit all employees and contract personnel from being under the influence of alcohol or illegal drugs while on the premises of the Fair, regardless of whether the alcohol or drugs are consumed on or off the premises. "Under the influence" means the state of not having the normal use of mental or physical faculties or any state which alters performance responsibilities resulting from the introduction into the body of an alcoholic beverage or illegal drug. This includes the inability to perform satisfactorily the services for which Contractor has been engaged. Consuming any illegal drug on the premises of the Fair, regardless of impairment, is also prohibited. An illegal drug is any drug or derivative thereof which the use, possession, transfer or manufacture is illegal or regulated under any federal, state or local law or regulation and includes any Controlled Substance as defined by federal statute and any prescription drug used for any reason other than a legitimate medical reason according to physician's instructions, and also includes inhalants used illegally. Included is marijuana or cannabis in all forms. Contractor agrees to abide strictly by this policy, and Fair shall have the right to terminate this agreement immediately upon any breach of the foregoing policy by Contractor, without prior warning based on, including but not limited to, types of the following physical symptoms and abnormalities: strong alcohol smell, staggering, unsteady gait, impaired speech, inability to perform, and/or the results of positive drug or alcohol test(s).

7. <u>Performances</u>.

It is contemplated that there will be a minimum of four (4) performances of the rodeo. The exact number of performances shall be designated by Fair. It is contemplated that calf scrambles, specialty acts, grand entries and other events will be held in connection with the rodeo performances. For the purpose of coordinating the program, Contractor shall contact representatives of Fair not less than thirty (30) days before the opening date of the show to coordinate the entire rodeo program.

8. Liability for Losses.

Fair shall not be liable for losses suffered by Contractor by reason of fire, storm, flood, or other acts beyond its control, nor shall it be liable for damage caused by imperfection in construction of pens and chutes, though it agrees to use its reasonable efforts to see that same are properly and safely constructed. Repair of said pens during the rodeo shall be at the cost and responsibility of the Fair.

9. <u>Taxes</u>.

This agreement does not create an employer-employee relationship. Contractor shall be responsible for all income, self-employment or other taxes attributable to all sums paid to Contractor hereunder, and Contractor agrees to hold Fair harmless from any liability for withholding or payment of such taxes.

10. <u>Compensation</u>.

B. The Fair shall pay to the Contractor in full payment for services rendered the sum of
 \$______ per Xtreme Bulls performance during the first year of the Agreement.

C. The New Mexico gross receipts tax levied on the amounts payable under this Agreement during the first year in an amount not to exceed \$______ shall be paid by the Fair to the Contractor. The total amount of the monies payable to the Contractor in the following years, including gross receipts tax, shall not exceed \$______. Payment in subsequent years is subject to availability of funds pursuant to the Appropriations Paragraph set forth below.

D. The Fair shall pay the Contractor upon receipt of a detailed statement of accounting for services performed and expenses incurred hereunder.

11. <u>Term</u>.

THIS AGREEMENT SHALL NOT BECOME EFFECTIVE UNTIL SIGNED BY THE GENERAL MANAGER OF THE FAIR. This Agreement shall terminate on June 30, 2023 unless terminated pursuant to paragraph 12 (Termination), or paragraph 36 (Appropriations). The Fair reserves the option of renewing the contract for a maximum of three additional one-year periods, or any combination of years and/or months not to exceed a total of four years, at the same terms and conditions contained herein.

12. <u>Termination</u>.

A. <u>Grounds</u>. The Fair may terminate this Agreement for convenience or cause. The Contractor may only terminate this Agreement based upon the Fair's uncured, material breach of this Agreement.

B. <u>Notice; Fair Opportunity to Cure.</u>

1. Except as otherwise provided in Paragraph (12)(B)(3), the Fair shall give Contractor written notice of termination at least thirty (30) days prior to the intended date of termination.

2. Contractor shall give Fair written notice of termination at least thirty (30) days prior to the intended date of termination, which notice shall (i) identify all the Fair's material breaches of this Agreement upon which the termination is based and (ii) state what the Fair must do to cure such material breaches. Contractor's notice of termination shall only be effective (i) if the Fair does not cure all material breaches within the thirty (30) day notice period or (ii) in the case of material breaches that cannot be cured within thirty (30) days, the Fair does not, within the thirty (30) day notice period, notify the Contractor of its intent to cure and begin with due diligence to cure the material breach.

Notwithstanding the foregoing, this Agreement may be terminated immediately upon written notice to the Contractor (i) if the Contractor becomes unable to perform the services contracted for, as determined by the Fair; (ii) if, during the term of this Agreement, the Contractor is suspended or debarred by the State Purchasing Agent; or (iii) the Agreement is terminated pursuant to Paragraph 36, "Appropriations", of this Agreement.

C. <u>Liability.</u> Except as otherwise expressly allowed or provided under this Agreement, the Fair's sole liability upon termination shall be to pay for acceptable work performed prior to the Contractor's receipt or issuance of a notice of termination; <u>provided</u>, <u>however</u>, that a notice of termination shall not nullify or otherwise affect either party's liability for pre-termination defaults under or breaches of this Agreement. The Contractor shall submit an invoice for such work within thirty (30) days of receiving or sending the notice of termination. <u>THIS PROVISION IS NOT EXCLUSIVE AND DOES NOT WAIVE THE FAIR'S OTHER LEGAL RIGHTS AND REMEDIES CAUSED BY THE CONTRACTOR'S DEFAULT/BREACH OF THIS AGREEMENT.</u>

D. <u>Termination Management</u>. Immediately upon receipt by either the Fair or the Contractor of notice of termination of this Agreement, the Contractor shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the Fair; 2) comply with all directives issued by the Fair in the notice of termination as to the performance of work under this Agreement; and 3) take such action as the Fair shall direct for the protection, preservation, retention or transfer of all property titled to the Fair and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the Contractor with contract funds shall become property of the Fair upon termination and shall be submitted to the Fair as soon as practicable.

13. <u>Conduct Harmful to Fair</u>.

A. In the event the Contractor engages in conduct, whether or not during working hours, which endangers the health or safety of the public, contestants, or other persons on the Fair's grounds, or tends to injure the property or reputation of the Fair, Fair shall have the right to immediately terminate Contractor's services.

B. Contractor assumes the full responsibility for the character, acts, and conduct of all persons under its employ and direction. Fair reserves the right to remove any person deemed by Fair detrimental to the Fair or the operations of its business.

14. Contract Administrator.

The Contract Administrator for this Agreement will be the Fair's Events Manager. This individual is designated to administer the Agreement on behalf of the Fair. The Fair's Contract Administrator may be changed only by means of writing by the Fair's general manager.

15. <u>Insurance</u>.

Contractor agrees to provide and maintain comprehensive general liability insurance coverage in the amount of at least \$1,000,000.00 single limit for bodily injury and property damage. Or as an alternate, a split limits policy with minimum limits of \$700,000.00 bodily injury per person, \$1,000,000.00 bodily injury per occurrence and \$100,000.00 property damage per occurrence is required. In addition, Contractor must provide to the Fair a certificate of insurance naming the <u>New Mexico State Fair</u> as an additional insured. A copy of the insurance policy and all riders or amendments naming the <u>New Mexico State</u>

Fair as an additional insured, must be available upon request of the Fair.

Contractor's insurance carrier must be admitted to do business in the State of New Mexico and be listed in the AM Best rating guide with a general policy holder's rating of B+ or higher and a financial category of VII or higher (B+VII). A non-admitted carrier approved by the New Mexico Department of Insurance will be considered if it has an AM Best rating of B+VII or higher.

16. Contractor's Property.

Contractor acknowledges that in conjunction with the Agreement, materials, items, and other tangible property may be brought into Expo. Such property is the sole responsibility of Contractor and as such, Contractor has the sole and exclusive responsibility for the care and safety of all such property brought into Expo. Fair does not make any warranties or promises as to the care, maintenance or security of any such property. Any damage to said property caused by rain, hail, wind, fire, or any other natural phenomena shall be covered by Contractor's insurance policy. Additionally, Fair is not responsible for any damage, direct or incidental, caused by the negligent or intentional acts of a third party.

17. Parking Rights.

Fair retains all parking rights. Designation of parking areas, entry gates and fees shall be at the discretion of Fair.

18. <u>Exclusive Grants by Fair</u>.

A. Fair may already have or may in the future enter into agreements with suppliers of certain products, which grant to that supplier the exclusive right to have their product sold and advertised on the Fairgrounds. Under no circumstance may the Licensee engage in conduct that conflicts with the Fair's exclusive contracts.

B. Fair currently has an exclusive contract for all carbonated beverages, bottled water, isotonic sports drinks, and energy drinks sold or dispensed on the Fairgrounds. Concessionaires approved to sell or dispense carbonated beverages, bottled water, isotonic sports drinks, and energy drinks are required to purchase the products from the exclusive contractor. Selling, dispensing, or advertising any other brands are prohibited. This includes all signage, cups, fountain taps, posters, etc.

19. <u>Regulation Compliance</u>.

Licensee and Licensee's employees, invitees or agents must comply with all state and federal laws. Licensee agrees to allow representatives of the Fair and other state agencies or departments access to all areas and activities described herein for the purpose of conducting audit or safety inspections. Licensee shall adhere to guidelines for containing the COVID-19 pandemic set forth by the New Mexico Department of Health (NMDOH) as well as all New Mexico State Fair COVID Safe practice policies and procedures. In addition, the State of New Mexico has published *All Together New Mexico (https:nmml.org/together-new-mexico-covid-safe-practices-individuals-employers/*), a guide for individuals and businesses on COVID Safe Practices.

20. Records and Financial Audit.

The Contractor shall maintain detailed time and expenditure records that indicate the date, time, nature and cost of services rendered during the Agreement's term and effect and retain them for a period of three (3) years from the date of final payment under this Agreement. The records shall be subject to inspection by the Fair, the Department of Finance and Administration and the State Auditor. The Fair shall have the right to audit billings both before and after payment. Payment under this Agreement shall not foreclose the right of the Fair to recover excessive or illegal payments.

21. Product of Service: Copyright.

All materials developed or acquired by the Contractor under this Agreement shall become the property of the State of New Mexico and shall be delivered to the Fair not later than the termination date of this Agreement. Nothing produced, in whole or in part, by the Contractor under this Agreement shall be the subject of an application for copyright or other claim of ownership by or on behalf of the Contractor.

22. <u>Penalties for violation of law.</u>

The Procurement Code, NMSA 1978 §§ 13-1-28 through 13-1-199, imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for illegal bribes, gratuities and kickbacks.

23. Incorporation by Reference and Precedence.

A. This Agreement is derived from (1) the Request for Proposals, written clarifications to the Request for Proposals, and the Fair's responses to questions; (2) the Contractor's Best and Final Offer, and (3) the Contractor's response to the Request for Proposals.

B. In the event of a dispute under this Agreement, applicable documents will be referred to for the purpose of clarification or for additional detail in the following order of precedence: (1) Amendments to the Agreement in reverse chronological order; (2) the Agreement, including the Scope of Work; (3) the Contractor's Best and Final Offer; (4) the Request for Proposals, including attachments thereto, and (5) written responses to questions and written clarifications, and (6) the Contractor's response to the Request for Proposals.

24. Confidentiality.

Any confidential information provided to or developed by the Contractor in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the Contractor without prior written approval of the Fair. The Fair, as a state agency, is subject to the Inspection of Public Records Act.

25. Status of Contractor.

Contractor acknowledges that its agents and employees are not employees of the State of New Mexico as a result of this Agreement. Fair and Contractor are independent contracting parties, and nothing contained in this Agreement shall be deemed to create a partnership, joint venture, or agency relationship between them, nor does it grant either party any authority to assume or create any obligation on behalf of or in the name of the other. Neither party shall have any control or right of control in regard to the other party's employees, agents or independent contractors. Contractor agrees that Fair shall not be liable for any salaries or sums of money due to Contractor's employees, agents or contractors (collectively Contractor's personnel) or those persons with whom Contractor contracts, or any expenses or debts incurred by Contractor, except as specifically set forth in this Agreement.

26. <u>Subcontracting</u>.

The Contractor shall not subcontract any portion of the services to be performed under this Agreement without the prior written approval of the Fair. No such subcontract shall relieve the primary Contractor from its obligations and liabilities under this Agreement, nor shall any subcontract obligate direct payment from the Fair.

27. Assignment.

The Contractor shall not assign or transfer any interest in this Agreement or assign any claims for money due or to become due under this Agreement without the prior written approval of the Fair.

28. Corporate Structure.

If the controlling interest in Contractor's company is sold, transferred, or assigned (by merger or otherwise) to a third party, or the current principals of Contractor, for any reason, cease to be active in the management and operation of Contractor's company at any time during the term of this Agreement, Contractor shall notify Fair of the change and Fair reserves the right to terminate this Agreement as provided in paragraph 12, "Termination".

29. Limited Liability.

Contractor agrees that Fair shall not be liable to Contractor for lost profit or other financial loss to Contractor of any type or description, including any special, indirect, reliance, incidental or consequential damages, which may be caused directly or indirectly from 1) performance of this agreement, 2) termination of this agreement for any reasons specified herein, 3) for any time delays, inadequacies of services of Fair or any use of its facilities, including the contracted space or by any deficiency or defect therein, or 4) Acts of God. Contractor agrees that it will continue to pay all charges and other sums due to Fair regardless of any such claim, loss, damage or expense until this Agreement is terminated in accordance with these terms.

30. <u>Force Majeure</u>

A "Force Majeure Event" is defined as an event or effect that can be neither anticipated nor controlled which renders performance of the terms of this Agreement impossible, impracticable, or unsafe. A "Force Majeure Event" can include a pandemic, epidemic, plague, outbreak of infectious disease, including quarantine or other employee restrictions, war, act of authority, compliance with any law or governmental order, rule, regulation or direction, or other event which renders the terms of this Agreement impossible, impractical or unsafe. If a Force Majeure Event occurs, the parties' respective obligations hereunder will be excused fully, without any additional obligation, and each of the parties shall bear its own costs incurred in connection with this Agreement.

31. <u>Indemnification</u>.

The Contractor shall defend, indemnify and hold harmless the Fair and the State of New Mexico from all actions, proceedings, claims, demands, costs, damages, attorneys' fees and all other liabilities and expenses of any kind from any source which may arise out of the performance of this Agreement, caused by the negligent act or failure to act of the Contractor, its officers, employees, servants, subcontractors or agents, or if caused by the actions of any client of the Contractor resulting in injury or damage to persons or property during the time when the Contractor or any officer, agent, employee, servant or subcontractor thereof has or is performing services pursuant to this Agreement. In the event that any action, suit or proceeding related to the services performed by the Contractor or any officer, agent, employee, servant or subcontractor shall, as soon as practicable but no later than two (2) days after it receives notice thereof, notify the legal counsel of the Fair and the Risk Management Division of the New Mexico General Services Department by certified mail.

32. Equal Opportunity Compliance.

The Contractor agrees to abide by all federal and state laws and rules and regulations, and executive orders of the Governor of the State of New Mexico, pertaining to equal employment opportunity. In accordance with all such laws of the State of New Mexico, the Contractor assures that no person in the United States shall, on the grounds of race, religion, color, national origin, ancestry, sex, age, physical or mental handicap, or serious medical condition, spousal affiliation, sexual orientation or gender identity, be excluded from employment with or participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity performed under this Agreement. If Contractor is found not to be in compliance with these requirements during the life of this Agreement, Contractor agrees to take appropriate steps to correct these deficiencies.

33. <u>Workers' Compensation</u>.

The Contractor agrees to comply with state laws and rules applicable to workers' compensation benefits for its employees. If the Contractor fails to comply with the Workers' Compensation Act and applicable rules when required to do so, this Agreement may be terminated by Fair.

34. <u>Conflict of Interest</u>.

The Contractor warrants that it presently has no interest and shall not acquire any interest, direct or indirect, that would conflict in any manner or degree with the performance or services required under this Agreement. The Contractor certifies that the requirements of the Governmental Conduct Act, Sections 10-16-1 through 10-16-17 NMSA 1978, regarding contracting with a public officer, state employee, or former state employee have been followed. Contractor agrees to complete the "Campaign Contribution Disclosure Form" attached to this Agreement as appendix "G".

35. <u>Applicable Law</u>.

The laws of the State of New Mexico shall govern this Agreement, without giving effect to its choice of law provisions. Venue shall be proper only in a New Mexico court of competent jurisdiction in accordance with NMSA 1978, § 38-3-1 (G). By execution of this Agreement,

Contractor acknowledges and agrees to the jurisdiction of the courts of the State of New Mexico over any and all lawsuits arising under or out of any term of this Agreement.

36. <u>Appropriations</u>.

The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the Legislature of New Mexico and funds generated by the New Mexico State Fair for the performance of this Agreement. If sufficient funds are not available, this Agreement shall terminate immediately upon written notice being given by the Fair to the Contractor. The Fair's decision as to whether sufficient funds are available shall be accepted by the Contractor and shall be final. If the Fair proposes an amendment to the Agreement to unilaterally reduce funding, the Contractor shall have the option to terminate the Agreement or agree to the reduced funding, within ten (30) days of receipt of the proposed amendment.

37. <u>Release</u>.

The Contractor's acceptance of final payment of the amount due under this Agreement shall operate as a release of the Fair, its officers and employees, and the State of New Mexico from all liabilities, claims and obligations whatsoever arising from or under this Agreement.

38. <u>Amendment</u>.

A. This Agreement shall not be altered, changed or amended except by instrument in writing executed by the parties hereto and all other required signatories.

39. <u>Merger</u>.

This Agreement incorporates all the Agreements, covenants and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, Agreements and understandings have been merged into this written Agreement. No prior Agreement or understanding, oral or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in this Agreement.

40. Invalid Term or Condition.

If any term or condition of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected and shall be valid and enforceable.

41. Enforcement of Agreement.

A party's failure to require strict performance of any provision of this Agreement shall not waive or diminish that party's right thereafter to demand strict compliance with that or any other provision. No waiver by a party of any of its rights under this Agreement shall be effective unless express and in writing, and no effective waiver by a party of any of its rights shall be effective to waive any other rights.

42. <u>Notices</u>.

Any notice required to be given to either party by this Agreement shall be in writing and shall be delivered in person, by courier service or by U.S. mail, either first class or certified, return receipt requested, postage prepaid, as follows:

43. <u>Authority</u>.

If Contractor is other than a natural person, the individual(s) signing this Agreement on behalf of Contractor represents and warrants that he or she has the power and authority to bind Contractor, and that no further action, resolution, or approval from Contractor is necessary to enter into a binding contract.



- "**Pendency of the procurement process**" means the time period commencing with the public notice of the request for proposals and ending with the award of the contract or the cancellation of the request for proposals.
- "Person" means any corporation, partnership, individual, joint venture, association or any other private legal entity.

"Prospective contractor" means a person who is subject to the competitive sealed proposal process set

forth in the Procurement Code or is not required to submit a competitive sealed proposal because that person qualifies for a sole source or a small purchase contract.
