The NC Seafood Festival only acts as an additional marketing tool in order to help boost sales traffic to your point(s) of sale.
2. Each vendor/business must be invited to participate or receive approval from the NC Seafood Festival Vendor Committee.
3. The vendor/business must have sales & use tax number from the State of North Carolina Department. Each vendor/business is responsible for individual sales and collecting/reporting applicable sales and use taxes.
4. The NC Seafood Festival reserves the right to delete any vendor/business from the Marketplace if it is determined that items for sale are not deemed appropriate or does not follow the intent of the items originally offered for consideration to the Festival. In addition, should the Festival receive specific unresolved complaints from buyers regarding a vendor/business, the sales site may be deleted from the Vendor Marketplace and may result in future rejection of vendor space approval.
5. The vendor/business can only provide a link to a site unique to their business only. In addition, no link should provide advertisement to a sponsor or outside business without prior written approval from the NC Seafood Festival.
6. The NC Seafood Festival will not become involved within disputes that may arise between the vendor/business and buyer.
7. Vendors/businesses will not hold the NC Seafood Festival, employees, sponsors, or the Board of Directors responsible for claims, losses, fees, damages or expense arising from participating within the Vendor Marketplace.
