Each contestant will be responsible for any injury to any animal or damage to any property while on the grounds, by any horse owned or used by him/her and shall indemnify the management against all legally established claims or demands of any nature that may grow out of injury occasioned by any horse used by him/her for any and all loss from fire, winds or acts of God.
