



## 2024 NORTH IDAHO STATE FAIR – YOUTH STOCK SALE FREQUENTLY ASKED QUESTIONS

### **Youth Stock Show and Sale (YSSS) Definitions:**

**-CAP Sale Weight:** An animal weighing more than the CAP Sale Weight at final weigh in is eligible to show and sell in the general market and showmanship classes for that species but will be capped at the published maximum weight by species for the sale amount by pound. Buyers will pay the final per pound bid only for the cap weight, not the actual weight.

**-Lightweight:** An animal not meeting the minimum weight requirement for their species at final weigh-in, is referred to as a 'lightweight' and will show in the progress class. These animals may be sold privately, after the Youth Stock Sale concludes, and can be removed after 8pm, Sunday, August 25, 2024.

**-Minimum ADG:** The average daily gain required to compete in quality judging championships. This can be determined by completing the following calculation:  $ADG \text{ (average daily gain)} = (\text{Final weight} - \text{Initial weight}) / \text{Days on test}$ . Please refer to the weight table as the ADG differs between species.

**-Progress Class:** Each of the species considered large livestock in the Youth Stock Show will have a progress class. This is a class for market animals who don't meet the minimum weight required at final weigh-in (lightweight) or are declared to have intent of exhibiting without selling (no sale).

**-Youth for the Quality Care of Animals (YQCA):** Every exhibitor is required to complete this certified quality assurance training. This program allows a test out option at ages 12, 15, and 19 so you may certify and not have to retake the training each year. Please keep a copy of your certification available if requested.

**-Custom Slaughter:** The most popular way to buy; get top quality beef, pork, lamb, and goat at an attractive price. All you do is purchase the animal at the sale and select a custom meat cutter. Contact a local processor for hauling and processing instructions. The Grand and Reserve of each species is required to pass inspection at the USDA facility chosen by the YSSS Committee, but can be transferred to the processor of the buyer's choice at no additional cost to the buyer.

**-Take out:** Buyers may purchase animals 'on the hoof', with the exception of Grand and Reserve Champion animals. They must make arrangements to pick up their animals after 8 PM Sunday, August 25.

**-Turn:** This is an easy way for businesses or organizations to support the sale. The buyer simply says 'Turn' and the animal is purchased by our floor buyers at the present market price. The buyer pays only the difference between their bid and the market price.



## **FREQUENTLY ASKED QUESTIONS:**

### **-How do I register?**

- All buyers and supporters must register and receive a bidding number prior to making a purchase.

### **-How do we register if we have multiple companies/names?**

If you have one company name with multiple locations or contacts, please be sure to include your specific/unique buyer information for each bidder number registration. (I.e. Super 1 Foods-McIntire, Les Schwab-Rathdrum,...)

### **-Which processors are available?**

Local processors, Country Meats and Mountain View Custom Meats, have agreed to coordinate load out times with the YSSS committee to manage custom animals and more. You can find these processors listed on the Youth Stock Sale page of the nisfair.fun website with their contacts, links to their websites, access to suggested cut orders, etc.

### **-How do I gain entry to the Fair on sale day?**

Please join us at 8 AM to ensure a smoother check-in process, avoid the lines, and enjoy the new buyers' hospitality area for snacks, drinks, bonding with exhibitors and other buyers, and more. This also ensures being able to enter the sale without being charged parking or admission. The sale will start promptly at 9 AM and passes will be required to enter the Fair starting at 10 AM.

### **-I have registered but want to edit my contact information, how can I change that?**

### **-How do I find out about updates?**

The nisfair.fun website includes all information for all exhibits: you can locate sale information on the Youth Stock Sale page. We will also post information on our Youth Stock Show and Sale Facebook page. Be sure to check your email for updates and new information as well!

### **-I heard the buyer can't choose what to do with their animal?**

As this is a terminal sale and we want to ensure the safety and quality of food that the buyers are receiving, **the Grand and Reserve champions of each species will be harvested at a USDA facility as organized by the YSSS**



**committee.** The USDA carcass inspection costs will be covered by the committee, and the buyer may request to transfer the harvested animal(s) to a processor of their choosing, at no additional cost to the buyer. All other animals sold through the Youth Stock Sale can be harvested at their place of choice, or taken out live after 8pm on Sunday, August 25.

### **-Ways to buy?**

To buy an animal you have 3 options: Turn, Take Out, or Custom Slaughter (See the definitions above for more information about each option.) Grand and Reserve Champion animals cannot be purchased as “take outs”.

### **-Want to support but don't want to buy?**

For those wishing to provide support money in the form of add-ons to individual members, please keep these items in mind.

- All buyers and supporters are to sign the buyer agreement that ensures you are responsible for the payment of any funds passed on to the exhibitor.
- Support money in the form of add-ons is available online until two weeks after the sale; visit <https://nifr.fairwire.com/buyerlogon.aspx>, and log into your buyer account (for help with your password, email [hannah@northidahostatefair.com](mailto:hannah@northidahostatefair.com)). Once logged in, below your information and to the right will be a button to click that says “Give Auction Add-ons”. Then you simply select the exhibitor you wish to give an add-on and type in the amount, then check out.

### **-Can I be invoiced/billed for payment?**

Payment is due and expected the day of the sale. All buyers present at the sale must pick up a copy of their invoice from the clerks before leaving the sale. Payment may be made by cash, check, or credit card (a service fee will be assessed for credit card payments). To extend the date of payment beyond August 24, a payment extension request must be completed and filed with the Youth Stock Show and Sale Committee. Every buyer/supporter will be required to submit a signed buyer agreement stating they are responsible for any purchases and support money applied to the buyer number assigned to them. Please make checks payable to: Youth Stock Show and Sale (YSSS)

### **Program Definitions:**

**-Open Class (OC):** Departments 2-24, ranked using the American system. An open class exhibitor is an individual of any age, entering a static or livestock exhibit with no connection to a specific program or club. Please see the Open Class Livestock calendar for exhibit and show times, Friday, August 16 - Sunday, August 18, 2024.

**-4-H:** 4-H is a youth agricultural education program for ages 8-18 as of January 1 each year (with younger members considered as cloverbuds). 4-H livestock exhibitors with market and/or breeding entries will enter in the Youth Stock Show (Department 25) this year, and must meet all requirements of both the YSSS Rules and Regulations as well as all program requirements of 4-H. All other livestock



entries and all static exhibits will be registered through Department 26. 4-H is ranked using the Danish system. Please check with your coordinator and see the YSSS and 4-H calendars for entry, show, and removal times.

**-FFA:** FFA is a higher level educational program, so exhibitors are local high school students. FFA livestock exhibitors with market and/or breeding entries will enter in the Youth Stock Show (Department 25) this year, and must meet all requirements of both the YSSS Rules and Regulations as well as all program requirements of FFA. All other livestock entries and all static exhibits will be registered through Department 27. FFA is ranked using the Danish system. Please check with your advisor and see the YSSS and 4-H calendars for entry, show, and removal times.

**-Independent:** An independent exhibitor is limited to the ages 8-18 as of January 1 of the current calendar year and must live within Kootenai or Shoshone County. These exhibitors register their market and/or breeding entries in the Youth Stock Show (Department 25) and must meet all requirements of the YSSS Rules and Regulations. Exhibitors wanting to enter other livestock or static exhibits will do so through the Open Class Departments 2-24. Independent exhibitors are ranked using the Danish system. Please see the YSSS calendar for entry, show, sale, and removal times, Monday, August 19 - Sunday, August 25, 2024.

**-Youth Stock Show and Sale (YSSS):** Department 25, ranked using the Danish system. The Youth Stock Show is how exhibitors will register and exhibit their market and breeding animals. Market exhibitors will be assumed to have the intent of selling, unless specified by a submitted Declaration of Intent to Exhibit Without Selling in which they'll show in a progress class and not be sold. All YSSS exhibitors must meet all requirements of the YSSS Rules and Regulations.

**-Ribbon Placings:**

- Blue-High quality; very desirable carcass (little fat trim)
- Red-Average quality, good carcass (moderate fat trim)
- White-Fair quality, carcass may lack ideal finish (may be over lean or over fat)
