Old Business

- Weigh in review
 - Positive comments on judge selection
 - Have heard that the tags are coming out easily. Something to consider for next year.
 - Shanda will reach out to All Flex to see if they have any suggestions or solutions
- Processor update
 - o Mountain View and Classic Meats agreed to open their books for custom processing. Animals will be delivered over the week to the processors.
- YQCA/Vet Q&A Review
 - Heard feedback that the YQCA platform was difficult to use after the kids left the training.
 - Have had interest in another date being offered. Fair staff will look for a date that may work

New Business

- Retagging of animals
 - o Exhibitors have reached out directly to Mike with problems like missing tags
 - o Fair staff will work to create a form on the website where exhibitors can submit their information and attach pictures
- Judge hospitality
 - o Past experience has been that judges have been escorted throughout the show.
 - o The committee feels that judges can be more independent and we will reimburse whatever they need.
- FFA rule change
 - o Animals can now be shown in open class and during the market show.
- Sale fees
 - o Have received the official letter of required fees
 - o Finance committee agreed that all fees will be paid out of the overall commission and not passed on directlyto the exhibitors
- Fair badges
 - o Please email pictures to Michaela by August 1 for use on badges
- New chute
 - o Delivered last Friday to the fairgrounds
 - o Can accommodate all large animal species, if needed

 - o Discussed the volunteer sign up sheet
 - o Committee members were asked to think of others who may be willing and able to help
- Fair vet update
 - o Discussed vet schedule
 - o Dr. Christensen can use the Livestock Office as a "home base" and can be reached by staff, committee and barn managers via cell phone
- Drug testing
 - o Shannon will provide a lockable cooler for samples
- Buyer contact/pre-registration
 - o Assigned large buyers to committee members to contact
 - o Committee decided day-of registration is the best process for buyers
- Kootenai Classic
 - o Top animals were taken directly to processors. Should not have any issues with animals coming back to the sale.
- Barn set up
 - o Jacklin needs roof work and may be able to do it in the first week of August. All other barns will be available the first week of August. August 4th is the cutoff date for all fair entries and we will know final numbers.
