# **Service Information**

**ADMINISTRATIVE OFFICE** - The General Manager will maintain an office in the E\*Plex. Concessions Office and Exhibits Office are in the E\*Plex lobby.

**LIVESTOCK OFFICE** - The Livestock Office is located in the E\*Plex until July 15. After that date, the office is located on the east end of the Wilson Logistics Arena through Aug. 9. The livestock office may be reached by calling the OEF at 417-833-2660 during office hours.

FIRST AID STATION - A First Aid Station will be available during the Fair.

**PUBLIC SAFETY** - The City of Springfield Police Department maintains a station on the fairgrounds for the duration of the Fair.

**HIGHWAYS** - U.S. Highways 60, 160, 65, 66 and 166; Interstate Highway 44; and Missouri Highways 13 and 123 all lead to Springfield and the Ozark Empire Fair. The Fairgrounds is located just east of the junction of I-44 and Missouri 13.

# **General Rules and Regulations**

- 1. INTERPRETATION AND VIOLATION OF RULES The Ozark Empire Fair (OEF) reserves to its management the right to interpret the following rules and regulations and determine all matters pertaining hereto; also the right to amend or add such rules as its judgment might determine in the best interest of the show. Violation of any of these regulations may cause forfeiture of all privileges, deposits, prize money, contracts and rights to further participation by the violator and their immediate family. This shall apply to all departments of the Ozark Empire Fair.
- 2. APPLICATION FOR ENTRY All applicants for entry to exhibit any animal or article, must be made through our online entry portal, ShoWorks. Online entries can be found at www.ozarkempirefair.com. When entering online, be sure to retain a copy of your receipt as confirmation. Junior Division entries must be checked by a legal guardian. Any entries determined invalid by the designated personnel will be returned. No refunds will be made. All entries must be in the name of the owner. Parents/guardians are responsible parties for minor exhibitors in all things pertaining to rules and legal issues. The Fair reserves the right to cancel at any time contracts made with exhibitors or concessionaires for the infraction of any rule or condition contained herein (in such cases no refund will be made). The Fair further reserves the right to cancel, without liability of any kind, all contracts of whatever kind by public notice should an act of Providence, such as war, national security concerns, riot, fire, flood, storm or pestilence, prevent or render impractical (in the sole discretion of the Ozark Empire Fair) the holding of the Fair. In all cases, management reserves the right to accept, reject or conditionally accept any entry as it is intended that only such animals as have merit shall be entered and shown and will be a credit to both the

exhibitor and exposition. Entries which do not meet eligibility criteria will be disqualified.

- **3.** ENTRY CLOSING DATE Entries in all divisions, except as noted in division rules, must be submitted no later than midnight JUNE 15, 2024. Entries will close at midnight on June 15th. Late entries will be accepted from June 16th to July 1st. Location in barns and exhibit buildings will be assigned by show personnel and livestock fair management.
- 4. ERRONEOUS ENTRY Exhibits that have been erroneously entered and do not meet the specifications of the class can be transferred to a proper class or disqualified by the superintendent prior to judging. If proper class has been judged, it shall not be re-judged. Any misrepresentation of the exhibit shall be cause for disqualification. It is the responsibility of the livestock exhibitor to check the official show programs prior to the scheduled livestock show to be sure they are in the correct classes.
- 5. LIMITATIONS OF COMPETITION Competition in all open divisions is open to the world unless otherwise specified. See Junior Livestock Show Rules. Any division without adequate numbers of entries at deadline time to make a viable show, management may cancel the division and return entries and fees.
- **6. RELEASES** Exhibits will be released according to each division's regulations. Any exhibitor violating rules will forfeit prize money.
- 7. JUDGING OF EXHIBITS - Judges have been carefully selected by the management and each is recognized for the capacity to make expert decisions in the respective division for which chosen. All exhibitors making entry for the Fair accept these judges and agree to abide by their decisions. The decision of the judge will be final in all cases. If an exhibitor attempts to interfere with in any manner, publicly expresses disapproval of decisions or disrespects the judge, he/she may be excluded from further competition and/or banned from future competition and any prize money previously won will be forfeited. Any attempt by an exhibitor, either personally or through an agent, to corrupt the judge or exert undue influence may subject the offender to expulsion from the fairgrounds and he/she will thereafter be prohibited from exhibiting or other privileges. Fair management may name a substitute judge should a regular judge fail to appear. Judges will be announcement prior to the entry deadline.
- 8. PROTESTS No protest based on the statement that the judge or judges were incompetent will be considered. Protest upon any other grounds must be presented in written form within 24 hours of the protested action and must be accompanied by a deposit of \$50 to be made with the manager of the Fair or designated representative. Deposit will be forfeited in case protest is not sustained. All questions of dispute with interpretation of rules shall be referred to the Fair Board of Directors, whose decision shall be final.
- PRIZE MONEY AND AWARDS Prize money and awards will only be 9. presented to exhibits listed in classifications contained in the Exhibitor Handbooks. The judge may recommend no award, third, second, or first according to the merit of the exhibit. Ribbons will not be used as basis for payment of prize money. Payments will be made only from the judging book after it has been officially marked by the superintendent and judge. All special and sponsored awards, such as trophies, medals, and other articles offered by individuals must be delivered to the fairgrounds prior to the first day of the Fair, otherwise they will not be awarded. An exhibitor may win no more than two monies per class unless otherwise specified. The Fair reserves the right to withhold payment of any award upon discovery of fraud, misrepresentation of description or dishonest practice in preparation or ownership of any exhibit or entry. OEF is not responsible for special premiums or awards offered by other organizations.
- **10. PAYMENT OF PRIZE MONEY** Any prize money not paid out by cash during the Fair will be mailed on or after September 1 to the address shown on the entry form. No claim that prize money has not been paid, or that there was a discrepancy in payment of prize money won, will be considered if made later than 10 days after receipt of payment. **Checks not cashed in 90 days are void.**
- **11. DEPARTMENTAL PERSONNEL** Each division of the Fair will be under the supervision of an experienced superintendent who, along with assistants, will be charged with the responsibility of enforcing all rules and regulations pertaining to that division. The superintendent shall see that all requested information on each article is recorded in the judging book before the class may be judged. The superintendent must instruct the ring clerk to make accurate recording of the judge's placing of each exhibit and to note entries made and not shown, as well as the number shown and judged in each class. After judging is completed, the superintendent will see that the books are signed by the judge and by himself/herself to certify the records to be correct. The superintendent shall then have the books returned to the livestock office since they

constitute the official record by which all prize money is paid. Superintendents and assistant superintendents may not exhibit in the division under their supervision.

- 12. LIABILITY The Greene County Agricultural and Mechanical Society, Inc. dba the Ozark Empire Fair, the Ozark Empire Fair Foundation, and the City of Springfield, Missouri expressly refuses to assume any liability for injuries to any person or damage to any property coming upon the Ozark Empire Fairgrounds and no claims for injury to any person, damage to property or loss shall be asserted or suit instituted or maintained against the said Greene County Agricultural and Mechanical Society, Inc., the Ozark Empire Fair Foundation, and the City of Springfield, Missouri and their officers, agents, or employees for said cause by any person having privilege to exhibit or license to operate on the fairgrounds or occupying any space thereon, and it is a part of the consideration for each license or privilege granted by the Ozark Empire Fair that such claims for injury or damage are specifically waived. If any damage or injury or loss to persons or property shall be caused by reason of neglect or willful act of any person, firm or corporation, or their agents, representatives or employees, having license or permit to exhibit or operate a business or occupy space at the Ozark Empire Fairgrounds, the Greene County Agricultural and Mechanical Society, Inc., shall in no manner be responsible therefore, and in no case will be subjected to any expense or liability. All persons causing same or liable therefore shall indemnify the said Greene County Agricultural and Mechanical Society, Inc. dba the Ozark Empire Fair, the Ozark Empire Fair Foundation, and the City of Springfield, Missouri.
- **13. FORCE MAJEURE** The Ozark Empire Fair is not liable for any delay or failure to perform its operations, activities, shows and/or events to the extent such delay or failure results in a force majeure occurrence. A force majeure occurrence is defined as any occurrence arising from causes beyond the reasonable control of the Ozark Empire Fair that delays or prevents performance of its duties.
- 14. HOMELAND SECURITY SYSTEMS WARNING STATEMENT During such times as deemed necessary by local, state or federal authorities, the Ozark Empire Fair and/or officials may temporarily or permanently evacuate the OEF facilities under the authority of the Homeland Security Act. Incidents such as, but not limited to: bomb threats, acts of war, declarations of war, code red of the Homeland Security Systems, etc. will be acted upon in accordance and cooperating with local, state and federal authorities. Priority evacuation will be given to human life, then livestock and/or equine. In such cases, exhibitors will turn over livestock or equine to the Ozark Empire Fair. Proper animal husbandry practices will be followed within reasonable expectations. At which time the evacuation notice is lifted, exhibitors will be allowed to re-enter the Ozark Empire Fairgrounds and claim livestock and/or equine. By making entry into the Ozark Empire Fair, exhibitors authorize the Ozark Empire Fair and its officials to detain livestock and/or equine on their premises. Furthermore, exhibitors agree to hold harmless and without liability the Ozark Empire Fair, its officials, directors, staff and/or volunteers for those animals under the reasonable care of the show.
- **15. PROHIBITED ACTIVITIES/ITEMS** No weapons (including firearms, ammunition, bows, arrows, TASERs, stun guns, swords, aces, etc.) allowed. No bicycles, skateboards, scooters, roller skates and/or any other type of non-motorized activities allowed. No personal golf carts, scooters, co-carts, utility vehicles, segways or other type of motorized activity allowed. The only exception being official fair transportation and handicap person with their vehicles. No Laser pointers or drones allowed (unless specified by fair officials). These items are prohibited in the interest of safety for all who attend the fair. Violators may have equipment confiscated. Items released by legal authorities may be picked up after the fair.
- **16. PHOTO AND VIDEO DISCLAIMER** When you enter an Ozark Empire Fair event, program or show, you enter an area where photography, audio and video recording may occur. Read full disclaimer on the OEF website.

Livestock Exhibitors and those wishing to watch livestock events. Other entrance gates will open to the public at 11 a.m. Gates will close at 11 p.m.

14. TRAFFIC REGULATIONS - Any person obstructing any fire lane, drive or street with any vehicle will be requested to remove same immediately. Failure to do so may result in expulsion from the fairgrounds and/or arrest. Parking in front of buildings, exhibits and midway concessions will not be tolerated. Anyone bringing exhibits, displays, equipment or materials into the fairgrounds must unload same as soon as possible and move vehicles to designated parking areas immediately after unloading.

## Livestock Entry Rules

#### A. IMPORTANT NOTICE

1. Read the preceding General Rules and Regulations before making entry in the Livestock Department.

#### **B. ENTRIES**

- 1. Entry must be made on the online entry portal, ShoWorks. The online entry link will be available on the livestock page at www.ozarkempirefair.com.
- 2. Entries must be submitted by 11:59 on June 15. Entries submitted after midnight must have additional late fees added manually to their ShoWorks account.
- 3. Exhibitor will be defined as an individual or farm as identified by Social Security or Federal Tax I.D. number.
- 4. In case entries exceed stall or pen facilities, entries will be accepted according to date received. Management reserves the right to limit tack stalls.
- 5. All species group classes including: Sheep, Dairy and Beef Cattle, must enter into group classes prior to arrival of the fairgrounds. No ringside group class entries will be accepted. All group class entry fees are \$5 per class.
- 5. Late entries **WILL NOT BE ACCEPTED ON POULTRY OR RABBITS.** Late entries for others may be accepted through July 1. When the portal reopens on June 16th these will be the late fees:

#### **C. ENTRY REQUIREMENTS**

- 1. Livestock exhibitors must furnish **all information** requested on the official entry and remit all stall and exhibitor ticket fees when entry is filed; otherwise, entry will not be accepted. THERE WILL BE A \$50 CHARGE ON ALL DECLINED CARDS.
- 2. Exhibitors shall be responsible for their own errors in making entries.
- 3. All animals entered and shown must be registered in their respective breed association as purebred or percentage as defined by breed standards for their division and class. All exhibitors must provide original registration papers upon check-in for each animal entered and be named as owner of the animal. No fax or photocopies will be accepted. In exceptional cases, electronic copies may be used at check-in provided the breed association makes them available online. This is at the discretion of the show officials. If a breed association must be contacted for any reason, a \$10 charge may be accessed to the exhibitor. Papers may be rechecked at any time. Animals that are properly registered in more than one breed association may compete in only one breed show.
- 4. Animals owned in partnership may be entered and shown only as the ownership is recorded in the office of the respective breed association.
- 5. FITTING SERVICES: Owner's name and address must be listed on entry.
- The Ozark Empire Fair does not require a premise identification number to exhibit livestock.

#### **D. STALL AND ENTRY FEES**

- 1. See entry blanks and appropriate division rules for stall and entry fees.
- 2. Junior entries are not automatically entered into their respective
- open division at time of entry. Junior Exhibitors must indicate on the entry form both the open class and the junior class.
- 3. Entries will not be accepted, or stalls and pens reserved, unless proper

fees accompany entry when filed. Payment of fees may be made by Visa, Discover or MasterCard.

- 4. STALLING REQUESTS: Requests for exhibitors to be stalled together, or next to, will be considered, but not guaranteed. Stall requests must be on entry forms to be considered. Livestock will have priority over tack stalls. The assignment of stalls for livestock and tack will be made by show officials and/or superintendents. Exhibitors not in need of the pens or stall space that was paid for, may be asked to forfeit that space.
- 5. Tack space in addition to stall, pen, cage or tie space reserved for animals is not guaranteed. Management reserves the right to return entries when stall, pen, cage or tie space is full.

### E. CANCELLATIONS AND SUBSTITUTIONS

- 1. No refunds will be considered after entry has been made.
- 2. Substitutions may be made only in the name of the original exhibitor as listed on the entry form within or out of class at any time, but not out of division, such as a breed. Substitutions must be made by time of check-in closing.

### F. ADMISSION FEES

- 1. Each livestock exhibitor is required to purchase admission tickets and parking passes as provided on the entry form. Tickets do not provide for parking. Tickets will only be given to the exhibitor on the entry form, one exhibitor per entry form. All admission tickets and parking passes, ordered with entries will be available for pick-up upon arrival at the fair. Tickets can be purchased in the "Tickets" button on ShoWorks. Please pay for entries and then complete a second transaction for tickets.
- 2. If an exhibitor needs additional tickets for family/workers, a discount gate admission ticket purchased, in advance, by the entry deadline may be used to gain admission or regular gate admission will be charged.
- 3. Admission and parking permit fees located on page 2 of general rules.
- 4. Exhibitors will be limited to 30 tickets purchased at advance livestock price. Any exhibitor found to be reselling exhibitor tickets will forfeit all prize money won and may be barred from future competition.

#### G. ARRIVAL AND RELEASE OF LIVESTOCK

- 1. Arrival and release times for each division of livestock are listed in the respective division rules. No livestock will be permitted on the Fairgrounds prior to 12 p.m. Tuesday, July 23.
- 2. Arrival and release times will be strictly enforced except for emergency. ABSOLUTELY NO EARLY ARRIVALS WILL BE PERMITTED. Early release for transport to another fair or livestock show may be granted only upon approval and requests must be accompanied by credentials supporting entry in another show.
- 3. On the official schedule for the 2024 fair, there is a release time and a time that the species is required to be off grounds. All animals must be off the grounds by 8 a.m., Sunday, August 4.

#### H. EXHIBITION AND JUDGING

- Classes will be judged according to the judging schedule as listed in each division. Animals must be brought into the show ring without delay when the class is called. All animals shall be exhibited at the discretion of the division superintendent. Failure to comply will cause forfeiture of prize money won and further competition by the exhibitor.
- 2. The management reserves the right to combine or divide show classes as warranted by entries, which may cause premiums to be divided.
- 3. **CHECK-IN:** All exhibitors must have animals checked in with superintendent or Livestock office by designated time. Animals not checked-in will be scratched from competition.
- 4. Judging time will be as near as possible to the tentative schedule. Exhibitors should ascertain at what time animals entered will be judged.
- 5. Exhibitors are responsible to have entries ready to enter the show ring when show officials call for the class. Classes may not re-run for any animal missing a class. If an animal misses a class, it cannot be put in another class. Due to unforeseeable problems with any mechanical device, the public address system is to be considered a courtesy.
- 6. **DISQUALIFICATION:** If an entry that has been awarded a prize be disqualified, the lower placing animal will not move into the higher position. Exceptions to this rule is at the discretion of show management on a case-by-case basis.

## I. PRIZE MONEY, PREMIUMS AND AWARDS

- 1. No exhibitor shall win more than two prize money awards in an individual class or more than one prize money in a group class.
- 2. Where there is no competition or only one exhibitor in a class, animals may be awarded first, second, third or no place according to merit.
- 3. Prize money not awarded as cash during the Fair will be mailed on or after Aug. 31, 2024 to the address submitted on entry form.
- 4. Social security numbers or EIN Numbers are required for entry. Any winnings \$600 and over will be reported to the IRS on Form 1099.

### J. COMPETITIVE CLASSIFICATIONS

- 1. Classes in beef divisions will be offered to breeds exhibiting at least 25 head of animals. Dairy, equine, goat, sheep and swine divisions must have at least 10 head of animals exhibited to maintain each division.
- 2. Failure to meet the required number for three consecutive years may cause that breed or division to be dropped from the Exhibitor's Handbook unless evidence is presented to management that a sufficient number of animals will be shown to present a credible show. All appeals should be made to the manager of the Livestock Office by Oct. 1.
- 3. If an entity wanted to start a new beef division; the beef breed must fund \$1000 for the first three years, after the third year if the division is at 25 head or more they will be established until they go under 25 head per show.

## K. LIVESTOCK BARNS

- 1. All barns and premises will be sprayed nightly for flies.
- 2. Livestock barns must be kept clean. All aisles, stalls and pens must be cleaned before 8 a.m. daily. Livestock can be tied ONLY in their designated stalls, tie-outs or wash rack. Not to any fence or other public areas.
- 3. All feed, bedding, tack, grooming chutes and other items MUST be inside exhibitor's stalls. Items left outside assigned stalls may be disposed of.
- 4. All straw, manure and other refuse must be properly disposed of in DESIGNATED AREAS ONLY. Any exhibitor who puts refuse in any unauthorized place is subject to forfeiture of prize money won, removal from fairgrounds or barring from future competition at the Fair.
- 5. All livestock must be washed in DESIGNATED WASH RACKS ONLY. Any exhibitor washing animals outside of wash racks is subject to the same penalties as in rule 4.
- 6. Blankets must be removed and stock kept in condition for inspection by the public from 8 a.m. until 7 p.m.
- 7. Herdsmanship awards are presented to encourage neatness, courtesy and attention to show requirements.
- 8. All fans and other electrical equipment used in the livestock barns must meet requirements of the City of Springfield electrical safety code and stand inspection by city agents.
- 9. Gasoline or other types of generators designed to produce electricity to power fans or equipment will be permitted in the livestock areas on show days only or by permission of the Livestock Office.
- 10.No fans or other equipment may be placed in aisles. NO BUTT FANS ALLOWED.
- 11. The management of the Fair reserves the right to limit the number and type of fans and appliances used by an individual exhibitor.
- 12. Smoking and use of alcoholic beverages in barns will not be tolerated. Smoking is prohibited by City Ordinance in all buildings. **The Ozark Empire Fair Board has adopted a policy of restricting smoking to designated areas. These areas will be identified as such, with facilities to accommodate the users.** Alcohol is prohibited ANYWHERE on the fairgrounds by City Ordinance during the Ozark Empire Fair. Alcohol may be served by OEF staff to adults in licensed venues on the Ozark Empire Fairgrounds and must be consumed on those premises. Exhibitors shall be responsible for the behavior of their helpers.
- 13.Dogs must be on leash at all times and will not be permitted in the barns.
- 14. The management of the fair HIGHLY discourages food and sleeping in the barns due to the health of exhibitors and fairgoers.
- 15. There will NOT be any open flame on the fairgrounds property.

## L. OEF SHOW RING CODE OF ETHICS AND CONDUCT

- 1. False representation, interference or unprofessional conduct on the part of any exhibitor will be dealt with by show management according to the circumstances of the case.
- 2. All animals entered and accepted for exhibition must be presented in the show ring in their natural conformation and physical condition, with no other preparation except natural feeding, fitting and training permitted. Unnatural practices in fitting will cause that animal to be disqualified.
- 3. The management of the Ozark Empire Fair reserves the right to disqualify any animal that has been altered in conformation and structure through the use of prohibited substances or unethical fitting. This shall include, but is not limited to the following:
  - a. The injection, use or administration of any drug that is prohibited by Federal, State or Local Law or any drug that is used in a manner prohibited by Federal, State or Local Law.
  - b. The injection or internal or external administration of any product or material, whether gas, solid or liquid, to an animal for the purpose of deception, including concealing, enhancing, or transforming the true conformation, configuration, color, breed, condition or age or by making the animal appear more sound than otherwise would appear. The use of performance enhancing drugs is prohibited (including, but

not limited to; steroids, caffeine, diuretics, anti-inflammatories, tranquilizers and pain killers.

- c. The administration of any substance for cosmetic purposes, tissue manipulation, surgical removal or attachment, or any other action to otherwise change, conceal, enhance or transform the true conformation or configuration of the animal.
- d. Attaching to the hide foreign objects including hair or hair substitutes, cloth or fiber for the purpose of deception.
- e. Any physical or physiological attempt to alter the natural musculature or weight by use of injections or ingested material not conducive to the continued health of the animal, marketability of carcasses or for deception.
- f. No drenching will be allowed. The act of artificially filling animals internally which includes stomach pumping, drench tubes, bottles or any other method by mouth or esophagus is prohibited.
- g. No coloring substances may be used that will change the natural color of an animal. In addition to disqualification of the animal, exhibitor may be banned from future competition at the Ozark Empire Fair.
- 4. The Ozark Empire Fair abides by the Purebred Dairy Cattle Association Show Ring Code of Ethics in defining violations in dairy shows. Major violations of that code are violations of the Ozark Empire Fair's Show Ring Code of Ethics. Other violations of the PDCA code will be handled according to established PDCA guidelines.
- 5. Each exhibitor, by making application for entry into the Ozark Empire Fair, agrees to abide by the Ozark Empire Fair Code of Ethics and agrees to submit any animal entered to inspection by a veterinarian appointed by management, and agrees to have such animal submitted to any tests as may be designated and requested by the veterinarian. Ozark Empire Fair officials may hold any market animal under quarantine for an extended period of time for any tests deemed necessary. Further, the exhibitor agrees that the conclusions reached by the veterinarian as to whether such animal is unethically fitted or altered shall be final, without recourse against the Ozark Empire Fair, its officers or employees.
- 6. Good animal health, feeding and handling practices must be followed by all exhibitors. Any failure to follow these practices could mean being banned from future competition at the Ozark Empire Fair if, in the opinion of the superintendent, any animal has been neglected or abused.

#### M. FEED AND BEDDING

- 1. The Fair management reserves the right to regulate the type of bedding materials that may be brought onto the grounds by exhibitors.
- 2. The only bedding materials approved for use: straw, wood chips, wood shavings and mulch. Materials NOT ACCEPTABLE: paper, bark or sand.
- 3. Feed and bedding will be available at the feed barn on the grounds at prevailing prices.
- 4. Feed and bedding may not be brought in for the purpose of resale other than by the official supplier having contract with the Ozark Empire Fair.

- 5. All feed and bedding purchased on grounds must be properly settled with the feed barn manager for before a release will be issued.
- 6. Absolutely NO BIG BALES will be allowed on the grounds for use by exhibitors. Big round bales of straw may be used to bed tie outs or stalls, but must be used in their entirety. No leftover bales will be permitted.

#### N. ENTRANCE AND PARKING

- Vehicles bringing livestock should enter the grounds off Smith Street, at Gate 10. Livestock will not be permitted to enter at any other gate.
- After unloading, vehicles that remain on the grounds must be moved to designated parking areas. ALL LIVESTOCK TRAILERS WILL BE PARKED at the Former Central Bible College Complex northeast of the grounds. Noncompliance may result in forfeiture of prize money.
- 3. Vehicles will be allowed in barn areas between the hours of 6-10 a.m.; 4-6 p.m., and 10 p.m.-midnight daily. Vehicles blocking barn entrances, manure pits or other vehicles will be removed at owner's expense.

#### **O. CAMPING FACILITIES**

Space must be paid for in advance and accompanied by livestock entry.
 Livestock camping is limited and restricted to certain areas. Camping

spaces assigned on a first-come basis. Rental is \$40 per night and includes admission, water and electricity. **Parking is not included.** To reserve camping, please call the Ozark Empire Fair office to talk to camping personnel. \*The camping fee above is from the 2023 Ozark Empire Fair and is subject to change closer to when camping reservations open.\*

#### 3. If you leave the fairgrounds, you must get a wrist band for re-entry.

P. IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS) CODE OF SHOW RING ETHICS - Exhibitors of animals at livestock shows shall at all times deport themselves with honesty and good sportsmanship. Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain & positive that those younger & more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers & absolutely responsible persons who violate the code of ethics will forfeit premiums, awards & auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs & livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors & should be prohibited from competition at all livestock shows in the United States & Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

- 1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
- 2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
- 3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
- 4. Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of, consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested by the laboratory, to which it is sent, is the one taken from the animal in question, its integrity is preserved and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications for the sole purpose of protecting the health of the animal shall be administered by a licensed veterinarian.
- 5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or

similar substance) which could affect the animal's performance or alter its natural contour, confirmation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.

- 6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- 7. Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
- 8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.
- 9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
- 10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expos and any special notices to members.
- 11. The act of entering of an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

# **Junior Show Rules**

RULES FOR JUNIOR EXHIBITORS: In addition to the General Rules and Regulations and Livestock Entry Rules printed in this Handbook, the following requirements will be in effect for junior exhibitors. A. ENTRIES

- - 1. Entry deadline is June 15. Entries must be submitted no later than midnight on this day. LATE ENTRIES ACCEPTED UPON PAYMENT OF PENALTY FEES.
  - 2. A parent or legal guardian must sign the official Fair entry form to certify that the exhibitor has owned and cared for animals since June 1 or as required by specific division rules. Any entries determined invalid will be returned. No refund will be made.
  - 3. Junior shows are open to all youth who are 8 years of age as of January 1, but not over 21 years of age as of January 1. Entries from in-state and out-of-state exhibitors will be accepted in the junior shows of all OEF divisions with the exception of the Gold Buckle Extravaganza and the Supreme Beef Heifer Show. To be eligible for the Gold Buckle Extravaganza and the Supreme Heifer Drive, the exhibitor's primary residence must be in one of the following counties: Barry, Barton, Bates, Benton, Camden, Cedar, Christian, Dade, Dallas, Douglas, Greene, Henry, Hickory, Howell, Jasper, Laclede, Lawrence, McDonald, Miller, Morgan, Newton, Ozark, Polk, Pulaski, St. Clair, Stone, Taney, Texas, Vernon, Webster and Wright. Breeding beef entries outside of the counties listed above will be accepted for the junior show and are eligible to compete for grand and reserve grand champion, but they will not be eligible to compete in the Supreme Drive. Should entries from outside of the counties listed above be selected as grand champion and/or reserve grand champion in a breed, a grand and/or reserve grand champion will be selected from the southwest region that represents the counties listed as eligible to represent such breed in the Supreme Drive. There is

no cap on the number of breeding beef divisions a junior exhibitor may show in or how many entries they can qualify to compete in the Supreme Drive. However, an exhibitor will only be eligible for one premium in the Supreme Drive. Heifers will be picked until five different exhibitors have been selected to pay premiums. For example, an exhibitor could win Supreme, Third and Fifth but will only be paid for Supreme and additional six, seven, eight or more heifers may have to be selected to find the five exhibitors to pay.

- 4. In order for a beef division to be eligible for the Supreme Drive and Bred & Owned Awards, a \$500 contribution will be required of each breed. This payment is due in the OEF Livestock office on or prior to June 15. The \$500 will be distributed as follows: \$250 will be awarded to the breed grand champion and \$250 will be awarded to the breed's bred and owned grand champion. Breed grand champions must be shown in the Supreme Drive in order to receive the \$250 award. Otherwise the award will be presented to the reserve breed champion. Should a breed's grand champion be selected as a top five female, \$250 will NOT be awarded on top of the supreme winnings. Any exhibitor who resides in the state of Missouri will be eligible for the bred and owned award, but will not be eligible for the Supreme Drive unless primary residence is in one of the counties listed in #3 above. A breed may elect to contribute \$250 to the bred & owned grand champion and not the \$250 for the breed grand champion and vice versa. However, breeds who elect not to contribute funds to the breed grand champion will not be permitted to compete in the Supreme Drive. The \$250 bred & owned or supreme awards will not be presented unless sponsored.
- 5. Gold Buckle Extravaganza entries will only be accepted from exhibitors who are 8 years of age as of January 1, but not over 21 years of age as of January 1, and whose primary residence is in one of the following counties: Barry, Barton, Bates, Benton, Camden, Cedar, Christian, Dade, Dallas, Douglas, Greene, Henry, Hickory, Howell, Jasper, Laclede, Lawrence, McDonald, Miller, Morgan, Newton, Ozark, Polk, Pulaski, St. Clair, Stone, Taney, Texas, Vernon, Webster and Wright. Entries from exhibitors outside of these counties will not be accepted. All information as requested on the entry form must be supplied or entry will not be accepted. Management reserves the right to split any class (based on entries) by age or weight of animals.

#### **B. OWNERSHIP**

- 1. All entries must be the property of the exhibitor. Breeding Beef and Dairy animals must be registered in exhibitor's name as of June 1, 2024. Breeding Swine, Sheep and Goats must be registered in exhibitor's name as of July 1, 2024. Market animals must be owned by the required deadline. See Division Rules. Poultry and Rabbits must be owned by July 1
- 2. Partnership Livestock Junior Exhibitors: Junior exhibitors may own livestock in partnership with other junior exhibitors who are immediate (brother/sister) family members and in the case of breeding livestock may have them registered jointly with the exception of Junior Dairy Cattle exhibitors. See Junior Dairy Cattle rules for explanation. Each member may show the same number of head, as if they were individually owned; however, fair entries should identify which animals are to be shown by each exhibitor. The exhibitor's name must be on the registration papers.
- 3. Bred & Owned: Exhibitor must be listed as breeder and only owner on original registration certificate to qualify for Bred & Owned division. C. COMPETITION
  - 1. Junior exhibitors are advised to refer to the "Show Ring Code of Ethics" section under Livestock Entry Rules regarding unethical fitting and handling practices.
  - 2. Junior exhibitors will show together except as designated.
  - 3. Exhibitors may not show more than two animals in an individual class.
  - Junior exhibitors must show their own animals. If a member has more than one entry in a class, it must be shown by another junior exhibitor.
  - 5. In the case of an illness or the junior exhibitor's inability to show the animal, a direct sibling, of junior age, OR a member of the same 4-H or FFA chapter can take the place of the junior owner. The premium money will still be sent directly to the original exhibitor that owns said animal.
  - 6. Exhibitors in junior livestock shows will be required to wear a special t-shirt. The t-shirt must be worn into the show ring. Noncompliance will result in disqualification from the show. T-shirts may be obtained after arrival on grounds. Please state t-shirt size on entry form. Extra t-shirts may be purchased on the entry form. The tshirt will be provided by fair and livestock sponsors.
  - 7. All participants in Junior Showmanship classes must have pre-entered and exhibited in the 2024 Ozark Empire Fair Junior Show. Showmanship must be in the species the exhibitor showed in regular classes.
  - 8. \$10 entry fee for Jackpot Showmanship for swine, beef and all Gold

Buckle Extravaganza junior exhibitors. You must pre-register online before check-in and the top three showman in each age division will receive a percentage of the payout. Every species first place showman in each age division will receive one banner.

- 9. Every precaution will be taken to protect exhibits, but the Fair will not be responsible for loss or damage to exhibits.
- 10. Animals must be fed, cared for and exhibited at the Fair by the exhibitor under the supervision of a parent or legal guardian. Excusing a member from personally exhibiting his/ her animal(s) defeats one of the important objectives of livestock projects. Hence, management does not approve substitute showmen except in extreme cases. In approved emergency cases, another junior member may assume these duties. In this instance, the Livestock Office should be notified prior to the show.
- 11. Rowdy conduct while on the Fairgrounds will not be tolerated. Junior exhibitors shall not loiter in the barns away from the area of their own exhibit between 10 p.m. and daylight. Superintendents shall release said exhibitors and request their immediate removal from the grounds for rowdy conduct such as removing, stealing, destroying or damaging any property not belonging to them. They shall forfeit all prize money and will be barred from any future shows.

Junior entries will NOT automatically be entered into their respective open division class at time of entry. Exhibitors must enter both junior and respective open class. No Refunds will be issued for withdrawing from the Open Show. Livestock office staff will try their best to catch entries that did not get entered into the open divisions. If they are not entered into the open division along with the junior division, the exhibitor will be called and will be requested to pay the open show entry fee.

- **E. ADMISSION**. Each exhibitor is to purchase all tickets on the online entry portal. Tickets ordered after entry deadline will be sold at full price. **The tickets do not provide for parking.** Admission tickets and parking passes ordered with entries will be available for pickup when you arrive to the Fair. See Livestock Entry Rule (F).
- F. **JUNIOR PREMIUMS.** Prize money not awarded as cash or check during the Fair will be mailed on or after August 31, 2024 to the address submitted on entry form. All judging will be done on the Straight Placing System and numerically ranking the animals.

# **Animal Health Requirements**

## 2024 Ozark Empire Fair | Springfield, Missouri

#### The following is a summary, and not a reprint of 2 CSR 30-2.040 Animal Health Requirements for Exhibition Regulations. Contact the Missouri State Veterinarian's office at (573) 751-7359 for clarification on the following. Effective Dec. 30, 2023.

PURPOSE: This rule revises and clarifies Missouri's regulations on intrastate and interstate requirements for exhibition.

- 1. Animals with active lesions of ringworm with resulting loss of hair or warts easily visible without close examination will not be permitted to exhibit and shall be subject to isolation or expulsion depending upon the nature and seriousness of the disease.
- 2. Scheduled breed association sales with shows in conjunction with the sales must employ accredited veterinarians other than state regulatory personnel for examining animals and processing Certificate of Veterinary Inspections (CVI) upon change of ownership.
- 3. The listed minimal health and testing requirements on livestock are for exhibition only and do not qualify livestock to be sold or moved to a new owner or destination.
- Exhibition Requirements for Cattle, Bison, and Exotic Bovids.

   (A) Intrastate (Missouri origin cattle and bison moving for exhibition only).
  - 1. A CVI is required.

2. All animals must be individually identified by an official ear tag as defined by official identification, or registration tattoo, or any other means approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.

- 3. Brucellosis—no test is required.
- 4. Tuberculosis—no test is required.

(B) Interstate (cattle, bison, and exotic bovids entering Missouri for exhibition only).

1. A CVI is required.

2. All animals must be individually identified by an official ear tag as defined by official identification, or registration tattoo, or any other means approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.

- 3. Brucellosis.
  - A. Cattle from brucellosis-free states. No brucellosis test or entry permit is required.

B. Cattle from brucellosis Class A states.

(I) Test-eligible animals include all sexually intact animals eighteen (18) months of age and over.
(II) All test-eligible cattle must be tested and negative within thirty (30) days prior to entry except— (a) Cattle from a certified brucellosis-free herd. The certified herd number and the date of the last test must be listed on the CVI.

(III) Steers. No brucellosis test required but must be individually identified and listed on a CVI.(IV) Rodeo bulls from a Class A state must have a

negative brucellosis test within twelve (12) months prior to exhibition.

4. Tuberculosis.

A. Beef cattle—All classes of beef cattle (including exotic bovids and bison), two (2) months of age and older, entering Missouri for exhibition must meet the following requirements:

(1) All classes of beef cattle entering Missouri for exhibition from a state having a tuberculosis-free status may enter without additional testing requirements or entry permit;

(II) All classes of beef cattle, six (6) months of age and older, entering Missouri for exhibition from a state having a tuberculosis status less than free must meet the following requirements:

(a)Must obtain an entry permit;

(b)Must have a negative tuberculosis test within sixty (60) days of shipment, test date must be listed on the CVI;

(c)Move from an accredited tuberculosis-free herd (herd test date must be listed on the CVI); or (d)Move directly from a herd of origin that has had one

 complete negative herd test within one

 year (date of test must be listed on the CVI).

 B. Dairy—All classes of dairy cattle, two (2) months of age and older, entering Missouri for exhibition must meet the following requirements:

I) Must obtain an entry permit;

(II) All sexually intact dairy cattle six (6) months and older must have a negative tuberculosis test within sixty (60) days of shipment, test date must be listed on the CVI; or

(III) Move from an accredited tuberculosis-free herd (herd test date must be listed on the CVI); or

(IV) Move directly from a herd of origin that has had

- one (1) complete negative herd test within one (1)
- year (date of test must be listed on the CVI). C. Rodeo Livestock.

(I) Rodeo livestock, eighteen (18) months of age and older, must be tested negative for tuberculosis every twelve (12) months and obtain an entry permit prior to entering Missouri.

(II) No sexually intact rodeo stock from Mexico will be permitted to enter Missouri without a negative tuberculosis test within sixty (60) days of shipment (test date must be listed on the CVI).

Exhibition Requirements for Swine.

5.

- (A) Intrastate (Missouri origin swine moving for exhibition only).
   1. A CVI is required.
  - 2. All swine must be individually identified by official ear tag as defined by official identification, or ear notch, tattoo, or any other means of permanent identification approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.
  - 3. Brucellosis. No test is required.
  - 4. Pseudorabies. No test is required.

(B) Interstate (swine entering Missouri for exhibition only).

- 1. A CVI is required.
- 2. All swine must be individually identified by official ear tag as defined by official identification, or ear notch, tattoo, or any other means of permanent identification approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.
- 3. An entry permit is required.
- 4. Brucellosis.
  - A. Swine originating from brucellosis-free states may exhibit without a brucellosis test.
  - B. Swine originating from a state having a brucellosis status less than free must be tested negative within sixty (60) days prior to exhibition except— (I) Breeding swine from a validated brucellosis-free herd. The validated herd number and date of last validating test must be listed on the CVI.
- 5. Pseudorabies.
  - A. Swine originating from a state classified as Stage V in the National Pseudorabies (PRV) Eradication Plan may exhibit without a pseudorabies test.
  - B. All other swine must be tested negative within sixty (60) days prior to exhibition except— (I) Swine from a qualified pseudorabies-free herd. The qualified herd number and date of the last qualifying test.
- 6. Exhibition Requirements for Equidae (including exotic equine, donkeys, asses, burros, and zebras).
  - (A) Intrastate (Missouri origin horses and other equidae moving for exhibition).
    - Equidae must be free of clinical signs of an infectious or contagious disease. Any equidae showing signs of infectious or contagious disease at an exhibition shall be excused by the official inspecting veterinarian. When an official inspecting veterinarian is present, all equidae will be subject to daily inspection.
    - 2. A CVI is not required.
    - 3. All equidae (except nursing foals accompanied by their dams) must be accompanied by a current VS Form 10-11 or any officially recognized federal/state Equine Infectious Anemia (EIA) test chart showing test date

within twelve (12) months prior to exhibition for each animal, the name of the EIA accredited testing laboratory and the test accession number assigned by the laboratory, the graphic description of all markings needed for identification, or microchip, or legible tattoo, or unique registered brand or imprinted photograph on any officially recognized federal/state EIA test chart. An electronically generated copy of the VS Form 10-11 or any officially recognized federal/state EIA test chart may be accepted for the purpose of exhibition.

A. Alteration or substitution of any information on any VS Form 10-11 or any officially recognized federal/state EIA test chart, including electronically generated copy, or CVI shall cause the document to be invalid and in violation of sections 267.010 to 267.730, RSMo, and may result in civil penalties not to exceed ten thousand dollars (\$10,000) per violation and subject to expulsion.

(B) Interstate (including exotic equine, donkeys, asses, burros, and zebras).

- Equidae must be free of clinical signs of an infectious or contagious disease. Any equidae showing signs of infectious or contagious diseases at an exhibition shall be excused by the official inspecting veterinarian. When an official inspecting veterinarian is present, all equidae will be subject to daily inspection.
- 2. A CVI is required on all equidae (except nursing foals accompanied by their dams) showing identification and description of equidae listed and negative test results of an official EIA test, showing test date within twelve (12) months prior to exhibition for each animal, and the name of the EIA accredited testing laboratory and the test accession number assigned by the laboratory. All equidae entering without an official CVI and/or EIA test shall be excused from the show until proper documentation and test are available.
- 3. All equidae (except nursing foals accompanied by their dams) must be accompanied by a current VS Form 10-11 or any officially recognized federal/ state EIA test chart showing test date within twelve (12) months prior to exhibition for each animal, the name of the EIA accredited testing laboratory and the test accession number assigned by the laboratory, the graphic description of all markings needed for identification or microchip, or legible tattoo, or unique registered brand or imprinted photograph on any officially recognized federal/ state EIA test chart. An electronically generated copy of the VS Form 10-11 or any officially recognized federal/state EIA test chart may be accepted for the purpose of exhibition. A. Alteration or substitution of any information on any VS Form 10-11 or any officially recognized federal/state EIA test chart, including electronically generated copy, or CVI shall cause the document to be invalid and in violation of sections 267.010 to 267.730, RSMo, and may result in civil penalties not to exceed ten thousand dollars (\$10,000) per violation and subject to expulsion.
- 4. A six- (6-) month passport from states with which there is a reciprocal agreement will be accepted in lieu of a CVI. These passports must have record of a negative EIA test within thirty (30) days of the date of application of the passport and permanent identification for each horse recorded on the passport and the VS Form 10-11 or any officially recognized federal/state EIA test chart, along with other identifying characteristics. In the event of confirmed vesicular stomatitis in any of the states with which reciprocal agreements exist, use of the six- (6-) month passport will be immediately suspended by the state veterinarian of Missouri.

- Venezuelan Equine Encephalomyelitis (VEE) vaccination and entry permit is required prior to entry on equidae originating from states in which VEE has been diagnosed within the preceding twelve (12) months.
- 6. The board, organization, or manager of each assembly or event is responsible for certifying that all equidae admitted or participating meet the regulations in this section and shall not admit or allow participation of equidae not so certified. Untested equidae shall not be allowed to congregate with other equidae. The owner of each animal shall comply with requirements under sections 267.010 to 267.730, RSMo, and may be assessed civil penalties not to exceed ten thousand dollars (\$10,000) for each violation.
- Exhibition Requirements for Sheep (including exotic sheep and antelope).
  - (A) Intrastate—Missouri origin sheep (including exotic sheep and antelope) moving for exhibition.
    - All sheep (including exotic sheep and antelope), regardless of age or sex, must be free of clinical signs of an infectious or contagious disease.
    - 2. All sheep (including exotic sheep and antelope), regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification, or any other means of permanent identification approved by the state veterinarian identifying them to the flock of origin and be listed on a CVI.
    - 3. No tests are required.
    - 4. Scabies.
      - A. Sheep from a scabies quarantined area must be dipped or treated by an officially approved method within ten (10) days prior to exhibition.

(B) Interstate—Sheep (including exotic sheep and antelope) entering Missouri for exhibition only.

- 1. All sheep (including exotic sheep and antelope), regardless of age or sex, must be free of clinical signs of an infectious or contagious disease.
- All sheep (including exotic sheep and antelope), regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification or any other means of permanent identification approved by the state veterinarian identifying them to the flock of origin and be listed on a CVI.
- 3. All rams six (6) months of age and older must have a negative Brucella ovis test within thirty (30) days of shipment (test date, results, and name of approved laboratory must be listed on the CVI).
  - A. Move from a certified Brucella ovis free flock (must be accompanied by the certificate number and date of last test).
- 4. Scabies

A. Sheep (including exotic sheep and antelope) from a scabies quarantined area must be dipped or treated by an officially approved method within ten (10) days prior to exhibition.

B. A permit number must be obtained and recorded on a CVI if the sheep (including exotic sheep and antelope) are from a scabies quarantined area.

- 8. Exhibition Requirements for Goats (including exotic goats).
  - (A) Intrastate—Missouri origin goats (including exotic goats) moving for exhibition only.
    - All goats (including exotic goats), regardless of age or sex, must be free of clinical signs of an infectious or conta@gious disease.
    - 2. All goats (including exotic goats), regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification or any other means of permanent

identification approved by the state veterinarian identifying them to the herd of origin and listed on a CVI.

(B) Interstate—Goats (including exotic goats) entering Missouri for exhibition only.

- All goats (including exotic goats), regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification or any other means of permanent identification approved by the state vet@erinarian identifying them to the herd of origin and listed on a CVI.

## Exhibition Requirements for Poultry.

- (A) Intrastate (Missouri origin poultry moving for
  - exhibition).
  - 1. All poultry must be free of clinical signs of any infectious or contagious disease.
  - 2. No CVI is required.
  - Pullorum-typhoid. All poultry exhibited (except Missouri origin waterfowl) shall be tested negative for pullorum-typhoid within ninety (90) days prior to exhibition or equivalent program in which the flock has been tested within the past twelve (12) months with no change of ownership. This information shall be documented on a VS Form 9-2 (see 2 CSR 30-8.020) or similar certificate which shall accompany the poultry to the exhibition and shall be made available on request.

(B) Interstate (poultry entering Missouri for exhibition only).

- All poultry must be free of clinical signs of any infecItious or contagious disease.
- 2. A CVI, VS Form 9-2 or similar certificate is required.
- 3. Pullorum-typhoid test. All poultry exhibited shall be tested negative for pullorum-typhoid within ninety (90) days prior to exhibition or originate from a flock approved by the National Poultry Improvement Plan (NPIP) or an equivalent program in which the flock has been tested within the past twelve (12) months with no change of ownership. This infor@mation shall be documented on a CVI, a VS Form 9-2 (see 2 CSR 30-8.020), or similar certificate which shall accompany the poultry to exhibition and shall be made available on request.
- 4. An entry permit is required. (C) Requirements for sponsoring exhibitions for poultry.
  - 1. An official representing the person or organization sponsoring any poultry exhibition shall notify the state veterinarian no later than thirty (30) days prior to the exhibition giving the names, place, inclusive dates, and times of the event.
  - 2. Recordkeeping. The sponsor of the exhibition shall compile a list of all poultry present at the exhibition. The list shall contain the name and address or voluntary premises identification number of each owner and the number, species, breed, variety, type, sex, and pullorum-typhoid status of all poultry present. A copy of this list shall be retained by the sponsor of the exhibition for at least twelve (12) months and shall be made available upon request to a representative of the department.
  - 3. Inspection. Poultry must be free of clinical signs of any infectious or

contagious disease. Any poultry showing signs of infectious or contagious disease at an exhibition may be excused by the official inspecting veterinarian or department representative. 4. Pullorumtyphoid status. All poultry (except Missouri origin waterfowl) exhibited shall be tested negative for pullo 2 rumtyphoid within the past ninety (90) days or originate from a flock approved by the NPIP or equivalent program in which the flock has been tested within the past twelve (12) months with no change of ownership. This information shall be documented on a VS Form 9-2 (see 2 CSR 30-8.020) or similar certificate which shall be made available on request.

- 10. Exhibition Requirements for Captive Cervids.
  - (A) Intrastate (Missouri origin captive cervids moving for exhibition only).
    - All captive cervids must be accompanied by a CVI or a Breeder's Movement Certificate and individually identified with two (2) forms of identification, with one (1) being an official ear tag as defined by official identification, or any other means of permanent identification approved by the state veterinarian, must not commingle with other animals, and must be individually listed on a CVI or Breeder's Movement Certificate.
      - Breeder's Movement Certificate. A Α. form provided by the Missouri Department of Agriculture (MDA) which documents the movement of cervids within Missouri and may be completed by the breeder and must list the official identification, age, sex, species of the cervids moving within Missouri, and a complete address of the farm of origin and destination. The form will also list any required testing and Chronic Wasting Disease status of the herd of origin. The original will accompany the shipment, and a copy will be submitted to the MDA within thirty (30) days of movement.
    - 2. Chronic Wasting Disease (CWD).
      - A. All CWD susceptible cervids over one (1) year of age must be enrolled in a CWD program sponsored by the Missouri Department of Agriculture. Original anniversary date must be listed on the CVI. All CWD susceptible cervids must have a CWD Status Level of 1 to move within Missouri.
      - B. Fallow deer must have documentation of a current annual inspection conducted by an accredited veterinarian and record of current inventory, except fallow deer that have contact with susceptible species must be enrolled in a CWD program sponsored by the Missouri Department of Agriculture.

(B) Interstate (captive cervids entering Missouri for exhibition only).

 All captive cervids must be accompanied by a CVI and individually identified with two (2) forms of identification, with one (1) being an official ear tag as defined by official identification, or any other means of permanent identification approved by the state veterinarian, must not commingle with other animals and must be individually listed on a CVI.
 An entry permit is required. 3.Brucellosis requirements. No testing is required, except— A. No cervidae from the Greater
Yellowstone Area or Ecosystem, or any brucellosis surveillance area will be allowed to enter Missouri
4. Tuberculosis.

- A. Captive cervids—Less than six (6) months of age, not known to be affected or exposed to tuberculosis and not in a status herd must have one (1) negative tuberculosis test, using the single cervical method or Dual Path Platform (DPP) test, within ninety (90) days prior to entering Missouri. The negative test date must be listed on the CVI. Captive cervids must have been isolated from other captive cervids during the testing period.
- B. Captive cervids, six (6) months of age and older, not known to be affected or exposed to tuberculosis and not in a status herd must have two (2) negative tuberculosis tests, not less than ninety (90) days apart, using the single cervical method or DPP test prior to entering Missouri for exhibition. The second test must be within ninety (90) days prior to exhibition. Both negative test dates must be listed on the CVI. Captive cervids must have been isolated from other captive cervids during the testing period.
- C. Movement from tuberculosis status herds.
  (I) Accredited herd—Captive cervids originating from an accredited tuberculosis -free cervid herd may enter on herd status without additional testing provided the accredited herd number and current test date is listed on the CVI.
  (II) Qualified herd—Captive cervids originating from a qualified herd must have one (1) negative tuberculosis test, using the single cervical method, within ninety (90) days prior to the date of

exhibition. (III) Monitored herd—Captive cervids originating from a monitored herd must have one (1) negative tuberculosis test, using the single cervical method, within ninety (90) days prior to the date of movement.

(IV) Captive cervids less than twelve (12) months of age born within and originating from a status herd may be moved without further testing provided that they have not been exposed to captive cervids from a lower status herd.

- 5. Chronic wasting disease.
  - A. Captive cervids will not be allowed to enter the state if, within the last five (5) years, the animal— (I) Originates from an area or has been in an area that has been reported as a CWD endemic area; and (II) Originates from a CWD positive captive herd.
  - B. CWD susceptible cervids entering Missouri from any state must have participated in a CWD certification program for five (5) consecutive years. Original anniversary date must be listed on the CVI.
  - C. Fallow deer entering Missouri from any state must have documentation of a current annual inspection conducted by an accredited veterinarian and record of current inventory, except fallow deer that have contact with susceptible species must meet the CWD certification program requirements.

- D. Captive cervids moving between publicly owned Association of Zoos and Aquariums (AZA) accredited zoos must meet the CWD certification program requirements. (11) Exhibition Requirements for Alpacas, Camels, and Llamas.
- (A) Intrastate (Missouri origin alpacas, camels, llamas, and other camelids moving for exhibition).
  - All alpacas, camels, llamas, and other camelids must be free of clinical signs of infectious or contagious disease.
  - 2. No CVI is required.
- (B) Interstate (alpacas, camels, llamas, and other camelids entering Missouri for exhibition only).
  - All alpacas, camels, llamas, and other camelids must be free of clinical signs of infectious or contagious diseases.
  - 2. All alpacas, camels, llamas, and other camelids must be accompanied by an official CVI showing an individual listing of the common name(s) of the animal(s) such as sex, age, weight, coloration, and the official ear tag as defined by official identification, microchip, tattoo, or any other means of permanent identification approved by the state veterinarian.
  - 3. No test is required.
  - 4. No permit is required. (12) Exhibition
  - Requirements for Ratites.
- (A) Intrastate.
  - Ratites (including but not limited to ostrich, rheas, and emus) must be veterinarian inspected and individually identified as defined, or by leg band, microchip, wing band, legible tattoo, or any other means approved by the state veterinarian and listed on the CVI.
- (B) Interstate.
  - Ratites (including but not limited to ostrich, rheas, and emus) must be veterinarian inspected and individually identified as defined, or by leg band, microchip, wing band, legible tattoo, or any other means approved by the state veterinarian and listed on the CVI.
  - 2. No test is required.
- 13. Exhibition Requirements for Dogs and Cats.

 (A) Intrastate (Missouri origin dogs and cats moving for exhibition).

- Dogs and cats must be free of clinical signs of infectious or contagious disease.
- No CVI is required.
- Dogs and cats, four (4) months of age and 3. older, must be vaccinated for rabies by one (1) of the methods and within the time period published in the March 1, 2016 edition of the Compendium of Animal Rabies Vaccines by the National Association of State Public Health Veterinarians, Inc., incorporated by reference and made a part of this rule, as published by the United States Government Publishing Office, 732 N. Capital Street NW, Washington, DC 20402-0001, phone: toll free (866) 512-1800, DC area (202) 512-1800, website: http://bookstore.gpo.gov. This rule does not incorporate any subsequent amendments or additions.

(B) Interstate (dogs and cats entering Missouri for exhibition only).

- 1. Dogs and cats must be free of clinical signs of infectious or contagious disease.
- 2. A CVI is required.
- All dogs and cats, four (4) months of age and older, must be vaccinated for rabies by one (1) of the methods and within the time period published in the March 1, 2016 edition of the Compendium of Animal Rabies Vaccines by the

(B) Interstate (miscellaneous animals entering Missouri for exhibition only).

- 1. All miscellaneous animals must be free of clinical signs of any infectious or contagious disease.
- 2. A CVI is required showing an individual listing of the common name(s) of the animal(s) and appropriate descriptions of animal(s) such as sex, age, weight, coloration, and must be individually identified as defined, or by any other means approved by the state veterinarian and listed on the CVI.
- 3. Exhibition and importation of wildlife into Missouri is regulated by the Missouri Wildlife Code 3 CSR 10-9. Exhibition and importation into Missouri of certain wildlife species is prohibited or may require a permit.
- 15. Exhibition Requirements for Exotic Animals.
  - (A) Intrastate (Missouri origin exotic animals moving for exhibition only).
    - A CVI is required showing an individual listing of the scientific and/or common name(s) of the animal(s), appropriate descriptions of animal(s) such as sex, age, weight, coloration, and must be individually identified as defined by official identification or any other means approved by the state veterinarian and listed on the CVI.
    - 2. Elephants (Asiatic, African) and non-human primates must be tested negative for tuberculosis within one (1) year prior to exhibition.
    - 3. No tests are required for animals moving between publicly owned Association of Zoos and Aquariums (AZA) accredited zoos, except cervids moving between publicly owned (AZA) accredited zoos must meet the chronic wasting disease monitoring requirements as outlined in section (10).
    - Exhibition and movement of wildlife within Missouri is regulated by the Missouri Wildlife Code 3 CSR 10-9. Exhibition of certain wildlife species is prohibited or may require a permit.

(B) Interstate (exotic animals entering Missouri for exhibition only).

- 1. All exotic animals must be free of clinical signs of any infectious or contagious disease.
- 2. A CVI is required showing an individual listing of the scientific and/or common name(s) of the animal(s), appropriate descriptions of animal(s) such as sex, age, weight, coloration, and must be individually identified as defined by official identification, or any other means approved by the state veterinarian and listed on the CVI.
- 3. Elephants (Asiatic and African) and non-human primates must be tested negative for

tuberculosis within one (1) year prior to exhibition.

- 4. No tests are required for animals moving between publicly owned Association of Zoos and Aquariums (AZA) accredited zoos, but shipment must be accompanied by a CVI. Cervids moving between publicly owned AZA accredited zoos must meet the CWD monitoring requirements as outlined in section (10). An entry permit is required on all animals moving between publicly owned AZA accredited zoos.
- 5. Exhibition and importation of wildlife into Missouri is regulated by the Missouri Wildlife Code 3 CSR 10-9. Exhibition and importation into Missouri of certain wildlife species is prohibited or may require a permit.
