The Grand Champion Market Beef will sell for a minimum of \$7,000. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

The Reserve Grand Champion Beef will sell for a minimum of \$4,000. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

The remaining top six market steers will sell at a minimum of \$2,000. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

### **MARKET LAMBS:**

The Grand Champion Market Lamb will sell for a minimum of \$1,000. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

The Reserve Grand Champion Lamb will sell for a minimum of \$500. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

The third place lamb will sell at a minimum of \$250. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

### **MARKET SWINE:**

The Grand Champion Market Hog will sell for a minimum of \$1,000. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

The Reserve Grand Champion Barrow will sell for a minimum of \$500. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

The third place barrow will sell at a minimum of \$250. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

### **MARKET GOATS:**

The Grand Champion Market Goat will sell for a minimum of \$1,000. The exhibitor will receive 75% of the total selling price in cash, the remaining 25% will go to the Ozark Empire Fair Foundation.

The Reserve Grand Champion Market Meat Goat will sell for a minimum of \$500. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

The third place wether will sell at a minimum of \$250. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

### **MARKET BROILERS:**

The Grand Champion Broilers will sell for a minimum of \$200. The Reserve Grand Champion Broilers will sell for a minimum of \$100. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

### **HAMS:**

The top four hams (Junior & Senior Grand and Reserve Grand Champions) will sell for a minimum of \$100 each. The exhibitor will receive 75% of the total selling price in cash. The remaining 25% will go to the Ozark Empire Fair Foundation.

**EXHIBITOR DRESS:** Black jeans; white, collared, long-sleeve shirt; and black show harness. Tie is optional. Only western boots or dark leather shoes allowed. No hats or caps allowed.

**EXHIBITOR CONDUCT:** All exhibitors must conduct themselves in a manner fitting to the occasion. All portions of the Show Ring Code of Ethics and Conduct apply. Purpose of this event is to showcase youth in agriculture to an urban society and raise funds for the Ozark Empire Fair Foundation which will benefit the facilities and programs of the Fair as well as provide additional funds for grants and scholarships. The Ozark Empire Fair reserves the right to remove any exhibitor, family member or friend of an exhibitor who acts in any way unbecoming to the event.

**ANIMAL CONDUCT:** Animals must be calm, and under control at all times. The sale ring will be surrounded with dining tables, with gala guests and spectators. If an animal shows behavior unfit for the event, the animal may be removed from the event and dropped from the sale order.

**CERTIFIED VET INSPECTION:** All animals must be accompanied by a CVI completed by the animal's vet, along with their Health Quality Assurance form. All health requirements outlined by the state of Missouri for animal exhibitions need to be followed.

## **Add-on Money To Be Accepted: 2026 Gold Buckle Gala**

Add-on money will be accepted for animals sold in the Gold Buckle Gala. All add-ons that are collected (money received) by the exhibitor prior to 3 p.m. on Saturday will be retained 100% by the exhibitor. Any add-on to be invoiced or received after 3 p.m. on Saturday will be split 75/25. Seventy-five percent will go to the junior exhibitor and twenty-five percent will be retained by the Ozark Empire Fair Foundation.

This is a **TERMINAL SHOW** for the **Top 3 Market Swine**. The **Top 3 Market Swine** will be sold in the **Gold Buckle Gala Auction** on **Saturday, July 25**. The **Ozark Empire Fair** will assume custody of the **Top 3 Barrows** following the **Gold Buckle Gala Auction**. The **barrows** will be loaded onto trailers immediately following the **Gala Auction** to be processed for the buyers.

**Ozark Empire Fair Rules, Livestock Entry Rules, Junior Show Rules and all portions of the Show Ring Code of Ethics and Conduct apply.**

**ELIGIBILITY:** Entries will only be accepted from exhibitors who are 8 years of age as of January 1, but not over 21 years of age as of January 1, and whose primary residence is in one of the following counties: Barry, Barton, Bates, Benton, Camden, Cedar, Christian, Dade, Dallas, Douglas, Greene, Henry, Hickory, Howell, Jasper, Laclede, Lawrence, McDonald, Miller, Morgan, Newton, Ozark, Polk, Pulaski, St. Clair, Stone, Taney, Texas, Vernon, Webster and Wright. Entries from exhibitors outside of these counties will not be accepted.

**NOMINATION & ENTRY:** Exhibitors may nominate Barrows for the show by submitting a DNA sample(s) to the Ozark Empire Fair Livestock Office by May 15. A processing fee of \$10 per head must accompany the DNA sample and is nonrefundable. **Full ownership of the animal must be established by May 15.** An exhibitor may nominate five (5) barrows, but may only show two (2) barrows. Only one (1) barrow per exhibitor will be allowed in the Gala Auction.

**NOMINATION DOES NOT REPRESENT AN ENTRY.**

**All barrows must also be entered into the Ozark Empire Fair on an official entry form with all fees paid as designated on the entry.**

**Entry Fee is \$20. ENTRY DEADLINE IS JUNE 15.**

**LATE ENTRY FEE IS \$20 + A LATE ENTRY FEE OF \$20 FOR A TOTAL OF \$40 PER ENTRY, ENTERED BY JULY 1.**

The exhibitor's legal guardian **must** sign the official Fair entry form. Any entries determined invalid will be returned. No refund will be made.

**HEALTH QUALITY ASSURANCE:** Each exhibitor will be required to maintain a Health Quality Assurance record on each entry up until the time of exhibition at the Ozark Empire Fair. This form will include all past history on the barrow as can best be determined from the time the exhibitor took ownership of the animal, as well as any veterinary treatments administered to the barrow up until exhibition. This form must be completed and submitted upon check-in at the Fairgrounds. **All exhibitors must hold a quality assurance certificate for at least one of the four species (beef, swine, lamb, goat) represented at the Gold Buckle Extravaganza.** Certification does not have to be for the same species exhibited. All state recognized programs will be accepted, including Show Me Quality Assurance. **Quality Assurance Certificate must be submitted to the livestock office with a postmark date no later than June 15.**

**EARTAGS:** Barrows must be identified with an OEF numbered tag provided in the nomination packet. Animals must be individually identified with the tag provided in your DNA packet. The identification on the DNA card must exactly match the identification on the animal(s) entered. Any discrepancies at weigh-in will be the responsibility of the exhibitor and the animal may be disqualified from the show. Should additional DNA testing be allowed (only if approved by show officials and determined on an individual basis), the cost to the exhibitor will be \$150 payable immediately by cash or credit card only.

**CHECK-IN:** Upon arrival on the Fairgrounds, barrows will be weighed to determine classes. **Swine must weigh between 220 and 300 pounds. Absolutely NO leniency will be made on weight.** Barrows will be weighed only once. Underweight and overweight hogs will show in separate classes before judging of eligible hogs. Underweight and overweight hogs are not eligible for Gold Buckle Gala Auction or to show for Champions. Barrows must have been farrowed on or after December 1, 2025. The Ozark Empire Fair reserves the right to take DNA, urine, blood and tissue samples on any and all animals. Stalls will be assigned by superintendents.

**FITTING AND GROOMING:** See Section L (Show Ring Code of Ethics and Conduct) under Livestock Rules found in Administration and General Rules.

**SHOW PROCEDURE:** Ozark Empire Fair dress code (t-shirts) required. Once class winners are selected, any exhibitor that does not want to sell his/her animal and relinquish all ownership rights, may drop out of the competition. Exhibitors must declare their intent to participate in the selection of the top 3 barrows once their class is over. Once exhibitors enter the ring for the champion drive they will no longer be able to pull out of the show and must sell their animal if selected in the top 3. All animals in the supreme drive must stay in the ring until the alternate is chosen (4th place for small animals and 9th place for Steers).

**ANIMAL IDENTITY DNA TESTING:** As a condition for participation in the Ozark Empire Fair's Gold Buckle Extravaganza, every exhibitor must agree to submit satisfactory DNA validation/registration samples from any and all animals entered by the exhibitor for purposes of identification. DNA samples will be collected on the Top 3 Barrows, Goats, Lambs and the 4th place alternate, and any other barrow(s), goat(s), lamb(s) as well as the Top 8 Steers and the 9<sup>th</sup> place alternate, and any other steer(s) as requested by show officials. "Satisfactory DNA" samples refer to DNA samples of sufficient quality and quantity (as specified on the DNA sample collector) to yield an analyzable genotype when tested. The Ozark Empire Fair requires that the animal exhibited at the Gold Buckle Extravaganza be the same as the animal enrolled at the validation/registration event. The Ozark Empire Fair specifically reserves the right to obtain and maintain hair and/or other DNA samples and have analysis made on any animal entered for the competition. If the exhibitor provides a DNA registration sample that does not conform with the requirements (single animal with hair follicles), then they may be disqualified from the contest. If the animal's identity (Show sample) is found to differ from its validation/registration sample, then the exhibitor may forfeit any prize money and/or sale proceeds and may forfeit all rights and privileges to exhibit in the future at the Gold Buckle Extravaganza, Gold Buckle Gala and the Ozark Empire Fair. The conclusion reached by the testing company/laboratories shall be final, without recourse against the Ozark Empire Fair or its service providers.

**DRUG TESTING:** Any animal exhibited in a market class must meet withdrawal times and be eligible for processing for human consumption at the time of show. Urine, blood, saliva and/or tissue samples may also be taken from any barrow(s) to conduct testing for anabolic steroids, diuretics, caffeine, feed additives or drug residues. A positive test may result in disqualification, forfeiture of any premiums, sale monies and salvage value and may ban the exhibitor, along with immediate family members, from participating in the Ozark Empire Fair for three years. The exhibitor is responsible for the full payment of costs incurred for any positive samples including, but not limited to, the lab fee of \$250.

**SHOWMANSHIP:** A jackpot swine showmanship contest will be held following the swine show. Entry in this showmanship requires pre entry with an entry fee of \$10.00

\* 80% of each entry fee will be jackpotted with three (3) payouts per age division; 45% to First, 35% to second, 20% to Third.

Two winners will be selected from each of the following age divisions: Junior - 12 years and under; Intermediate - 13 to 16 years, and Senior 17 years and over. Winners will qualify for participation in the Round-Robin Showmanship Contest on Saturday, July 25.

**GOLD BUCKLE GALA:** Junior exhibitors with animals qualifying and selling in the Gold Buckle Gala must take their own animal through the sale ring. Animals must remain under the exhibitor's care and expense until sold. All participants in the auction warrant that (1) the carcass of their animal complies with the United States Department of Agriculture Wholesome Meat Act and is fit for human consumption; (2) the carcass of their animal contains no trace or residue of any illegal drug or any other substance not approved for administration to such animal; (3) the carcass of their animal reveals no evidence of any unethical

**ELIGIBILITY:** Entries will only be accepted from exhibitors who are 8 years of age as of January 1, but not over 21 years of age as of January 1, and whose primary residence is in one of the following counties: Barry, Barton, Bates, Benton, Camden, Cedar, Christian, Dade, Dallas, Douglas, Greene, Henry, Hickory, Howell, Jasper, Laclede, Lawrence, McDonald, Miller, Morgan, Newton, Ozark, Polk, Pulaski, St. Clair, Stone, Taney, Texas, Vernon, Webster and Wright. Entries from exhibitors outside of these counties will not be accepted.

1. An entry consists of 4 birds.
2. Exhibitors are allowed two entries in the JR Market Broiler Show.
3. Entry fee is \$5.00 for a pen of 4 birds.
4. Owners are responsible for care of birds prior to judging.
5. There is no weight range for an entry.
6. Only the 4 birds submitted as a pen will be judged as one entry.
7. Judging will begin at 9 a.m. following the 7 a.m. check-in on Thursday, July 23. All entries must be present at that time and remain until time of release.
8. Champion and Reserve pens will sell in the Gold Buckle Gala on Saturday, July 25.
9. Pens will be judged on the following criteria: uniformity, soundness, market value and product.
10. **All broilers should be entered into class Y1700 in the JR Market Broilers Division of the Youth Gold Buckle Extravaganza Market Shows Department.** Entry must be made on an official Ozark Empire Fair Poultry entry form available online at [www.ozarkempirefair.com](http://www.ozarkempirefair.com) or through the online entry process at [www.ozarkempirefair.com](http://www.ozarkempirefair.com).

**Important!** Ordering broilers from the Ozark Empire Fair Livestock Office does not constitute entry into the Gold Buckle Extravaganza Broiler Show. Entry procedures must be followed.

- Broilers losing their wing bands, for whatever reason, will not be allowed to enter the show. Birds with wing bands that show evidence of tampering will be sifted, & the decision of the superintendent is final.
- The superintendent will instruct the judge to disregard wing bruising and damage caused by a wing band.

Entries from exhibitors outside of these counties will not be accepted.

5. A Grand and Reserve Grand Champion will be selected in each the Jr. (ages 8 –12) and Sr. (ages 13 & up) Youth Divisions. Should an exhibitor win Grand Champion, their other entry will not be eligible for Reserve Champion.**

Once class winners are selected, any exhibitor that does not want to sell his/her animal and relinquish all ownership rights, may drop out of the competition. Exhibitors must declare their intent to participate in the selection of the top 3 wethers once their class is over. Once exhibitors enter the ring for the champion drive they will no longer be able to pull out of the show and must sell their animal if selected in the top 3. All animals in the supreme drive must stay in the ring until the alternate is chosen (4th place for small animals and 9th place for Steers).

**DNA SAMPLES:** DNA samples will be collected on the Top 3 wethers and any other wethers as requested by show officials. These samples, along with those submitted in May, will be analyzed. Should DNA samples taken in May, not match those taken during the Fair, exhibitors, parents and guardians may be banned from competing at future Gold Buckle Extravaganzas, Gold Buckle Galas and the Ozark Empire Fair. Additionally, a violation of any published rule may disqualify entries, and premium, sale monies and salvage value will NOT be paid.

**DRUG TESTING:** Any animal exhibited in a market class must meet withdrawal times and be eligible for processing for human consumption at the time of show. Urine, blood, saliva and/or tissue samples may also be taken from any goat(s) to conduct testing for anabolic steroids, diuretics, caffeine, feed additives or drug residues. A positive test may result in disqualification, forfeiture of any premiums, sale monies and salvage value and may ban the exhibitor, along with immediate family members, from participating in the Ozark Empire Fair for three years. The exhibitor is responsible for the full payment of costs incurred for any positive samples including, but not limited to, the lab fee of \$250.

The Ozark Empire Fair will assume custody of the Top 3 Lambs following the Gold Buckle Gala Auction. The lambs will be loaded onto trailers immediately following the Gala auction to be processed.

**Ozark Empire Fair Rules, Livestock Entry Rules, Junior Show Rules and all portions of the Show Ring Code of Ethics and Conduct apply.**

**ELIGIBILITY:** Entries will only be accepted from exhibitors who are 8 years of age as of January 1, but not over 21 years of age as of January 1, and whose primary residence is in one of the following counties: Barry, Barton, Bates, Benton, Camden, Cedar, Christian, Dade, Dallas, Douglas, Greene, Henry, Hickory, Howell, Jasper, Laclède, Lawrence, McDonald, Miller, Morgan, Newton, Ozark, Polk, Pulaski, St. Clair, Stone, Taney, Texas, Vernon, Webster and Wright. Entries from exhibitors outside of these counties will not be accepted.

**NOMINATION & ENTRY:** Exhibitors may nominate wether lambs for the show by submitting a DNA sample(s) to the Ozark Empire Fair Livestock Office by May 15. A processing fee of \$10 per lamb must accompany the DNA sample and is nonrefundable. **Full ownership of the animal must be established by May 15.** An exhibitor may nominate five (5) lambs, but may only show two (2) lambs. Only one (1) lamb per exhibitor will be allowed in the sale. Ewe lambs shown in market classes are not eligible to show in breeding classes.

**NOMINATION DOES NOT REPRESENT AN ENTRY.**

**All lambs must also be entered into the Ozark Empire Fair on an official entry form with all fees paid as designated on the entry.**

**Entry Fee is \$20. ENTRY DEADLINE IS JUNE 15.**

**LATE ENTRY FEE IS \$20 + A LATE ENTRY FEE OF \$20 FOR A TOTAL OF \$40 PER ENTRY, ENTERED BY JULY 1.**

The exhibitor's legal guardian **must** sign the official Fair entry form. Any entries determined invalid will be returned. No refund will be made.

**EARTAGS:** Lambs must be identified with an OEF numbered tag provided in the nomination packet. Animals must be individually identified with the tag provided in your DNA packet. The identification on the DNA card must exactly match the identification on the animal(s) entered. Any discrepancies at weigh-in will be the responsibility of the exhibitor and the animal may be disqualified from the show. Should additional DNA testing be allowed (only if approved by show officials and determined on an individual basis), the cost to the exhibitor will be \$150 payable immediately by cash or credit card only.

**CHECK-IN:** Upon arrival on the Fairgrounds, lambs will be weighed to determine classes. **Lambs must weigh at least 100 lbs. to be eligible.** Absolutely **NO** leniency will be made on weight. Lambs will be weighed only once. Underweight lambs will show in separate classes before judging of eligible lambs. Lambs will also be mouthed. All lamb teeth must be in place. Lambs must be slick sheared from behind ears to hocks within three days prior to check-in. Stalls will be assigned by superintendents.
