This shall include, but is not limited to: 1) The injection, use or administration of any drug that is prohibited by Federal, State or Local Law or any drug that is used in a manner prohibited by Federal, State or Local Law; 2) The injection or internal or external administration of any product or material to an animal for the purpose of deception, including concealing, enhancing, or transforming the true conformation, configuration, color, breed, condition or age; 3) The administration of diuretics, tissue manipulation, surgical removal or attachment, or any other action to otherwise change, conceal, enhance or transform the true conformation or configuration of the animal; 4) Any physical or physiological attempt to alter the natural musculature or weight by use of injections or ingested material not conducive to the continued health of the animal, marketability of carcasses or for deception; 5) drenching.

I certify that the above information is true and correct to the best of my knowledge. I agree to abide by all Ozark Empire Fair Rules as printed in the Livestock Exhibitor's Handbook and also understand that the Ozark Empire Fair reserves the right to obtain, urine, blood and/or tissue samples from this steer to assure the animal complies with acceptable levels for meat producing animals of drugs or foreign substances as determined by the United States Department of Agriculture and/or the Food and Drug Administration. **Any drug found, that is not listed above, whether or not it is within the legal limits, will result in immediate disqualification of the steer, forfeiture of any premiums and/or awards and will ban the exhibitor, along with immediate family members, from participating in the Ozark Empire Fair for three years.**
