REPORT FROM THE PA DEPT. OF AG. - Tracy Barone, Laura England

Tracy reported 2016 capital improvements have been processed. 2017-2018 reimbursements have been processed. 2017-2018 capital improvements priority 1 and 2 have been approved at \$1,134,000. Youth Poster Contest Strength in our Diversity. Friends of the Fair are due 6/1/18. ## REPORT FROM LEGISLATIVE CONSULTANTS. – Andy Goodman

Governor's office Wagner/Mango heavy hitting campaign, currently neck and neck. He is expecting a blue wave in 2018. Republicans will still have a majority both in house and Senate. Expects Wolfe and Redding for the next 4 years. 21 house retirements, 9 running for different offices. Senate 5 running for 2 offices. Expect Wagner and Mango to be at your Fair. Fairs should not have a political preference with \$4M funding. Budge next 2-3 years will expand, property tax changes, sales tax on everything including Fair admission he will keep an eye on this. Election year hard to get property tax change. Regarding the proposed changes to the Fair Act being postponed in 2019 we have won the battle but not the war. Tourism new dollars proposed \$10M. Cruelty to animals and animal exhibitions, no push not moving. Labor Day school starts, teacher union against. Seasonal utilities no bill this session. 2019 \$2 billion deficit, there will be tax changes.

Confederate Flag keeping tabs on working with Rep. Millard. Secretary does not have authority, looking for language, Confederate flag big mistake. There should have been a broad base statement giving to fairs for the restriction, and giving money to fairs applying strings. If we fight tooth and nail what will be proposed next. They must prove in the statue they have the authority to implement this. Why just the confederate flag, why just Fairs. Andy offered to compose a letter to the Secretary. The Secretary indicated he receives a lot of phone calls regarding the flags. Martha motioned to write a letter with regards to our stand, 2<sup>nd</sup> by Roger, carried, copy to Tracy. President Hallstrom indicated the executive officers will review and implement. Showmen support the letter. Discussion this was a result of us not getting on board with the Fair Fund changes. Wages to Tracy, Fair Fund is restricted and should not be coming out of the Fund.
