TREASURER'S REPORT - Harry Reffner

Referring to the Balance Sheet:

Compared to last year we have approximately \$8,000 more in the accounts. However as I will mention in the General Fund we will be at approximately the same as last year.

Convention Account:

Approximately \$700 to be coming will transfer \$33,00 to savings. The trade Show continues to be very profitable, and why the officers Continue during zone meetings stress Fairs to support the exhibitors. General Fund:

Approximately \$10,000 has not been paid for the baking premiums. There is \$6,000 of Fair dues still outstanding.

Savings Account:

Have been transferring from the savings into the general, after the \$33,000 transfer from the Convention account we will be \$7,000 ahead of last year at this time.

Scholarship:

The account is required to keep 2 years scholarship \$12,000 before scholarships can be given. When I first started, that was difficult without asking for donations. As you can see due to contributions we have 4 years available funds for scholarships. Largely due to the spouse program at Convention, however Zone 1 contributions and those from Fairs and individuals have been a factor.

CD accounts:

Due to Federal regulations, I have had to keep 2 CD accounts at another bank. Due to interest rates, they have maintained a slow growth.

John Blaney motioned to accept the treasurer's report, 2nd by Roger Dirlam, carried.

IAFE Zone 1 Conference

The sale of these products doesn't violate our agreements with the fairs. The state of the laws regulating these sorts of things is uncertain at this time and the landscape re: same may change in the near future. Right now, it's an individual fair decision, maybe something each fair should discuss with legal counsel if uncertain.

Fairs

There are 107 fairs in the association; NorthEast and Mountain Springs have been dropped. Fair Dues were \$47,500, with \$6,000 still outstanding.

ATT offensive advertisement

OABA and NICA have emailed containing the offensive advertisement and where to register a complaint.

"The staged scene purports to show a carnival amusement ride, and suggests that our industry employs careless workers, operates decrepit rides, is unconcerned about ride safety and simply leaves town if someone is injured," said Greg Chiecko, president of the Outdoor Amusement Business Association. "Experts who have viewed the ride say it was intentionally doctored by the ad producers to make it appear to be unsafe."
