TREASURER'S REPORT – Harry Reffner Balance Sheet:

Last year at this time our Balance sheet had a balance of \$308,550.94, compared to the current balance we have an increase of approximately \$6,000.

Scholarship Register:

A healthy balance, we can currently can awards for 2020 and 2021. With the canceling of Convention, there will be approximately \$6,000 loss from the spouse program. With the Zoom meetings there has been over \$1,000 loss from the Zone 1 donations.

Savings Register:

1) The savings account is approximately \$1,000 more than compared to last year at this time.

Due to no income from Convention, the savings will be drawn on more than they have been in the past.

Convention Income/Expense

1) \$57,000 was transferred to either the general account or to savings.

General Income/Expense

With COVID our income was impacted, but also our expenses were lower.

 - d) IAFEE expenses were under \$13,400
 - e) Queen Mileage under \$1,500
 - f) Postage under \$750
 - h) Board Meeting Mileage under \$1,900

Fair Poster contest if you still held mail to the office in the Ag building by November 1st, trying something virtual.2019 Capital Improvements working on the grants and their payments, received by late November. Issued automatic extensions through December. 2021 Fair reimbursements if your Fair was canceled or modified everything is on hold we have to wait until bill 1182 passes and is signed.
