MINUTES CONVENTION SURVEY REVIEW MEETING SEPTEMBER 23, 2020 7:00PM ZOOM MEETING

Review of Zoom procedures Sally Nolt called the meeting to order.

Harry reviewed the survey regarding the 2021 Convention. 92 Fairs responded with a return rate of 85%. The survey consisted of 3 sheets. Each was noted. Based on the survey Fairs indicated 236 members would attend, this is compared to 1032 members that attended the 2020 Convention. A decline of 77%. A possible 90 would attend from the Queen program, and 28 from PSSA. Saturday the Coronation ceremony, commencing with a Luncheon of 300. Discussion of 25 in a room, however Hershey indicated the count would be by square footage.

Kevin Bieber reviewed the meeting with Hershey, indicating they realized the disastrous affect if PSACF was charged a cancellation fee.

Discussion followed regarding seminars round tables. Kevin limitation of 25 at a meeting. Has not attempted to schedule speakers, not sure now difficult to obtain them.

Question if Convention canceled, or impossible to hold the Queen program at Hershey how would it be handled. Karen indicated virtually.

Discussion of regular Flu season, increase COVID cases in the area, insurance.
