MINUTES SPRING MEETING APRIL 15, 2021 - 7PM **ZOOM MEETING**

Sam Zaffuto called the meeting to order. Kevin Bieber led the Pledge of Allegiance and Karen Dobson offered prayer.

MINUTES OF FALL AND CONVENTION MEETINGS – Harry Reffner I had asked that minutes from our Fall, and Reorganization be printed down. Harry asked if the minutes would be read. Sally Nolt motioned to suspend the reading of the minutes and approve, 2nd by Roger Dirlam, motion carried.

TREASURER'S REPORT – Harry Reffner

- 1) Balance Sheet
 - Last year at this time our Balance sheet reflected a balance of \$336,393.43 in our 6 accounts. Currently our balance reflects \$278,592.37, approximately a \$57,800 decrease. Due to the lateness of the 2020 reimbursement to the Fairs, I did not issue due notices until the first week of April. Dues for 2021 as the Fair Dues report reflect will be \$47,265, which will reflect a \$10,500 decrease to last year at this time. Due to the low interest rate from our CD01 and its maturity date, I closed it and placed the funds into our Savings account, this can be seen in the two registers.
- 2) Scholarship Register
 - The account continues to maintain a healthy balance with the lack of funds from the Spouse's program from Convention. The current balance of \$24,558 will allow us to fund 6 scholarships in 2021.
- 3) Savings Register
 - Compared to last year this time the Saving accounts reflected a balance of \$215,962, currently \$208,773 an decrease of approximately \$7,000
- 4) General Income/Expense
- a) Due to economic conditions from 2020, we lost 69 associates resulting in a decrease of dues in the amount of \$4,485.

Despite the negative results given to us by the Pandemic, the Association is still financially sound.

I would ask for any questions regarding the reports.

Roger Dirlam motioned to accept the report, John Blaney 2nd, motion carried.

Reopening guidelines - Sam

Our Association and the Showmen's Association collaborated to create a plan to allow for the safe re-opening of the fair industry. It can be found on our Association's website. I trust you have all seen it and read it.

We worked with Milliron and Goodman and the Showmen's Association. I'd like to thank Jeff Good, president of the Showmen's Association; Kerry Lange from Milliron and Goodman; and from the Pa Dept of Agriculture thanks to Tracy Barone, Cheryl Cook, and Laura England for their help and support.

The plan highlights the **mandatory** requirements set forth for large outdoor events by the state of Pennsylvania and also presents "best practices" fairs should follow to help stop the spread of COVID-19. We have been told that the state will not issue separate guidance for fair events, which is what we hoped for when we started this project back in January.

This guidance supplements but doesn't replace state and local health and safety guidance. It is important to continue to monitor COVID-19 data and associated mitigation orders and follow the guidance for large events, which may be in effect at the time of your fair.

As I said, these guidelines contain the mandatory requirements set forth by the state of Pennsylvania. These requirements begin on page 2. Please remember that these are not our rules, they are the governor's rules. These mandatory rules that are in effect today include three main issues...they are Occupancy requirements, Mask Wearing, and Social Distancing. The re-opening plan includes details about these three issues. Hopefully, these regulations will be changed before fair time but there is no guarantee that this will happen.

Page 4 begins the Best Practices sections. Each fair will have to determine what they can do to help mitigate the spread of COVID. It will be difficult for many of our fairs to adopt many of these best practices. It is definitely a financial burden to make many of these changes. Just do the best you can.

Best Practices include Staffing, Medical Response, Physical Barriers and Pedestrian Traffic, Vendors, Cleaning and Disinfection, Restrooms, Communications, Food and Beverage Services, Livestock Events, Agricultural Exhibits, Carnival Midway, Entertainment, Transportation, and Special Days.

Just one comment... on page 12 under Livestock Events, it mentions "Show and Go". This is something that is available for this year only. If this is something that your fair is considering, I'm asking that you have a discussion with Tracy about it.

Fairs need to have a consistent message. Communication with the public will be very important. We need to tell our fairgoers what we are doing to keep them safe. You should dedicate one person who is designated to communicate and handle all COVID issues that may come up. It will be important to make sure everyone in your organization knows who that person is. All issues and communications should be handled by that person.

Everyone has to make their own decisions and establish their comfort level with dealing with any consequences. This is important both for fair associations and for fair goers.

Page 17 lists the resources that were used to develop this guidance. We relied on information from CDC, IAFE, the Pa Department of Health, and OABA. The last several pages include a sample website notice, posters and signs you can use to communicate what your fair is doing to help keep your fair visitors safe.

Report from the PA Showmen's Association – Jeff Good

I had reported 2 carnival operations going on the road. One has done 2 separate counties, another in Philadelphia proper. Happy to report 0 issues and 0 media inquiries. All 3 have been successful. Most Fairs will be later, I think we will be fine. 25 rides in the city of Philadelphia, no back lash. Thank you to Kerry, Tracy for the guidelines. Diligent with signage, stick with your plans.

Report from the Association Representative - Galla

We have lost a considerable number of associates, due to lack of work last year. I am hearing once up and running we will build backup.
