A reminder that <u>all contestants from all fairs must be at least 16 years old by June 1, 2022</u>, regardless of the actual dates of the fair. Check contestants' applications to make sure they meet the age and other eligibility requirements.

The next state competition will be held Thursday, January 19 through Saturday, January 21 at Hershey Lodge & Convention Center. The application process will be done entirely online, with a deadline of November 15, 2022. The application will be made available to all registered fairs after June 1.

This year the Queen Program will be offering webinars to fair queen coordinators as part of its "Queen Coordinator Leadership Series". The first webinar was held at the end of March on the topic of "Dress to Impress" and covered the 2022 dress code and other queen attire tips. The second webinar is scheduled for April 26 and will cover "Titleholder Contracts & Working With Queen Parents". Future topics include "Recruiting Contestants", "Completing the State Contest Application" and "Prepping Your Contestant for the State Competition." The webinar schedule will continue in, May, Sept, Oct, and Dec. Invitations will be sent to all coordinators who are listed in the 2022 database.

We will be distributing flyers at the Zone meetings to encourage all fairs to participate in the Queen Program's fundraising at the 2023 convention. Individuals and fairs can donate a raffle basket, an auction item or a monetary gift. Think outside the box by asking fair vendors or community businesses about items they could donate!
