We will then discuss incorporating technologies in other areas of the organization such as at ticket gates, livestock and fair entries/sales, as well as camping and storage management. You may have known what FFA was many years ago, or maybe you are even a proud alumni of the organization yourself... but do you know what the National FFA Organization is today? This seminar conducted by the Pennsylvania FFA State Officers will examine the history of our organization and take a look at the many opportunities available to members today. Sharing of monumental events in our organization's history and our own personal experiences will help tell our collective story. In sharing this narrative, we hope to foster conversations on increased youth leadership in fairs across the state. We hope you will join us as we showcase the future of youth in agriculture!

Swine Health Monitor Training Overview

Swine health monitors (SHM) are persons appointed by the fair board or livestock show committee who have some familiarity with pigs and can recognize when something is off. The SHM training will take place during the fair convention and will last approximately 30 minutes. This training will explain the role the SHM assumes in safeguarding swine health by working in conjunction with the fair board or livestock show committee and the veterinarian of record. This training will be in lecture format using a series of power point slides to train participants on recognizing the clinical signs associated with the three major diseases that have potential to devastate the swine industry (Foot and Mouth Disease, Classical Swine Fever and African Swine Fever). At the conclusion of the training SHMs will be able to recognize possible signs of these diseases and will know who to report it to. SHM will be the first line of defense.







The second-place winning poster in the 2019 Fair Season Poster contest was designed by Nathan Davis (12-14 year old category, McKean County Fair). While this poster's graphics are eye-catching and informative, the thing that stood out the most for the judges is the text in the lower right-hand corner. It reads: "Once in your life you need a doctor, a lawyer, a policeman and a preacher, but every day, three times a day, you need a farmer." The quote is attributed to Brenda Schoepp, a motivational speaker who uses these words of wisdom imparted to her from her grandfather, a dairy farmer, to highlight the importance agriculture plays in everyone's daily life.

When you're working on securing private funding for your fair, never underestimate the fairs' role in telling Pennsylvania's agriculture story and the value Pennsylvanians place on the industry. Whether you are building support for your fairs via sponsorship, volunteerism, legacy gifts, or just trying to garner community buy-in, it's important to demonstrate how you highlight and promote growth of the commonwealth's No. 1 industry. Fairs aren't just good, old-fashioned entertainment, they're informative community events that draw thousands of visitors each year. Fairgrounds are ideal locations for businesses to showcase their products and services.

With this in mind, now is a great time of year to begin thinking about how your fair can generate income through sponsorship. Have you thought of selling advertising space on your main stage? Maybe asking the local auto collision folks if they'd ike to sponsor the demolition derby? How about letting your local beverage company sponsor drink cup holders on your grandstand seats? Or, maybe just sell the grandstand seats to fair patrons? Plan on attending the "Show Me the Money" session on January 25 at the 2020 convention to learn the basics and some of the tricks of the sponsorship trade.

Fiscal Year 2018-2019 Capital Improvement Project Matching Fund Grants

We anticipate all the FY 2018/2019 Capital Improvement Project payments will be processed by the end of December.

Fiscal Year 2019-2020 Capital Improvement Project
Matching Funds Grants: Priority 1 Projects Approved
At this time, we anticipate the Priority 1 Projects will receive at
least 80% of the funds requested from the department. The
contract award letters and corresponding contracts will be issued
in late January 2020 and will contain the final grant awards. It is
our hope to fund the projects at 100%; however, the Fair
Premium Reimbursement, FFA, 4-H and Statewide Ag
Organizations' applications must be processed prior to making a
final funding decision.

Fair Reimbursements

The Fair Reimbursement Applications will be processed for payment by December 31.

Payments to Fairs

We're doing everything we can to speed up the payment process on our end. Generally, it takes four weeks to review and process the Fair Reimbursement Applications, with an additional three to six weeks to distribute payments. That said, fairs should receive Fair Premium Reimbursement checks by the second week of February at the very latest.

Spotted Lanternfly Permitting

The Spotted Lanternfly may be pretty, but it presents an ugly outlook for Pennsylvania. It is an invasive and extremely destructive pest that threatens our commonwealth's agricultural commodities and trade.

What is being done?

- Pennsylvania has put a quarantine zone in place to stop the spread of SLF to new areas in or out of the current quarantine zone.
- Businesses, agencies, and organizations operating within the quarantine zone that move vehicles, products, or other conveyances are required to obtain an SLF permit.
- On May 1, 2019, The Pennsylvania Department of Agriculture Bureau of PlantIndustry began performing inspections and verification checks to confirm that businesses are properly permitted.

Why are permits important?

- Permits are critical to protect interstate commerce and to avoid spreading the bug, ensuring our crops and quality of life is not affected.
- Permit training is available at no cost, and teaches businesses what to look for and how to safeguard against moving Spotted Lanternfly.



This year I am extremely thankful to be one of those commodity representatives, be a role model for youth, and to answer the public's questions about agriculture and our state fair.

The theme "Fairs Feature Agriculture," was so fitting for me this year and I wanted to incorporate some very important parts of agriculture to my life. In closing, I just want to provide a few simple tips that are absolutely necessary for your queen contestants this year. It is a chance to make lifelong connections with fair directors, other young women with similar passions, future employers, family, and so much more.

OVERVIEW:

Lawmakers are wrapping-up the Fall Legislative Session and heading into the second year of the two-year legislative session. After the holiday break, session convenes for one day on January 7 and then meets regularly throughout the year. Per the Pennsylvania Constitution, "The General Assembly shall be a continuing body during the term for which its Representatives are elected. It shall meet at 12 o'clock noon on the first Tuesday of January each year." The state House will return to regular voting session on January 13 and the state Senate is scheduled to return January 27.

Among the big-ticket items considered during the Fall Session include a bill signed into law that would raise the minimum age for the purchase of tobacco products to age 21, effective next July 1. The legal age for tobacco products now is 18. There will remain an exception under the new law for military veterans or service members who are at least 18. The law also expands the definition of a tobacco product to include e-cigarettes and other vaping products, and expressly prohibits the possession of these items on school grounds.

MINIMUM WAGE LEGISLATION:

Legislation (SB 79) to raise Pennsylvania's minimum wage for the first time since 2009 passed the state Senate. By a vote of 42-7, the GOP-controlled Senate approved the bill to raise **Pennsylvania's minimum wage to \$9.50 over the next two years**. The bill would increase the wage in four steps. On July 1, 2020, the wage would rise to \$8 an hour; to \$8.50 on Jan. 1, 2021; to \$9 on July 1, 2021; and to \$9.50 on Jan. 1, 2022. Pennsylvania's current minimum wage is the federal minimum of \$7.25.

Democratic Governor Tom Wolf gave up a number of concessions to win its passage, and its prospects in Pennsylvania's state House aren't clear. The bill is more modest than the immediate \$12 minimum that Wolf proposed in January. Another concession Wolf made in the agreement with Republican lawmakers was to rescind his proposed overtime regulation that would extend overtime pay eligibility to tens of thousands of workers. The Pennsylvania Chamber of Business and Industry, which has long opposed an increase in the minimum wage, backed the compromise on raising minimum wage as the lesser of two evils. Its officials say Wolf's overtime proposal threatened steeper cost increases on employers.

At the time of this writing, Governor Wolf put the state House on a timeline to pass the legislation. If the House doesn't pass the bill, Wolf's office said he will let the state rulemaking board proceed with a vote on his overtime pay regulation at its Jan. 30 meeting. The five-member Independent Regulatory Review Commission has a 3-2 Democratic majority.

MOBILE FOOD LICENSING LEGISLATION:

Representative Doyle Heffley (R-Carbon) has reintroduced the mobile food truck licensing bill (HB 671). This legislation would establish the concept of an 'operating base location.' Mobile units would be required to pay food licensing fees based on the operating base location instead of fees in multiple jurisdictions. In addition, while conducting business in jurisdictions other than their base location, mobile units can still be inspected by that jurisdiction, but they are not responsible for inspection fees. Milliron Goodman was successful in getting the bill voted out of the House Agriculture and Rural Affairs Committee. Our team is now working with various stakeholders on an amendment and will be pushing for a floor vote in the House in early 2020.

AMUSEMENT REGULATIONS:

Milliron Goodman continues to monitor the Department of Agriculture's (Bureau of Ride and Measurement Standards) updates to the amusement regulations. Milliron Goodman along with the PA State Showmen's Association (PSSA) has met with the Department and submitted feedback outlining concerns with the current draft. We will let you know if/when the Dept. if Agriculture schedules any additional meetings on this subject.

BUDGET:

Governor's Budget Address for fiscal year 2020-21 is scheduled for Tuesday, February 4, 2020, with budget hearings to be held for three weeks following the address. Last year, Governor Wolf proposed \$4 million for Pennsylvania's fairs in the state budget. During this time, Milliron Goodman will be meeting with key legislators and ask that you contact your local legislators on the importance of funding Pennsylvania's fairs.

POLITICAL:

A state senator from Luzerne County is changing his party registration from the Democratic Party to become an Independent and will start attending caucus meetings in Harrisburg with the majority Republicans. Sen. **John Yudichak** said in a statement that he is leaving his old party because he is weary of "'purist' politicians who demand that you choose a battle camp. You must pass their litmus test, and declare if you support 'us,' or 'them.'"

Three State GOP Lawmakers were successful in their November bids for local office. Republican State Rep. Justin Walsh secured one of two spots for judge on the Westmoreland County Court of Common Pleas bench. Walsh touted 22 years of experience as an attorney, legislator and small businessman. He pledged to continue his work protecting local families and their Constitutional rights as judge. State Rep. Tedd Nesbit (R) was also successful in his bid for one of two judge seats on the Mercer County Court

of Common Pleas. Nesbit was a former assistant district attorney in Mercer County. Republican State Rep. **Gene DiGirolamo** won his race for Bucks County Commissioner. DiGirolamo represented the Bensalem area in the state House since being elected in 1994, establishing himself as a moderate. He currently serves as the chairman of the House Human Services Committee. He stressed fighting the opioid epidemic, environmental protection and holding the line on taxes in his bid for the board of commissioners. Republicans hold the state House majority with 110 seats. Democrats have 93 seats. There will be three vacancies created as a result of these wins.

Four legislators recently announced they will not seek reelection in 2020. State Rep. **Steve McCarter** (D-Montgomery), first elected in 2012, said in a Facebook post that he won't seek reelection so that he "can devote my remaining time in the Legislature and beyond to the environmental causes for which I feel so strongly." State Rep. **Cris Dush** (R-Jefferson/Indiana) officially confirmed that he is not seeking a fourth term. In a statement, Dush said he intends to honor the pledge he made six years ago to only run for three terms in the state House. State Rep. **Neal Goodman** (D- Schuylkill) also announced he will retire in 2020. Goodman was first elected in 2002. He is currently part of the House Democratic Leadership team, serving as Caucus Administrator. State Rep. **Marcy Toepel** (R-Montgomery) announced she will not seek re-election at the end of her current legislative term. She has been a member of the state House since 2010, and currently serves in leadership as majority chairman of the House Republican Caucus.

The state finals at January's PA Farm Show are just around the corner. Make sure your special contest 1st place winners receive their Farm Show Certification Forms. They should <u>not</u> register through the Farm Show. The PSACF baking contest state finals are by invitation only, i.e. only contestants who were issued as signed official certification form are eligible to compete at the PA Farm Show. If the 1st place winners choose not to or cannot come to Farm Show, fairs can certify their next place winner. If the certified winner is unable to physically get to Farm Show, a representative can bring their entry for them as long they possess that signed certification form.

Contest premiums reimbursements will be distributed after November 15 only if the Fair has submitted its Contest Summary Reports on time. Reports can be mailed or emailed to the respective PSACF baking contest coordinator, or submitted online at

Only two contests are eligible for sponsored premiums: Angel Food Cake (\$50) and the Junior Baking (\$45). All other contest premiums are at the discretion of the Fair.
