#### Payment of royalties on music at an Agricultural Fair.

One of our Fairs received a music license agreement that it was asked to sign from a Nashville firm. Below is the exemption from the Federal Copyright Law for agricultural and horticultural fairs. If you receive a letter, please return a written letter explaining that your Fair is exempt, including the statement of the law below. This exemption applies only to the duration of your annual Fair, performances other than during the Fair are not exempt.

Under Public Law 94-553, of the Federal Copyright Law, which was effective January 1, 1978, non-profit fairs are exempt from the payment of any royalties on music.

The exemption is included under Section 110:

"Limitations on exclusive rights: Exemption of certain performances and displays," and reads as follows:

fair or exhibition, but shall not excuse any such person from liability for the performance."

"(6) performance of a non-dramatic musical work by a government body or a nonprofit agricultural or horticultural organization, in the course of an annual agricultural or horticultural fair or exhibition conducted by such body or organization; the exemption provided by this clause shall extend to any liability for copyright infringement that would otherwise be imposed on such body or organization, under doctrines of vicarious liability or related infringement, for a performance by a concessionaire, business establishment, or other person at such

Hello, I'm Zach Gihorski, your Pennsylvania Fair Coordinator. I enjoyed learning about Pennsylvania's agricultural fairs last

year as PA Preferred™ Coordinator for the Department of Agriculture, and was honored when Secretary Russell Redding tapped me to serve as fair coordinator. Since then, I've met many great volunteers, attended several fairs, and gotten a taste for how special this fair season will be. I'm looking forward to visiting your fair, as we work together to build momentum to the 100th Pennsylvania Farm Show in January!

#### Heightened Biosecurity against H5N2 Avian Influenza

Thirty-two years ago, Pennsylvania faced a highly pathogenic avian influenza (HPAI) which caused the death of 17 million birds and resulted in \$65 million in economic damage to the industry. We know we don't want to face this same scenario in 2015.

We in the department have received many phone calls on the subject. I wanted to follow up regarding the Department of Agriculture's decision to suspend all poultry shows and related activities at the state-sponsored fairs this fair season. This decision was not made lightly. It was made as part of our efforts to safeguard our state's poultry industry - which positively benefits Pennsylvania's economy to the tune of \$13 billion – against the threat of avian influenza. That suspension includes live bird shows, egg competitions, carcass classes, petting zoo birds, feather distributors and any other avian-related activities.

We appreciate your willingness to help us in our preparedness efforts against HPAI. We feel that the avian show suspension is in the best interest of our state's residents, birds, and poultry producers.

We want to reiterate that HPAI has not entered Pennsylvania to date, but it continues to move eastward across the country. One of the most recent confirmed cases was in eastern Michigan just 150 miles across Lake Erie from Pennsylvania's shoreline. The proximity of the disease, coupled with the reality that the Mississippi flyway,

where infected birds have been found, intersects Fair Coordinator with the Atlantic flyway, which over-DEPARTMENT OF AGRICULTURE lies Pennsylvania, warrants extra vigilance and thorough preparation. We





A maximum of six strong applicants from each zone can be submitted to the PSACF scholarship committee. The committee should have a maximum of 24 candidates to evaluate.

#### **M&G Legislative Update**

The 2015-2016 Pennsylvania Legislative Session is in full swing. Over the course of the two-year session thousands of bills will be introduced and hundreds considered. PSACF's lobbying firm, Milliron and Goodman, LLC, is working hard in Harrisburg to protect Pennsylvania's county fairs.

#### **Sales Tax Expansion:**

Heading into the homestretch of the state budget, Republican leaders are giving no hint of compromise with new Democratic Gov. Tom Wolf. Early discussions appear to be mere restatements of positions. Complicating matters, there is really no mutual agreement on the baseline numbers. State revenues are up and deficit projections are shrinking, but depending on who you talk to, budget shortfall figures range from \$900 million to \$1.2 billion.

Republican leaders insist that the Wolf team is overestimating the budget deficit by hundreds of millions of dollars. They contend the deficit can largely be filled with liquor privatization and public pension reform. Until the governor takes those issues seriously, they say there is no need for conversations of tax increases on Pennsylvanians. Meanwhile, Wolf is calling for his major budget proposals including a new tax on natural gas production and an increase and expansion of the sales and use tax to bolster funding for education and property tax relief. Starting at different Child Abuse Background Checks Law (Act points, there will have to be a compromise on additional revenue sources.

Wolf's tax plan would increase the state sales tax Act 153 requires employees and adult volunteers from 6% to 6.6% and expand the tax to dozens of goods and services currently exempt. The huge tax expansion would apply to amusement and recreational activities, including admission amusement parks and fairs.

House Republicans introduced and advanced their own tax proposal. Unlike the governor's plans, the House measure does not expand the sales tax to county fairs. The House plan calls for ry three years. increasing the 6 percent sales tax to 7 percent, and the 3.07 percent personal income tax to 3.7 percent.

Areas of disagreement remain. Backers of the plan say it is a rare chance to make significant cuts in a tax system that can subject homeowners to a heavy tax burden. But opponents say there's no quarantee that school boards won't eventually raise property tax rates back to their current levels. Some Republican members criticized the proposal for not going far enough to eliminate school property taxes altogether while others want to use the additional revenue to fill the budget gap.

With the June 30 budget deadline quickly approaching, there are rumblings that Senate leadership would rather separate this issue from the budget altogether and complete it later this session. That being said, Wolf's team is still pushing forward with this as a centerpiece of the budget.

M&G has been busy advocating against this proposed tax expansion on county fairs and will continue to do so as negotiations move forward.

#### **County Fair Funding:**

Milliron & Goodman is pleased with the information we are hearing. As in previous years, we are hearing that county fairs will receive funding from the Race Horse Development Fund. County Fair Caucus members are advocating for \$3 million and an additional \$1 million for grants, but we are cautiously optimistic. M&G will continue meeting with key legislators and ask that you continue to contact your legislators on the importance of our fairs and the need for budget dollars.

who are directly involved with children to obtain state police criminal background checks and Department of Human Services (DHS) child abuse clearances, costing \$10 each. In addition, FBI background checks are required for all affected employees and adult volunteers who have lived in Pennsylvania for fewer than 10 continuous years. Background checks and clearances must be eve-

Since taking effect on Dec. 31, an overwhelming number of questions and complaints have been raised about the state's new background checks law being too costly, onerous and far-reaching. Milliron and Goodman is being told that the spirit of the law is not to apply to the county fairs, the performers, the ticket takers or showmen. However, nothing prevents a school or another organization from having additional standards/requirements. As such, if your fair is being held on school grounds, M&G suggests contacting the school business administrator or solicitor for advice.

Legislators and staff in the state House and Senate have been meeting with representatives from the Pennsylvania State Police, Department of Human Services, and Department of Education on revisions to make clear who is subject to the law and the timetables for obtaining background checks. Despite initial pushback, M&G has been working with the various stakeholders to make the process less onerous.

On June 17, the state House approved House Bill 1276 to clarify child abuse background checks for employees and volunteers. Among the proposed changes the House agreed-to are:

- Clarifies that the law applies to employees and volunteers with direct and routine interaction with a child as part of a child care service, a school, or a program, activity or service. Routine interaction is defined as regular and repeated contact that is integral to a person's employment or volunteer responsibilities.
- Permits employers or organizations to accept non-original copies of the required documents on file.
- Portability of the background check certifications applicable to employees who are employed in more than one paid position in which they work directly with children. The portability measure is already in place for volunteers.
- Exemption for minor employees (14-17) from the FBI clearance if the minor has been a PA resident for the previous 10 years.
- Stipulation of the actual calendar dates by which employees and volunteers must be in compliance with the background check requirements. An employee without certifications is required to obtain certifications no later than

- December 31, 2015. A volunteer without certifications is required to obtain certifications no later than July 1, 2016.
- Waiver of the fee volunteers must pay to obtain state criminal background and child abuse certifications.
- Exemption for employers who work with minors who are participants in a co-op or internship program if the child participating in the program is at least 16 years of age.
- Exemption for international seasonal workers who have J-1 Visa who already have had background checks done and work in U.S. no more than 90 days.
- Changes the recertification requirement for the FBI background check for employees from every three years to every five years.
- Allowing background checks obtained by school bus drivers who are independent contractors to be portable so they can be used for multiple employment positions that require clearances.
- Exemption for employees of higher education institutions whose job brings them into contact with current and prospective college students age 16 and up.

Earlier this month, Gov. Tom Wolf announced the administration will waive the state background check and clearance fees for volunteers and reduce the fees for employees from \$10 each to \$8 each, effective July 25. Because FBI clearances are administered by the federal government current costs (\$27.50) will continue to apply.

HB 1276 now heads to the state Senate for consideration. While the legislation is a work in progress, there is a push to make the revisions law before the Legislature breaks for the summer. 


