Msgr. John W. Mignot PSACF Scholarship

It is time for fairs to communicate with agricultural organizations and school counselors about the Mignot Scholarship which is for those who are seeking higher education and have a relationship with the local fair.

Suggestions to help the applicant submit a better application:

- 1. Keep in mind, fairs are supervised by the Pennsylvania Department of Agriculture. Therefore, the mission is to promote Agriculture.
- 2. Essays should be written with correct grammar, no spelling errors, and a fluency which captivates the reader.
- 3. Categorize activities as related to school, community, and the local fair.
- 4. Letters of reference need to express who the candidate is in relation to the outlined activities and, in particular, in relation to helping the local fair.

Suggestions for fairs to be more proactive in reaching out to potential candidates

and in helping to sustain the scholarship:

- 1. All 2015 high school graduating seniors from all local fairs are eligible to submit an application. Youth in all four zones should be encouraged to apply.
- 2. Local fairs should establish a committee assigned to encourage those pursuing higher education to apply.
- 3. Letters of reference and support should give the PSACF scholarship committee enough information to become acquainted with the candidate.
- 4. A maximum of six strong applicants from each zone can be submitted to the PSACF scholarship committee. The committee should have a maximum of 24 candidates to evaluate.
- 5. Use technology, if at all possible, when submitting applications to the next level.
- 6. PSACF has committed to six one-thousand dollar scholarships. In order to help maintain the fund, each fair should consider a line item in its budget or sponsor a fundraiser.

Deadlines for all levels to follow to adhere to the application process:

- 1. June 30-applications due to the local fair
- 2. July 31⁻ applications due to the Zone chairperson
- 3. August 31-maximum of six applications from each zone due to the chairperson of the PSACF scholarship committee
- 4. September 30-application rankings by each PSACF committee member due to the state chairperson
- 5. October 1-state committee chairperson identifies the top six candidates to the state secretary, local fairs of selected recipients, and each individual recipient

York County Teen to Reign as 2015 Pennsylvania Fair Queen

York Fair Queen Alana Eisenhour of Wellsville, York County, was crowned the 2015 Pennsylvania Fair Queen on Saturday, January 24 at the Pennsylvania State Association of County Fairs and the Pennsylvania State Showmen's Association convention.

Eisenhour was selected from 59 contestants representing county and community agricultural PA fairs during the three-day competition. Each contestant prepared a brief speech highlighting her fair's unique traditions and events, an essay about the fair's significance in her community, and gave a stage introduction at the convention's annual banquet. They were also interviewed by the contest's judges.

Contestants are evaluated on their public speaking skills and knowledge of fairs and the agriculture industry, as well as on their poise and personal presentation in an evening gown competition.

Eisenhour, 18, is the daughter of James and Gloria Eisenhour and a 2014 graduate of Northern High School. She is studying agribusiness management at Penn State – York campus. She helps with her family's Cedar Hill Farms and has exhibited registered Angus cattle through the American Angus Association since age 9. She was an active member of Gifford Pinchot FFA and currently serves on the school's Agriculture Advisory Board. She has been active in York County's 4-H program, taking part in several clubs as well as the 2012 Pennsylvania State 4-H Livestock Judging team.

Eisenhour, the 29th PA Fair Queen, will receive a \$2,500 scholarship sponsored by PSACF at the conclusion of her reign in January 2016. She was crowned by outgoing Pennsylvania Fair Queen Lia Schmittel of Middletown, Dauphin County.

Five finalists were chosen and gave an impromptu answer on what they would share about the importance of agricultural fairs if they had a chance to meet with the new Governor Tom Wolf. Eisenhour said she would explain that agriculture is the leading sector in our economy, and that we need Fair Queens as the youth advocates for agriculture to keep our cities, state and country going.

Manheim Community Farm Show Queen Brittany Balmer of Manheim, Lancaster County, was selected as the Alternate Pennsylvania Fair Queen. She is the 18-year-old daughter of Dale and Sharon Balmer and a senior at Manheim Central High School. She is active in music, student council, the National Honor Society and serves as secretary of Manheim FFA. She also participates in the county's 4-H program, showing swine and dairy beef. She plans to pursue a college degree in marketing.

Other top five finalists were Centre County Grange Fair Queen Emily Allegar, Reading Fair Queen Caitlyn Pool and Troy Fair Queen Michala Kuhlman. Clearfield County Fair Queen Chelsea Folmar was named Miss Congeniality by her fellow contestants.

The three judges were Cindi Jaques, Certified Fair Executive from West Springfield, Massachusetts; Mark St. Jacques, Certified Fair Executive from Greenwich, New York; and Jody Whipple from North Stonington, Connecticut. Special Queen activities during convention included a seminar on "Young Women's Leadership" presented by former PA Fair Queen Denise Sustrik Yoho (1990) and sponsored by **Washington County Ag Fair**. A Queen Contestants' party featured commemorative tee-shirts sponsored by **S & S Amusements** and a Pizza Buffet sponsored by **Drum The Bucket**. Each contestant received a commemorative photo with 2014 PA Fair Queen Lia Schmittel sponsored by **Tons of Fun Shows**. Contestants mingled with judges, state directors and other special guests on Friday night during the Judges' Reception sponsored by **Skelly's Amusements**. Convention attendees and queen contestants were treated to a special panel discussion with four former state queen contestants: Laura Brenner, (West Lampeter Community Fair and now with PA Farm Bureau; Casey Hall, 2010 PA Fair Queen (Troy Fair); Emily Housler, 2014 Junior Fair Person of the Year (McKean County Fair); and Kelley Jay, 2014 Alternate PA Fair Queen (Bedford Co. Fair) who discussed how the PA Fair Queen Program has influenced their leadership skills, their fair involvement and their ag education involvement. It was great to be with you in Hershey for the annual convention. I'm looking forward to seeing many of you this summer at your fairs.

It's an honor to serve Pennsylvania as acting secretary of agriculture. Governor Wolf and I share a vision of agriculture as a resource for Pennsylvania, both as a natural

resource and an economic one. The governor outlined an agenda focused on jobs that pay, schools that teach, and government that works. Agriculture is primed to support those goals.

As the gateway to agriculture, fairs play an important role in educating consumers and attracting youth to careers in agriculture and related industries.

Governor Wolf Proposes Budget with Bold Changes

Governor Wolf has crafted an important budget that reflects his belief that it's time for bold thinking. This budget is about rebuilding the middle class and doing what we need to do to give all Pennsylvanians a shot at a brighter future.

It proposes landmark funding for schools, including technical education and job training that will greatly benefit agriculture. It also provides additional funding that will help our department with needed upgrades for the Pennsylvania Equine Toxicology Laboratory, help us better support at-risk Pennsylvanians through the State Food Purchase Program, and help us meet our core mission – protecting public health and safety.

Beyond that, it provides broad property tax cuts that will benefit producers across the state, and retains many of the sales tax exemptions for agribusinesses and farmers.

It also preserves the \$3 million in funding for fairs, with enough money for capital improvements. The funding will help ensure fairs remain showcases of agricultural talent.

And like our fairs, which preserve our connection to Pennsylvania's agricultural heritage, this budget will preserve the future viability of our state's leading economic enterprise.

Capital Improvement Matching Grant Projects

We received 120 capital improvement applications from 68 fairs for fiscal year 2014-15. The Fair Advisory Committee decided to fund one top-priority project for each of the 68 fairs by allotting an equal percentage to each project. With \$226,600 available for the projects, we can improve the fair experience by helping fairs address issues like handicap accessibility, new roofs, updating exhibitor facilities, and constructing new buildings. Grant contracts have been executed and are coming back to the Pennsylvania Fair Office. If General Assembly adopts the governor's budget, we anticipate \$225,000 in funding for FY 2015-16 capital improvement grants after fair reimbursements are completed. If your fair is considering an improvement project (repairs or deferred maintenance) in the next year, submit an application by June 30. Download the application at <u>www.agriculture.state.pa.us</u> by searching "improvement grant."

PA Preferred[™] Again Sponsors Display, Baking Contests Fairs play an integral role in educating consumers about the local food system – and I thank you for your important and growing role in outreach about PA Preferred.

Handwashing Returns as Fair Safety Poster Theme

Proper handwashing goes a long way toward staying healthy at a fair whether you're a guest, exhibitor, vendor, or volunteer. With that in mind, handwashing is back as this year's Fun Safety on the Fairgrounds poster contest theme.

I encourage you to sponsor a local poster competition. There are three age groups. Each fair's first place division winners can compete in the state contest at the 2016 PA Farm Show. Awards for each age group are:

 1^{st} place – rosette and \$100 2^{nd} place – ribbon and \$75 3^{rd} place – ribbon and \$50

All 4 baking contest sponsors have renewed their commitment for 2015. Contest rules were distributed and reviewed at the Convention. Unclaimed packets were mailed to the Fairs. All 2015 Special Baking Contest documents and items will be distributed at the Spring Zone meetings to Fairs that returned their Intent to Participate form by the February deadline.

A few notes for the 2015 contest season:

- The contest summary form for the PA Preferred Chocolate contests will be expanded to now collect information about the number of counties represented by the contestants at each fair, as well as a listing of the various PA Preferred ingredients that those contestants used in their recipes.
- 2. Once a contestant wins 1st place at a 2015 Fair in a particular PSACF Special Baking contest, they are no longer eligible to compete in that same baking contest at any other Fair in 2015.
- Make sure to communicate all the special baking contest rules and requirements to your Fair's contest volunteers and judges so that winners are properly certified and are legitimately eligible to compete at the next PA Farm Show competition.
- 4. Fair contest ribbons will only be provided for the special Chocolate contests. Ribbons for Apple Pie and Angel Food Cake are at the discretion of the Fairs.
- 5. Display those Angel Food Cake and PA Preferred sponsor banners at the contest area.
- 6. Scrapbook materials <u>not</u> required for any of the contests. Fairs will only need to send in the Contest Summary forms in a standard envelope. This saves the fairs time and money!
- The sponsored prize monies obtained by PSACF will be sent to participating fairs in the summer. Any of this sponsored prize money that is not awarded must be returned to PSACF, Attn: Harry Reffner.

County Fairs Could be Taxed under new Governor Wolf Budget

Governor Tom Wolf presented his budget to the Legislature last week and one of his requests could have a serious impact on all of us. He has proposed that the Pennsylvania sales tax be increased from 6% to 6.6% but also that it be extended to all amusements - including admission to amusement parks and fairs, and all tickets sold for individual rides! More details will be forthcoming, but for now I want you to be aware.

You must write to your state representative before You will be receiving emails from us to give you you begin your spring travels. Do you know who he or she is? Do you know their district office address or email? If not, please go to www.legis.state.pa.us and enter your home address. This webpage will then give you your representatives' name and contact information.

The quickest and most effective thing to do is to send them an email. If you do not use email, then pick up the phone and leave a message at their district office. Please tell them that you are a constituent and your company is a small family busi-

ness. Tell them that the Governor's proposal to tax your amusement rides at their church, schools and volunteer fire company festivals will fall on the shoulders of families everywhere. In these difficult times, our local fairs and festivals are often the only opportunity families have for entertainment and enjoyment together.

Do not emphasize the increase in the sales tax. Emphasize that the proposed expansion of sales tax it is not fair to working families.

Please follow what the House and Senate are doing in the coming months. We realize it is the beginning of your busy season, but none of us can afford to lose business because of the Governor's proposal to put an additional tax on us. We already pay (in many cases) a local amusement tax and an additional 6% on consumers is a nonstarter.
