Legislative Update

The last newsletter update optimistically anticipated a 2015 budget being signed into law by Christmas day. Despite a Republican issued \$30.8 billion budget hitting Governor Tom Wolf's desk by December 24, 2015, the budget impasse continues. Governor Wolf reviewed the budget presented to him at the end of December, and 5 days later announced a partial veto, releasing emergency funding to schools and social service programs only. The appropriation to county fairs was not included in the released funding. Nor was the entire Department of Agriculture budget. The Governors February budget address, did however, include a transfer of \$4 million dollars from the Race Horse Development Fund.

For the past three weeks the House and Senate Appropriation Committees has been meeting with each state department, agency, and entity. This long process is important and allows House and Senate members the opportunity to ask questions directly related to their constituency. The topic of funding for fairs was discussed at length at each hearing with the Department of Agriculture. PSACF's 2015 legislators of the year (Senator Vogel and Rep. Millard), continued to be great champions for the Association. Both expressed the importance of fairs. Senator Vogel testified that fairs are suffering, being forced to do more with less, and some might cease to exist this year. Rep. Millard noted that the dollars collected locally by the fairs stay local. He also inquired about how the funds for fairs will be al-

lotted once a budget is passed. Department of Agriculture Secretary Russell Redding stated that \$4 million will be used for youth organizations, operations, and capital projects.

We at Milliron & Goodman are doing all that we can to keep the General Assembly well versed with how this budget impasse is effecting the fair industry. At this time, we would ask that you back us up back home by writing a letter, making a phone call, or sending an email to your local Senator and House member. Please convey how this matter is affecting your local fair and by extension, community. Request that a budget is passed sooner rather than later and includes \$4 million for fairs.

Milliron & Goodman will continue to send out reports to the Association regarding the status of the budget, as they are announced. These reports will include rumored tax increases and expansions, including the amusement tax. Do note, the Governor's budget proposal presented nearly \$33 billion in spending, representing two-years, and a 14 percent increase. To pay for it, Governor Wolf is proposing \$2.7 billion in new and higher taxes. Negotiations fiercely continue. Likewise, our advocacy for PSACF fervently continues. And, if each fair goer, volunteer, director, board member citizen of Pennsylvania - joins the "fight," the impasse will likely end sooner.

Msgr. John W. Mignot PSACF Scholarship

It is time for fairs to communicate with agricultural organizations and school counselors about the Mignot Scholarship which is for those who are seeking higher education and have a relationship with the local fair.

Suggestions to help the applicant submit a better application:

1. Keep in mind; fairs are supervised by the Pennsylvania Department of Agriculture. Therefore, the mission is to promote Agriculture.

2. Essays should be written with correct grammar, no spelling errors, and a fluency which captivates the reader.

3. Categorize activities as related to school, community, and the local fair.

4. Letters of reference need to express who the candidate is in relation to the outlined activities and, in particular, in relation to helping the local fair.

Suggestions for fairs to be more proactive in reaching out to potential candidates and in helping to sustain the scholarship:

1. All 2016 high school graduating seniors from all local fairs are eligible to submit an application. Youth in all four zones should be encouraged to apply.

2. Local fairs should establish a committee assigned to encourage those pursuing higher education to apply.

3. Letters of reference and support should give the PSACF scholarship committee enough information to become acquainted with the candidate.

4. A maximum of six strong applicants from each zone can be submitted to the PSACF scholarship committee. The committee should have a maximum of 24 candidates to evaluate.

5. Use technology, if at all possible, when submitting applications to the next level.

6. PSACF has committed to six one-thousand dollar scholarships. In order to help maintain the fund, each fair should consider a line item in its budget or sponsor a fundraiser.

Deadlines for all levels to follow to adhere to the application process:

1. June 30–applications due to the local fair

2. July 31– applications due to the Zone chairperson

3. August 31–maximum of six applications from each zone due to the chairperson of the PSACF scholarship committee

A. Please submit no more than six.

4. September 30–application rankings by each PSACF committee member due to the state chairperson

Tioga County Teen Crowned 2016 PA Fair Queen

Tioga County Queen Darby Kasper of Roseville, Tioga County, was crowned the 2016 PA Fair Queen on Saturday, January 23 at the PSACF/PSSA convention.

Darby was selected from 60 contestants representing county and community agricultural PA fairs during the three-day competition. Each contestant prepared a brief speech highlighting her fair's unique traditions and events, an essay about the fair's significance in her community, and gave a stage introduction at the convention's annual banquet. They were also interviewed by the contest's judges.

Contestants are evaluated on their public speaking skills and knowledge of fairs and the agriculture industry, as well as on their poise and personal presentation in an evening gown competition.

Darby, 17, is the daughter of Bradley and Kathleen Kasper. She is a dual enrollment student through North-Penn Mansfield High School and Mansfield University. The proprietor of Kasper's Rabbitry, Darby is a 4-Her as well as a member of the Future Business Leaders of America, National Honor Society, and band and chorus. She volunteers with Sunnybrook Meadow therapeutic riding and Appalachian Horse Help & Rescue. She enjoys figure skating and is a certified coach through the Ice Skating Institute.

Darby is the program's 30th PA Fair Queen. She will receive a \$2,500 scholarship **sponsored by PSACF** at the conclusion of her reign in January 2017. She was crowned by outgoing Pennsylvania Fair Queen Alana Eisenhour of York County.

Five finalists were chosen and gave an impromptu answer on how they see PA Fairs evolving in the future. Darby said she would saw fairs evolving by encouraging more children to get involved and using social media to get more exhibitors and visitors to the fairs; the more people we can encourage to come to our fairs, the more knowledge every day people will have about agriculture on our communities.

Juniata County Fair Queen Molly Arnold of Mifflintown was selected as Alternate 2016 Pennsylvania Fair Queen. A student at Lancaster Bible College on its basketball team, she enjoys sports, camping, public speaking, mission trips and spending time with friends and family. An avid competitor at the Juniata County Fair, she has entered rabbits, decorated cakes, chocolate cakes, crafts, and other 4-H items. We Have Good Things Growing at Fair Convention

I've had the privilege to attend the fair convention in previous years, but never in the role of fair coordinator. It was rewarding to distribute the photos and frames from the Farm Show to representatives of your fair as a thank you for your work in strengthening your communities, developing skilled youth, and promoting agritourism in your regions. I appreciated the opportunity for my colleague Jan McNamara and I to host the breakout session on fair funding. The questions were thought provoking and the discussion insightful.

And I could not have asked for a better group of people to be snowed in with than the fairs and showmen crowd! Add to that an accommodating Hershey Lodge staff and I'll say that Winter Storm Jonas will be a fond memory for me for many years.

High-Path Avian Influenza and the Suspension

Last year at this time Pennsylvania was bracing for the worst, with the prospect of highly pathogenic avian influenza (HPAI) becoming more real with each infected flock. With that in mind, we made the tough decision to suspend poultry activities at Pennsylvania's fairs.

Fast forward to 2016: even in the middle of a prime time for HPAI to manifest itself in Pennsylvania flocks, aside from a lone outbreak in Dubois County, Indiana, the disease is quiet. Knowing this, we included this with our fair animal health rules update from earlier this year:

It remains our goal to resume poultry exhibitions in 2016. We will continue to monitor reports of avian influenza cases that occur in the United States and put our poultry industry at risk. Our final decision to lift the current suspension will be made by June 1, 2016, in cooperation with the Penn State College of Agricultural Sciences and will be based on an assessment of risk to Pennsylvania poultry.

You can access those updated rules by visiting <u>www.agriculture.pa.gov</u> and searching "fair animal health rules". Please keep this in mind as you develop your premium guides and plan for space and shows.

2015-16 Pennsylvania Budget

Secretary Redding may have said it best at the Fair Convention: "Keep the faith." This is a challenging time for everyone involved. When we get a fully-enacted 2015-16 budget, we will begin processing your reimbursements.

All 4 baking contest sponsors have renewed their commitment for 2016. Contest rules were distributed and reviewed at the Convention. Unclaimed packets were mailed to the Fairs. The 2016 information can also be downloaded from PSACF's website: <u>www.pafairs.org</u>, Members/Baking Contest menu (no login required). Please make sure the person who updates your Fair's Premium Book has received the 2016 information.

All 2016 Special Baking Contest documents and items will be distributed at the Spring Zone meetings to Fairs that returned their Intent to Participate form by the February deadline.

A few notes for the 2016 contest season:

- Once a contestant wins 1st place at a 2016 Fair in a particular PSACF Special Baking contest, they are no longer eligible to compete in that same baking contest at any other Fair in 2016.
- Make sure to communicate all the special baking contest rules and requirements to your Fair's contest volunteers and judges so that winners are properly certified and are legitimately eligible to compete at the next PA Farm Show competition.
- Fair contest ribbons will only be provided for the special Chocolate contests. Ribbons for Apple Pie and Angel Food Cake are at the discretion. The PA Preferred Chocolate contest forms will also require additional information about the number of counties represented by the contestants and a listing of the various PA Preferred ingredients those contestants used in their recipes. We will also be piloting an optional online submission form for those who prefer to electronically submit their contest results!
- Display the Angel Food Cake and PA Preferred sponsor banners at the contest area. Fairs only need to send in the Contest Summary for each contest. This year an online submission option will be available along with the standard paper form that can be mailed in a standard envelope. This saves the fairs time and money!
- The sponsored prize monies obtained by PSACF will be sent to participating fairs in the summer. Any of this sponsored prize money that is not awarded must be returned to PSACF, Attn: Harry Reffner.
