### FAIR PERSON OF THE YEAR NOMINATIONS NEEDED —Bruce Koppenhaver

As in years past, a 2018 "Fair Person of the Year" award will be presented at the 2019 Convention. The following criteria have been established as a guide in this award presentation, according to Committee Chair, Bruce Koppenhaver.

Rules for the award are:

- In honor of the service rendered to the fair industry, an annual award is given to an individual for distinguished achievement in or contribution to the fair industry under conditions herein described.
- The presentation of the award will be made at the annual convention.
- The eligibility is as follows:
  - 1) The candidate must be a living person at the time of the nomination.
  - 2) The person must be identified with the fair industry for a minimum of ten years.
  - 3) The person shall have contributed to the fair industry in addition to his/her own fair or association of fairs, and something of value in the field of leadership at the state association level.
  - 4) He/she shall have fairly consistently attended the meetings and conventions of PSACF.
  - 5) Each PSACF member fair is entitled to nominate one person. The person need NOT be from the fair making the nomination.

Submit the application (located on the association website or request one be emailed/mailed), along with a brief write-up, supporting documentation, and resume of the nominee on official fair letterhead to Bruce Koppenhaver, PO Box 217, Gratz PA 17030 no later than November 1, 2018. ### What Could Shut Down Your Fair? Activists' Tactics and How to Prepare

Panel Discussion by the SouthCentral Task Force Ag Subcommittee, Pennsylvania Panelists:

> John Sancenito, president and co-owner of Information Network Associates, Inc., an international investigative and corporate consulting firm

Duane Haglegans, Assistant Professor at Millersville University in Emergency Management Linda Spahr, PSU Extension 4-H Science Educator in York County Dr. Gregory Martin, PSU Extension

Description: There are many emergencies or crises to prepare for related to animal welfare and human safety at a fair. This breakout session will address to animal diseases, guarantine considerations, and intentional disruptions as a form of protest. We will discuss current tactics of animal activists, what you have to allow, how you can prepare, and how to potentially identify activists ahead of time. We will also provide an updated Emergency Planning Template to attendees.

Dr. Duane Hagelgans has been involved in the emergency services for over 30 years. He has been working and volunteering in the field of emergency management for over 14 years. He retired in 2011 from the City of Lancaster, Bureau of Fire. He holds an A.S. in Fire Science Technology from Harrisburg Area Community College, a B.S. degree in Occupational Safety from Millersville University and Juris Doctorate from Widener University School of Law. Duane currently serves on the South Central Pennsylvania Counter Terrorism Task Force (SCTF) and the Lancaster County Emergency Management Agency. He is an assistant professor at Millersville University and has taught numerous emergency management courses for the Department of Homeland Security. He specializes in the area of public information and emergency response. He is currently researching better methods to teach emergency preparedness to school age children.

Dr. Gregory Martin serves as the Extension Educator in Poultry in Pennsylvania. His expertise includes poultry health, poultry diseases, poultry production best management practices and is well versed in emergency response and preparedness. Dr. Martin has his undergraduate degree in Poultry Industry from Cal Poly, San Luis Obispo, CA; his masters in Business Administration from Cal Poly, and he received his Doctor of Philosophy in Poultry Science

He was also a teacher of Technology and Robotics for 32 years in Jackson Township Public Schools, Jackson, NJ (Retired). In 2006 David was name Jackson Township Teacher of the Year and 2007 State of New Jersey Technology Teacher runner-up. He is currently an active member of the

Ocean Fair County (NJ) and a Director for the Maryland Association of Agricultural Fairs and Shows.

Research suggests fairgoers who expect to be able to use a credit card is increasing year-overyear. Accepting credit card payments can be a training and logistical nightmare without the right framework before, during and after implementation. In this seminar, we will discuss all the technical and non-technical considerations for adopting a point-of -sale system that will benefit and grow your fair.

Be sure to attend your zone meeting as you will be electing your State Directors and Zone 2 & 4 will be electing Queen Board members.


#### **New Faces at Convention**

#### Look Before You Leave: Help Pennsylvania Combat the Spotted Lanternfly

The Spotted Lanternfly is an inch-long black, red and white spotted insect native to Southeast Asia and first identified in Pennsylvania in 2014. The invasive insect, whose first egg hatch was spotted in May in Berks County, feeds on agricultural commodities produced in the state, such as hops, grapes, apples, and hardwoods.

After the pest was found, a quarantine was immediately put in place to slow its spread. The Spotted Lanternfly population is currently concentrated in a 13-county quarantine zone in the southeast portion of the state: Berks, Bucks, Carbon, Chester, Delaware, Lancaster, Lebanon, Lehigh, Monroe, Montgomery, Northampton, Philadelphia, and Schuylkill.

These bugs have trouble flying, but they are great hitchhikers. They can be transported on vehicles, on commodities traveling in and out of the quarantine zone, and on belongings. Visitors to fairs should take extra care as they travel this season, as they may unknowingly transport these insects as they hitch a ride.

Some commonly asked questions include:

#### How can I identify a Spotted Lanternfly?

After hatching, Spotted Lanternflies go through five stages of growth. Their life begins as masses laid on trees, under bark, on yard furniture, cars and trailers, outdoor grills, and other surfaces. During the nymph stage, Spotted Lanternflies are small with black spots, and can look like ticks. Adults, first seen in July, have a black head and grayish wings with black



spots. When startled or flying, the Spotted Lanternfly will display hind wings that are red at the base and black at the tip with a white stripe dividing them. The red portion of the wing is also adorned with black spots. The abdomen is bright to pale yellow with bands of black.

#### I think I saw/killed/caught a Spotted Lanternfly—what do I do now?

If you live outside the quarantine zone, report any sighting of Spotted Lanternfly to the Pennsylvania Department of Agriculture (PDA) at <u>Badbug@pa.gov</u> or 1-866-253-7189.

#### Where can I stay up-to-date on information about Spotted Lanternflies?

PDA, Penn State University, and the United States Department of Agriculture (USDA) provide helpful information, quarantine up-dates, printed material, educational videos and other resources on their websites.

### PENNSYLVANIA STATE ASSOCIATION OF COUNTY FAIRS

#### **OVERVIEW**

After three years of protracted budget fights, Pennsylvania's election year budget plan was wrapped-up more than a week ahead of its June 30<sup>th</sup> deadline. And, for the first time in Democratic Governor Tom Wolf's tenure, he has signed a budget. His signature came hours after the Republican-controlled Leg-islature sent a \$32.7 billion spending plan to his desk, barely three days after the first details of the no-new-taxes or fees package were unveiled. The <u>budget</u> increases overall spending by 2.2%, invests in education with an emphasis on workforce development and school safety initiatives and increases funding to combat the opioid crisis, among others.

With the state budget complete, Lawmakers spent the summer back home in the districts gearing up for the looming general election. All 203 state House members and half of the state Senate (25 seats – even numbered district seats) are on the November ballot along with Democratic Governor Tom Wolf. The House and Senate will return to Harrisburg the week of September 24. With the election stakes high, there will be limited voting session days this fall – 9 days in the Senate and 8 days in the House. Although the 2-year Legislative Session constitutionally ends on November 30, lawmakers have refrained from coming back to session to vote on bills after the November Election.

#### PENNSYLVANIA'S FAIRS FUNDING

The 2018-19 state budget provides \$4 million for Pennsylvania's fairs. We are pleased lawmakers and the Governor continue to recognize the importance of funding Pennsylvania's fairs and thank them for maintaining the funding in this year's budget.

#### SALES TAX EXPANSION

A six percent sales tax on admissions to amusement parks, fairs and other recreation-type businesses was considered by the state Legislature during past budget negotiations as well as negotiations on property tax relief. Milliron Goodman continues to be actively engaged on this issue. We would like to thank all the PSACF members that contacted their local legislators on the sales tax issue in the past. Next year Pennsylvania is expected to face fiscal challenges. As lawmakers look for ways to balance the budget or reduce property taxes, we will need your continued support. Taxing affordable familyfriendly amusement is counterproductive. If ticket prices go up, more people will choose to stay home. Pennsylvania's fairs, festivals and amusement parks are economic drivers for every community of the Commonwealth. As always, please stay alert for updates.

#### **MOBILE FOOD LICENSING LEGISLATION**

The lobbyists at Milliron Goodman are working on language that would address the members' concerns regarding food licensing fees.

As you know, to participate in events throughout the state, some mobile retail food facilities are subject to multiple licensing fees per year. This legislation would address the issue by utilizing the concept of an "operating base location," which is essentially the area where trucks return regularly to restock, clean, etc. Mobile units would be required to pay food licensing fees based on the "operating base location" instead of fees from multiple jurisdictions.

State Rep. Doyle Heffley (R-Carbon) has introduced this legislation as <u>HB 2518</u>. The bill is currently awaiting consideration by the House Agriculture and Rural Affairs Committee. We plan to begin meeting with committee members throughout the fall session, clarify any questions and generate overall support. However, with only nine session days remaining between now and December, we are anticipating a reintroduction of the bill and a heavy push for legislative committee and floor votes next session. The 2019-20 legislative session begins on January 1, 2019.

#### PROPOSED MINIMUM WAGE REGULATION CHANGES

The House Labor and Industry Committee recently held a hearing regarding the Department of Labor and Industry's proposed minimum wage regulation changes. The proposal would increase the overtime salary threshold for white collar employees from \$455 per week (\$23,660 per year) to \$921 per week (\$47,892 per year). Public, private, and nonprofit groups provided the committee with testimony regarding the impact this proposal would have on their organization.

Secretary of Labor and Industry Gerard Oleksiak noted that the goal of the regulation is to: modernize (increase) the minimum weekly salary an employee must earn to be exempt from overtime compensation and simplify the duties test to improve compliance and align with federal regulations. He stated that salaried workers earning about \$24,000 a year may be subject to unlimited hours a week without a guarantee of overtime. He argued that this is unfair. Deputy Secretary for Safety and Labor-Management Relations Jennifer Berrier noted that to qualify for the white collar exemptions, employees must meet the minimum threshold and duties test. When it was originally enacted into law, the exemption was intended for higher salaried employees. Further, she stated that the salary threshold has become outdated.

Organizations, including MHY Family Services, Mercyhurst University, Skirmish Paintball and Pocono Whitewater Rafting, and North Country Brewing Company, provided testimony in opposition of the proposed regulations. Some reasoned that this would increase employment costs, limit overall budgets and lower the quality of services. Others noted that some nonprofit health care organizations would be unable to continue services altogether. And some noted they would have to switch from paying salaries to hourly wages.

#### **ELECTIONS 2018**

Four incumbent lawmakers – Sen. Randy Vulakovich (R-Allegheny), Rep. Paul Costa (D-Allegheny), Rep. Emilio Vazquez (D-Philadelphia), and Rep. Dom Costa (D-Allegheny) – and Lt. Governor Mike Stack lost their Primary Elections and will not be on the November ballot. State Senator Scott Wagner secured the GOP nomination for governor, setting up an Election Day matchup between him and a fellow millionaire and York Countian Democratic Governor Tom Wolf. In June, Wagner resigned from his Senate Seat to focus on his campaign. Nearly 30 state lawmakers are not seeking reelection.

Stephen Bloom (R-Cumberland); Sen. John Eichelberger (R-Blair); Rep. Jim Christiana (R-Beaver); Rep. Rick Saccone (R-Allegheny); Rep. Nick Miccarelli (R-Delaware); Rep. Dave Reed (R-Indiana); Rep. John McGinnis (R-Blair); Rep. Curtis Thomas (D-Philadelphia); Rep. William Keller (D-Philadelphia); Rep. Mike Hanna (D-Clinton); Rep. John Maher (R-Allegheny); Rep. Joe Markosek (D-Allegheny); Rep. Mark Mustio (R-Allegheny); Rep. Flo Fabrizio (D-Erie); Rep. Kevin Haggerty (D-Lackawanna); Rep. C. Adam Harris (R-Juniata); Sen. Stewart Greenleaf (R-Montgomery); Sen. Charles McIlhinney (R-Bucks); Rep. Ron Marsico (R-Dauphin); Rep. Bob Godshall (R-Montgomery); Rep. Katharine Watson (R-Bucks); Rep. Will Tallman (R-Adams); Rep. Harry Lewis (R-Chester); Rep. John Taylor (R-Philadelphia); and Rep. Eli Evankovich (R-Westmoreland).

Lawmakers who are not running for reelection and are running for a different seat in 2018 are: Sen. Guy Reschenthaler (R-Allegheny) - running for US House (not up for reelection to State Senate); Rep. Marguerite Quinn (R-Bucks) - running for State Senate; Rep. Kristin Phillips-Hill (R-York) - running for State Senate; Rep. Judith Ward (R-Blair) - running for State Senate; and Rep. Madeleine Dean (D-Montgomery) - running for US House. Rep. Tina Davis (D-Bucks) is running for reelection in her current seat and running for the state Senate seat held by incumbent Republican Senator Tommy Tomlinson.

#### **TOURISM FUNDING**


The 2018-2019 state budget dedicates \$17,839,000 for Marketing to Attract Tourists. After earmarks, the budget level funds the dollars directed to the Pennsylvania Tourism Office at \$4,067,000 for statewide tourism promotion. Less than a decade ago, Pennsylvania was investing \$30 million each year in tourism marketing and promotion. Tourism is a vital part of Pennsylvania's economy. Over the years, state investment in tourism has dwindled. With limited state dollars, the industry is being challenged to develop a sustainable funding model that doesn't rely on the annual budget. One of the proposals being looked at this Session would require online travel companies (OTCs) - such as Expedia, Orbitz, and Travelocity - to pay the full retail rate on the hotel occupancy tax on transactions booked for hotel stays on their sites. A current loophole in Pennsylvania law allows the OTCs to calculate the hotel tax they remit on their wholesale costs rather than the retail price paid by their customer and the OTCs keep the balance as profit. Closing this loophole is projected to generate nearly \$20 million in new revenue a year for tourism. The bill would direct funds collected from closing this loophole to the Pennsylvania Tourism Office. House Bill 1511 (Rep. Marguerite Quinn, R-Bucks) is pending in the State House. The bill was voted out of the House Finance Committee before the Summer recess. On the Senate side, Senate Bill 721 (Sen. Guy Reschenthaler, R -Allegheny) was introduced and is pending in the Senate Community, Economic and Recreational Development Committee. Another measure that is being discussed is <u>House Bill 1810</u>. This legislation, sponsored by Rep. Doyle Heffley (R-Carbon), requires online home-sharing and short-term rental companies, such as AirBnB and HomeAway, doing business in Pennsylvania to register with the state and share information with taxing authorities. This will help the state enforce hotel tax collection laws, further warranting both fair competition across the hospitality industry and accurate hotel tax revenue for the state and counties. HB 1810 was passed by the State House and is currently in the Senate Community, Economic and Recreational Development Committee.

#### **GRASSROOTS ADVOCACY**

#### **SPECIAL BAKING CONTESTS**

As I travel around to my fair visitations this summer, I make sure to take special notes of each Fair's special baking contest displays. I always look forward to seeing the creativity and detail that Baking Department volunteers put into making these displays eye-catching for the fairgoers. The displays are also a meaningful way to give the well-deserved recognition to the baking contestants who took the time to bake the entries and travel to the fair to compete.



Our baking contest sponsors also appreciate recognition. They play a big part in making these contests successful each year. Every time they see their name in print, it reassures them that their sponsorship has a real impact.

Fairs can help promote these sponsors in various ways including the premium book, newspaper ads, tabloids, brochures, flyers, website and social media. Two of our major contest sponsorships – PA Egg Farmers (Angel Food Cake contest) and PA Preferred (Junior Baking contest) – include special contest banners as another way to promote and recognize. All participating fairs are <u>required</u> to display these banners at their events. PA Preferred even redesigned the Junior Baking contest banner and made sure each fair received the brand-new version this year.

However, throughout the summer I saw that some fairs are still incorrectly advertising the cake and youth contests as "*PA Preferred Chocolate Baking*". Some are still displaying the old banners. Others are still using the wrong contest name in their premium books, entry tags and bake sale signage. So just to set the record straight... The Homemade Chocolate Cake contest is sponsored by PSACF; <u>not PA Preferred</u>.

The youth contest is called the "PA Preferred Junior Baking Contest". It is <u>not</u> to be advertised as a "chocolate" contest. While contestants may use chocolate in their recipes, youth bakers can use a variety of PA Preferred products including fruits and, vegetables!

So, if your fair still has the old "chocolate contest" banner, please remove it from your collection of fair display items! Check your premium books and other advertising to be sure that you are using the correct contest names. Share this newsletter article with your Baking Department chairperson! Let's show our appreciation to our sponsors and our contestants by promoting the proper contest information.

The state finals at January's PA Farm Show are just around the corner. Make sure your special contest 1<sup>st</sup> place winners receive their Farm Show Certification Forms. They do not need to register through the Farm Show. They already have the "golden ticket" by just bringing that certificate credential at the time they bring their entry. If the 1<sup>st</sup> place winners choose not to come to Farm Show, fairs can certify their next place winner. If the certified winner is unable to physically get to Farm Show, a representative can bring their entry for them if they possess that Certification Form.

Remember this year ... "*Report Made-Get Paid*!" Premiums will be distributed after November 15 only if the Fair submitted its Contest Summary Reports on time. Reports can be mailed or emailed to the respective PSACF baking contest coordinator, or submitted online at :

https://goo.gl/forms/32XnLXydwqIF0wvm1 Only two contests are eligible for sponsored premiums: Angel Food Cake (\$50) and the Junior Baking (\$45). All other contest premiums are at the discretion of the Fair.

#### **E-Grants**

The applications we received this year have been processed and were presented at the September Fair Advisory Committee meeting for review, comment and recommendation. Once the 2018 fair reimbursement applications have been processed, we will officially notify you of your grant status in early January.

#### Payments: 2017-2018 Capital Improvement Matching Funds Grants

We are waiting for the fully executed contracts to be returned from the executive branch. Once we have them in hand, we'll process the FY 2017-2018 payments. If you haven't done so already, please forward your certificates of completion and associated documentation so we'll be able to process your payments as soon as possible.

Plans for the 2019 PSACF/ PSSA convention are coming along well. The dates are January 23 – 26, which is later than

in recent years. Our annual associates meeting will take place (in the Trade Show) after the Trade Show closes on Thursday, January 24<sup>th</sup>, at 4:00.

I welcome all new associates and encourage you to check out the PSACF website. Go to <u>www.pafairs.org</u>.

If you have not already done so, BOOK YOUR ROOM now. In the past, some people were not able to get rooms as they waited too long to make their reservation. Call 1-800-437-7439 and to receive the convention rate, tell them that you are with the "PA Fairs and Showmen Convention." Go to www.pafairs.org; click on CONVENTION/Hotel Reservations for everything you need to know.

Associates meeting the criteria (eligible to apply if you have not showcased in the last 2 years) should have received the letter and application to participate in the talent showcase. This year the showcase will take place at 6:30 on Wednesday, January 23<sup>rd</sup>.

You must be a paid up member of the state association at the time you submit your application as well as at the time of the convention - January 2019.

The applications for the showcase and strolling entertainment must be received by Sam Zaffuto by October 15th. *This year the application process offers a new option of submitting a link to a short (3 to 5 minute) video of you performing live. The video should be available on YouTube or a similar alternative. A link to a video of you performing 'live' is required as part of your packet.* 

DVDs of you performing 'live' mailed in with your application (instead of submitting a link to a video) will also be accepted, Sam confirmed. If you do prefer to mail a DVD, make sure it plays on players other than your computer. And **no paper labels**! It's frustrating when there are acts that cannot be considered because their DVD will not play. Paper labels are a major culprit, or the DVD is only formatted for the computer on which it was burned.

The DVD or video link should be a sample of your actual live performance, not just a produced 'music video' or CD.

I strongly urge those of you who qualify, to send in an application. You may not be selected because out of 45 – 50 acts, 17 acts are chosen, but continue to submit yourself. The Wednesday night showcase committee looks for diversity: juggling, magic/illusion and novelty stage acts as well as musical groups, bands and singers – for all sizes of venues. Those showcasing perform for over 100 fairs and buyers from all over Pennsylvania (some from Maryland and New Jersey too) who are actively looking for acts that will make their fair special. The showcase is a highlight of the convention, an excellent opportunity for fairs to experience acts/ attractions/bands firsthand and book them early for the 2019 fair season.

Additionally, strolling acts/street musicians/grounds entertainers (roving acts who do not offer a stage show) may apply to perform in the Chocolate Ballroom lobby prior to the banquets on Thursday and Friday evenings. The strolling act application is on the PSACF website <u>www.pafairs.org</u>.

Finally, a big THANK YOU to the fairs who utilize all that the Trade Show vendors and associates have to offer.
