## FROM THE PRESIDENT

As usual, once fair season began it seems that the summer just flew by. I was able to visit several fairs this year that I had never been to before. Every fair provides wholesome family enter-

tainment for the public as well as promoting agriculture and each one does it in their own unique way. Pennsylvania should be proud of its county fairs. Of course some fairs had some rain but the biggest problem this year was "HEAT". Most fairs experienced some decrease in attendance during the hot midday temperatures. Vendors generally complained that food sales were low on the extremely hot days. At the time of this writing, cooler fall temperatures have arrived. Fairs that are still to be held shouldbenefit from these sunny but cooler days.

Now it's time to be thinking about our fall meetings and convention. Every fair has people that should be nominated for State Fair Person of the Year, Zone Person of the Year and Junior Zone Person of the Year. We all have people at our fairs that are most deserving of these awards for the efforts they put forth to make our fairs a success.

Your PSACF officers will be in attendance at all Zone Meetings to keep you up to date on concerns of the Association and the latest plans for Convention. Once again, the committees have a great convention planned with great speakers, judges school, a full slate of table topics, a huge trade show and lots of entertainment. The Spouse's Program and the State Fair Queen Coronation will round out the convention. But to me, one of the best parts of the convention is the time spent visiting and reminiscing with other fair people and old friends. It seems almost like "going to the county fair". See you at convention.





#### Overview

Pennsylvania lawmakers are heading into the final stretch of the current legislative session and the clock is fees in each county the mobile food vendor is in operaticking for the passage of legislation. The session ends November 30, but lawmakers have refrained from passing bills after Election Day in recent years. Between now and then, the Senate is scheduled for 9 days and the House is scheduled for 12 days.

Combatting the opioid abuse epidemic, pension reform and expansion of gaming are among the issues left in limbo before the summer break. With the pressure of the November 8 general election around the corner, it is unclear what will be accomplished. Any legislation left unresolved will need to be reintroduced in January when a new legislative session begins. The House returns to session September 19 and the Senate returns September 26.

#### **Budget/Revenue**

Pennsylvania's fiscal year started July 1. Lawmakers avoided another lengthy impasse and sent an on-time budget bill to Governor Tom Wolf's desk. Negotiations on how to pay for the \$31.53 billion budget stretched into mid-July. Despite the budget challenges facing the state, we are happy to report that Pennsylvania's fairs were funded with a state appropriation of \$4 million.

To balance the spending plan, lawmakers approved a \$1.3 billion revenue package. The package includes one-time revenue sources, relies on pending legislation to legalize internet gaming and allows tax delinquents to pay back taxes without penalty. It includes higher taxes on banks and also increases the tax on cigarettes from \$1.60 to \$2.60 per pack, imposes a 55-cents-perounce tax on roll-your-own tobacco and smokeless tobacco, and sets a 40 percent tax on the wholesale price of electronic cigarettes. The state's six percent sales tax is extended to digital downloads of videos, books, games, music, and applications.

There are no broad-based tax increases (i.e. personal income tax or sales and use taxes) in the electionyear budget. With your help, we were successful opposing efforts this session to put a six percent sales tax on admissions to amusement parks and other recreation-type businesses (e.g., county fairs, festivals, etc.). However, looking ahead to next year we do expect taxes to be on the table again. The revenue package did

We are continuing our efforts to enact legislation that would allow mobile food vendors to operate in multiple jurisdictions without having to pay multiple tion. As the law currently stands, mobile food vendors are required to purchase a license and be inspected in each food safety jurisdiction which they operate. This is an expensive venture that has proven to be unnecessary. We were successful in getting the legislation unanimously approved by the Senate and our strong push in the House is now bringing stakeholders to the table. Facing a short window for passage, there is a commitment to work on language to resolve the issue and hit the ground running in 2017-18.

#### **Political Landscape/Grassroots**

This year, along with presidential candidates Hillary Clinton and Donald Trump, all 203 House seats and half of the 50 Senate seats will be on the November 8 ballot. At this point, we do not foresee major shifts in Pennsylvania politics. It is likely that the Republicans will maintain control of the House of Representatives and Senate. Democratic Governor Tom Wolf has two more years of his original four year term remaining. Your issues are not partisan and there are many good friends working with us in the House, Senate and Administration. We must continue to build upon those relationships.

During a typical legislative session, there will be nearly 3000 bills introduced in the House of Representatives. In the Senate another 2000 bills. On top of that 2000 resolutions. Of the 5000 bills introduced, it is likely that about 4% or less will actually become law. The legislative process is meant to be frustrating, long and difficult. Imagine the outcomes if it was not.

This is why your involvement in the process is crucial to the future success and stability of Pennsylvania's County Fairs – whether advocating for a bill, funding or opposing a tax. After the November general election, it is go-time for 2017-18. Please get engaged.

I strongly urge those of you who qualify, to send in an application. The Wednesday night showcase committee looks for diversity: juggling, magic/illusion and novelty stage acts as well as musical groups, bands and singers – for all sizes of venues. Out of approximately 50 acts, 17 acts are chosen. If you are selected, you will be performing for over 100 fairs and buyers from all over Pennsylvania (from Maryland and New Jersey too) who are actively looking for acts that will

make their fair special. The showcase is a highlight of the convention, an excellent opportunity for fairs to experience acts/attractions/bands firsthand and book them early for the 2017 fair season.

Additionally, strolling acts/street musicians/ grounds entertainers (roving acts who do not offer a stage show) may apply to perform in the Chocolate Ballroom lobby prior to the banquets on Thursday and Friday evenings. The strolling act application is on the PSACF website <a href="https://www.pafairs.org">www.pafairs.org</a>. For those of you who are going to the website with a smart phone, some may need to click on 'desktop site' to get to the 'members' tab. Then click on 'associate information' and the strolling performers application is there.

The applications for the showcase and strolling entertainment must be received by October 15th. A DVD of you performing 'live' is required as part of your packet, not just an audio CD or a produced 'music video'. The entertainment decision-makers want to see what your actual live performance would be. Your submitted DVD should be short - 3 to 5 minutes of your best material. Please make sure it plays on players other than your computer. And *no paper labels*! Each year there are several acts that cannot be considered because their DVD will not play. Paper labels are a major culprit, or the DVD is only formatted for the computer on which it was burned. You must be a paid up member of the state association at the time you submit your application as well as at the time of the convention - January 2017.



### **Update from The Zones**


Zone One –Sam Zaffuto

## Preferred Contests & Angel Food Cake Contest

Checks for PA Preferred Contests and/or Angel Food Cake Contest have been mailed. Please cash this check as soon as received. Also, coordinate between the contest coordinator(s) and fair that the check was received for the contest(s) and cashed. Note that you are obligated to pay full premium for each placement regardless of the state budget and any decision your fair makes to pay less than full premium. In addition, any unpaid premium due to the lack of entries, etc. are to be returned to PSACF. Failure to do so will result in next year's check being reduced by that amount. Your post contest report will be used to identify unpaid premium. Any questions are to be directed to the appropriate state baking contest coordinator. Remember to submit your Contest Summary information to the appropriate person by the deadline specified; otherwise, your fair will be ineligible to participate in 2017.

#### **Showcase**

Associate members eligible to showcase were mailed applications in September. To be considered for the showcase, the application must be postmarked by October 15th to the showcase chairperson. Note: Dues must be paid in the year you receive the application, and if selected, in the year you showcase.

#### **Communications Competition**

A Communications Competition application is included in the convention packet and also available in the "Fairs Only" section of our website and must be postmarked no later than November 1st.

#### **Fair Person**

A Fair Person of the Year application is available in the "Member Fairs Only" section of our website, and also included in the convention packet application must be postmarked no later than November 1st.
