

## PA FAIR QUEEN STATE CONTEST

Many PSACF State Directors have reported, as they make their Fair Visitations, that this summer's local fair queen contests have gone extremely well, and that we will be seeing some excellent candidates vying for the title of 2012 PA Fair Queen. The state competition will once again be held in conjunction with the PSACF/PSSA Convention in January in Hershey, PA. Contest Applications have been mailed to fairs that submitted their Request Forms by the September 1 deadline. State Contestants' completed applications must be postmarked by November 15.

Some State Contest items of importance: 1) State Contestant Orientation will be moved up to a 3:30 pm start time on Thursday afternoon during convention; 2) There will be a "Contestant Pizza Party" on Friday night as part of the Queens' Party so fairs should not purchase Showmen's Banquet tickets for their Queen contestant that same Friday night; 3) Convention badge registration is necessary for all convention attendees (contestants, fair board, coordinators, chaperones, family and friends). Those only attending the Saturday coronation banquet must request tickets under their fair's registration; 4) Fairs should coordinate with their State Contestants on hotel room reservations; and 5) Next year's Queen Contest Information Packets distribution will take place at the 2012 convention during designated times near the Convention Registration Desk. Fairs must submit their Intent To Participate in the Program form by February 28. The 2013 State Application Packets will then be distributed to these responsive fairs at the Spring Zone meetings (similar to how Baking Contest packets are distributed).

The convention is always an important fundraising time for the PA Fair Queen Program. We invite all fairs and individuals to participate in this effort. We need volunteers to help out with the nightly 50/50 Raffle. We are also collecting monies to help purchase Gift Baskets for the Queens' Raffle Table. And we hope to hold a live auction again during the Coronation Banquet to raise additional funds. Any fair or person interested in helping with the fundraising events at convention, or who has sponsorship suggestions or new fundraising ideas, should contact John Berne (McKean County Fair) or Judy Kmetz (Luzerne County Fair).

#### Hershey Contests & Angel Food Cake Contest

Checks for Hershey Contests and/or Angel Food Cake Contest were mailed in August. Please cash this check as soon as received. Also, coordinate between the contest coordinator(s) and fair that the check was received for the contest(s) and cashed. Note that you are obligated to pay full premium for each placement regardless of the state budget and any decision your fair makes to pay less than full premium. In addition, any unpaid premium due to the lack of entries, etc. are to be returned to PSACF. Failure to do so will result in next year's check being reduced by that amount. Your post contest report will be used to identify unpaid premium. Any guestions are to be directed to the appropriate state baking Remember to submit your contest coordinator. Contest Summary information to the appropriate person by the deadline specified; otherwise, your fair will be ineligible to participate in 2012.

#### Showcase

Associate members eligible to showcase were mailed an application in early September. To be considered for the showcase, that application must be postmarked by October 15th to the showcase chairperson. Note: Dues must be paid in the year you receive the application, and if selected, in the year you showcase.

#### Fair Person of the Year

A Fair Person of the Year application is available in the "Fairs Only" section of the association website. Completed applications must be postmarked no later than November 1st.

#### **Communications Competition**

A Communications Competition application is available in the "Fairs Only" section of the association website and must be postmarked no later than November 1st.

#### **Future Association Mailings**

Please refer to the "Dates to Remember" on the cover concerning future mailings for the remainder of the year. These mailings will be important to both fairs and associate members as we approach the 2012 convention and the next fair season.

#### Fair Dates for 2012

I received some fairs 2012 dates previously; however, I will be confirming those dates at the zone meetings or through personal contact. Many requests are received before the end of the year for next year's dates, and those dates will be posted on the association web site by mid-November. Please assist me in compiling this information.

#### **Reimbursement Applications**

Read the instructions, complete the 2011 Reimbursement Application using the current version of the



MarTech Blue Ribbon software or the application through the association/PDA website. Print 3 copies of the completed application, obtain original signatures on all copies, and send to PDA Fair Fund Office along with the required supporting documentation (i.e. Premium Book, addendums, etc.). Also, an electronic copy is to be emailed or placed on a CD and mailed with the paperwork. Deadline is November 15th.

#### Msgr. John W. Mignot Scholarship Fund

Six scholarship selections have been made and the selected applicants/fairs will be notified by the committee chairperson. Those not selected will be notified by the committee chairperson or the zone chairperson.

#### **County Fairs Appropriation Falls \$10,000**

The final budget passed by the legislator and signed by the governor for fiscal year 2011-2012, lists the County Fairs appropriation at \$971,000. That's down \$10,000 from the prior budget. It is anticipated that the percentage of your request this year will be similar to last year. The following county fairs did not run or are running outside of the Fair Fund Act requirements this year: Bellwood-Antis Farm Show, Cumberland Ag Expo, Findlay Township Fair, Morrisons Cove Community Fair, Pike County Fair and Tri-Valley Community Fair.

#### Fair Season of Heat and Rain, Rain, Rain

A number of fairs in mid-summer saw a decline in attendance because of high temperatures and afternoon thunderstorms.

Then, came September with hurricane Irene and tropical storm Lee. Power outages, storm damage, flooding, and more. Some fairs experienced low attendance or didn't open several days (Juniata County Fair, Luzerne County Fair and others). Other fairs cancelled completely (Bloomsburg Fair and Denver Fair).

I'm sure fairs in your area will be more than willing to assist in any way possible with your recovery.



I am requesting a meeting with the Secretary of Agriculture and his staff in the month of September for the officers to discuss future funding of the fairs. The funding requests are due into the Governor by October 1st. Requests are then reviewed prior to the Governor's Budget Address in February. It is our hope, the state will double our appropriation in 2011-2012. Without this increase, we will continue to lose our smaller fairs. We could lose 3 fairs due to financial problems this year.

I have visited the Elizabethtown Fair and intend to visit the Allentown, West End, York and Gratz Fairs. I personally want to thank all the fairs that issued me invitations to their events, because only through their kind invitations do I see what good work and service the fairs provide their communities, counties, region and state.

Please make sure you invite your local legislators

to your fairs and take them around your fair to see what the fairs mean to the Commonwealth of Pennsylvania.

## 2011 DISASTER RECOVERY FOR FAIRS

Flood waters from Hurricane Irene and Tropical Storm Lee have affected many areas of the Pennsylvania's Commonwealth. agriculture community, including the fairs, was one of the hardest The Governor has given a disaster hit groups. declaration for 11 counties affected by Hurricane Irene and 26 counties affected by Tropical Storm Lee. If your fair sustained physical damage flood-related cleanup expenses, you are urged to contact the Emergency Management Agency (EMA) for your county for possible help. A list of the EMA's for each county is located in the "Fairs Only" section of the association's web site. The following is a list of all disaster declaration counties.

Hurricane Irene (Eligible counties include: Bucks, Chester, Delaware, Lehigh, Luzerne, Monroe, Montgomery, Northampton, Philadelphia, Sullivan and Wyoming).

Tropical Storm Lee (Eligible counties include: Adams, Berks, Bradford, Bucks, Chester, Columbia, Cumberland, Dauphin, Delaware, Lancaster, Lebanon, Luzerne, Lycoming, Montgomery, Montour, Northampton, Northumberland, Perry, Philadelphia, Schuylkill, Snyder, Sullivan, Susquehanna, Union, Wyoming and York).

Remember that it is imperative for you to apply before the October 15, 2011 deadline.
