PA FAIR QUEEN PROGRAM

The PA Fair Queen Program held its 26th Coronation on Saturday January 21, during the 2012 PA State Association of County Fairs and PA State Showmen's Association Convention in Hershey. 57 qualifying contestants competed for the title of PA Fair Queen.

Drew An Brubaker representing the **West Lampeter Community Fair** (Lancaster County) was crowned the winner. She is the 17-year-old daughter of Andrew and Pamela Brubaker and is a senior at Lampeter-Strasburg High School. She is involved in the National Honor Society, Fellowship of Christian Students, student tutoring, choir, swing dance club, school musicals and the school newspaper, among other activities. She plans to major in psychology and Chinese, the latter of which she studied last semester at Franklin & Marshall College's Early to College program. Drew An will receive a \$2,000 scholarship from the PA State Association of County Fairs at the conclusion of her reign as PA Fair Queen.

Amanda Mitcheltree representing the **Lawrence County Fair** was chosen as the 2012 1st Runner Up and will be the recipient of a \$500 scholarship at the end of this year. She is the daughter of Scott and Marlene Mitcheltree and is a sophomore at Virginia Polytechnic Institute and State University where she is studying dairy and animal science.

Both Brubaker and Mitcheltree will now go on to travel across Pennsylvania, meeting and speaking with legislators, the agri-business sector, and the public about the importance of Fairs and agriculture. State-sanctioned events will include Cornucopia, Tourism Day, Ag Progress Days, Farm-City Day, the 2013 Pennsylvania Farm Show, and the 2013 PSACF/PSSA Convention, along with

numerous Fair visits.

The other finalists included **Laura Metrick**, Big Butler Fair Queen; **Krystal Wasson**, Centre County Grange and Encampment Fair; and **Elizabeth Leasure**, Washington County Agricultural Fair.

Aimee Beth Gillispie, of the Jacktown Fair in Greene County, was named "Miss Congeniality," an award voted on by the other contestants.

This year's panel of judges included returning Judge Becky Brashear from Frederick, Maryland; Dennis Hazzard of Harrington, Delaware; and Dr. James Howe of Oley, Berks County. They reviewed each contestant based on a written essay, a personal interview, a speech presentation, and a stage Introduction at the PSACF Annual Banquet. The top finalists each had to answer the final question that if they became the next PA Fair Queen, what would they want people to remember as their legacy at the end of their reign.

All contestants participated in several activities during convention including a seminar on "Young Women's Leadership" presented by former PA Fair Queen Denise Sustrik Yoho (1990) and sponsored by Washington County Ag Fair.

They also assisted with the Communications displays in the Trade Show and the Queen Program's fundraising table. New experiences this year included a Pizza Buffet at the Queens' Party, sponsored by Drum The Bucket entertainers, and the live Lonestar concert at the PSACF banquet!

The Contest Coordinators would like to recognize the major sponsors - PA Department of Agriculture, PSACF, S & S Amusements, Drum The Bucket, Skelly's Amusements and Great Signs (t-shirts). A special "live" auction of a print and wooden artwork during the coronation banquet helped raise an additional monies for the Program.

The official 2013 State Competition Application Packets will then be distributed at the Spring Zone meetings to these responsive fairs.

The PA Fair Queen is a wonderful asset for promoting your Fair or agricultural event! The Queen and the First Runner Up are available for appearances throughout the year. These can include special ceremonies, contests, parades and ag-related events. All appearances are to be initiated in writing using the Queen Program's official Scheduling Request Form (available at www.pafairs.org) from an authorized event coordinator or event board member.




GOVERNMENTAL CONSULTANT'S REPORT

The Governor's budget was a gut wrenching experience. The Governor removed the county fair funding from the line item in the Department of Agriculture's budget. The funding was returned in the section from gambling proceeds.

The advantage to the new process is that the funding is going to be a dedicated stream of funds to the fairs every year. That funding is near \$900,000 and the legislators are trying to increase that amount before the budget becomes final in late June or early July. The best estimate would be for the fairs to receive funding somewhere between \$3 and 4 million.

Our advocates for increased funding will be Rep. Millard, Rep. Maher, Senator Vogel, Senator Robbins and Senator Waugh and the sixty-some members of the fair caucus. I will be designing a support program for our members to follow to assist the legislators as they work on increased funding.

We will coordinate our efforts with the legislators and the fair caucus, and hopefully increase the \$900,000 to a somewhat higher figure for this year's budget. Please await our plan but be ready to work with your legislator when called upon to do so.

At present, please thank the legislators named in this report. I will try to obtain a list of the fair caucus members and include them in our thank you and support element.

The fairs received 2 citations, one from the Senate and one from the House for the 100 Anniversary celebration. We are also obtaining a House and Senate citation for Bruce Koppenhaver for "2011 Fair Person of the Year" and the 2012 PA State Fair Queen Drew An Brubaker which will be presented to them in the near future.

Every fair should write a thank you email or letter to Rep. Millard for his tireless efforts on behalf of the fairs. His support was responsible for our keeping our funding.

Remember, things just don't happen...people and programs are the driving force to success.

Congratulations to **Kempton Country Fair** (Apple Pie), **Allentown Fair** (Angel Food Cake), **Sykesville Ag & Youth Fair** (Chocolate Cookie-Brownie-Bar) and **Elizabethtown Fair** (Chocolate Cake) on having a first-place winner at the 2012 PA Farm Show! Total Farm Show participation included **66** Angel Food Cakes, **73** Apple Pies, **79** Chocolate Cookies-Brownies or Bars, and **75** **Chocolate** Cakes.

All 4 baking contests will be held again in 2012. In addition, we are excited to announce a **NEW sponsor** for the Chocolate Cake and Chocolate Cookies-Brownies-Bars contests, **PA Preferred™**, a state-sponsored agricultural marketing program that identifies and promotes food and agricultural products grown, produced or processed in Pennsylvania. New contest rules, sponsor logo, display banners and 1st place rosette ribbons will be made available to all fairs participating in the 2012 Chocolate Baking Contests. Contestants will be encouraged to use as many Pennsylvania-produced ingredients as possible in their chocolate baking recipes. A list of member locations can be found on www.PAPreferred.com.

With this new sponsorship, it will be very important for fairs to update their premium book and all other media (tabloids, websites, press releases, etc.) to reflect the new rules and PA Preferred™ as the new Sponsor. *Discontinue use of any "Hershey" banners, ribbons, etc. as they are no longer the sponsor.*

All 2012 Special Baking Contest Chocolate Contest ribbons and banners, as well as contest documents for all the special baking contests, will be distributed at the Spring Zone meetings to fairs that returned their Intent to Participate form by the February deadline. Contest documents are also available from the PSACF website (www.pafairs.org, use Member Login, Baking Contest link).

A few reminders for the 2012 contest season:

1. Continue to follow the "once and done"

contestant eligibility rule; i.e. once a contestant wins 1st place at a 2012 fair in a particular PSACF Special Baking contest, they are no longer eligible to compete in that same baking contest at any other fair in 2012.

2. Communicate all special baking contest rules and requirements to your fair's contest volunteers and judges so that winners are properly certified and are legitimately eligible to compete at the PA Farm Show competition. Remember, if your fair's first place winner cannot attend the PA Farm Show competition, fairs can certify the next eligible winner. A great turnout of fairs at the PA Farm Show is a great boost for the contest sponsors!

3. Fair contest ribbons will only be provided for the special Chocolate contests. Ribbons for Apple Pie and Angel Food Cake are at the discretion of the fairs.

4. Scrapbook materials are no longer required to be submitted for any of the contests. Fairs will only need to send in the Contest Summary forms in a standard envelope. This will save fairs time and money!

Fairs must provide the winner names and phone numbers for places 1st through 3rd for each contest. Any sponsored prize money not awarded must be returned to PSACF.





KOPPENHAVER NAMED FAIR PERSON OF THE YEAR

GRATZ - He was literally born into it and at the mention of his birth date, is when Bruce Koppenhaver, of Gratz, finally realized he was being named this year's Fair Person of the Year.

Koppenhaver received the prestigious award during the 100th Annual Convention of the PA State Association of County Fairs held January 18-21, at the Hershey Lodge and Convention Center, in Hershey.

As the presenter at the convention listed Bruce's involvements, his daughter, Nicole and her husband, Mike Wehry, who reside in Kansas, waited in the shadows until Bruce's name was announced and then surprised him with their presence at the convention.

"It was so nice for Bruce to get this award," said Dorothy Klouser, a new member to the Gratz Fair Board of Directors. "He sat there listening and thought it was someone else they were talking about until he heard his birth date. His entire face changed and he knew then that they were describing him and then when his daughter and son-in-law appeared he was really surprised."

Bruce's family affair began with his parents Gilbert and Marie's first date at the Bloomsburg Fair," said Bruce. He says his began at birth during fair week in 1949.

One of my childhood memories was when my dad had my brother, Gary, and I perform security one evening for the Grange Building," shares Bruce. "The family car was pulled into the building where we slept. I'm not sure how much "security" we offered because during the night we heard a loud crash. We both refused to get out of the car due to what I'm assuming could only be classified as paralyzing fear. When the sun rose it was HORRIBLE - actually we discovered a fallen photo's glass had broken. No robbers had attempted to steal anything!"

Not only was his father Gilbert involved in the fair business, but his grandfather as well. Three generations of hard work for agriculture came from the Koppenhaver family.

Bruce's official fair experience started when his father, Gilbert, saw the Gratz Fair's need for the younger generation to get involved with the fair. Bruce purchased a fair stock in 1980, and was elected to the Gratz Fair Board of Directors and Executive Committee, being elected Treasurer. Both Bruce and his brother-in-law Rod, began their trip down the fair path. Rod was on a number of committees and eventually as chairman for gate and security. Bruce was involved in exhibits, treasurer, and later as president. He was elected President of Gratz Fair, a position he still holds today. Bruce is also the executive secretary/treasurer of the Pennsylvania State Association of County Fairs (PSACF).

"He truly has earned this recognition and as his auto license plate states, he is MR FAIRS," said the presenter at the convention.

PSACF says they have witnessed Bruce's management skills as he leads the Gratz Fair Board members and other community leaders of the Upper Dauphin area to work together to promote, improve and set standards for the operation of the Gratz Fair. Bruce used his programmer skill to provide leadership for exhibit management software to be purchased and utilized.

Bruce established a scholarship program for exhibitors in 1994. In the past 17 years, 100 exhibitors have received over \$50,000. Scholarships are funded by the craft shows he coordinates annually.

Under his leadership, the Gratz Fair Queen Program was re-established in 1993, with 18 Queens

and alternatives receiving scholarships.

Bruce's father was involved at the state level on the PA State Association of County Fairs Executive Committee since the mid-80's. Again, his father thought of younger participation, and so Bruce was elected to take his father's place on the board in 1989. He has served and chaired various committees. He is editor of the PSACF newsletter, FairTalk. He has served since 1995 as Executive Secretary/Treasurer of the association and organizes the annual convention.

Bruce earned the title of Certified Fair Executive from IAFE in 2002.

"Having enjoyed my time at the state level, my 12th two-year term expires at the next convention," said Bruce. "I will not be seeking reelection and will turn my focus back to the local fair."

Although Bruce says he plans to turn his focus back to the local fair, it truly has never left, Bruce is constantly trying to come up with new ideas and different things to boost the fair. A new event is being planned for this year and more details will be announced as they become available.

"We are hoping to add revenue to the fair with a music and wine festival and are hopeful that this event will also bring awareness that there is a fair held each year," said Bruce. "I would also like to promote and generate more non-fair usage, which would mean more revenue, but also requires more time and effort. It's no use having the facility set idle except for fair week."

Bruce says young people involvement is a



problem that most fairs throughout the state are facing. He said he would like to pursue a junior fair board to assist and add youthful insight.

"Over the years we have lost some key people and you wonder how you're going to cover those areas and then you are fortunate to have folks like Dottie and Bruce Klouser step up to the plate," said Bruce. "Without a great board of directors the Gratz Fair could not take place. It's not one single person who makes the fair happen, it's the efforts of the entire board."

Other than fairs, Bruce is involved in his community fire company, the Masons and Tall Cedars, and has served on the Borough Zoning Board for many years.

On a personal note, he attended Upper Dauphin Area High School and graduated from Harrisburg Area Community College. For over 30 years he worked for the Commonwealth of Pennsylvania in the civil service, personnel and payroll departments, retiring in 1999. In 1970 he married his wife Linda.

He is very active at his church and has been a member of the church choir since a teenager.

"My dad and I are the only father-son to receive this award," says Bruce. "He received his award in 1992. As I look at the honor of this award, I'll reflect on the accomplishments that dad, Rod, and I, plus others that gone on before, shared together."

100th PSACF/PSSA Convention

The 100th PSACF/PSSA Convention began the 100th anniversary celebration of the PA State Association of County Fairs, with the theme "A Century of Celebrating Fairs and Agriculture." The convention was held at the Hershey Lodge and Convention Center in Hershey, PA on January 18 - 21, 2012. Registration was 1,677, a slight increase from the previous convention. Points of interest during the convention were: Showcase of Entertainment (Wednesday) and a number of meal functions with entertainment. Seminars, consisting of education topics, and Table Topics for general discussion and sharing. The spouses programs consisted of "Basket Bingo" and "Quilting." In addition, they could shuttle to/from the "Hershey Story" Museum. The Trade Show had over 150 booths, and consisted of various goods and services. The indoor space allowed for a variety of items to be on display such as booking agents, musical groups, miscellaneous entertainment, fair suppliers, and others. As in previous years, there was a food court located in the Trade Show area. Of special interest this convention was a memorial booth (photos/names/affiliation of those departed in the past year) and 100th anniversary booth (memorabilia from previous conventions) directly inside the Trade Show entrance.

Thursday

The Opening Celebration on Thursday morning had entertainment and was highlighted by keynote speaker, Sam Hayes Jr., a former PA legislator and PA Secretary of Agriculture. His presentation was sponsored by Power Pulling Productions, LLC - Lucas Oil Pro Pulling League, New Brighton PA. A 100th anniversary prize of a John Deere Gator was awarded to the Crawford County Fair, Meadville PA. The PSACF Annual Banquet where the PSACF officers, directors, past presidents, and past fair persons of the year were acknowledged. Bruce Koppenhaver, CFE of the Gratz Fair, Gratz PA was named "2011 Fair Person of the Year." Entertainment for the evening was the national recording band "Lonestar." A 100th anniversary prize of a golf cart, sponsored by GC Supply of Uniontown PA, was awarded to the Mifflin County Youth Fair, Reedsville PA. This event was attended by over 950 people.

Friday

The Communications Breakfast where the winners of the communications exhibits were awarded.

The PSACF Annual Meeting was well attended. A 100th anniversary prize of a computer package, laptop and printer, was awarded to the Kempton Country Fair, Kempton PA.

The PA Showmen's Banquet where Irv Good was named "2011 Showman of the Year." Another golf cart, sponsored by the PA Showmen's Association, was presented to Boots Klinger of the PA Showmen's Association.

Saturday

During the noontime auction drawings, a 100th anniversary prize of an office equipment package, copy machine and supplies, was awarded to the Clearfield County Fair, Clearfield PA.

The Coronation Banquet where the 2012 PA Fair Queen, Drew An Brubaker from the West Lampeter Community Fair, was crowned from among 57 fair queen contestants. A 100th anniversary prize of a computer package, laptop and printer, was awarded to the Sullivan County Fair, Forksville PA.

PSACF officers for 2011-2012: President – Ron Miller, Kutztown Fair; Vice-President – John Blaney Jr., Fayette Co. Fair; Exec. Secretary/Treasurer – Bruce Koppenhaver, Gratz Fair; Immediate Past President Jim Davis, Huntingdon Co. Fair.

2013 Convention is January 23-26 at the Hershey Lodge & Convention Center, Hershey PA.

Promoter License

The PA Department of Revenue did a renewal of each fair's promoter license for 2012. Every fair's license expired in January, 2012. Contact Marvin Paulk at (717) 772-2906 or mpaulk@state.pa.us if your fair did not receive a valid license for the year. Reminder: if any business, person, etc. has sales (food, supplies, equipment, etc.) at your fair, the fair must have a promoter license. An application is located on the association website under "Fairs Only." If the fair only has sales (and nobody else), then no license is required.

Fair Funding

The line item for "Payments to PA Fairs" was moved from the "PA Department of Agriculture" into the "PA Race Horse Development Fund." The proposed amount is \$874,000 and is at the current budget's post-freeze level.

The association's officers will be scheduling meetings with key legislators and leadership during the coming weeks. After the budget hearings, which recently concluded, we will meet to discuss and develop a "plan of action." It is anticipated that this plan will be released to fairs (at zone meetings) and to other interested parties.

Prior to the release of this plan, we will be accepting comments for consideration.

2012 Theme

The 2012 fair season theme, and for the fair display at the 2013 convention, will be "A Century of Celebrating Fairs and Agriculture." No theme slick was printed; however, a sample will be available in the "Fairs Only" section of the association website by late-March.

Msgr. John W. Mignot Scholarship Program

The 2013 scholarship material will be posted to the association website by April 1. At the present time, funds are available to release five (5) scholarships. In order to release the maximum of six (6) scholarships, a minimum of \$1,772 must be raised. Please consider donating to this worthwhile program.

Based on last year's applications, the following observations were made:

An applicant must apply his/her efforts equally to all areas/criteria. Even though "fair participation" counts for 30%, the other areas/criteria are as important.

A fair's endorsement should be detailed/knowledgeable/enthusiastic of the applicant and not a "rubber stamp."

The 2012 show was a huge success, with all time records set in attendance, parking and food court sales.

It was great to see so many fair volunteers helping make the Farm Show happen. The Department of Agriculture thanks members of the fair family who worked tirelessly to ensure the Farm Show's ultimate success.

In a twist to a favorite contest, the chocolate cake contest will be sponsored by PA Preferred™, the permanent branding program for our state's agricultural products. Keep an eye out for its logo: a gold checkmark inside the blue keystone with the tagline: "Made in PA. It makes a difference." We created a special tagline for our fruit and vegetable growers: "Grown in PA. It makes a difference." Whether it's grown or made in PA, it makes a difference in our economy. The program keeps money and jobs in Pennsylvania by identifying for consumers the goods produced by our local farmers and agribusinesses. We're proud to sponsor a contest that celebrates the talent and creativity of Pennsylvanians.

Congratulations to the fair association and Pennsylvania State Showmen's Association for another successful convention. We enjoyed the camaraderie with our fair friends and the excellent entertainment. We look forward to working with 2012 PA State Fair Queen Drew An Brubaker in continuing to celebrate the fair association's centennial.

It's great to see Bruce Koppenhaver, PSACF Secretary-Treasurer and Gratz Fair Board President, honored as the 2011 PSACF Fair Person of the Year. Bruce works tirelessly every day for the betterment of Pennsylvania's fairs, and serves as a great resource to me and my assistant Michelle Worden.

Secretary George Greig recently announced appointments to the PA Fair Advisory Board. We thank John McMullen of the Indiana County Fair, Beverly Gruber of the Schnecksville and Allentown Fairs and Larry Krome of the West End Fair for their years of dedicated service on the board. We welcome James Davis, Huntingdon County Fair and PSACF Past President; Ed Nehrig, Indiana County

Fair and PSACF 2010 Fair Person of the Year; and Casey Hall, PA FFA State President and 2010 PA State Fair Queen, as the newest members of the board.

We're nearly finished with the Fair Fund reimbursements.

Just a reminder: the Department of Agriculture does not issue any payments. We submit your approved application to the comptroller and on to Treasury for payment. If the organization's name, address, federal EIN or vendor number is inconsistent with current state records, the application will not be sent to treasury. Because each organization is considered a vendor, any discrepancies can only be resolved by the vendor filing a formal change request. We will try to prescreen applications next year. If you have any of the aforementioned changes, please let us know before the November application deadline. A little work beforehand will make the process a lot smoother.

We are also updating all our applications and forms, giving them a fresh look and better accessibility and flexibility. You'll be able to download the forms, fill them out by computer and email them back to us, or print them for filling out and mailing back.

Questions that came up during the application approval process:

Our fair pays out small awards in cash. Is that a reimbursable expense? According to the PA Agricultural Fair Act regulations (102.23 Eligibility), to be eligible for a grant, the applicant shall have complied with, and agree to comply with, the following requirements: **Premiums, awards and operational expenses shall be paid by check.**

How long must we keep our fair records? The Pennsylvania Agricultural Fair Act Regulations requires all applicants to keep records **for a period of three years or more** and make them available to PDA for audit or inspection. You should discuss with your accountant or a tax expert concerning any state or federal requirements on record keeping.

The 2012 PA fair season will soon be upon us, and I'm ready for it. It begins in Somerset County at the Pennsylvania Maple Festival March 24. Secretary Greig and I look forward to visiting with you at your local fair.
