**TOURNAMENT DATE:** Saturday, June 8, 2024

**LOCATION:** Jackie's Brickhouse: 1053 Marina Bay Dr, Kemah TX 77565

**ENTRY FEES PER DIVISION:**

- Open (Ages 17 and up) - \$125 per angler (\$150 after May 11, 2024)
- Youth (Ages 8-16) - \$75 per angler
- Team (2-4 Person) - \$600 per team

**NOTE:** No Guides in open or youth divisions! Guides may register as a team member in the team division (see rule 20).

**Stringer Info:** The angler weighing the heaviest stringer of up to 3 legal Speckled Trout (15"-20") and up to 2 legal red drum (20"-28").

**Open Division – 1 Stringer**

1. **Grand Champion:** \$500, 1 Belt Buckle, and 1 new rod
2. **Reserve Grand:** \$250, 1 Belt Buckle, and 1 new rod
3. **3rd Place:** \$125, and 1 new rod

**Youth Division – 1 Stringer - In the event of no stringer any legal fish will be allowed to enter.**

1. **Grand Champion:** 1 Belt Buckle, and 1 new rod
2. **Reserve Grand:** 1 Belt Buckle, and 1 new rod
3. **3rd Place:** 1 new rod

**Team Division – 2 Stringers**

1. **Grand Champion:** \$1,200, 4 Belt Buckles and 4 new rods.
2. **Reserve Grand:** \$600, 4 Belt Buckles and 4 new rods.

**ANGLER KICKOFF MEETING:** Friday, June 7, 2024, at Jackie's Brickhouse from 6:00 PM to 8:00 PM (**All Anglers are strongly encouraged to attend**). The meeting will review rules, prizes, and any other event details. Entry registration will be taken until end of the meeting.

**TIME:** There is no morning check-in. Fishing starts at 5:45 AM and Weigh-in starts at 1:00 PM and ends at 3:00 PM sharp. YOU MAY NOT BEGIN FISHING UNTIL 5:45 AM AND YOU MUST BE IN LINE BY 3:00 PM WITH FISH IN HAND FOR WEIGH IN! NO EXCEPTIONS!

**REGISTRATION:** The attached entry registration form must be mailed, emailed, or delivered to the Rodeo office before May 11, 2024. Entry fee is nonrefundable. We will accept registrations after May 11, 2024, but will not be guaranteed a T-shirt.

**WEATHER:** If the weather is determined too dangerous by the Tournament Director, the tournament will be rescheduled for a later date. Please keep the Tournament Director's cell phone number with you during tournament hours. If we believe the weather could be a factor, we will update our Facebook page (PLS&R Reel Rodeo Fishing Tournament) with information as well.

**TOURNAMENT RULES**

1. All Federal and State rules and regulations will apply. Violation(s) will result in disqualification.
2. Fishing will not start until 5:45 AM, you may be at your fishing location, but you cannot start fishing until 5:45 AM.
3. All entry fees must be paid when you send in your registration form.
4. No one may hold your fishing spots.
5. There is no limit as to the area that may be fished if it is in Texas waters that are open to the public.
6. All fish must be submitted for weigh-in by 3:00 PM. If you are in line at 3:00 PM WITH FISH IN HAND, then you have made the deadline, and your fish will be weighed. No exceptions!!! We will go by Verizon Cell Phone Satellite time. Please allow time for unexpected delays getting back to weigh-in.
7. Only fish caught during the tournament hours are eligible. All fish should be fresh and in an edible condition. Fish that have been frozen, gutted, or mutilated will not be eligible and the angler attempting to weigh a fish that is not legal will be disqualified.
8. Although it is legal to retain and tag a Red Fish over 28 inches, for the purpose of this tournament a tagged Red Fish will not be accepted. (Slot reds only 20"-28")
9. All fish entered are subject to inspection and seizure by the Tournament Director after dissection and/or Torrymeter if the Director feels that the need is necessary.
10. All fish must be caught on rod and reel. Each Angler may only fish with one rod and reel at a time.
11. Any Angler found to be in breach of tournament rules will be disqualified and will forfeit all fees and awards.
12. Pooling or transfer of fish is strictly prohibited.
13. Protests must be addressed to the Tournament Director by 3:15 PM.
14. When a tie exists, with respect to weight, then the first fish/stringer weighed in will be declared the winner, unless the Tournament Director rules otherwise.
15. The Tournament Directors decision will be final.
16. All anglers of age required must have a current Texas Fishing License and Saltwater Stamp.
17. Boat, bank, pier, kayak, wade fishing with rod and reel are all eligible methods for this tournament within TPWD guidelines and regulations.
18. Each angler will weigh their choice of up to three (3) legal speckled trout and two (2) legal red drum they have caught.
19. All fish will be measured in accordance with TPWD rules on measuring fish. Pinching of tail to get maximum length will be in place according to TPWD guidelines.
20. **Guides are only allowed to participate or be present with tournament contestants in the Team Division.** A Guide is considered any person who has received payment for fishing services within the last 2 years with or without a Captains license.

**Side Pots**

**1. Reel Rodeo Slam (\$25/per entry)**

- Weigh in 3 fish consisting of (1) Trout (15" – 20"), (1) Flounder (15" or greater), (1) Redfish (20" – 28"). Winner will be heaviest 3 fish stringer. If there are no 3 fish stringer, the winner will be the heaviest 2 fish stringer. A full 3 fish stringer will beat a heavier 2 fish stringer
- Winning Angler receives 50% of pot, PLS&R receives 50% of the pot

**2. Redfish with most spots (\$25/per entry)**

- Angler that turns in a legal "slot" red with the most spots wins 50% of the pot PLS&R receives 50% of the pot
- If there is a tie the Angler who turns in the heaviest slot legal red will be declared the winner

**3. Largest Hardhead (\$25/per entry)**

- Angler that weighs in the largest hardhead (excludes "Gafftopsail") wins 50% of the pot PLS&R receives 50% of the pot
- If there is a tie the Angler who weighs in first wins.

Note: Tournament entries may be used for side pots entries.

**Angler must be a paid participant to be eligible to enter and win all side pots**

**Fishing Tournament RELEASE AND WAIVER OF LIABILITY**

For consideration of participation in the PLS&R Reel Rodeo "Fishing Tournament" event to be held on Saturday, June 8, 2024 I, \_\_\_\_\_, waive and release the Pasadena Livestock Show and Rodeo ("PLS&R"), its chapters, directors, officers, administrators, representatives and executors, past and present employees, volunteers, agents, supervisors, participants, all city and state governments, assigns, all sponsors, their representatives and successors (collectively, the "Releasees"), from any and all claims, liabilities, or cause of actions arising out of an injury to me (or my child) and from any and all claims, liabilities, or cause of actions arising from my (or my child's) participation or attendance in this event.

**Inherent and Potential Risks**

I understand that the Fishing Tournament involves strenuous physical activity associated with fishing. I understand that physical activity, by its very nature, carries with it certain inherent risks. I assume all risks associated with participating in the Fishing Tournament relating to the risk of strenuous physical activity. I acknowledge that I may incur minor injuries, major injuries, and catastrophic injuries including paralysis and death. I assume risks from contact with other participants, negligent or wanton acts of other participants, failure of other participants and non-participants from observing the guidelines of the Fishing Tournament, any defects of conditions of premises (including high or low water levels and rough waters), and the effects of weather including high heat, thunderstorms, lightning, precipitation, cold temperatures, high winds, and/or humidity.

I agree to dress myself (or my child) appropriately as to mitigate risk of physical injury to myself (or my child) including, but not limited to: wearing shoes appropriate for strenuous physical activity involved in the Fishing Tournament; and dressing in conjunction with the weather.

I agree that the Releasees are not responsible for any personal items or property lost or stolen before, during, or after the Fishing Tournament.

**Medical Evaluation**

I attest that I (or my child) am medically and physically able to participate in the Fishing Tournament. If I experience any doubt as to my (or my child's) ability to successfully and safely participate in and/or complete the Fishing Tournament, I take full responsibility for consulting a physician. I attest that, if I (or my child) am pregnant, disabled in any way, or have recently suffered an illness, injury, or impairment, I (or my child) should have or did consult a physician prior to participating in the Fishing Tournament.

I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me (or my child) as medical professionals may deem appropriate. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency, including, but not limited to, negligence emergency rescue operations.

**Voluntary Participation**

I am fully aware of the risks connected with participation in the Fishing Tournament, whether specifically listed in this Release or not, and I voluntarily elect to participate in the Fishing Tournament knowing that this participation involves these risks. I understand that my participation in the Fishing Tournament accompanies a minimum fundraising obligation for the benefit of PLS&R.

**Assumption of Risk, Waiver of Liability, Release, and Covenant Not To Sue**

In consideration for being permitted to participate in the Fishing Tournament, I voluntarily agree for myself, my family, heirs, assigns, executors, and administrators to the following:

1. TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me (or my child), or any loss or damage to property owned by me (or my child), as a result of participating in the Fishing Tournament.

I understand and agree to stock my vessel with one Coast Guard Approved Personal Flotation Device (PFD) per passenger, including captain and crew, in accordance with Coast Guard Regulations. For vessels over sixteen feet long, a throw-able PFD (such as a boat cushion or life ring) must be on board.

**Severability**

I agree that if any portion of this Release is deemed to be invalid, the remainder of the Release will still be binding and enforceable.
