APPROVAL OF MINUTES

Mr. Kenney presented requests for approval/recommendation

- A. Tazewell County Asphalt The Marquee parking lot received one bid to include sealcoat, striping, crack filling and patches from Tazewell County Asphalt for \$28,000. The Marquee parking lot may need additional work done. There is \$53,000 budgeted for the parking lot. Ms. Bourland made a motion to approve the proposal, with the option of taking an additional \$25,000 for parking lot repairs. The motion was seconded by Mr. Silverthorn and was unanimously approved.
- B. Sterling Commercial Roofing Inc. A bid to complete the removal and disposal of existing pavers and installing new Firestone Sky paver for all the balconies came to \$101,800. For efficiency and finances the committee would like this project complete all at once. Mr. Silverthorn made a motion approve the proposal. The motion was seconded by Ms. Bourland and was unanimously approved.
