Regular Business:

January 2023 Financial Statements

Director of Finance Mindi Baumann reviewed the January 2023 Financial Statements. We had 31 event days with an attendance of 50,618. We had one grant funded event: IL Music Educators. Successful events included Winter Jam, Globetrotters, Stomp, IL Music Educators, and IL Fertilizer and Chemical Annual Meeting. Operational Supplies were up \$4,269 and included paint removal for the Spotted Cow signs. Net Income was up \$227,371 Actual vs Budget.

Discussion/Informational Items:

1. Naming Rights RFP

There was nothing to report at this time.

2. SAVOR - Cash Handling

Director of Finance Mindi Baumann informed the Committee that there will be an update from discussions with corporate at the next meeting.

3. Director and Officer Insurance

Director of Finance Mindi Baumann reported that the quote for the Director and Officer Insurance has not yet been received. Cyber Liability Insurance was down \$100.

4. Capital Committee Action Item Update

Projects:

Installing Locks Theater Balcony – Parts are expected Mid-February.

Domestic Hot Water Heaters – One of the hot water heaters is still under warranty.

Arcade Doors and Frames Hit by Vehicle – Project is complete.

Arena Zam Entrance Doors – Replacement is complete.

DCEO Capital Grant:

Cooling Towers – 85% Complete. Final testing still needs to be done.

Parking Lot Resurface – Project is complete.

Roof Replacement – Work to begin in March, contractors ordering materials/supplies. Staff is working to determine where supplies can be stored and where equipment can be set up.

Glass Arcade – Discussions on design.

Arena Retractable Seating – Out for bid. Bids will be opened March 28, 2023. Half of the project is expected to be done this year and the other half next year.

Arena Star Dressing Room – This project should start in late March or early April. Scoreboard and Video Boards – Replacement Hoist has been ordered. The plan is for it to be installed before next season.

5. Capital Spending Report

The Capital Committee is reviewing the spending report as it is currently over budget and some budgeted amounts need to be rearranged. There is a budget line item for contingency. A lot of this work has not gone out to bid at this time.

6. DCEO Grant Implementation, Amendments and Capital Priorities Design work only is being reimbursed at this time.

7. Capital Improvements / Grant Resources / Allocations

Capital Committee Chairman Matt Bartolo discussed the capital project list created from the 30 year capital budget created in 2019. Quality of life issues need to be considered and the Rivermen started that process. The City of Peoria has discussed working on a plan so that the Peoria Civic Center would get \$20 million to cover most of the capital needs on the project list. PCCA Chairman Yvonne Greer-Batton stated that these funds would give the PCC the availability to address most of the capital projects. City Manager of the City of Peoria Patrick Urich spoke about the debt service plan currently in place and possible options for funding for the future. These options have not been approved by the City of Peoria at this time. If funding is approved, the current
