We had four funded events which included: State Skills Conference, Collie Club, PSO, & Clean Water Celebration. Total Event Income was up Actual vs Budget. Successful events included: Journey, AEW, Jesus Christ Superstar, Riverman Playoffs, State Skills Conference, & Collie Club. Ticket Rebates were up Actual vs Budget. Convention Services were up Actual vs Budget. Parking was up \$15,227 Actual vs Budget. HRA Tax Revenue was \$74,540. Interest Income was up Actual vs Budget. Net Income for the month was up \$161,917 Actual vs Budget.
