#### **April 2021 Financial Statements**

Director of Finance Mindi Baumann reviewed the April 2021 Financial Statements. We had one event in April. It was a testing site for Engineering students. Direct Event Income included recognizing income for the one April event and expenses for two cancelled events. Convention Services showed our first money generated by the Peoria Flag acquisition. Expenses continue to be down due to the current mitigation plans in place. Net Income for the month was up \$87,142. Commissioner Ross asked about the current cash flow statement. General Manager Rik Edgar stated that we will be receiving \$1 million dollars from the city before June 1st. This is part of the \$4 million

dollars that was approved from the bond restructuring. As of the date of this meeting the Peoria Civic Center has received \$2 million dollars.
