FY 18 Budget

Beau Sutherland discussed the two open suites, Winterfest plans, and Lexus Club upgrades.

Andrew VanDeweghe stated that there will be no renovations to stands and there will be normal price increases for Savor. Danette Snopek then presented an adjusted budget and explained the changes. There were discussions on using the building as a cell tower and how HRA is accounted for and showed on reports. The capital budget was reduced from \$900,000 to \$600,000.

New Business

July 2017 Financial Statements

Danette Snopek reported 20 event days versus a budget of 10. In the convention center, four banquets occurred versus two budgeted. The Illinois Deer and Turkey Expo consumer show

was budgeted in August, but occurred in July. The Diocese Beatification was budgeted but did not occur. Six meetings occurred versus a budget of one. In the theater, both the Brit Floyd concert and Dancing with the Stars entertainment event were unbudgeted. Wages/benefits, insurance expense, and electricity are under budget for the month with repairs/maintenance being over budget. The HRA to the Peoria Civic Center was over budget by \$73,826 due to several hotels paying past due amounts to the City. The re-projected operating loss for the fiscal year is \$12,274.
