Will Kenney presented the ASM Global Venue Shield program.

- Program to design re-opening plan.
- Introduced the Workforce Safety pillar of the Venue Shield program
- Guidelines follow best practices
- ASM Peoria is creating a venue specific program to match Peoria market

- Monthly Operations Call
 - o ASM Global Venues are re-opening and implementing the Venue Shield program, giving us the opportunity to strengthen our re-opening plan through the experience of other venues.
 - Working on public awareness and client expectations as to what safety precautions PCC is taking.
 - Our revised client contract now requires COVID mitigation plan from client 30 days prior to event.

- o Mr. Kasper suggested we look into antigen testing as this is becoming the new standard in COVID testing. Will make contact with U of I Chicago.
- o Exploring establishing a PCC Medical Expert
- We are also looking at establishing a contact tracing system through the sale of cashless tickets.
- Recommendation Clear Bag Policy
 - o Enhanced Security
 - o Speeds up lines
 - o Decreases contact in regards to COVID
 - o Opportunity for Team Branding
 - o New standard among venues.

Commissioner Eddlemon conducted a roll call vote to recommend the adoption of the Clear Bag Policy to the Peoria Civic Center Authority and it was approved by unanimous consent.
