LIVESTOCK RULES FOR CAMPING ON-SITE FOR THE FAIR

- 1. Camper must stay overnight for the nights listed above with exception of ONE (1) night only.
2. No one under the age of 18 will be permitted to stay without an adult.
3. Campers must help feed hogs in the mornings on a rotating schedule.
4. Large animal exhibitors will take priority, FFA Advisors & 4-H Leaders next, then Show Directors and Volunteer workers.
5. There are 12 camping spots available. If more eligible campers apply, preference will be given to previous participation and volunteer hours.
6. Donation of Time or Talent is a MUST.
7. MUST attend the Beef Exhibitor & Camping meeting in September.
8. Camper will be issued ONE (1) drive-in vehicle pass.
9. The Fair Authority will determine location, direction and assign all camper spaces.
10. NO alcoholic beverages, drugs, vulgar language is permitted.
11. There will be connections for water and power only. Use of your on-board holding tanks is required for all gray and black water.
12. It is the responsibility of the individual to take care of their holding tanks. We do not offer on-site disposal.
13. The Fairgrounds is a Non-smoking facility. Please limit your smoking to your personal camper or off the grounds.
14. No pets are allowed.
15. The Fair Authority and Livestock Committee reserve the right to make adjustments to these rules at any time as deemed necessary.
16. The Putnam County Fair Authority, Inc. and Putnam County shall not be responsible for any loss or damage to the campers' personal private property. Campers agree to hold harmless the Fair Authority from any debt, liability or judgment incurred for any cause of action, claim of damage or liability during stay and in signing this agreement, expressly releases the Putnam County Fair Authority, Inc. and Putnam County from any and all claims from such loss, damages or injuries.
17. Failure to comply with and abide by these rules may result in expulsion from the grounds and/or exclusion from future camping privileges.
