Lucas Oil Pro Pulling League will provide Liability Insurance in the amount of \$10 million dollars naming Promoter as additional insured.

The insurance premium in the amount of \$500 for a one (1) day event, \$1000 for a two (2) day event or \$1500 for a three (3) day event **shall be paid upon signing this contract.** Charges for sled, trophies, and other cost expressed in this contract shall be due the day of the event. The total cost to the promoter shall not exceed \$ 1,000.00

In addition to the aforementioned items, the promoter shall also provide the following:

1. **A suitable site for the said event.**
2. **A Minimum of 2 - 50hp tractors and 1 tractor or skid loader with forks**
3. **A roller**
4. **A grader, disk or tiller to condition the track.**
5. **A grader box or groomer to maintain the track during the event.**
6. **A water truck / fire truck on site for track maintenance.**
7. **Ambulance, Emergency Squad, or Emergency personnel on site one (1) hour prior to, during, and one (1) hour after the event.**
8. **Adequate lighting if to be a night event.**
9. **Three (3) fire extinguishers.**

Additionally, if there is an entrance fee charged to the event, the promoter agrees to allow **free admittance** to:

- a. **Two (2) persons per registered tractor**
- b. **One (1) Sled operator**
- c. **Two (2) Officials**
- d. **One (1) Entry Clerk**
- e. **One (1) announcer**

Reimbursements are to be paid at the time of the event.

Please make a copy of this contract for your records, mail the original with your signature along with the check for the insurance premium payable to SVTPA, and return at least 60 days prior to your event so that we can register your event with the Pro Pulling League. In addition, any event cancelled within 15 days of the event-scheduled date is subject to a \$100 cancellation fee, which may be deducted from your deposit return. Any contract written and signed inside of 30 days of the event date may be subject to a \$50 rush-processing fee. In the event of inclement weather and the event is cancelled 24 hours prior to the event starting time, the promoter will be reimbursed 100% of the insurance premium and no other fees shall be incurred, If rain occurs after the start of the event, the promoter shall pay all expenses stated in the agreement.

1. **Limitation of Liability.** EXCEPT FOR EACH PARTY'S INDEMNIFICATION OBLIGATIONS, BREACH OF CONFIDENTIALITY, OR ANY LIABILITY ARISING FROM THE BREACH OF INTELLECTUAL PROPERTY RIGHTS, NEITHER PARTY WILL BE LIABLE TO THE OTHER UNDER ANY CIRCUMSTANCES FOR CONSEQUENTIAL, INCIDENTAL, SPECIAL OR PUNITIVE DAMAGES, OR FOR LOSS OF REVENUE OR PROFIT FROM THIRD PARTIES IN CONNECTION WITH THE PERFORMANCE OR FAILURE TO PERFORM THIS AGREEMENT REGARDLESS OF WHETHER SUCH LIABILITY ARISES FROM BREACH OF CONTRACT, TORT, OR ANY OTHER THEORY OF LIABILITY.

2. **Promoter, Lessor, and Fair agree to release, indemnify and hold the PRO PULLING LEAGUE, its parent, affiliates, related entities, its directors, officials, official representatives, employees, and executive officers ("Indemnified Parties") harmless for claims and liabilities resulting from negligence, and all costs and expenses, including attorneys' fees, incurred in defense thereof, asserted or imposed upon the Indemnified Parties arising out of, or related to defects in portions of the leased premises not directly under its control, including but not limited to grandstands, bleachers, walkways, and parking lots.**
