



2023 San Antonio Stock Show & Rodeo Western Art Contest Entry Form Package

This contest is open to South Central Texas high school students ages 14 to 18 as of August 31, 2022, and currently enrolled in an accredited public or private high school or a home school environment. See listings of eligible school districts and counties in the Rules and Regulations, Appendix I and II. Those wishing to seek accommodations for the age requirement must do so by contacting the S.A.L.E. office before check-in of the event. Any student participating in the contest must be a citizen of the United States and able to provide a valid Social Security card. Students who have had, or are in the process of having artwork published and/or used for profit are not eligible. Below are reminders regarding required paperwork, but it is not a substitute for reading the complete Rules and Regulations provided, which have been updated and revised for the current year.

- **Western Art Contest Release Agreement (REQUIRED)**
 - Please print all information at the top of page one
 - Student is required to state their source of inspiration. Entries that do not comply will be disqualified.
 - Student and parent must initial each section. Student and parent must sign the Acknowledgment section on page two
 - If a student is 18 years of age or older, a copy of a photo ID must be attached which indicates the students date of birth (i.e. driver's license). Those wishing to seek accommodations for the age requirement must do so by contacting the S.A.L.E. office **before check-in of the event.**
 - Paperwork must be complete **prior to check-in.** Incomplete paperwork may result in disqualification of artwork from the contest.

- **Artwork Receipt Tag (REQUIRED-DO NOT STAPLE TO RELEASE FORMS)**
 - This tag is hung on the artwork during the judging (bottom of tag) and during the reception (full tag) to identify the artwork.
 - Please print clearly and neatly so the judges and reception patrons can read your information.
 - Student must initial (second paragraph) to indicate they understand if their artwork is judged to be in the Top 12 it will not be returned.
 - The entry class must be circled and medium and source must be entered.
 - It must be indicated whether student used a grid to complete artwork.
 - Do not fill in the tag ID#. This number will be assigned at check-in by contest officials.

- **Photography Release (REQUIRED IF ANY PHOTO SOURCE USED)**
 - Refer to the Rules and Regulations regarding the acceptability of using a non-published photograph as a source reference. Stock photography from an internet site is not an acceptable photographic source.
 - The photographer, even if it is student's personal photo, must sign the photography release form. No modification or substitute form is allowed. Original signature is required.
 - If the photographer is less than 18 years of age, their parent or legal guardian must sign the release.
 - If the photographer is no longer alive (i.e., old family photo) then the owner of the photograph must sign the release form and state their relationship to the photographer.
 - A copy of the photograph(s) used should be included in the envelope with the photography release. **The photocopy will NOT be returned.**
 - The original photo(s) or digital disk must be available for review upon request.

- **Digital Artwork**
 - A "storyboard" printout documenting the process/procedures used to create the artwork. Must include which computer programs were used to create the artwork. Reminder that any photo used as starting concept must be original unpublished art of the student artist and a copy included with the photography release form per above.

Further we certify that the student has not used mechanical devices such as opaque projectors, photocopiers, computer-enhancements or sewing machines in the creation of the artwork. We agree that San Antonio Livestock Exposition, Inc. ("SALE"), the Briscoe Western Art Museum, and their duly authorized persons and representatives will not be held responsible for any copyright infringements, and we will release and indemnify and hold them harmless from any and all claims.

We, the student and parent/legal guardian, have read the current year "Rules and Regulations," as provided to me by the SALE Western Art Committee and agree to abide by the terms. We understand that any proceeds awarded on the student's behalf may be forfeited if it is determined that the artwork was copied or if student fails to comply with any of the "Rules and Regulations". We agree that SALE and the Briscoe Western Art Museum shall not be liable or responsible for the NEGLIGENCE or other act or omission of either of them or of any other person or entity that causes in whole or in part or results in the loss, theft, destruction or damage of the student's artwork or other property.

DECLARATION OF CITIZENSHIP

We, the student and parent/legal guardian, hereby certify that student is a citizen of the United States and able to provide a valid Social Security number.

RELEASE OF ARTWORK

We, the student and his or her parent/legal guardian, understand that if the student's artwork is judged to be one of the Top 10 entries, it will not be returned to the student and will be the property of SALE. We waive any rights we may have in the artwork, and release, discharge and agree to hold harmless SALE, The Briscoe Western Art Museum, and their duly authorized persons and representatives from any liability by virtue of the use of the artwork. We grant permission to be photographed or interviewed in connection with SALE and the Briscoe Western Art Museum.

We, the student and parent/legal guardian, hereby grant and convey SALE the absolute right and permission to copyright, publish, use, reproduce, and publish the student's artwork and photographic portraits, motion pictures, and video graphic recordings of the student or his or her artwork, in whole or in part, in composite, or distorted in character or form, in conjunction with student's own or a fictitious name reproduction thereof, in color or otherwise, through any media at a studio, on SALE grounds, at the Briscoe Western Art Museum, or at any other location, and for any lawful purpose.

We, the student and parent or legal guardian, further acknowledge that our voluntary execution and delivery to SALE of this Release Agreement is consideration for the participation of the student in this exhibition and contest and that a properly executed copy of this release is part of student's valid application to be a contestant in any such event. We understand that if we do not sign and return this agreement, student's artwork will not be judged or displayed at the Briscoe Western Art Museum, the Western Art exhibit at SALE, or any other event sponsored or produced by SALE

I (we) hereby release, discharge and agree to hold harmless, SALE, the Briscoe Western Art Museum, and their respective agents, employees, and representatives from any liability by virtue of any blurring, distortion, alteration, optical illusion or use in composite form, whether intentional or otherwise, that might occur or be produced in the taking of pictures, or in any processing tending towards the completion of the finished product.

We, the student and his or her parent or legal guardian, hereby further agree that neither of us will receive any financial consideration or compensation with respect to the artwork or the exercise of the rights granted in this Release Agreement and that we waive any rights that we may have to further consent to, receive notice of, inspect, or approve any use, reproduction, or display, in whole, part, or composite, of the student's artwork. We further waive all claims and rights, monetary or otherwise, that may arise because or any additional or future use of the student's artwork at this or any other future time; and agree that SALE shall have and retain the sole right to determine how it will use, display, or reproduce the student's artwork.

We, the student and his or her parent or legal guardian, represent and warrant that the student has not had and is not in the process of having the artwork published or used for profit and has not conveyed or licensed the artwork to any person or entity.

All recordings and/or images, in whatever form or medium, are the sole property of SALE We release and agree to hold harmless Publishers from any liability, and any cause of action, related to any use of the recordings and/or images, whether intentional or otherwise.
