



Livestock Sales Agreement

THIS DOCUMENT MUST BE UPLOADED WITH YOUR ENTRY BY APRIL 01, 2024

I, _____ the owner, consign my livestock project to the Salinas Valley Fair Junior Livestock Auction (SVFJLA) and authorize the Salinas Valley Fair, Inc. to act as the agent for selling my animal.

I CHOOSE TO CONSIGN THE SPECIES LISTED BELOW AND DELIVER:

- Sheep, Wednesday, May 15th Goat, Wednesday, May 15th Hog, Tuesday, May 14th
- Steer, Wednesday, May 15th Replacement Heifer, Wednesday, May 15th

SALE AGREEMENT

1. I understand that when my livestock project is sold, there will be charges deducted from my check, including an 8% commission fee and species specific fees/assessments as mandated.
2. I understand that all beef, sheep, goat and swine consigned to the sale will be processed by the Salinas Valley Fair with an option for custom harvest or to be resold by the contracted processor.
3. I understand that all auction sales are final. I understand that market price for livestock will be established on the day before auction.
4. I understand that the sale of my market animal project is contingent upon a veterinarian inspection and weight requirements. If my animal is deemed not market ready by the veterinarian, I will not be able to participate in the SVF and my animal must be removed from the fairgrounds immediately. If my animal fails inspection, I will also forfeit any auction and add-on monies.
5. I understand that I must follow all 4-H and/or FFA requirements to participate in the SVFJLA.
6. If needed, I agree to provide all photos, videos, forms and marketing materials by the deadline set forth for the success of the market show and SVFJLA.
7. To participate in the SVFJLA, I understand that it is mandatory to show my project and follow the rules of the scheduled market show.
8. I understand that I will do my best to encourage a buyer to participate in the SVFJLA to bid on my livestock project.
9. I will deliver my livestock project to the Salinas Valley Fairgrounds on the designated date, location, in good health, market ready and in designated weight range as specified in the Salinas Valley Fair Livestock Guidebook.
10. All swine must comply with Prop 12 as I will indicate by uploading my signed form with my entry.

DRUG STATEMENT:

1. I understand that all harvested animals are subject to inspection for drug residues and I will be held responsible for any unauthorized residues found in the carcass, resulting in a rejection of the carcass and will be liable for 3 times the amount the animal was sold for in the SVFJLA and other noted consequences in the Salinas Valley Fair Livestock Guidebook.
2. I will complete and return the Declaration of Medication Form with my animals on the delivery date.

INDEMNITY:

1. The owner agrees to indemnify and hold harmless, Salinas Valley Fair, their Directors, Servants, Agents, Employees and successors from any and all losses, claims, actions or proceedings of any kind, including reimbursement for all legal costs and attorney fees incurred by the indemnified parties or any of them, for the defense of any such actions which may hereinafter occur.
