



Antique Vehicle Owners:

The 94th annual rodeo parade is Saturday 4/4/26 at 10:00 a.m. The entry deadline is 03/27/26 or the first 100 entries, whichever comes first. Please complete the enclosed 2 forms for entry.

The parade committee considers original and non-modified antique cars and trucks to be 1942 models and earlier. Antique tractors are considered to be 1948 models and earlier. Any vehicle older than 1942 for cars/trucks, and 1948 for tractors will not qualify as an antique. Cars, trucks, and tractors are invited to participate. **NO STREET RODS PLEASE!**

SEE BELOW PARADE RULES:

1. Please stay consistent with the flow and speed of the parade by staying 1 car length behind the entry/float in front of you.
2. Nothing may be thrown, handed out, sold, given away or otherwise distributed from any parade participant during the parade or along the parade route.
3. Anyone displaying the American flag must do so in a respectful manner and must be sure it is secured at all times.
4. All drivers must have a valid driver's license in order to participate in the parade.
5. The committee and management of the San Angelo Stock Show and Rodeo Association have the right to disqualify any person that does not follow the rules given in this notice, and will be asked to leave the parade route to ensure the safety of the public and parade participants.
6. **PLEASE NOTE: The Board of Directors of the San Angelo Stock Show and Rodeo Association has established the following policy regarding parade entries:**
 - A. **Political Entries: Political slogans, banners, or messages of any kind are not permitted in the parade. Only elected officials specifically invited by the Association may participate as dignitaries.**
 - B. **Approval of Entries: The San Angelo Stock Show and Rodeo Association reserves the right to approve or refuse any parade entry. Any politically affiliated group wishing to participate must receive explicit approval from the Board. The Association may decline entries that it deems are promoting a political agenda inconsistent with the event's neutral stance.**

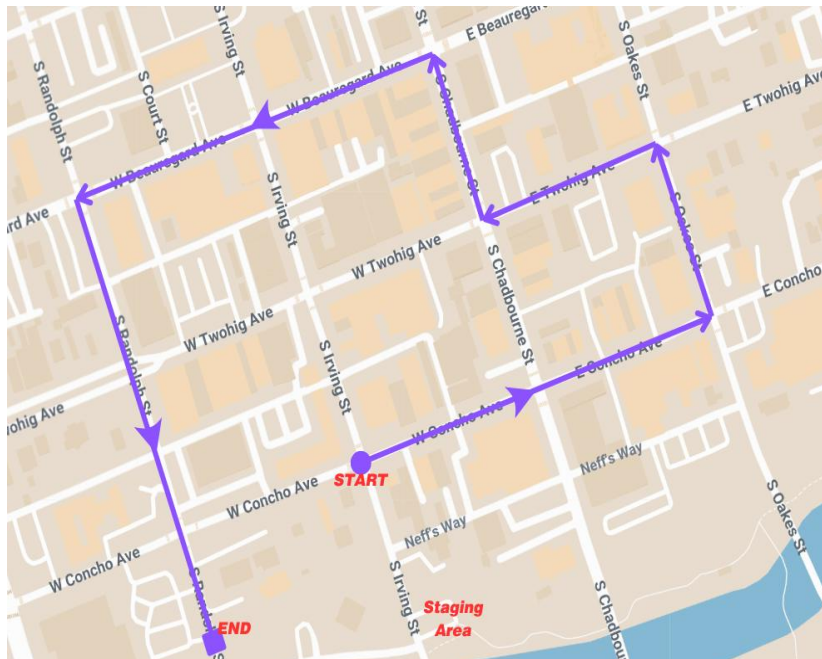

ANTIQUÉ VEHICLES - PARADE LINE UP AND ROUTE

All parade participants must be in line and in place by 9:00 a.m. sharp. The judging will begin promptly at 9:00 a.m. and the parade will start at 10:00 a.m. Antique vehicles and tractors will enter from North Bryant (Koenigheim St.) or South Bryant (Abe St.) onto Concho, and line up on the NORTH side of Concho, going EAST to the staging area at Irving St. Parking is available on Randolph between Concho and Twohig.

Awards will be given to 1st, 2nd, & 3rd place!

1. BEGIN AT IRVING AND CONCHO
2. PROCEED EAST TO OAKES
3. LEFT ON OAKES TO TWOHIG
4. LEFT ON TWOHIG, PROCEED TO CHADBOURNE
5. RIGHT ON CHADBOURNE TO BEAUREGARD
6. LEFT ON BEAUREGARD, PROCEED TO RANDOLPH
7. LEFT ON RANDOLPH TO RIVER DR. & DISMISS
