- Please complete the Rabbit Show entry form in its entirety.
- Trio Pens all show together regardless of breed, but please list the breed of the pen. Tattoo numbers are required at time of entry. If you do not have your rabbit tattooed yet, please list what tattoos you will put in the rabbit.
- Commercial/Fancy Breeding Rabbits show by breed type only– no color variation. Please just list the breed.
- Please mark the sex of the rabbit and the age, then mark the correct class number for the rabbit.
- See the complete listing of ARBA approved breeds below.
