- A. Noceti motorsports update
 - Tony's response to the fair's initial offer was received last night and Steve will provide a report once he's reviewed
- B. Sports Car Club of America (SCCA) lease paving update
 - The executive committee is recommending the Board not sign the proposed SCCA paving agreement
- C. Progress on electrical repairs and upgrades
 - Steve talked to Michael Sellens yesterday and phase two is completed.

 - Bring in more tractor companies, maybe a "tractor show" of sorts and other equipment
