

# Santa Maria Fairpark

## RV Camping – Terms & Conditions

### Fees:

- RV Site- FULL hook ups: \$50 per night
- Extra Vehicle/Trailer (tow/cargo) limit 1 per reserved site: \$10 per night
- Reservation: \$10 per transaction
- All Reservations must be made online at [SantaMariaFairpark.com](http://SantaMariaFairpark.com).

### Check-In & Check Out Time:

- Check-In 2:00 – 8:00 PM daily.
- You MUST display reservation confirmation on dashboard on drivers' side of RV and vehicles. Please read check in process in email confirmation.
- Check-Out 12:00 PM daily.
- PLEASE cleanup & remove all debris from your camp site.
- Early check-in or late check-outs may be arranged, depending on availability. Additional fees may apply. To request any special arrangements email: [reservations@santamariafairpark.com](mailto:reservations@santamariafairpark.com).

### Occupancy Guidelines:

- Campers: Maximum of 6 guests per site.
- Visitors: Up to 6 visitors are welcome per site during non-quiet hours (Quiet Hours 10 PM – 8 AM). Visitors MUST Park in designated Visitor Parking area ONLY. NOT at your (or any other) campsite.

### Pet Guidelines:

- Pets are welcome & must have current registration & vaccinations. Maximum of 2 pets permitted.
- Guests are responsible to “clean up” after their pet. All pet droppings must be properly disposed of in a trash receptacle.
- Pets must be kept on a leash (maximum 10 ft.) and are not permitted inside buildings.
- Pets are not to be left unattended at any time. Fairpark is not responsible for, and will hold pet owner accountable for, any injury or damage caused by pet(s).

### Parking Guidelines:

- All RV's, vehicles and trailers must have current license and registration.
- RV's older than 20 years are NOT permitted to stay.
- The Fairpark may already have a spot assigned for you. No pre reserving a specific site. You will be placed in a spot appropriate to the size of your RV. You will be asked to move if you park in a site that is the improper size for your RV.
- One RV is allowed per site and must be parked completely on the site. One extra vehicle/trailer (tow/cargo) is permitted (subject to availability) per site for an additional \$10 per night. All vehicles must fit within your site or park in designated Visitor Parking.
- All RV'S must be fully self - contained, NO tent camping. NO sleeping in cars or trucks.

## Quiet Hours:

- Quiet hours are from 10:00 PM to 8:00 AM. Generators may not be used during these hours.
- Please be courteous to other guests around you. Inconsiderate guests will be asked to leave.
- Loud, objectionable music or noise is not allowed at any time.

## Things to Keep in Mind:

- Please be prepared with the following, extra long sewer hose & power cords as some of the hookup ups are located further away from where RV's are parked. Leveling blocks, as not all sites are level.
- The upkeep of our facility and grounds is important, so we ask that you keep a clean camp area. No outside refrigerators, clothes lines, tarps, broken down equipment, worn furniture or carpet. If you have a satellite dish it must be within the perimeter of your site. If your camp site looks cluttered or unkept you will be asked to clean up or vacate the premises. NO dumping of excessive materials, liquids, or trash at any time.
- Management is not responsible for lost, stolen, or damaged articles. Keep valuables locked up.

## Park Policies:

- Observe the speed limit of 5 MPH. Reckless driving is not permitted at any time.
- These grounds are not zoned for working on or construction of vehicles. Therefore repairing, working on, storing of, any/all vehicles is prohibited. No washing of RV's or vehicles on site.
- No fires allowed. Fully contained BBQ grills and camping stoves are permitted.
- Drugs, weapons, fighting, lewd conduct are not permitted at any time.
- Alcohol is not permitted outside your RV Camping site or area. Public intoxication is strictly prohibited pursuant to CA Penal Code 647f.
- Smoking is prohibited in all indoor facilities and within 25 feet of any building.
- Motorized/non-motorized scooters and skateboards are not permitted.
- Profanity or violence towards others and the park team will not be tolerated.
- Report any problems with your site to the Fairpark immediately. Call 805-925-8824.
- Campers may stay up to a maximum 30 consecutive days per visit. There may be a required break of 7 days between visits with a maximum of 120 days per calendar year. Please be aware that there are certain blackout dates, please refer to website for dates. Email requests to [reservations@santamariafairpark.com](mailto:reservations@santamariafairpark.com).

## Cancellations/Refunds:

- Requests for full cancellations must be made in writing within 7 days of arrival date.
- Requests for partial cancellations may be requested 48 hours prior to but will forfeit the fees of a 1-night stay.
- All cancellations/refunds are subject to a \$35 Administration Fee.

## Adhering to Terms & Conditions:

- The Terms & Conditions must be adhered to, as well as any other directions given by the Santa Maria Fairpark. Any violators of the above policies will be asked to leave the property without refund of fees. Fairpark Management reserves the right to close the campground, either partially or entirely without notice.
- Pursuant to the CA Recreational Vehicle Occupancy Law, A "RECREATIONAL VEHICLE MAY BE REMOVED AS SPECIFIED IN SECTION 799.99 FOR FAILURE TO PAY OR FAILURE TO COMPLY WITH PARK CAMPING POLICY." CA Civil Code Sections 799.22, 799.43 and 799.58.
