By signing this release, I grant the Elks Recreation, Inc., Santa Maria Pediatric Dental Group, Wrangler, Coca-Cola and Santa Maria Elks Lodge #1538 and the operators of its activities and events, their employees, agents, and assigns my permission to initiate emergency first aid treatment for myself or my child in the event such treatment is reasonably required, which determination may be made at their discretion.

I agree and understand this agreement is intended to be as broad and inclusive as permitted by the laws of the State of California, and if any portion of this agreement is invalid, it is agreed the remainder of this agreement shall continue in full force and effect.
