



WHAT'S NEW IN 2021?

The Exhibitor Handbook will only be on the website. It will be separated in sections and labeled for easier location of information. Be sure to read all rules and regulations before entering.

Any exhibitor that has more than 10 items in the same department must deliver the items BEFORE 3:00 PM on receiving day or contact the fair office to schedule an appointment with the Department Supervisor.

Fine Arts, Crafts and Vocational Education Projects receiving day moved to Sunday from 8:00 AM to 6:00 PM and judging will be held on Monday.

Vocational Education Projects will be part of the JLAC live auction; all rules will apply to the projects that apply to the market livestock.

Sweepstakes awards are now based on all still exhibits entered with placings. This replaces sweepstakes in each department. One award will go to an Open exhibitor and one will go to a Junior exhibitor.

Still exhibits will only be available for pickup on the Monday after fair from 8 AM to 6 PM.
No more removing exhibits on Sunday.

New Classes: Video Editing (Photography); Seed Art & Creative Writing (Arts & Crafts).

Horse Show Drug Fee has increased to \$8.00 per horse from \$5.00 per horse.

Livestock drop off times will vary depending on the species. Be sure to check the appropriate species section for the correct day and time.

Lightweight class for Junior Market Sheep (80 to 110 lbs).

Open Dairy Cattle and Open Dairy Goat classes have been eliminated.

Small animal exhibitors **MUST** wear a white shirt with long sleeves during showing.

Parent Passes **MUST** be purchased online through the entry program. Two passes per family of a junior livestock exhibitor may be purchased in advance at a discount. Passes **WILL NOT** be sold onsite.

Auction Thank You cards must be turned into the fair office no later than September 30th or the seller will have to request their check from the Junior Livestock Auction Committee once meetings resume.

REMINDERS:

- **ENTRY DEADLINE IS FRIDAY, JULY 23, 2021.**
- All still exhibits premium payouts will be paid out in cash at the fair office during posted hours. A form of identification or exhibit claim ticket and a signature will be required for pickup of premiums. Premiums not picked up within 10 working days of the closing of the annual fair will be considered a donation to the Association. Premiums will be paid out in accordance to State Rule IV Awards and Scoring – 4. (Cash awards will be paid only as recorded on the signed judging sheet or judging affidavit and only to the exhibitor).
- Livestock fair premium checks will be available on Sunday at the Livestock Office. Starting Monday, they can be picked up in the main office; any premium checks not picked up within 10 working days of the closing of the annual fair will be considered a donation to the Association.
- The **ONLY** premiums mailed will be the Senior Horse Show.
