# 2024 Siskiyou Golden Fair **SHOWMANSHIP**

ENTRY DEADLINE: Friday, July 19th at 5:00 PM

Entry Fees: No entry fee if entered by deadline; \$5.00 entry fee if entering onsite

Limit: One (1) entry per exhibitor; mandatory for market exhibitors

Type of Judging: American

Restrictions: Open to 10<sup>th</sup> District residents only

#### SHOWMANSHIP

- Only animals entered by a junior exhibitor in the junior department are eligible.
- Showmanship is MANDATORY for junior exhibitors entering market classes and must be entered with other livestock entries prior to the entry deadline. The exhibitor has to do showmanship for any market animal entered (ex. Johnny enters a steer and a turkey; he has to enter showmanship for each species).
- Exhibitors must show their own animal and be on hand and ready to exhibit at the time called for judging.
- The animal used for the overall species showmanship lot must be the same animal that was used to gain entry into said lot.
- All FFA and Grange member exhibitors must wear the official uniform of their organization while showing their animals.
- 4-H Club and Independent exhibitors are encouraged to wear the traditional 4-H uniform. New blue or black jeans may be substituted for the white jeans. A white collared shirt (short or long sleeved) must be worn.
- Small animal exhibitors must wear a long-sleeved white shirt.
- Hats and headgear of any kind (unless part of the official uniform) shall not be worn with official show uniforms.
- There will be no cash premiums issued for showmanship classes.

#### LARGE ANIMAL SHOWMANSHIP

There will be an overall showman selected from each species that will include the first and second place beginner, the first and second place intermediate and the first and second place senior showman. Unless the overall showman was the intermediate or senior first place showman, they will not be eligible for round robin.

## LARGE ANIMAL ROUND ROBIN SHOWMANSHIP

# Qualifications:

- Showmanship in each species will have three divisions: beginning, intermediate and senior, the first-place exhibitor from intermediate and senior showmanship will be eligible to enter the Round Robin.
- The species in Large Animal Round Robin are beef, swine, sheep, meat goat, dairy goat, turkey and dairy cattle. At least three (3) exhibitors must show an animal in showmanship for that species to be eligible for Round Robin. Any species without three (3) exhibitors will be excluded for the current year.

- Example there are only two (2) junior dairy cattle exhibitors, dairy cattle will not be included in Round Robin Showmanship.
- If an exhibitor becomes eligible in more than one (1) species, they are automatically entered into Round Robin in the first species exhibited and the second-place exhibitor is moved into the contest in the subsequent species won.

#### Rules:

- Animals will be selected from those shown at the fair for Round Robin, in no case should an exhibitor show their own animal in the competition.
- Exhibitors must show in stated showring attire.
- Round Robin scores will be tallied under supervision and verification of the Livestock Superintendent.
- Tie Breaker the score from the species that the exhibitor showed to qualify for Round Robin will be removed from the final tally and secondly, if needed, the lowest score will be removed.

# SMALL ANIMAL SHOWMANSHIP

There will be an overall showman selected from each species that will include the first and second place beginner, the first and second play intermediate and the first and section place senior showman. Unless the overall showman was the intermediate or senior first place showman, they will not be eligible for round robin.

# SMALL ANIMAL ROUND ROBIN SHOWMANSHIP

#### Qualifications:

- The species in Small Animal Round Robin are Poultry, Cavy and Rabbits. At least three (3) exhibitors must show an animal in showmanship for that species to be eligible for Round Robin. Any species without three (3) exhibitors will be excluded for the current year. Example there are only two (2) junior cavy exhibitors, cavy will not be included in Round Robin Showmanship.
- If an exhibitor becomes eligible in more than one (1) species, they are automatically entered into Round Robin in the first species exhibited and the second-place exhibitor is moved into the contest in the subsequent species won.

#### Rules:

- Animals will be selected from those shown at the fair for Round Robin, in no case should an exhibitor show their own animal in the competition.
- Exhibitors must show in accepted showring attire.
- Round Robin scores will be tallied under supervision and verification of the Livestock Superintendent.
- Tie Breaker the score from the species that the exhibitor showed to qualify for Round Robin will be removed from the final tally and secondly, if needed, the lowest score will be removed.

## PEE WEE SHOWMANSHIP

- Limited to youth aged 5 prior to the opening day of fair and up to 8 years of age on January 1<sup>st</sup> of this year and who are not entered into another showmanship class (See State Rule VII Junior Department #12).
- It is advised for pee wee exhibitors to bring their birth certificate to the livestock office at check-in.
- Animals may be shown by exhibitors in breeding lots.
- Non-castrated males over six months old will not be allowed.
- Pee wee exhibitors and parents are subject to all the livestock rules.
- Due to increased entries and safety issues, Pee Wee Rounds will be held before each specie overall showmanship class. The top winner in each specie will participate in the overall Pee Wee Championship on Saturday. There will be no roll overs if the pee wee wins multiple species (they will show the one they won with first).
- Animals must be brought in on the regular exhibitor schedule and times. Exhibitor may be stalled with siblings or club in which they are affiliated if agreeable by all parties. Animals will not leave the fair until scheduled on Sunday after 8:00 PM.

- Animals do not have to be owned by the exhibitor. They may use an animal that is already on the grounds and owned by another exhibitor.
- Exhibitors should bring a copy of their birth certificate when checking in at the livestock office.
- The Livestock Superintendent will provide further instructions to those that participate in the Pee Wee Championship Show.
- Pee Wee Showmanship classes are signed up under the Species (Junior Department).
- Pee Wee entrants do not need to take the Quality Assurance course online.
