BOARD OF DIRECTORS MEETING
August 23, 2022**

CALL TO ORDER: The 10th District Agricultural Association Board of Directors meeting was called to order at 5:46 PM by President Finley.

ROLL CALL/DIRECTORS ABSENT: All directors were present with the exception of Director Salters who called. There are two (2) vacant board positions.

INTRODUCTION OF GUESTS AND STAFF: Also present were Cliff Munson, CEO; Michelle Eiler, AGPA, and Mike Luiz, Senior Maintenance Worker.

PUBLIC COMMENT: None.

CONSENT CALENDAR (Action by Board): Director Mercier made a motion, seconded by Director Fawaz and carried to accept the consent calendar which included minutes from the July 6, 2022, and August 1, 2022, meetings, contracts and cash disbursements for July.

CORRESPONDENCE (Information/Action):

- Letter from Scinto Group LLC regarding the 2021 Financial Statement Audit – CEO Munson reported that one of the findings was his vacation accrual. He did find out that due to COVID-19 the maximum was increased by 192 hours, but must be back down to 640 hours total by June 20, 2023; he plans on taking some time off between now and then. No public comment.

COMMITTEE REPORTS (Informational/Action):

- Junior Livestock Auction Committee – Director Mercier reported that the new committee worked hard and worked good together this year. It was impressive to see everyone work together and pull the sale off. Abby Salters and Julie Brown were great assistance to pulling the auction off. All processors were happy. They are currently working on getting the sellers lists and buyers' invoices mailed. No public comment.
- Junior Fair Board – There was no representative at the meeting. CEO Munson reported that the scholarship recipients were announced at the beginning of the auction on Sunday: Kylie Daws and Jonathan De Los Santos. No public comment.

FRIENDS OF THE FAIR: There was no representative present. CEO Munson reported that he attended the meeting last Wednesday and he was the only one there outside of the friends of the fair members. They reported that they were working on and close to an agreement with the Lily Foundation. They made no appearance at or with the events moving to the Jackson County Expo. Director Mercier has been in contact

with their attorney and gave an update on the agreement. He was given a draft and they are continuing to communicate and proceed towards an agreement that works for both parties. No public comment.

BUSINESS REPORT & INFORMATION (Action by Board):

- Billboard Contract with Rain Rock Casino/Karuk Tribe – CEO Munson reported that the individual that was dealing with this contract is out on extended leave. He was directed to sign up for a CRUISE PAL account for billing purposes. It seems that we are back to square one. No public comment.
- McKinney Fire – CEO Munson reported that the fire camp has cleared out. The total payment that we will be receiving is \$311,780. No public comment.

2022 FAIR/LIVESTOCK SHOW & SALE AT JACKSON COUNTY EXPO (Information/Action):

CEO Munson reported he was pleased with everything – the community presence, the grounds/facility, the amount of advertising. It was quite a ride and a big thanks to the Jackson County Expo, congratulations to the staff and JLAC; it was pretty amazing to cancel a fair 9 days before it starts and to host another event out of the area. He has been in contact with CDFA & CFSA about reporting the loss of revenue once all expenses have been received. The following items came up in discussion:

- Terminal Sale vs. Non-Terminal – Director Mercier said that is a JLAC issue but any recommendation by the fair board would be appreciated. He doesn't see any benefit to go strictly to a terminal sale.
- Exhibitors showing two animals – The situation that occurred at the show brought up questions regarding rule #50 in the Local Rules. This will be added to the next agenda and revised as needed.
- Independent Exhibitors – The number of individuals that participate is growing and their needs to be a better oversight of the program. CEO Munson will check into the legality of having Independent Exhibitors at the fair.
- JLAC Meeting Requirements – Director Mercier stated that JLAC should not be an enforcer of meetings for exhibitors training requirements. They should be having functioning meetings, where public is welcome, but focus on Pre and Post Fair/Auction Meetings where the public participates and provides input.

No public comment.

CEO REPORT (Information/Action): CEO Munson reported that the Rodeo and Bike Rally that were scheduled for Labor Day weekend have cancelled but the Farmers Market will be resuming. The PSPS Project electrician will be here tomorrow at 10:00 AM to look at Winema Hall. CEO Munson and Maintenance Worker Luiz have been working with CDFA in hopes to get some smaller projects completed as "Maintenance Project" instead of having to go through the full CCA process. No public comment.

BOARD COMMENTS:

- Director Allen – It was a great event and glad it was pulled off.
- Director Burrone – The AuctionTime system was great to use and they were very helpful even on a Sunday.
- Director Hanna – Asked if we have ever talked about the fair moving outside of fire season. CEO Munson commented that we usually have made it work; this was the first year that it was cancelled due to that issue.
- Director Mercier – We need to create a fire policy so everyone is on the same page and that the request must come in writing. CEO Munson will obtain the wording from OES regarding the actual takeover of the property. He also mentioned that Jackson County was complimentary to our staff, kids, community. It was an amazing operation of how people came together and all the communities (Jackson & Siskiyou) support.
- Director Fawaz – He was only able to attend on Sunday and the kids were great at the auction; very attentive bringing food and water to buyers. He would like Director Mercier and CEO Munson to

look into the carnival contract (all contracts) about canceling due to smoke or air quality. He also inquired about the transition of the fairgrounds from the state. CEO Munson reported that the Governor has put it on hold until after the election. It was great to have Fiona Ma visit the fairgrounds; he was able to spend some time with her. He would also like the board to review the rental agreement regarding emergency services in October or November before it is issued to Cal Fire. And lastly, he mentioned that Jeff Fowle reported to the Farm Bureau that the fairgrounds was hosting a Fall Harvest Fest. CEO Munson said that it was mentioned to Robin Wood that she could use the buckles at the October Horse Show and that the small animals may have an event, but he confirmed that there is no Fall Harvest Festival (despite all the rumors).

- President Finley – Thanked all the staff and said that Della Hayden, Abby Salters and JLAC all did a great job. He really liked the steak dinner that was put on by their auction committee on Friday night.

STAFF COMMENTS:

- CEO Munson mentioned that we should do something to thank the Jackson County Expo Staff and Board, possibly the Blue-Ribbon Award next year. He also mentioned that he will be out of the office from September 14-16, 2022, to attend the Feature Fair Tour.
- Michelle mentioned that several things had been said about the small animal department and that she didn't realize that Kendra Gill was a 4H Leader. Not sure if it is starting to become a conflict due to the different hats they wear and her daughter is involved in that department.
- Mike wanted to give a big shout out to Grange Co-Op for picking up and bringing back all the pens, plus they bought a ton of animals. It was very interesting working up there with their staff, we saw many benefits in how they do things.

#15IN-22 EXHIBIT A – TERMS & CONDITIONS

RENTER AGREES TO THE FOLLOWING:

1. CONTRACT TERM:

The term of this contract for operation of the speedway is for a period of one season. The 10th DAA reserves the right to approve the yearly racing schedule and may book other activities at the speedway based on availability of the facility as established by the approved calendar of events submitted by Barba Promotions and approved by management for each year of the agreement. The term of this agreement is **March 1, 2022, to July 24, 2022**; there will be NO racing after the annual fair. Contract specifics (ex. public, food, etc.) may be altered due to COVID-19 restrictions with the county and state.

2. SCHEDULES & RACING OPERATIONS

- a. Races are to be held on Friday nights only with the option of three (3) multi day events (Friday & Saturday) but must be approved by the 10th DAA. There will be only 15 races and 1 test and tune allowed for the season.
- b. Test and Tune events may be held on either a Saturday or Sunday as approved by the 10th DAA.
- c. Race Schedule is to be submitted and approved prior to the commencement date of this agreement. The schedule will be set for the season unless a cancelation occurs and the 10th DAA approves the rescheduled date.
- d. A schedule will be given to the fair office to distribute to the public. Included on the schedule should be types of racing, dates, times, prices, specials, contact name and number.
- e. There will be after no racing after Friday, **July 15, 2022**. July 16th may be used for a rescheduled event if approved by the 10th DAA CEO.
- f. The 10th DAA CEO will notify Barba Promotions, not less than two (2) weeks before a race if the 10th DAA cannot allow a scheduled race to occur because of a conflicting date. Barba Promotions is responsible for taking down debris fence, announcer's stand, K-rails, etc., if requested by the Fair CEO, to accommodate other grandstand events. Concessions must be vacated as well, if requested.
- g. Barba Promotions will be required to provide all equipment, personnel and supplies necessary to operate and maintain the speedway facility and conduct automobile racing events. The condition of the facility shall be fit for safety of event participants, spectators and minimum air and noise pollution to the community.
- h. Contract equipment must be kept in good running condition. Any inoperable equipment must be removed from the facility immediately. Barba Promotions must be able to demonstrate operability of any equipment at the facility at any time with given notice.

- i. Barba Promotions will provide an equipment list to the 10th DAA with the annual racing schedule and within 48 hours if it changes during the season and must be approved by the 10th DAA. Barba Promotions will not under any circumstances allow race cars to be left at the track after an event.
- j. Barba Promotions will maintain and keep clean the premises (as listed above) for the duration of the contract term. Barba Promotions is to clean the grandstands (top, side and underneath), bathrooms (concession and grandstand), concessions (food and alcohol), racetrack and pit area within 24 hours after each scheduled event. The 10th DAA will provide restroom paper products.

3. FEES FOR RENTAL & SERVICES

- a. \$900 fee per event: \$700 per race event and \$200 per race to go towards utility expenses. Rental fee will include one ad space on the LED sign for each race. If a race is cancelled it may be rescheduled to another Friday with the approval of the 10th DAA.
- b. \$150 fee for one (1) test and tune: any additional test and tunes after the first one will be at the event rate of \$700. The test and tune may be scheduled on a Saturday or Sunday and must be on the original submitted and approved schedule. There is to be drivers and crews only, no public spectators and no paid concessions. Distribution of food and non-alcoholic beverages, with no fee, to drivers and crews is acceptable. There is to be a maximum of five (5) cars on the track at any one time.
- c. All event payments are to be made the first business day after the event unless other arrangements have been made with the 10th DAA.
- d. Utility fees will be monitored during the season and the \$200 per event deducted from the amount. Utility fees will be calculated from the date keys are picked up and keys are returned. At the end of the contract, once all invoices have been received, it will be computed for the balance due. The balance due will be paid to the 10th DAA within 15 days of receiving the invoice. The utility fees will consist of the Grandstand Electrical Meter, the Standpipe Water Meter, the Infield Water Meter, and the Concession Stand Propane (which will be filled prior to the contract start date).
- e. Special Races: Malls 1-4 may be used for vendors during a special event race. There will be a fee of \$50 per vendor per day for any vendors using electricity. Barba Promotions is responsible for payment to the 10th DAA.
- f. Barba Promotions will reimburse the 10th DAA all utility costs and miscellaneous expenses that are incurred during the duration of this contract (ex. concession propane, additional paper products or garbage bags, etc.). Any damage that occurs to the property and/or equipment will be billed to Barba Promotions. There will be a 2% administration fee for all pass-through expenses. Payment is to be made within 15 days of receiving the invoice.

- g. All Fire Marshall expenses including inspection for fireworks, to certify the fire suppression unit, and have the hood professionally cleaned will be passed through and billed to Barba Promotions. Payment is to be made within 15 days of receiving the invoice.
- h. All fines that may be assessed including but not limited to any cost as a result of legal or administrative environmental action or requirements will be borne by the Licensee, and the Licensee shall indemnify the 10th DAA against all claims as a result of these actions.
- i. Barba Promotions will be responsible for at least \$5,000 in capital improvements in the facility during the term of this contract. All improvements must be discussed with and approved by the 10th DAA CEO prior to commencement.

4. INSURANCE & BOND REQUIREMENTS

- a. A \$10,000 Bond or Deposit will be provided by Barba Promotions for the duration of the contract. In place of the bond the 10th DAA will accept an asset list and agreed upon value with a letter that should Barba Promotions not fulfill the contract requirements the 10th DAA becomes the legal owner of such equipment listed. The bond and/or letter will remain in effect until September 30, 2022, for all fees to be paid, unless released by the 10th DAA CEO. All outstanding invoices, fines and expenses can and will be charged against the bond/equipment after September 30th.
- b. Barba Promotions will provide a current general liability insurance certificate naming the 10th DAA, as additionally insured. The attached CFSA Insurance Requirements attached must be followed. The current certificate must cover the entire contract period (policy may change during the season so a new certificate would need to be issued). If the 10th DAA receives notice that Barba Promotions insurance has been cancelled or suspended all future races will cease until a current policy is on file.
- c. For insurance purposes automobile racing is considered a "Hazardous Activity" under insurance requirements. Contractor may allow motorcycles, quads and other "pit" vehicles during events but must have specific coverage for those vehicles in the insurance policy.
- d. Barba Promotions will report any accidents to the 10th DAA CEO within one (1) hour of the occurrence (530-598-4343) and the completed accident report needs to be in the 10th DAA office within 48 hours.
- e. Barba Promotions must have an Emergency Response Plan in place to respond to any accident at the speedway which addresses maintaining access for ambulance and medical personnel while limiting spectator and pit crew interference with access and present it to the 10th DAA thirty (30) days before the first event. This is required for safety and insurance purposes.
- f. Any alcohol/food concessionaires must provide liability insurance, if not covered under Barba Promotions. Liquor liability must be provided for any alcohol sales. All Alcohol Beverage Control

regulations must be followed, and a copy of the ABC permit turned into the fair office. See CFSA Insurance Requirements attached.

- g. Indemnification: Barba Promotions agrees to indemnify, defend, and save harmless the State of California, the California Fair Services Authority, 10th DAA, Siskiyou County, its Directors, officers, agents and employees (collectively "Indemnities") from any and all claims for loss, damage, injury or liability (collectively "Losses") of whatsoever nature and howsoever the same may be caused or may arise resulting directly or indirectly from the use of the 10th DAA facility by Barba Promotions or those claiming under Barba Promotions excepting only Losses caused by the sole, active negligence or willful misconduct of an indemnity.
- h. Should Barba Promotions, during the course of this agreement, find it necessary to hire any employees, Barba Promotions must provide a Certificate of Workers Compensation Insurance to the 10th DAA.

5. PREMISES

- a. The premises to be utilized by Barba Promotions for operation of the speedway consists of the Grandstand, Grandstand Concession Building, Concession Restroom, Grandstand Restroom, Racetrack with lighting and the pit area. Events with a high car count may need to use the Exhibitor Parking Lot for overflow and may be added with the 10th DAA approval. Barba Promotions will have use of the Front Parking Lot and access to the Racetrack using the malls on the midway from the Front Office to Mall Three (3) during events. Pit area restrooms will not be provided by the 10th DAA.
- b. In the event the 10th DAA has a policy change that initiate paid parking for all fairgrounds events, the 10th DAA reserved the right to collect and keep all parking revenue.
- c. The 10th DAA is a public facility that is reserved on a first come, first served basis and individuals or organizations that rent the facility and requests no racing for their event will be honored. In the event that the racing schedule has been approved the request will be denied.
- d. The 10th DAA is a state facility and as such must be available for emergency use at all times. In the event that a natural disaster occurs in our service area, the Siskiyou Golden Fairgrounds will be unavailable for all rentals.

6. TRACK AND MAINTENANCE

- a. Barba Promotions agrees to accept the track as is, and replace whatever clay is necessary to make the track and fence suitable for racing and to maintain same.
- b. The racing fence must meet the approval of California Fairs Services Authority and be fixed or repaired prior to the start of each race season.

- c. Any and all expenses of preparation and maintenance of the track, grandstand area and other facilities included in this agreement for said races, as well as all operating costs shall be borne solely by Barba Promotions.
- d. Barba Promotions is responsible to contract with a cleanup crew to gather all debris and trash from the grandstand, infield, concession parking lot, all bathrooms, exhibitor parking lot, front parking lot and grounds areas that are accessible to Barba Promotions and their patrons.
- e. Barba Promotions will be responsible for maintaining garbage in a dumpster or covered container/trailer until removed from the grounds to prevent greater cleanup.
- f. Barba Promotions agrees to repair any damage created by Barba Promotions, their patrons or their event to any and all property and grounds of the 10th DAA within 48 hours after each race to the satisfaction of the 10th DAA CEO. A fine of \$100 per occurrence plus \$50 per hour for the 10th DAA staff to complete the work will be assessed for cleanup. In the event the 10th DAA staff is used, there will be a minimum of one (1) hour charged.
- g. Barba Promotions is responsible for maintenance and repair of the speedway facility. Maintenance and repair are defined as routine activities that are necessary for the speedway to operate in a safe condition for the racers and the general public. If Barba Promotions fails to adequately maintain or repair the speedway facility, the 10th DAA CEO will give Barba Promotions forty-eight (48) hours to comply by written notice to perform the necessary repairs and maintenance. If Barba Promotions fails to comply, the 10th DAA will complete the necessary repairs/maintenance and bill Barba Promotions for parts and labor. Maintenance and repairs include, but not limited, to the following:
 - i. Maintenance and repair of the interior and exterior fence.
 - ii. Removal of dirt and garbage under bleachers, in pit area and on track from each event.
 - iii. Removal of tires and other auto parts.
 - iv. Proper handling and storage of all fuel, waste oil and other chemicals used on the premises. Barba Promotions is responsible and liable for any spill and cleanup costs of hazardous materials.
 - v. Responsible for all damage to restrooms, excluding normal wear and tear.
 - vi. Emptying all garbage cans in use along the event path from the front parking lot to the premises.
 - vii. Responsible for all annual health and safety inspections required.
 - viii. Will be required to equip and operate the permanent grandstand concession for food and beer sales and meet or exceed all requirements of Siskiyou County Environmental Health Department and the California State Fire Marshall, including appropriate health, safety and alcohol licensing permits.
- h. Barba Promotions agrees to remove all barricades, racing fence, flag stand and to restore the arena surface to fair time conditions no later than July 24th, unless notified by the 10th DAA CEO of any changes. The track needs to be level with the marks on the grandstand fence. If it becomes necessary

for the 10th DAA to do any, or all, of this work, the actual expense incurred will be paid to the 10th DAA by Barba Promotions. In the event that the 10th DAA grounds are not cleaned and organized to the 10th DAA's standards, a \$500 fine will be implemented plus \$40 per 10th DAA staff hour or actual cost if hired out to complete the work. In the event the 10th DAA is used, there will be a one (1) hour minimum. Specific cleaning and or vacating that must be completed includes but is not limited to the grandstand, grandstand concession, bleachers and from the concession restroom roof and walls, clay on all concrete walls, walkways and both track areas.

7. CURFEWS & RESTRICTIONS

- a. The races must be concluded not later than 10:30 PM. The facility must be vacated and secured by midnight.
- b. Barba Promotions will be responsible for measuring the decibel level of sound generated at the speedway events, both vehicle and public address systems. Readings are to be taken 100 feet from the source of the sound and a permanent record of readings maintained and available for inspection by the 10th DAA CEO. Records must be kept for a minimum of three (3) years following the term of this agreement.
 - i. Maximum DBA levels per vehicle shall not exceed 95 DBA or the current level set by the State of California.
 - ii. All vehicles must be equipped with mufflers.
 - iii. Racing will be limited to two (2) nights in a calendar week.
 - iv. Violations of DBA and Time restrictions will cause the following fines to be enforced:
 - 1st offense in an annual season - \$500 fine paid by Barba Promotions
 - 2nd offense in an annual season - \$1,000 fine paid by Barba Promotions
 - 3rd offense in an annual season - \$2,500 fine paid by Barba Promotions AND a meeting with the 10th DAA CEO and a representative from the 10th DAA Board of Directors to determine corrective action.

8. CONCESSIONS (FOOD & BEER)

- a. Barba Promotions is responsible to meet any and all distributors that are delivering products. Beer distributors may pick up keys for the beer concession stand at the 10th DAA office should staff be available. All delivery receipts will be left in the concession stand(s).
- b. All health department rules and regulations must be followed. A health permit must be on file at the fair office and posted in the food concession booth.

- c. The attached alcohol policy is incorporated into this agreement and is to be used as a guideline in the sale of Alcoholic Beverages. A current ABC License is to be posted at all times and a copy on file in the fair office.
- d. Beer is to be served in cups no larger than 16 ounces and the cups must be clear and totally distinct from any other cup being used. Only persons 21 years of age or older may consume or be served alcoholic beverages.
- e. Only beer and wine may be sold, no liquor.
- f. No glass will be served to patrons. Any alcohol in a glass container must be poured into a plastic cup.
- g. Drinking alcoholic beverages in the grandstand arena and pit area is prohibited until all racing is completed.
- h. The ice machine in the concession stand needs to remain on during the contract term and is available to the 10th DAA as needed.
- i. Any issues with the concession stand (food or beer) and the restrooms must be submitted to the fair office no later than the Monday after the event to give the 10th DAA staff time to resolve it. Issues may be emailed to michellee@sisqfair.com or dropped off in writing at the fair office. Information learned of after Monday will not be guaranteed to be resolved by the next event date.
- j. Barba Promotions will have the 10th DAA concession booths (food and alcohol) cleaned and vacated no later than July 24th. All property belonging to Barba Promotions must be removed from the concession booths.

9. PARKING & SECURITY

- a. Barba Promotions vehicles are limited to the back-gate entrance with parking behind the concession stands only. No vehicles will be allowed in the main mall area of the fairgrounds without special permission from the 10th DAA. At no time will any vehicle park on the lawn, around the barns or within 50 feet of buildings, in accordance with State Fire Marshall regulations. The parking violation fee is set at \$100 per occurrence plus supplies and \$50 per 10th DAA staff hour to repair any damage. Fee will be enforced upon first occurrence.
- b. No race cars are to be left on the grounds after each race without prior approval from the 10th DAA CEO.
- c. Barba Promotions agrees to provide two (2) sets, of two (2) people, for security personnel in the Grandstand and two (2) personnel patrolling all internal grounds at each event open to the public. Barba Promotions is responsible for the fairground facility until all vehicles, members and patrons have exited the 10th DAA property.

- d. Barba Promotions contract and insurance policy needs to cover accessible grounds from the time of the weekly scheduled event until the following business day or until the next interim rental, whichever is first. In the event there is a major vandalism, the Barba Promotions insurance must be notified, and a claim filed. Barba Promotions will not be held liable for any vandalism if the exterior fence is breached during a scheduled event. The 10th DAA will not be held liable for any damage or theft of Barba Promotions equipment, supplies, etc.
- e. Barba Promotions has access to the areas listed on the agreement, but all gates and entrances need to be securely locked when no one is on the grounds.

10. MISCELLANEOUS

- a. Barba Promotions may pick up keys once all paperwork pertaining to this agreement are on file and approved. Barba Promotions shall receive keys for the appropriate facilities from the 10th DAA office: Grandstand Food Concession (1), Grandstand Concession Window (1), Grandstand Beer Concession (1), Concession Fixtures (1), Grandstand Restroom (2), Concession Restroom (2), Gate (1), Electrical Panel (1) and Miscellaneous Other Gate keys. If additional keys are necessary, they are to be requested from the 10th DAA. At no time will duplication of keys be allowed. All keys must be turned in to the 10th DAA office no later than July 25th by 12:00 PM (end of the agreement). The fine for non-returned keys by the specified dates is \$100 plus \$40 per hour 10th DAA staff time plus any parts and equipment needed to change locks (one (1) hour minimum).
- b. Barba Promotions will report any repairs or problems (to do with any aspect of this contract) on a weekly basis by written list turned into the office or emailed (michellee@sisqfair.com).
- c. Barba Promotions will put their pit gate lock on the pit gate starting on the contract date. It will be made sure that the 10th DAA office has a copy of that key for access purposes. The 10th DAA will change the lock on **July 25th**, at the end of the contract.
- d. Barba Promotions is responsible for procuring dumpster service and portable restrooms with hand washing stations in the pit area.
- e. The 10th DAA PA System will be available for Barba Promotions to use during the agreement dates. The system needs to be returned by July 22nd to be used at the annual fair.
- f. There is a policy that "No Food & Drink or Pets" are to be brought onto the grounds by the public; water is acceptable. Alcohol is included as a drink.

11. TERMINATION OF AGREEMENT

PROCLAMATION OF A STATE OF EMERGENCY

WHEREAS on July 29, 2022, the McKinney Fire began burning in Klamath National Forest near the Pacific Crest Trail and has since spread onto state land in Siskiyou County; and

WHEREAS the McKinney Fire has burned more than 29,000 acres and continues to burn; and

WHEREAS the McKinney Fire has damaged and destroyed several homes and threatens the area around Yreka, necessitating the evacuation of more than eighteen hundred residents; and

WHEREAS the China 2 and Evans fires in Siskiyou County merged, burning more than three hundred acres and causing an evacuation warning for more than two hundred residents; and

WHEREAS these wildfires have forced road closures and continue to threaten critical infrastructure, including water and communication sites, private timberlands, and other structures; and

WHEREAS overnight thunderstorms and lightning, high temperatures, extreme drought conditions, dry fuels, winds, and continued critical fire weather conditions have increased the intensity and spread of these wildfires; and

WHEREAS the combined effects of these wildfires, other fires, and fire weather conditions are compounding impacts on firefighting and other response resources; and

WHEREAS under the provisions of Government Code section 8558(b), I find that conditions of extreme peril to the safety of persons and property exist due to these wildfires in Siskiyou County; and

WHEREAS under the provisions of Government Code section 8558(b), I find that the conditions caused by these wildfires, by reason of their magnitude, are or are likely to be beyond the control of the services, personnel, equipment, and facilities of any single local government and require the combined forces of a mutual aid region or regions to appropriately respond; and

WHEREAS under the provisions of Government Code section 8625(c), I find that local authority is inadequate to cope with the magnitude of the damage

statutes, including the California Emergency Services Act, and in particular, Government Code section 8625, **HEREBY PROCLAIM A STATE OF EMERGENCY** to exist in Siskiyou County due to these wildfires.

IT IS HEREBY ORDERED THAT:

1. All agencies of the state government utilize and employ state personnel, equipment, and facilities for the performance of any and all activities consistent with the direction of the Office of Emergency Services and the State Emergency Plan. Also, all residents are to obey the direction of emergency officials with regard to this emergency in order to protect their safety.
2. The Office of Emergency Services shall provide assistance to local governments, if appropriate, under the authority of the California Disaster Assistance Act, Government Code section 8680 et seq., and California Code of Regulations, Title 19, section 2900 et seq.
3. As necessary to assist local governments and for the protection of public health and the environment, state agencies shall enter into contracts to arrange for the procurement of materials, goods, and services necessary to quickly assist with the response to and recovery from the impacts of these fires. Applicable provisions of the Government Code and the Public Contract Code, including but not limited to travel, advertising, and competitive bidding requirements, are suspended to the extent necessary to address the effects of these fires.
4. The provisions of Unemployment Insurance Code section 1253 imposing a one-week waiting period for unemployment insurance applicants are suspended as to all applicants who are unemployed as a direct result of these fires and who apply for unemployment insurance benefits during the time period beginning July 29, 2022, and ending on the close of business on January 30, 2023, and who are otherwise eligible for unemployment insurance benefits.
5. Vehicle Code sections 9265(a), 9867, 14901, 14902, and 15255.2, requiring the imposition of fees, are suspended with regard to any request for replacement of an identification card, driver's license card, vehicle registration certificate, certificate of title, or registration stickers, by any individual who lost such records as a result of these fires. Such records shall be replaced without charge.
6. The provisions of Vehicle Code sections 4602 and 5902, requiring the timely registration or transfer of title, are suspended with regard to any

who lost such records as a result of these fires. Such copies shall be provided without charge.

8. Any fairgrounds that the Office of Emergency Services determines are suitable to assist individuals impacted by these wildfires shall be made available to the Office of Emergency Services pursuant to the Emergency Services Act, Government Code section 8589. The Office of Emergency Services shall notify the fairgrounds of the intended use and may immediately utilize the fairgrounds without the fairground board of directors' approval.
9. The California National Guard may be mobilized under Military and Veterans Code section 146 to support disaster response and relief efforts, as directed by Cal OES, and to coordinate with all relevant state agencies and state and local emergency responders and law enforcement within the impacted areas. Sections 147 and 188 of the Military and Veterans Code are applicable during the period of participation in this mission, exempting the California Military Department from applicable procurement rules for specified emergency purchases, and those rules are hereby suspended.

I FURTHER DIRECT that as soon as hereafter possible, this Proclamation be filed in the Office of the Secretary of State and that widespread publicity and notice be given of this Proclamation.

This Proclamation is not intended to, and does not, create any rights or benefits, substantive or procedural, enforceable at law or in equity, against the State of California, its agencies, departments, entities, officers, employees, or any other person.

Local rules have to be at least as restrictive as State Rules

No person shall act as a judge in any division in which he/she or a member of his/her immediate family is an exhibitor, is in charge of an exhibit or division, in charge of a group of exhibitors, or a member of a group of exhibitors

Department heads, judges, staff, anyone directly involved in the judging process, and their spouses are not allowed to exhibit or sign entry forms in any division in which they or their spouse are directly involved. Department supervisors cannot supervise in a department where direct relatives exhibit. First cousin or closer.

CURRENT RULES

2022 Siskiyou Golden Fair LOCAL RULES

1. All Local & State Rules must be followed by all exhibitors. Any infraction of these rules will result in the loss of all premiums and possible removal from the fairgrounds.
2. No pets, other than dogs performing at the fair or service dogs will be allowed on the grounds.
3. No soliciting, other than by authorized concessionaires and commercial vendors will be permitted on the grounds and only within the confines of their designated space.
4. Extension cords used to distribute power to any electrical apparatus such as fans, etc. shall be rated 15 amps minimum and contain a ground wire. Cords not meeting these requirements shall be confiscated for the duration of the fair.

ADMISSION, CAMPING & PARKING

5. Adult passes are available only to 4-H, FFA, Grange leaders and parents/legal guardians of junior livestock exhibitors, who have paid entry fees. Adult passes/wristbands will not be given out without an official weigh slip and/or checked registration papers.
6. All persons wishing to stay on the fairgrounds/RV Park/Dry Camp Lot must register with the fair office. Trailers will be assigned to a specific location and must stay in that space. Spaces will be assigned based on total length (including all hitches, spare tires, etc.) taken up.
7. A fee will be charged for each space in the camping area for the duration of the fair and must be paid prior to the fair. There are no electrical or water hookups in the dry camping lot.
8. Fair staff will be available to assist with the placing of trailers on the Sunday prior to the fair. For an additional fee, trailers may be parked on Saturday from 10 AM to 1 PM. All units must be in place by Tuesday and stay on the grounds until Sunday.
9. Camping area adult supervisors must be a minimum age of 25. Name of supervisor must be listed on the contract. Junior exhibitors who, in the opinion of the adults in charge, fail to conform to accepted standards of conduct will be removed immediately (with livestock) from the fairgrounds and all premiums forfeited.
10. A midnight curfew will be enforced for all campers. Any disturbances or violations should be reported immediately to the Livestock Superintendent. Disturbances will not be tolerated, and violators will be removed from the grounds and their premiums forfeited. No generators are to be used in the camping area.
11. Areas are to be kept clean and fire-hazard free. There will be no open flames.
12. There will be absolutely no camping in the livestock barns.
13. Only motor vehicles with the appropriate pass will be allowed in the RV Park lot (Gate 9 with access from Sharps Road). Those found in the RV Park without a pass

will be towed at the owner's expense. There will be no vehicles allowed through the Livestock Gate (Gate 1) after 10 PM on Tuesday for the duration of the fair without Fair Management's approval.

EXHIBITORS, ENTRIES, JUDGING & PREMIUMS

14. Exhibitors are allowed to exhibit in the Junior Department through December 31st of the year that they turn 19 years of age.
15. All independent junior livestock exhibitors entering market animals must provide Fair Management with a picture of the project animal with identification number/notching, appropriate proof of ownership/bill of sale, permanent tag, tattoo and/or hog ear notch information 120 days prior to fair for beef and dairy; 60 days prior to fair for swine, sheep and goats; and 30 days prior to fair for rabbits and poultry.
16. Independent exhibitors must comply with all State and Local Rules including the following: must be at least 9 years old and not older than 19 on January 1st or one year out of high school; must maintain an Independent Record Book and follow all local compliance requirements; and must wear blue or black jeans and a white button-down shirt in the show ring.
17. The owner or authorized agent(s) must present exhibits in person. Exhibits will not be accepted by mail or dropped off early. Items entered in previous Siskiyou Golden Fairs may not be entered.
18. Fair Management reserves the right to limit the number of entries made by an exhibitor.
19. All junior livestock exhibitors (excluding peewee) will be competing for specie overall showmanship in market or breeding classes. Those selected from those classes will come back for the overall showmanship drive at the end of all market and breeding classes. The animal used for the overall species showmanship lot must be the same animal that was used to gain entry into said lot. The overall specie showman will then be eligible for Round Robin Showmanship.
20. Any Junior Livestock Exhibitor that sells a market animal is responsible for all duties as an exhibitor until the fair closes at 8:00 PM on Sunday. Noncompliance will result in disqualification.
21. No entry will be accepted where an exhibitor prescribes conditions under which he/she will enter.
22. Fair Management reserves the right to return entries, transfer entries or combine classes or lots and/or cancel classes or lots in which, in its judgment, the entries are insufficient to secure adequate competition or in case of an emergency.
23. The 10th DAA/Siskiyou Golden Fair has a **"no refund" policy**. Upon entering an exhibit in the fair, signing the entry form online or hard copy, you are agreeing that there will be no refunds or exchanges for any fees charged.
24. The State Fire Marshal shall check each booth and barn area for fire hazards. All material and decorations must

- be of a nonflammable material or treated and maintained with a flame retarding product.
25. Livestock will be released from 8 PM to 9 PM on the Sunday of fair. Still exhibits will be released from 8 AM to 6 PM on the Monday following the fair. After that exhibits will be released during business hours.
 26. All exhibits and equipment must be claimed and removed within 5 working days of the close of the fair. Anything not claimed after 5 days becomes property of the 10th DAA and may be disposed of after that time.
 27. Occasionally discrepancies arise between the color of the ribbon on the exhibit and the judge's placement sheet. If this occurs the official judging sheets will take precedence.
 28. The 10th District Agricultural Association has budgeted to pay premiums for the fair. In the event the total premiums won by the exhibitors exceed the budgeted amount, premiums may be pro-rated to the exhibitors at the discretion of the Board of Directors and Fair Management.
 29. All still exhibit premium payments will be paid out in cash at the fair office during posted hours. A form of identification or the issued claim ticket and a signature will be required for pickup of premiums. Livestock premiums (including small animal) will be available at the Livestock Office Sunday of the fair and then at the fair office. Cash and check premiums not picked up within 10 working days of the closing of the annual fair will be considered a donation to the association. Premiums will be paid out in accordance with State Rule IV. Awards and Scoring – 4. Cash awards will be paid only as recorded on the signed judging sheet or judging affidavit and only to the exhibitor.
 30. Premium checks will not be mailed (with the exception of the Senior Horse Show). Livestock checks not picked up within 10 days of the closing of the fair will be null and void and not reissued.
 31. In the case of Senior Livestock & Horse Show lots, full premiums will only be paid out in lots with three or more animals.
- LIVESTOCK & HORSE DEPARTMENTS**
32. Livestock will be accepted on the fairgrounds from 8 AM to 10 PM on Tuesday; times depend on species. Arrivals prior to Tuesday must make arrangements with Fair Management. A charge of \$5.00 per head will be assessed on all early arrivals and those who have not vacated the grounds within 24 hours after the close of the fair.
 33. All animals must be loaded/unloaded on the grass surrounding the livestock barns. No animals will be permitted to be loaded/unloaded on the pavement. Once an animal has been loaded/unloaded, the vehicle must be removed from the livestock area. An automatic red tag will be issued for loading/unloading animals on the pavement.
 34. All animals must be stalled according to the space allocated by Fair Management. Pens/stalls are not to be transferred without approval from the Livestock Superintendent.
 35. All junior livestock exhibitors, including horse exhibitors, must have a stall card on their pens/stalls identifying themselves, their animals and their club/chapter/independent. Pens/stalls in use but not identified will be red tagged by Fair Management.
 36. No "For Sale" signs are to be put on pens/stalls until after the auction on Sunday.
 37. The fair will not allow straw bedding, with the exception of breeding sheep and senior cattle classes. This rule applies to both junior and senior exhibitors. The fair will furnish first bedding to junior exhibitors only.
 38. Pelletized bedding is prohibited.
 39. All junior livestock exhibitors must attend a mandatory meeting on Wednesday at 7:45 AM in the auction arena.
 40. Weighing of animals for classification will be held at the time of unloading. See appropriate species for weigh in and preg/health check dates and times. If there is a protest of weight, the exhibitor must indicate it immediately. The animal will be taken off the scale and held in the adjacent area while the scale is rebalanced. The animal and the exhibitor may not leave the weigh area. The animal will be immediately reweighed. This will then be the official weight and the one assigned to the animal.
 41. There are to be no private scales on the grounds.
 42. Immediate family members can raise one backup animal per family/for all siblings. The animal needs to be listed on each exhibitor's entry form to be eligible.
 43. Any market animal failing to meet minimum or exceeding maximum weight limits is to be removed from the grounds on the day of weighing.
 44. All pens/stalls (of Junior and Senior exhibitors) must be cleaned by 8 AM each day.
 45. All livestock are to be washed inside wash racks only. Anyone found not complying and creating a water and mud nuisance will be issued a Red Tag.
 46. There will be no grooming or clipping of animals on the mall lawn or in the judging arenas at any time.
 47. No cross-species nursing allowed. No nurse-animals allowed on the grounds.
 48. Exhibitors found guilty of any form of mistreatment or cruelty to livestock such as salting, force feeding, muzzling or tying animals while in pens to restrict them from feed or water, etc. will forfeit all premiums and privileges.
 49. All livestock, except horses, is to be confined to the south side of the Small Animal Barn and west of the center mall asphalt. Horses will not be permitted in any area other than the Equestrian Complex and the Grandstand Arena, if being shown there.
 50. Juniors, who for extraordinary reasons cannot show their own animals, must make arrangements for their care and showing and receive approval from Fair Management. Only juniors eligible to show in the Junior Department may show and care for the animal for the absent exhibitor.
 51. Substitutions can only be made within the same lot as the original entry.
 52. No one, with the exception of the judge, exhibitors and fair staff, will be allowed in the show ring during judging.

Violation of this rule may cause disqualification of the exhibitor and forfeiture of any premiums.

53. The judge of any market animal may call for a reweigh at his/her discretion. The official weigh master weight will be used for breaking lots and for the auction.
54. All market livestock receiving "not market ready", "not market acceptable" or "Grade 2" in a market lot are not eligible for auction. The Livestock Superintendent may remove said animals from the fairgrounds at any time during the fair should the exhibitor fail to care for the animals.
55. Junior Exhibitors receiving Grand or Reserve Champion honors must move their market animal to the Avenue of Champions. The animal must remain in the avenue on public display until it is sold in the auction. After this time, it may be returned to its respective barn to be loaded with the other animals. All Red Tag rules apply to the Avenue of Champions.
56. There will be no gate holds.
57. No food or alcohol will be allowed in any livestock barns at any time. Non-alcoholic drinks with lids are acceptable. This does not apply to the Sedge Nelson Judging Arena.
58. All livestock, including rabbits and poultry, will be released at 8 PM Sunday evening. Buyers with live pick up may make arrangements with the Livestock Superintendent to pick up animals prior to 8 PM.
59. Pen decorations may not be removed until 6 PM on Sunday.

HORSES:

60. State Rules shall supersede any Horse Association Rules. Rules and definitions for conducting each lot as contained in the rule book for the USA Equestrian will apply, unless otherwise specified.
61. Entrants may not cross enter in halter lots.
62. Stalls will be available starting the Tuesday of fair week. A fee per stall per day must be paid with entry fees.
63. Horses may be led to the arena gate, but riders must enter on their own. Violation of this rule will result in disqualification of the rider.

BEEF & DAIRY CATTLE:

64. All cattle are to be halter broke-to-lead. Runaway cattle are subject to removal from the grounds.
65. Cattle will be required to have a double tie at night. One tie will be around the neck.
66. All bulls over the age of 12 months must have a nose lead or the animal will be removed from the grounds.
67. Bred beef market heifers under 24 months of age must calve by April 30th. Heifers 24 to 30 months must be due to calve by December 31st. No heifers over 30 months of age.
68. Bred beef market and dairy heifers must have a mandatory second opinion on all pregnancy tests if the first veterinarian determines any abnormalities or the heifer to not be pregnant. A second opinion is mandatory prior to the animal being removed from the fairgrounds. See appropriate species for weigh in and preg/health check dates and times.

69. All market bred heifers are required to have four working quarters.
70. If the fair's veterinarian determines any heifer to have an unacceptable narrow pelvic canal, the animal will be sifted and sent home.
71. Junior yearling dairy cattle in milk must be shown with two-year olds in both the individual and group lots. Please let the livestock supervisor know "in milk" at check in.

SHEEP & GOATS:

72. All breeds for market goats will be judged together.
73. All market goats must be castrated, disbudded and completely healed by the official weigh date.
74. Dwarf goats are considered small animals.
75. Horn re-growth must not exceed one inch in length and be blunt ended.
76. Market goats must be one year old or less and show kid teeth.
77. Market goats must be slick shorn to 3/8", but not below the knees and hocks.
78. All goats and sheep will be vet checked. Market animals will be checked at the scales, all other animals will be checked at their pens. Exhibitors need not be present at their pens. Should there be any problems; the Livestock Superintendent will notify the exhibitor. Any animals failing to pass the check will be sent home immediately. See appropriate species for weigh in and preg/health check dates and times.

POULTRY:

79. Rules, definitions and judging procedures as prescribed in the latest edition of the Official Show Rules and Standards of Perfection of the American Poultry Association, Inc. shall apply to all district and county fair poultry shows, except in such instances where they are in conflict with the rule and regulations prescribed by the Department of Food & Agriculture.
80. Poultry will not be permitted on the fairgrounds until they have been inspected by the Poultry Inspector. See appropriate species for weigh in and preg/health check dates and times.
81. Leg bands are required on all entries. All birds must be numbered with legible numbered bands prior to cooping at the fair. The number of this band must be the same as shown on the entry form. Duplicate numbers must not be used on birds of the same variety.
82. All crates must be removed from the showroom as soon as the birds are transferred to the show coops.
83. All birds will be shown in suitable coops. The right is reserved to double-coop females of the same variety, owned by one exhibitor.
84. Turkey leg bands will be issued at check in at the Livestock Office.
85. Turkeys will be penned in the sheep barn.
86. Substitutions can only be made within the same class as the original entry.
87. Eggs laid will become property of the fair.

88. Judging of eggs will be based on size, interior quality, condition of shell, uniformity of size and shape, shell texture, uniformity of color and shape.
89. The judge reserves the right to break the eggs if it is deemed necessary in order to properly judge the exhibit.

RABBITS & CAVY:

90. The age in months or date of birth, breed and color must be stated on the entry form for each animal entered.
91. All animals must be identified by legible permanent ear markings conforming to the entry form on arrival at the show. Any duplication of ear markings by one exhibitor in the same lot must be eliminated and the change recorded on the judging sheet before judging.
92. Animals to be shown in the order posted in the Small Animal Barn.
93. A judge may disqualify a rabbit from competition because of temporary or curable defects.

Local Rules (2023 Revision)

It is the responsibility of all exhibitors to read and follow all State and Local Rules. Any infraction of these rules will result in the forfeiture of all premiums and possible removal from the fairgrounds.

1. No pets are allowed on the fairgrounds, including the camping areas, without fair management approval.
2. Soliciting is prohibited on the fairgrounds without a contract.
3. Extension cords used to distribute power in all areas of the fairground must be rated 15 amps minimum and contain a ground wire. Cords not meeting these requirements will be confiscated.

Admission, Camping & Parking

4. Adult passes are available for parents/legal guardians of junior livestock exhibitors who have paid entry fees online at the time the child enters the fair. No onsite sales. Two passes available per exhibitor.
5. All livestock exhibitors receive a free admission wristband at check in.
6. 4-H, FFA or Grange Leaders with proof of leadership receive a free admission wristband.
7. Camping contracts are established prior to the fair and all rules and regulations must be followed. Those failing to follow camping guidelines will be removed from the fairground and all premiums and privileges will be forfeited.
8. Absolutely no camping in the livestock barns.
9. The livestock gate (gate 1) will be closed to through traffic at 10 PM on Tuesday without prior approval from fair management. The south parking lot is provided free of charge.

Exhibitors, Entries, Judging & Premiums

10. The 10th DAA/Siskiyou Golden Fair has a **"no refund" policy**. Upon entering an exhibit in the fair and by signing the online or hard copy entry form, you are agreeing that there will be no refunds or exchanges for any fees paid.
11. Fair management reserves the right to limit the number of entries made by an exhibitor.
12. Junior market exhibitors are not limited on the number of species they can enter but should refer to the auction rules for selling of animals.
13. No entry will be accepted when an exhibitor prescribes conditions under which he/she will enter. Items entered and judged in previous Siskiyou Golden Fairs are ineligible.
14. Fair Management reserves the right to return entries, transfer entries or combine classes or lots to secure adequate competition or in case of emergency.
15. Substitutions can only be made within the same department as the original entry.
16. The State Fire Marshal will check all exhibits and barns for fire hazards. All material and decorations must be non-flammable or treated and maintained with a flame retarding product.

17. The owner or authorized agent(s) must present exhibits in person during posted hours. Exhibits will not be accepted early or by mail.
18. Occasionally discrepancies arise between the color of the ribbon on the exhibit and the judge's official placement sheet. If this occurs the official judging sheet will take precedence.
19. The 10th District Agriculture Association has budgeted to pay premiums for the fair. In the event the total premiums won by the exhibitors exceed the budgeted amount, premiums may be pro-rated to the exhibitors at the discretion of fair management.
20. All still exhibit premiums will be paid out in cash at the fair office during posted hours. A form of ID or the issued claim ticket and a signature will be required for pickup of premiums.
21. Livestock premiums (including small animal) will be available at the livestock office on Sunday of the fair, those remaining after Sunday will be available in the fair office. Cash and premium checks not picked up within 10 working days after the fair will be considered a donation to the association. Premiums will be paid out in accordance with State Rule IV. Awards and Scoring – 4. Cash awards will be paid only as recorded on the signed judging sheet or judging affidavit and only to the exhibitor.
22. Premium checks will not be mailed (except for the Senior Horse Show).
23. For Senior Livestock and Horse Show lots – Full premium will only be paid out in classes with three or more animals exhibited.
24. Livestock will be released after 8 PM on Sunday of the fair. Still Exhibits will be released from 8 AM to 6 PM on Monday following the fair. After that, all exhibits will be released during business hours.
25. All exhibits and equipment must be claimed and removed within 5 business days after the close of fair. All unclaimed goods become the property of the 10th DAA and will be disposed of after that time.
26. Exhibitors exhibit in the **Junior Department** through December 31st of the year that they turn 19 years of age.
27. All junior market animal exhibitors are required to enter showmanship. Junior exhibitors with breeding projects are encouraged to enter showmanship. Showmanship winners from the Senior and Junior Showmanship class will compete for round robin. Pee Wee showmanship finalists will also be selected during each specie show. Failure to enter showmanship will result in a \$10.00 late fee.
28. Immediate family members can raise one backup animal per family for all siblings. The animal needs to be entered on each exhibitor's entry form to be eligible. Each exhibitor listed on the back up animal must have an animal entered in that market class.

Independent Exhibitors:

29. Independent exhibitors entering a market animal will be required to register with the fair office by March 1 and pay the independent project entry fee for project

administration. The \$100.00 fee will be used as a stipend for the independent project supervisor.

30. All independent junior livestock exhibitors will be required to provide a picture of the project animal with identification number /notching, proof of ownership/bill of sale, permanent tag, or tattoo information 120 days prior to fair for beef and dairy cattle; 60 days prior to fair for swine, sheep, and goats; and 30 days prior to fair for rabbits, turkeys, and poultry.
31. Independent exhibitors must comply with all State and Local Rules: Exhibitor must be at least 9 years of age and not older than 19 on January 1st of current year or one year out of high school; must maintain an Independent Record Book and follow all local compliance requirements; and must wear black or blue jeans and a white collared shirt in the show ring.

Livestock & Horse Departments

32. All livestock, except horses, is to be confined to the south side of the Small Animal Barn and west of the center mall asphalt. Horses will not be permitted in any area other than the Equestrian Complex and the Grandstand Arena if being exhibited there.
33. Market animal load-in times can be found in the livestock schedule. All livestock will arrive between 8 AM and 10 PM on Tuesday of fair week. Early arrivals must contact fair management for approval. A \$5.00 per head per day charge will be assessed on all early arrivals and those that have not vacated the grounds within 24 hours after the close of the fair.
34. Weigh-in for all market animals will occur at the time designated for unloading. See the livestock schedule for all dates and times. If there is a weight protest, the exhibitor must indicate it immediately. The animal will be taken off the scale, the scale rebalanced, and the animal will be immediately reweighed. This will then be the official weight and the one assigned to that animal for class breaks and the JLAC auction.
35. Animals that do not meet the weight requirement are still eligible for showmanship and may stay on grounds for the duration of the fair. If the exhibitor so chooses, they can leave immediately.
36. All Junior Livestock Exhibitors must attend the mandatory meeting on Wednesday at 7:45 AM in the large show ring.

Non-Compliance with local rules 42 – 48 will result in the exhibitor receiving a RED TAG.

37. All pens/stalls (Junior and Senior Exhibitors) must be cleaned by 8 AM each day.
38. All animals must load or unload on the grass areas in the livestock area. Animals loaded or unloaded on asphalt will be issued a RED TAG.
39. All junior livestock exhibitors, including horse exhibitors, must have a stall card identifying themselves, their animal, and their affiliation – 4-H, FFA or independent.
40. Livestock are to be washed/rinsed inside wash racks only.

41. Grooming is not allowed in the judging arenas or on mall lawns.
42. No cross-species nursing allowed. Nurse-animals are not permitted.
43. Food and alcohol are not allowed inside any barn. Non-alcoholic drinks with a lid are acceptable. This does not apply to the Large Show Ring or the Small Show Ring.
44. Junior market animal exhibitors that sell a market animal are responsible for all the duties associated with their project until the fair closes at 8 PM on Sunday of fair. Failure to comply will result in disqualification and forfeiture of all proceeds of sale.

RED TAG POLICY

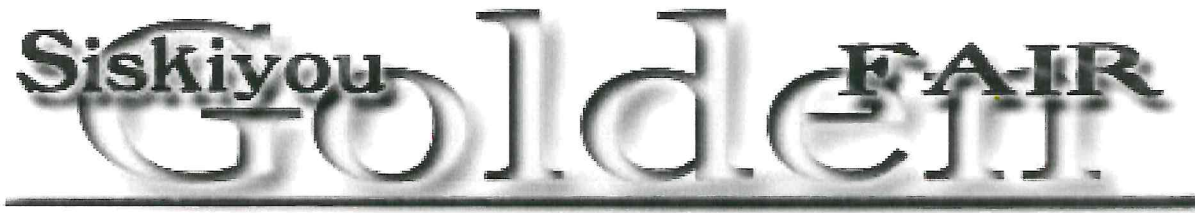
This policy is to ensure that livestock exhibited at the Siskiyou Golden Fair are cared for and treated in a humane and ethical manner and that livestock pens/stalls are suitable for public display. Livestock exhibitors (junior and senior) are solely responsible for the care of their animals while on exhibit at the Siskiyou Golden Fair. If the Livestock Superintendent becomes aware of any livestock exhibit that is not being cared for in an acceptable state of pen cleanliness as determined by the Livestock Superintendent or is not being maintained, the following will occur:

- The Livestock Superintendent will determine the name and affiliation of the responsible exhibitor.
- A Red Tag with the following information will be affixed to the exhibitor's pen/stall: exhibitors name, observed problem, date and time of citation, Livestock Superintendent's signature. The Livestock Superintendent will make reasonable efforts to contact the exhibitor's advisor, parent or designee and advise them of the situation resulting in the Red Tag citation.
- It is the exhibitor's responsibility to respond to the Red Tag by contacting the Livestock Superintendent within 12 hours of the citation being issued. The exhibitor will formulate and initiate a plan of correction approved by the Livestock Superintendent.
- Any exhibitor failing to make contact within 12 hours will be issued another citation.
- Any exhibitor receiving two Red Tag citations during the fair will be declared ineligible for further competition, including participation in the Junior Livestock Auction. All fair premiums and awards earned will be forfeited, and the exhibitor will be required to remove their animal(s) from the fairgrounds.
- Any exhibitor that is required to remove their animal(s) from the fairgrounds must do so within 12 hours from the time of notification and coordinate with the Livestock Superintendent.
- Adults are not to groom, or in any way, care for animals of junior exhibitors. Violation of this rule will result in a red tag.

45. All animals must be stalled in the space allocated by fair management. The Livestock Superintendent must approve changes.
46. Junior Livestock exhibitors are provided chips and shavings for first bedding. Shavings are available for purchase for the remainder of the fair.
47. Straw bedding is not allowed except for breeding sheep and senior cattle entries.
48. Pelletized bedding is not permitted.
49. Private scales are not permitted on the fairgrounds.
50. Cruelty to animals will not be tolerated. Salting, force feeding, muzzling, or tying animals while in pens to restrict them from feed or water will evoke an immediate disqualification and removal from the fairgrounds.
51. Friends, family, and the public are not allowed in the showing during judging. Participation is limited to the judge, the exhibitors, and fair staff or volunteers.
52. There will be no gate holds.

53. Juniors who cannot show their own market animal(s) must request in writing with specifics and receive written fair management approval before being allowed to participate. Care and showing of animals must be done by an eligible junior if approved.
54. The judge of any market animal may call for a reweigh at his/her discretion.
55. Market livestock receiving "not market ready", "not market acceptable", or "Grade 2" in a market lot are not eligible for auction and are required to stay on grounds for the duration of the fair.
56. Junior livestock receiving Grand or Reserve Champion honors must move their market animal to the Avenue of Champions. The animal must remain in the avenue on public display until it is sold at auction.
57. No "For Sale" signs are allowed on pens or stalls.
58. All livestock, including rabbits and poultry, will be released after the fair closes at 8 PM on Sunday. Buyers with live pick-up may arrange pick up with the livestock superintendent.
59. Barn decorations can be removed after 6 PM on Sunday.

2022 SISKIYOU GOLDEN FAIR JUNIOR LIVESTOCK INDEPENDENT EXHIBITOR PROGRAM REQUIREMENTS

Welcome to the Siskiyou Golden Fair Junior Livestock Independent Exhibitor Program! We are very pleased that you have decided to bring an animal to the fair to exhibit, and possibly sell at the 10th District Junior Livestock Auction. **Be sure to read all the enclosed information carefully and meet all the requirements and deadlines.** Failure to comply with any rules or requirements/deadlines may result in disqualification of all entries and the forfeiture of all entry fees.

WHO QUALIFIES AS AN INDEPENDENT EXHIBITOR?

An exhibitor who is not eligible to compete in a certain category as a member of a 4H, Grange or FFA junior organization (i.e., exhibitor is not a member of a club; exhibitor is a member of 4H but there is no project leader for the exhibitor's chosen project species or high school students who cannot fit FFA into their school class schedule may show at the Siskiyou Golden Fair as an independent exhibitor). Independent Exhibitors **MUST** be 9 years of age by **January 1, 2022**, to compete in large animal (Beef, Sheep, Swine, Dairy Cattle, Dairy Goats, Boer Goats, Market & Fiber Goats, Horse & Llama) competition at California Fairs or to sell in the 10th District Junior Livestock Auction held during the Siskiyou Golden Fair. Exhibitors are eligible to complete/exhibit through December 31st of the year in which they turn 19 years of age. Exhibitors may be ineligible to participate as an Independent Exhibitor if documented, disciplinary action involving their project(s) has been taken against them by 4H, FFA or Grange organizations. Length of ineligibility is to be determined by fair management. All exhibitors must have "on ground" supervisor by a responsible adult during the fair. Independent Exhibitor Records are only required for market animals going to auction; not breeding animals.

INDEPENDENT EXHIBITOR REQUIREMENTS (Market Animals Only):

Proof of Ownership - DEADLINE (by species) no later than 5:00 PM at the Fair Office (ALL following documents and pictures MUST be turned in together and no emails will be accepted):

- Project Registration page (attached) completed and signed by both the Exhibitor and Parent/Guardian.

 - Appropriate proof of ownership/bill of sale. A bill of sale, with all the pertinent information, **is required even if the animal was raised from birth by the exhibitor.**

- If you have a backup animal (individual or family), the same above information needs to be submitted.
 - Quality Assurance training verification. The course may be completed online (www.yqca.org) or attend the training provided by the 10th DAA/Siskiyou Golden Fairgrounds in February/March. There will be no 10th DAA makeup trainings. You must turn in a copy of your online training certificate or have signed in on the training check in sheet. The check in sheet will be verified when you turn in your proof of ownership documents. Quality Assurance is good for one year from the date taken.
 - Adult Supervision/Independent Exhibitor Leader Information Form completed and signed.
 - Providing these documents will REGISTER you as an Independent Exhibitor for the 2022 Siskiyou Golden Fair. Turning in the Exhibitor Information form **DOES NOT** enter the exhibitor into the fair. See Entering the Fair section below.
- **Entering the Fair - DEADLINE no later than 5:00 PM on Friday, July 22, 2022, ONLINE ONLY:**
 - The project animal must be “entered” into the annual fair or through the online system on the fair website (www.sisqfair.com). Please input IND for the club’s name. Be sure to complete the online entry by clicking submit, paying the fees and getting a confirmation email. Maintain this confirmation email for your records.
 - Class Listings will be available on the fair website no later than June 1st.
 - All State and Local Rules are to be reviewed and followed by the Exhibitor.
 - Parent passes MUST be purchased at the same time as the project gets entered at a discounted price. Each pass is \$20.00 and a maximum of two may be purchased (you will need to add the class once for 1 pass, twice for 2 passes). Please see the appropriate class under each species or under Department 20.
- **Training, Education & Other Reporting – DEADLINE (minimum of 9 meetings total) no later than 5:00 PM at the Fair Office on Monday, August 1, 2022:**
 - Exhibitor **MUST** attend six (6) educational meetings/trainings from October to July of the current year related to your project.
 - Exhibitor **MUST** attend three (3) Junior Livestock Auction Committee Meetings with an adult. These meetings are held the 3rd Thursday at 7:00 PM of each month (meetings are held in September, October, April, May, June and July) at Winema Hall on the fairgrounds (unless otherwise noted), be sure to sign in. **Failure to do so will result in a 12% commission deducted from your auction check instead of the standard 6%.**
 - Document each meeting, in your own format, with the following items: Date of Meeting, Type of Meeting/Training, a Summary of what was discussed and Location of the Meeting.
 - Exhibitor **MUST** provide a minimum of six (6) hours of community service. Document each service, in your own format, with the following items: Date of Service, Type of Service, a Summary/Description of the service that you provided and who it benefited, Location of Service and time spent on Service.
 - Exhibitor **MUST** provide documentation of all medication and weight gain/loss during the project. This record will show any shots or medication (including dosage and purpose) that was received and when (follow withdrawal times on all medication). If NO medication was provided, a document stating that is to be turned in.
 - This information is to be turned into the fair office by the deadline. If it is not turned in, the Independent Exhibitor **WILL NOT** be able to participate in the 2022 fair.

Siskiyou Golden Fair

- All Exhibitors **MUST** attend the livestock meeting prior to the fair on **Wednesday, August 10, 2022, at 7:45 AM in the Show Ring.**
 - A stall card is mandatory on the project pens. It is to identify themselves, their animals, and their hometown.
 - Exhibitors must follow all rules and regulations, including dress code, pertaining to junior livestock exhibitors at the annual fair. See all rules listed on the fair website www.sisqfair.com.
- **After the Siskiyou Golden Fair & 10th District Junior Livestock Auction**
 - The Auction Committee will mail out a listing of all that participated in the purchase of your animal so you can prepare the thank you cards. Thank you cards are to be wrote out to everyone on the list, including add on buyers.
 - Approximately 10 days after the close of the annual fair the payments to Exhibitors from the auction will be available at the fair office.
 - **TO PICK UP YOUR PAYMENT**, all above items must have been turned in by the deadlines and the following:
 - Exhibitor **MUST** produce a Project Record. This record is used to record all expenses and income related to the project. If you have two projects, each animal should have its own project record. Document the information, in your own format, with the following items: Date, Description, Expense (including the purchase of the animal and feed costs), Income and Hours Spent on the project (training, feeding, etc.). All records should be documented clearly. Be sure to include all entry fees and sale costs as well as document the net profit on the project.
 - The Exhibitor **MUST** submit a one (1) page, typed, double spaced summary of your overall project. This report will include what you learned, liked, would do again, etc.
 - Addressed, sealed and stamped thank you cards to each buyer and add-ons **MUST** be brought in with the final reports **NO LATER THAN SEPTEMBER 30th**.
 - Auction checks **WILL NOT** be released without the receipt of the Independent Exhibitor's Project Record & Project Summary and appropriate thank you cards.

All reports and records, with the exception of the Project Registration Page and Supervisor Form, may be handwritten or typed by the Exhibitor and in a format of the Exhibitors choice.

Please use the Exhibitor Checklist page to assist you in completing the correct documents and submitting them to the Fair Office on time.

Complete Independent Exhibitor Documents will be available for pickup after September 30th. Independent Exhibitor Documents not picked up by November 1st will be destroyed.

Unacceptable Record Books/Documents turned in may result in not being able to register as an Independent Exhibitor in the following year.

All documents need to have the Exhibitor's Name and Project Year listed on the front.

The Siskiyou Golden Fair will run August 10-14, 2022.
